Newest Tubb Well Rates 301 Barrels For 24-Hour Flow

Sun Jameson Reef Unit No. 4-P on the Willie I. Tubb lease west of Silver has been completed for a daily flowing potential of 301.1 barrels of 48.4 gravity oil, no water, with gas-oil ratio of 1,524-1.

Production was through a 1/4-inch choke and perforations between 6,378-86 feet and open hole between 6,396-6,463 feet. Top of pay was 6,377 feet. The pay section was acidized with 5,000 gallons.

Jameson Reef Unit No. 8-N, also located on the Tubb lease, flowed 250 barrels of oil and 97.5 barrels of wash water during a 16 1/2 hour test the first of the week. Tubing pressure was 850 pounds and casing pressure 1,000 pounds. Gas-oil ratio 1,330-1. It was treated with 5,000 gallons of acid.

Baker-Taylor had the contract and moved to Sun Mathers No. 24 where surface casing was cemented at 514 feet.

Sun Mathers A-5 is cleaning to pits after acid treatment of 8,000 gallons of acid. No guage has been made of the oil recovery. The hole is bottomed at 6,374 feet.

Jameson Reef Unit 15-H on the Fred Jameson lease was drilling Wednesday at 6,082 feet in shale and sand.

Sun No. 23 Mathers cemented an oil string seated at 6,404 feet.

Sun No. 26 Mathers was drilling in shale at 5,502 feet.

CUMMINGS RUNS HIGH

In the Millican field west of Edith Sun No. 14 Annie L. Cummings hit the lime reef 60 feet high and cemented casing to 5,866 feet.

Union Oil Co. No. 3 Elizabeth McCutchen has been completed for a daily flowing potential of 110.4 barrels of 43.4 gravity oil, with gas-oil ratio of 237-1.

Production was through a 14-64ths inch choke and perforations between 3,961-87 feet in 5 1/2 inch casing cemented at 3,999 feet. Top of pay was 3,961 feet.

Twenty acre spacing is permitted in the field, allowing eight locations in the northeast quarter of Section 445, where mineral rights are owned by heirs of the late Elizabeth McCutchen.

Morgan Drilling Co. had the contract, but a new location has not been staked by Union on this lease. Contractors stacked their rig Wednesday and crew was layed off temporarily.

Inches of Rainfall Meaning Explained

What do people mean when they speak of a "two-inch rainfall"?

According to data included in the new edition of the Smithsonian meteorological tables, just published by that institution, this means that approximately 227 tons, or 54,308 gallons, of water has fallen on each acre of the area designated.

Similarly, a hundredth-of-an-inch rainfall means 1 ton, or 272 gallons, of water per acre. A half-inch fall represents 57 tons, or 13,577 gallons per acre. For a one-inch fall the figures rise to 113 tons, or 27,154 gallons.

The destiny of water is calculated at 62.4 pounds per cubic foot.

Bible Reading Is Urged by Society

The people of the world express themselves in 2,796 languages and dialects. The Bible has been printed in 1,035 of these tongues.

Twenty-one Bibles per minute, every day around the clock, are placed into circulation. It is estimated that more than a billion Bibles have been printed.

These statistics certainly support the statement that the Bible is the world's most widely distributed book. But is the Bible the world's most widely read book?

Even the nation's foremost Bible distributing agency, the American Bible Society, doesn't think so. A scoffer once said that if all the Bibles that gather dust from disuse were cleaned off, the ensuing cloud of dust would obscure the sun. No one believes this, of course, least of all the American Bible Society. But the fact remains that readership of the Bible has not kept pace with its circulation, and therefore the society is sponsoring a campaign to promote daily usage of the Bible.



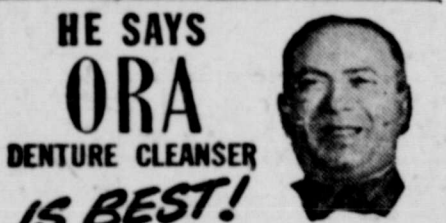

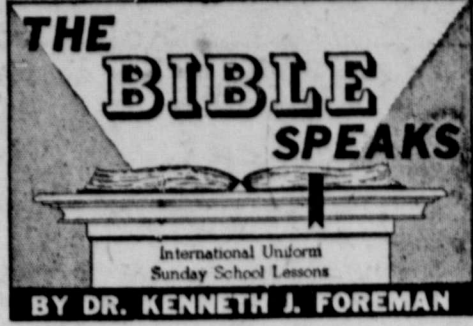

Born Again

Lesson for January 27, 1952

IN many places one often hears the expression, "born - again Christians". As a matter of fact, there are no other kinds. If a person is not born again he is not a Christian.

The first birth is of the natural self, the awakening, so to speak, to this natural world. The second birth is of the supernatural self, the awakening to the spiritual world, the beginning of "living unto God." Sometimes this new birth comes very early in life. Dr. Warfield, a very conservative theologian, used to think that the second birth might in some cases actually come before the natural birth. (Jeremiah 1:5).

A man may become very distinguished, may be a great scholar, and still not have been born again. Nicodemus is a case in point. He was a man who had everything, as the saying is; he was a judge in the Jewish High Court, a man both wealthy and respectable. But he had not been born again.

God Is the Life-Giver

THE English translation of John 3:7 has given many persons the idea that being born again is a duty. Now a duty is something that you ought to do, and that by your own choice you can do if you will. It's up to you. But (taking the teaching of the Bible as a whole) being born again is not a duty. It is the act of God.

What Jesus was saying (as the Greek of John 3 indicates) is that it is necessary, it is indispensable, to be born again.

The seed which we sow in field or garden must have the germ of life in it or it will never grow. But no farmer can give life to lifeless seed, God alone is the life-giver, in the first birth or in the second.

Turn; Follow

SOME people get this far in their thinking and then they become discouraged. "If only God can give life," they think, "what is the use of my trying to obey him? If God takes that first step then all I can do is to wait for him. No matter how much I want to be a Christian in my heart, I may not be able to for God may not see fit to make it possible for me to do what I want to do." This is a mistaken thought.

John Calvin, as is well known, was a very strong believer in predestination. As pastor of a large church, he had numbers of people in his congregation who heard him talking about predestination, the doctrine that we are in God's hands and that spiritual life can come only as he himself begins it in our souls.

They would ask just about this same question: I want to be a Christian, but how do I know that God has chosen me? I want to be a Christian, but how can I know whether I have been born again? Calvin's answer was a simple one: If you really want to be a Christian in your heart, that is a sign, the very best sign, that you have been born again.

Turn; Follow

IN the Bible, the commands are "Turn"; "Follow"; "Believe"; "Obey". If we have not been born again these commands fall on deaf ears. If they stir our conscience, if they make us respond, then that is a sign we have been born again.

Then can't we tell when we are born again? Certainly we can tell; just by being alive. "We know that we have passed from death unto life, because we love the brethren," said the same apostle who recorded Jesus' conversation with Nicodemus.

We know Matthew was born again because he turned his back on his former life and followed Jesus. We know that Nicodemus said some kind things about Jesus. We know that after Jesus was dead, Nicodemus came through with a handsome contribution for the funeral. Was that only late, or was it too late?

Court Prohibits Divorced Couple From Conversing

With an injunction which forbids the couple from conversing with each other, even by telephone, a decree of divorce was granted here last week to Annie Laura Forehand from M. B. (Reuben) Forehand.

The divorce action came up in a special session of district court on Monday before Judge John Sutton. During recent years Mrs. Forehand's petition for a divorce had been in and out of court a number of times, but had never before come to trial.

Recent trouble between the couple occurred several weeks ago, when Forehand beat up his wife, causing her to be hospitalized.

The decree gives Mrs. Forehand custody of their four minor children, including a baby, 16 weeks old. It is specified that the father may see the children four times a year at the court house. Mrs. Forehand also was given full ownership and possession of the real estate and personal property.

Mrs. Forehand was represented in court by Frank Dickey, while Earl Smith was the defendant's lawyer.
