POLL TAXES COMING IN; 557 HAVE PAID

A total of 557 poll tax receipts had been issued Tuesday morning by Tax Assessor-Collector O. B. Jacobs' office. This number is well above the 333 which had been issued by the same date last year. However, it is below the 694 which had been issued by Jan. 15, 1964, the last major election year.

Jacobs said he expects a rush of Coke County residents to pay the poll tax between now and Jan. 31, which is the last day for paying.

Jan. 31 is also the deadline for paying state and county, city and school taxes without having a penalty added.

Poll taxes may be paid at the tax assessor's office in the courthouse any time during regular office hours until the deadline.

BCD Membership Drive Underway

The annual membership drive for the Board of Community Development is underway and new cards for display in each place of business which is a member will be in the mail soon, according to Cumbie Ivey Jr., who reported Tuesday noon to the BCD. Three new members were welcomed at the meeting, bringing the number of new members during January to five.

Garland Davis spoke briefly on progress being made on working up a new brochure and letterhead for the BCD. He and Supt. Jimmy Bickley are on a committee to work out the new printed materials. Davis stated they still had lots of work to do on this project.

President Vaughan Davis brought up the matter of having letterheads

printed similar to those of the BCD, which could be put on sale to promote the city and county. G. C. Allen offered pictures he has of the present city lake for use on the printing.

Mayor Robert Vaughan suggested that BCD members think over the idea of a contest to select a catchy slogan for Robert Lee, similar to the one recently sponsored by the Abilene Reporter-News.

The mayor also reported that a letter was written to Sun Oil Co. regarding the ball field, lights and stands at Silver, since they will not be needed there after the end of the present school term. An answer to the inquiry informed him that the lights and stands have already been donated to Robert Lee, with the understanding that local interests will take care of dismantling and moving them. It was also specified that the name "Gladney Field" be carried on, since the late Mr. Gladney, for whom the field was named, was the first promoter and donor to make the field possible.

Fern Havins, a member of Silver Lions Club, said the club recently voted to move to Robert Lee the latter part of February. The move will be made after the club's annual pancake supper is held. Havins also asked the help of everyone in putting over the pancake supper, since so many of the club's regular members have been transferred.

President Davis, who is also a city commissioner, brought up the matter of city elections, which are held in early April. He asked those present how they felt about changing Robert Lee's three-man commission type government to the alderman type, which has six members.

Mayor Vaughan spoke on this matter, and reported there has been some discussion in the past in regard to this change. Former mayors and commissioners present were asked their opinions, and Ivey and W. D. McAdams both stated they felt the change should be made in order to do a better job of running the city government. Vaughn was asked to look into the matter for more information and for legal procedures necessary to make the change.

Allen informed the group that within two weeks houses being moved in from Silver plus those which have been moved in during the past year would total 24.

A. B. Sheppard, who is employed with the survey group planning the Robert Lee Lake asked if the present school system is adequate for the anticipated growth which is facing Robert Lee. Supt. Bickley replied that school administrators and trustees are working with an architectural firm in making plans for facilities to be needed in the future.

President Davis praised Marshall Jennings on his past work as president of Silver Lions Club. Davis welcomed Jennings and the other two new BCD members. New members during this month are Jennings, J. B. Swanson, Bill Roe, Garland Davis and A. B. Sheppard.



Such hearing will be continued from time to time, and from place to place, if necessary, until such determination has been made relative to said application as the said Texas Water Rights Commission may deem right, equitable and proper.

H D Agent's News Dept.

Older citizens need to eat well-balanced meals just as much as do youngsters. But too often they neglect to do it.

A problem that often makes cooking seem dull is using the leftovers that tend to accumulate in cooking for only one or two people. One can cut this problem down to size by using the leftovers imaginatively, instead of just serving them the same way over and over.

Home Economists with the U.S. Department of Agriculture and Extension home economists offer these tips:

- Combine leftovers in a one-dish meal. Meat combines beautifully with vegetables, macaroni or rice. Add a cheese or tomato sauce or just plain white sauce and heat in a baking dish. Get extra flavor by adding chopped tomatoes or green onions or chives.

- Top a tossed salad with cut strips of leftover cooked meat or poultry.

- Mix leftover cooked vegetables with raw fresh ones, such as chopped celery, cucumber slices, tomatoes, green pepper, shredded cabbage.

- Cream vegetables, meat, fish or chicken. Or serve them with a tasty sauce. Use a can of tomato or mushroom soup for quick and easy sauce. If the dish is a bit skimpy, a hard-cooked egg may stretch it to serving size.

- Add a bit of relish, snappy cheese or diced cucumber to a cooked dressing for meat or vegetable salad.

A New Shrub for Your Garden

Now is the time to start planning your spring and summer garden. The autumn olive is a shrub that blooms in spring and summer and bears beautiful red berries in the fall and winter.

It is a graceful shrub with sweet-scented, yellow trumpet-shaped flowers. It bears a bountiful supply of red berries which attract and feed all kinds of birds.

On a city lot, the autumn olive is best used as a single plant because it grows 4 to 8 feet tall in 3 to 5 years. Under favorable conditions it bears berries in the same time.

The USDA has developed a new variety called the "Cardinal." It is characterized by its hardiness and fruit bearing. This variety thrives on moderately well-drained soil and survives on very dry soils.

Cold Water Laundering Facts

What happens to the bacteria count when homemakers launder with cold water detergents?

Many inquiries have been received along this line, and to answer these inquiries the U. S. Department of Agriculture began new tests with actual family washes.

This was done as part of long range research on survival of bacteria in home laundering, using both hot and cold water. Earlier studies indicated that large numbers of bacteria survive laundering with both hot and cold water.

In recent tests with cold water detergent, comparisons were made with and without disinfectants. The same concentration of disinfectants were used with cold water which proved effective with hot water.

With no disinfectant, far more bacteria survived in cold water than in hot water washes. When scientists added the appropriate amount of chlorine in the wash cycle, or quaternary disinfectants in the rinse, bacteria count was cut to 40 or less per square inch of fabrics at the end of the spin-dry cycle — regardless of the water temperature.

When laundry was washed in cold water with a cold water detergent, on the other hand, the addition of phenolic or pine oil disinfectants in the wash cycle was relatively in-
