Governor Connally Coming Here Tuesday

Governor John Connally will be here Tuesday, July 30, to inspect the dam construction project now underway on the Colorado River above Robert Lee.

Plans announced early in the week state that the crowded schedule will not allow him to stop in Robert Lee, but his caravan will proceed to the park site above the dam.

Everyone is invited to go to the site in order to meet him.

Mayor Wilson Bryan is making arrangements for the inspection with the cooperation of officials of the Colorado River Municipal Water District. Mayor Royce Lee of Bronte was appointed coordinator for the governors' tour through Coke County.

The Bronte mayor said that a coffee and reception honoring Connally will be held at Bronte city hall, and all Robert Lee residents are invited to attend the gathering. Following the reception, local residents will be able to join the governor's caravan as it proceeds to the damsite.

Governor Connally will leave Abilene Tuesday morning, with the tour bus going through Tuscola and Winters. It will cut back through Wingate and proceed to Fort Chadbourne where a stop will be made. Tentative arrival time at Bronte from Fort Chadbourne is 10 a.m., when the reception is planned.

Estimated time of arrival at Robert Lee is 10:30 to 11 a.m. Following his tour of the dam project, he will go on to San Angelo where a luncheon will be held. The caravan will travel from San Angelo through Christoval to Fort McKavett for another stop. The party will then go to Menard, Brady and Brownwood, where the tour began. There, the governor will board his plane for Austin.

Frank Hildebrand, director of the Texas Tourist Development Agency, is in charge of the tour, which has been designated by Connally as a dedication of the Texas Fords Trail.

Mayor Bryan urged that a large delegation of local citizens should be on hand to greet the governor. He emphasized that a cordial invitation is issued to everyone to meet Connally either at his stop at the damsite or at the reception in Bronte.

A large crowd is expected Sunday, July 28, for the Silver homecoming. The gathering will be held in the fellowship hall of Silver Baptist Church.

Farm Bureau Contests Set For Saturday

P. O. Curtails Saturday Service

Effective Saturday, July 28, all Saturday window service will be discontinued at the Robert Lee post office with the exception of handing out general delivery mail and parcel post until 11 a.m.

There will be no stamps sold, no money orders issued, or any other service which requires a financial transaction. There will be no change in window service hours currently provided Monday through Friday.

Also, there will be no change on star route delivery service.

Postmaster Hugh Lewis Jr. made the announcement this week of the discontinuance of part of the Saturday service offered by the post office.

The cutback in Saturday service is part of a curtailment of postal services throughout the country which was announced following an order to cut expenses.

The expense cutting resulted from insistence by the Congress that federal spending be cut along with passage of the new 10 percent surtax on all income tax paid.

Door Is Smashed At Westway Groc.

Either an attempted break-in or vandalism occurred Saturday night at Westway Grocery in Robert Lee. The glass front door of the food store was smashed, but nothing has been found missing from the store.

Vaughan Davis, owner of the store, told the Observer that he had been unable to find any merchandise missing from his place of business. He said it is possible that the would-be burglar made so much noise breaking in the door that they got "cold feet" and ran away without entering.

Sheriff Melvin Childress said that it is impossible to determine the motives of the culprits, but he was inclined to believe that the incident was simply an act of vandalism.

Constable Ollie Roe discovered the smashed front door on his rounds Saturday night. He called Sheriff Childress and they investigated. Childress said Tuesday that no leads have been obtained.

DICK STANDER TO TEACH SCIENCE AT RL HIGH

Dick Stander, whose home is at Wilson, has been hired as a teacher in Robert Lee high school for the 1968-69 school term. He will teach science in the high school grades.

Stander is a graduate of Wilson High School and Angelo State College. He is single.

Classes To Start Aug. 26 at RLHS

Classes for the 1968-69 school term in Robert Lee will start Aug. 26. However, students will be required to register in advance of that date.

High School students will register Aug. 22 and first graders who are entering school for the first time will register Aug. 23.

Supt. Jimmy Bickley announced the 1968-69 school calendar which shows that a total of 175 days of instruction are awaiting the youngsters who attend school here this coming year.

Students will hardly get used to the routine of going back to school before they get a holiday, on Sept. 2, in observance of Labor Day.

The next holiday is scheduled for Thanksgiving when school will be dismissed on Nov. 27 and will resume Dec. 2. Christmas holidays will start Dec. 20 and continue until Jan. 6.

A holiday will come Jan. 13 when classes will be dismissed for the county stock show. Another one-day holiday is scheduled for March 7, when classes will be dismissed so teachers can attend the district convention of the Texas State Teachers Association.

Easter holidays will begin April 3 and continue until April 8 to wind up holidays of the school year.

May 20 will be the last day of classes, followed by junior high graduation on May 22 and senior high graduation May 23.

Two to Attend Citizenship Meet

Two high school students from this county will attend the sixth annual Texas Farm Bureau Citizenship Seminar July 30-Aug. 3 on the campus of Baylor University in Waco, according to Wayne Arrott, president of the Coke County Farm Bureau.

The students are Joy Cervenka, a student in Bronte High School, and Darrel Pitcock of Sanco, a student in Robert Lee High School.

The annual training school for high school junior and senior students is an intensive course in citizenship, our American heritage and the proper role of government, according to Arrott.

"It is designed to complement the formal education of these young folks and make their roles as citizens more meaningful," the local farm leader said.

The county Farm Bureau sponsors the local students by paying their tuition, room and board and transportation to and from Waco. Travel is by chartered bus. A total of 425 students from 156 counties are enrolled for this year's seminar.

Four nationally known lecturers will address the 1968 school. They are: Dr. Clifton L. Ganus, president, Harding College, Searcy, Ark.; Dr. C. L. Kay, president of Lubbock Christian College; John Noble, author of "I Was a Slave in Russia"; and W. Cleon Skouson, author, lawyer, and former FBI agent.

Emphasis will be placed on the economic, moral and social aspects of American society. Instruction will consist of lectures, films and panel discussions.

Miss Cervenka and Pitcock will catch the bus in San Angelo. It will be under the sponsorship of Mr. and Mrs. Edward Cumble of Bronte.

Report Is Given to BCD Members On Changes to Be Made by P. O.

BCD President Hugh Lewis Jr. presided at the Tuesday meeting of the organization and explained some of the new postal regulations which become effective Saturday.

The main change will be in Saturday window service. The window service will be open about two hours each Saturday, until 11 a.m. However, the only service will be for delivery of parcels and general delivery mail.

No stamps will be sold, money orders will not be available and no other service will be available which requires a financial transaction. The new schedule will not affect delivery of mail on routes out of Robert Lee. Pickup of outgoing mail will be the same as for Sundays and holidays.

Lewis disclosed that fourth class post offices will be closed out as soon as retirement of present postmasters comes around. There are two fourth class offices in Coke County, at Sanco and Tennyson. Silver is third class, and since the removal of so many oil personnel from the community, stands a good chance to revert back to fourth class, Lewis said.

Mayor Wilson Bryan reported on plans to entertain Governor John Connally who will be here Tuesday, July 30, for a tour of the Robert Lee dam construction project. More details on this event are included in another story in this edition. The BCD did vote to help defray expenses of any member of Coke County Historical Survey Committee who would like to join the governor's tour in Abilene and leave it in San Angelo.

President Lewis reported that he had talked with E. H. Ivey, cemetery association president, and was told that the old associa-

tion has little money left in its treasury and was never able to make any real progress in setting up a permanent plan of maintenance. Ivey told Lewis that a number of supporting pledges were received to finance cemetery maintenance and beautification, but the money was never received. Lewis said his conclusion was that other ways of financing the project would have to be found. Help from the county was suggested as one way to finance the project.

Mayor Bryan announced that new city dump would be ready for use Aug. 1. It is on the 30 to 40 acre tract below the old city lake. The new dump ground is being fenced and trenches dug, in order to use the burying method of trash disposal. Bryan said the old dump ground will be bulldozed off and a complete cleanup will be done in the area.

Common Plants May Be Poisonous

"The summertime beauty of our state's lush vegetation in yards, fields, pastures, and woodlands also holds dangers that the public should heed," H. N. Smith, State Conservationist for the USDA Soil Conservation Service in Temple, warned this week.

Smith said that throughout the U. S. and Canada more than 700 species of plants are known to cause death, illness or extreme discomfort to people.

"Chewing, swallowing or otherwise contacting the toxic parts of certain plants, trees and shrubs takes a heavy toll," Smith said. "Each year health services report that about 12,000 children are poisoned or injured by these sources."

Parents should be concerned, the SCS official stated, because many of the plants are quite common in flower and vegetable gardens, and in ornamental landscaping, as well as in wild places. Bulbs, roots, seeds, leaves, beans, stems or berries may contain poison, depending on the species of plant.

The beautiful oleander bush, for example, grown all over the country, contains a deadly heart stimulant similar to the drug digitalis. The toxin is so strong that a single leaf can kill a child. People have died merely from

eating steaks speared on oleander twigs and roasted over a fire.

The popular Christmas flower poinsettia is full of an acid, burning juice, so lethal that a child who consumed one leaf might die. Mistletoe berries can also be deadly.

Peach tree leaves contain hydrocyanic acid, one of the most dangerous poisons known. Potato and tomato plants, close kin to the deadly nightshade, have foliage that contains alkaloid poisons which can cause severe digestive upset and nervous disorder if eaten.

Jimson weed, sometimes called thorn apple and stinkweed, grows almost everywhere and causes more poisoning than any other plant. It grows from 2 to 5 feet tall, has large leaves and white funnel-shaped flowers resembling morning glories. All parts are poisonous, especially seeds and leaves.

Duffenbachia, or dumb cane, is a beautiful house plant grown in millions of homes, but merely biting its stalk can cause swelling of the mouth and tongue that can be deadly. It is called dumb cane because of its power to strike its victims speechless. The stalk contains needle-like crystals of calcium oxalate that become imbedded in the tissue of

the mouth and tongue causing severe swelling and pain.

Castor bean seeds are especially dangerous because they are so deadly and so readily available. They are sold in garden stores for about 25 cents a packet and are popular because they produce large, lush plants in one season. Yet one seed contains enough ricin, a powerful blood poison, to kill a child.

Mescalbean, or mountain laurel, is also dangerous. It has a poison bean with a hard coat. If it is swallow whole there may be no ill effects, but if chewed or crushed it can be lethal.

Other common plants in Texas that have poisonous parts include elephant ear, larkspur, azaleas, lantana canana, yew, oaks, water hemlock, poison hemlock, poisoning, poison oak and poison sumac. "More detailed information on these and other plants can be secured from health and plant authorities," Smith said. "However, we have requested SCS offices in our state's 184 soil and water conservation districts to cooperate fully with the National Safety Council in keeping the public alerted to plants that cause these problems."

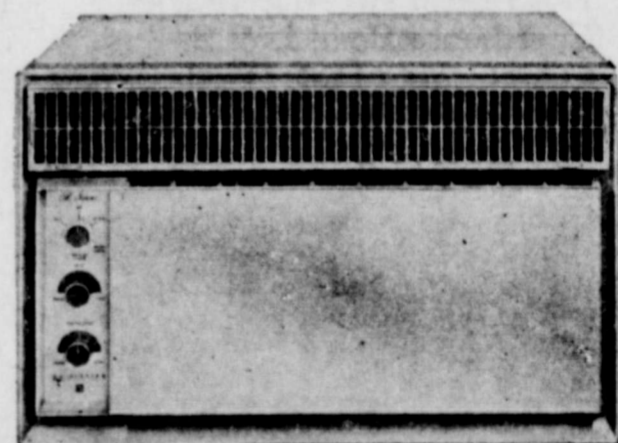

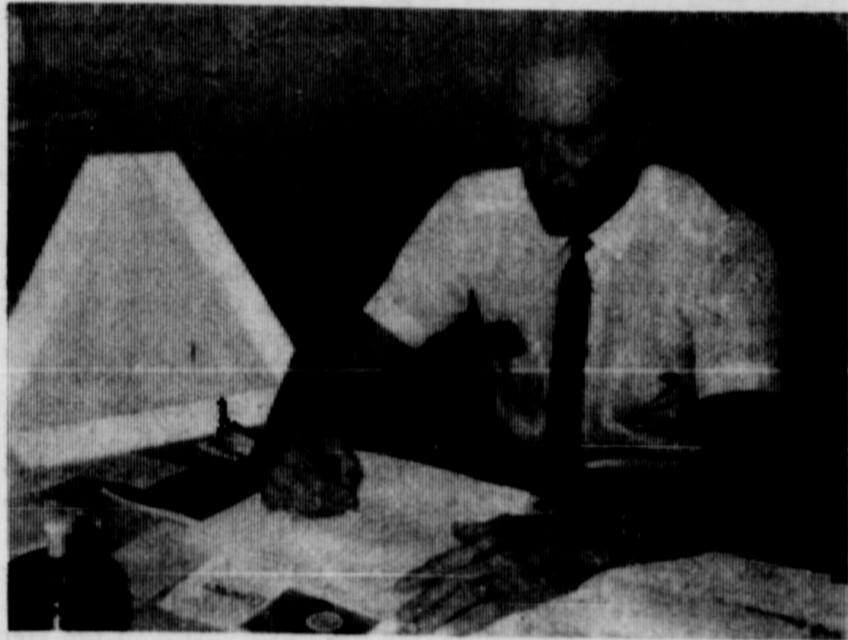

the county for the special farm safety program.

Arrott said the accidental death rate for farm residents is steadily increasing.

"If this trend is to be reversed and the needless suffering and losses substantially reduced, each of us must have a renewed effort," he continued. He emphasized that farming remains one of the most hazardous occupations in this country today; but added, many of the present losses could be prevented with the use of safety tools such as seat belts, fire extinguishers, SMV emblems and tractor roll-guards.

In his proclamation, Judge Thetford said "the citizens of Coke County are proud of our farm families from whom come our abundance of food and fiber; therefore, our citizens are deeply concerned about the safety and well-being of this segment of our population as they go about the sometimes hazardous task of producing the commodities needed by the entire population."

The proclamation said the special safety campaign is a coordinated effort by Farm Bureau and various local and state agricultural and safety groups.

The judge urged farm families "to become more safety conscious, not only during Farm Safety Week, but every day of the year."

President Johnson and Governor Connally have previously designated the same period as Farm Safety Week nationally and in Texas.
