SEPT. 6 IS LABOR DAY

GOVERNOR MeDONALD ISSUES PROCLAMATION.

Santa Fé.-Governor William C. Mc Donald, following the custom of form er years, has issued a Labor Day proclamation, naming Monday, Sept.

6th as the day, a legal holiday. His proclamation is as follows: "Labor in one form or another is the force that moves all the affairs of man. The real laborer is the prime factor of our civilization. By labor is produced all that sustains the life of the nations. It tills the soil, maintains our industries and makes trans portation convenient and effective. "It is but fair and just that we set

aside one day on which we may exalt and magnify the importance of the foundation in production of all things that fructify and expand the earth's usefulness to man.

"Now, therefore, in accordance with the law of our land and the custom of our people, I, William C. McDonald, Governor of the state of New Mexico, do hereby proclaim Monday, the 6th day of September, 1915, as Labor Day. and heartily recommend that it be observed by all the people of New Mexico as a legal holiday; that the state offices be closed and the ordinary business of the day be suspended, in order that all may do honor to the great body of our people who labor in the fields, the factories, the forests. the mines, in the shops and on the railroads, and in all the varied industries of the state."

Indian Village Unearthed:

Santa Fé. - Discoveries of great archeological value have been made by the Wilson-Bradfield-Troutman expedition, which concluded a month of excavation work at the ruins of the evtinct communal city of Otowi, twenty-eight miles northwest of this city the work being done under the auspices of the Philadelphia Commercial museum in connection with the University of Pennsylvania. The most important discovery was that of the skeletal remains of a cacique, or chief, of heroic size, accompanied by cere monial trappings, including copper, turquoise and shell ornaments of great value. There were also unearthed some other forty skeletons, with fif teen ceremonial clay pipes in excel lent preservation, specimens of pre historic basketry and pottery and shards of unusual beauty and unique

The Gold Crown Mines Company, organized by E. A. Wayne and associates, has taken over the New Strike group of five claims in the Twin Peaks camp in Steeple Rock district.

Clovis -- Joseph Roach, an employé of the Santa Fé, aged about 40 years committed suicide at his home in this city.



VACATIONS FOR DAIRY COWS

Six Weeks Rest is None Toe Long for Animal to Rest Between Lactation Periode.

It is fairly well understood that the dairy cow should be given a vacation or a rest between lactation periods. The longer the rest up to a certain point the better it is for the cow. Ten and one-half months continuous milking out of every twelve is all that can be reasonably expected. It is claimed that it is as hard on a cow

to produce a liberal yield of milk daily as it is for a horse to work at hard labor all day. When this is fully understood the necessity for a few weeks' rest on the part of the cow becomes evident. Furthermore, the cow during seven
