## And Necessary Supplies Will be Sent at Once.

Postmaster C. O. Leach has received notice that on January 16th, 1912, a postal savings bank will be instituted in Portales at the postoffice and that all necessary supplies for this purpose will be bere in time for those who so desire, to open accounts with the United States. Whether this will prove the boon it has been predicted it would, is somewhat problematical. The postmaster explained to the Herald mun at some length, the various good features this new system of banking has, also, he stated that the money deposited was not sent out of the town to help swell the deposits of foreign institutions, but that where the local banks complied with the requirements of the department, that the money was still kept in the town in which it was deposited. This being a it is difficult to see in what way it could work a hardship on our home bankers. It is further contended that the postal banks have grown by leaps and bounds in the public favor since they have been installed and that, in those cities and towns where they have been instituted, they are eminently successful. The Herald man is free to confess that he knows absolutely nothing about them, only through report and that he was not very enthusiastic in their favor until the plan was so intelligently explained to him by Postmaster Leach, however, it will not be long now until Portales will have a postal savings bank and when that time comes we will all know more about them than we do now and will be enabled to pass an intelligent opinion on their merits or their demerits, as the occasion may require.




