FINANCE IS HERE.

Evidence of Rapid Growth of New Mexico.

The following is an extract from a late publication of the Santa Fe New Mexican:
"Concrete examples are often more convincing than general statements. Up at Texico, a point on the boundary between New Mexico and the Panhandle of Texas, there is a bank which started business last spring with first day's deposits of \$4487.11. The 11 cents were not to be despised either in those young days. But in one month the deposits had risen to \$44,791, just ten times the first day's deposits.
"Fifty per cent increase brought the total up to \$61,000 at the end of the second month. The third month showed \$70,000 on deposit, the fourth \$75,000, in the dead summer, the fifth month \$89,000, then a jump to \$114,000, and now after eight months the deposits total over \$150,000, or thirty-three times the total at the beginning.
This refers to the Texico National bank, Mr. B. D. Oldham, cashier. This is a kindred bank to the First National bank, of Portales, which also has a fine showing. Their deposits on the 12th as made to the comptroller was \$217,812.25 and has a steady, healthy upward growth.
New Mexico is rapidly coming to the front and Portales occupies an attractive place on the map.

A VERY SEVERE STORM.

One of the Worst Ever Known in This Locality.

When daylight came Sunday morning the ground was found to be covered with snow and a genuine blizzard was raging over this part of New Mexico. The snow continued to fall Monday and part of the day Tuesday. The depth of the fall of snow is very hard to estimate, as quite a fierce wind blew from the north all the time and drifted it very badly. There was probably about eight inches of the "beautiful" and drifts in places from two to five feet deep.

While the storm has been very severe on stock it will be fine for the land. This is coming to be a farming country rather than a stock country, and especially those farmers who have in wheat are rejoicing over this snow, believing that it will insure them a prospect for a good crop.

The coldest time of the late storm was Tuesday night when the mercury dropped to below zero. We don't know just what it was here, but from the report from the U. S. weather bureau at Roswell it was six below Tuesday at midnight. Sunday and Monday nights it was somewhere between 15 and 20 above.

There are several reports of loss of stock during the storm. This is mainly due to the lack of shelter and facilities to give stock proper attention during such unusual weather in this locality.

The weather moderated considerably Wednesday, and Thursday it was warm enough to be quite agreeable out of doors, except very slushy underfoot. A few quite serious happenings are reported during the storm. A telephone message from Bovina states that three cow boys rode out from the L. F. D ranch Sunday morning to look after stock, and at last reports they had not been heard from.

Another report came from Nigger Hill, about forty miles southeast of Portales, that a young man by the name of Ira Putnam went out Sunday morning with a bunch of sheep and he and the sheep failed to return. It was feared he had succumbed to the severity of the storm.

Railroad traffic and mails were badly demoralized during the storm. The first mail from the east came in Thursday afternoon. Regarding the train service the Roswell Record of Wednesday says:

The first train since the big snow that began Sunday arrived from Amarillo Tuesday night at 6:30. It was a freight loaded with railroad coal. It

was sent out to clear the track more than for any other purpose, and the coal made good ballast for butting the snow drifts. It had two engines but no snow plow. The train was three days and two nights on the road from Amarillo, and the engine and trainmen endured hardships of both cold and hunger before they finally dropped in to Roswell. Herbert Gill was the conductor and "Red" Plumbie, the "old Santa Fe engineer," as he is known in railroad circles, and H. T. Stanfield were the engineers. The deepest drift they encountered was five feet in depth, and the worst one of all was one mile north of Kenna, where the snow was five feet deep for a distance of a quarter of a mile on the track. It required lots of work to get through this drift, but the two engines were finally successful.

"This is much colder than the average winter weather for Roswell. There were but three cold mornings all last winter, and the temperature on those days, according to the U. S. records, was as follows: On December 24, five above zero; January 2, ten above zero; These three mornings were the coldest in the three months of winter, 1905-6."

OUR SUGAR BEETS GOOD

Government Analysis of Samples Make Good Showing.

A report has lately been received by Judge Lindsey from the United States Department of Agriculture giving an analysis of some sugar beets raised in this county which Mr. Lindsey had sent for that purpose. The report is very encouraging.

The beets sent were raised by Mr. Albertus Dowler three miles west of Portales, and were raised on sod plowed ground without irrigation.

The report is printed in full below and shows these beets analyzed over 14 per cent sugar. This is about the average analysis of the beets raised in eastern Colorado, where they are grown so successfully and profitably with irrigation. If we can grow this high quality of beets here without irrigation the sugar beet proposition for us is one of the greatest things in the world and could be made immensely profitable.

Sugar beet lands in Colorado produce from \$75 to \$150 worth of beets per acre each year, and the land that raises them sells at a very high figure. Truly the possibilities of this virgin soil of Roosevelt county can hardly be conjectured as yet.

The report giving the beet analysis received by Mr. Lindsey is as follows: Washington, D. C., Oct. 19, 1906.
Mr. W. E. LINDSEY,
Dear Sir:—In regard to the sample of sugar beets which you sent to this Department for analysis, I will say that I have just received the following report from the Bureau of Chemistry where the analysis was made:

Average weight of beets 18 oz.
Sugar in the beet 14.10 per cent.
Sugar in the juice 15.25 per cent.
Co-efficient of purity 82.30.

This sample makes a good showing for New Mexico, and I have no doubt that the soil and climate there are well adapted to sugar beet production. I will be glad to get other samples for further information in regard to this point. Very truly yours,

New Mexico Rubber Industry.

From Santa Fe News Herald.

It was by an accident that the virtues of a plant native to this part of the country from which it is destined a fine substitute for rubber can be made was discovered. The Western Patent Crude Rubber company of Santa Fe has secured the patent rights for the manufacture of this new substance with which its promoters expect to revolutionize the rubber industry of the United States. Benjamin F. Spencer was the discoverer and it was from him that the patent rights were obtained. Mr. Spencer has identified himself with the local concern as vice-president. All of the other officers are well known residents of Santa Fe. Imanuel Sparks is the president, H. F. DuVal the secretary and Dr. Charles A. Wheelon the treasurer. The company was incorporated about two years ago under the laws of New Mexico at a total authorized capitalization of \$100,000. All of the stock has been subscribed.

Mr. Spencer learned of the rubber making possibilities of the plant while on a prospecting trip several years ago. His water supply gave out unexpectedly while he was many miles civilization and a long distance from any spring or stream. He began searching for a certain weed, this grows in the mountains and semi-arid regions, the roots of which when chewed have a thirst quenching effect. He had been in a similar predicament before and had cooled his parched throat by masticating the moisture giving roots of this plant. He hunted high and low for one of the weeds but could not find any anywhere. Finally in desperation he pulled out a plant closely resembling the kind he was looking for and began chewing the roots in an effort to slake his thirst. To his surprise the roots began assuming a gum like consistency and collected in a ball in his mouth. The similarity of the substance to rubber in its crude state led him to make experiments with the weed upon his return to his home at Denver. The result of the tests was his application for a patent covering the exclusive rights to manufacture the substitute for rubber from the weed and the subsequent organization of the Western Patent Crude Rubber company.

This rubber weed grows prolifically all over the Rocky mountain region. It is found in greatest abundance in the high altitudes. It is probably best known as pingue, a name given to it by the Indians. According to an estimate made by one of the officers of the company there are two hundred thousand acres of these weeds in New Mexico. The concern has not placed any of the new article of commerce on the market or established a factory yet for its manufacture. The promoters up to the present time have been devoting their time to experimenting with different processes of extracting the gummy particles from the plant and perfecting machinery with which to do the work. The plastic substance contained in the weed is insoluble in water but dissolves readily in gasoline, benzine or other light hydrocarbon. The imitation rubber can be separated and stuck together.

Shortly after Mr. Spencer applied for his patent a Colorado Springs Company was formed to utilize pingue for rubber making purposes. The local corporation at once instituted legal proceedings to prevent the rival enterprise from infringing on its monopoly and won in the courts. The patent was granted last week after the law suit had been settled and the coveted document is now in Santa Fe.

"Owing to this litigation we have not been able to make much progress financing the enterprise," Mr. Sparks informed a reporter of the New Mexican, "but now that it is out of the way we propose to push the matter."

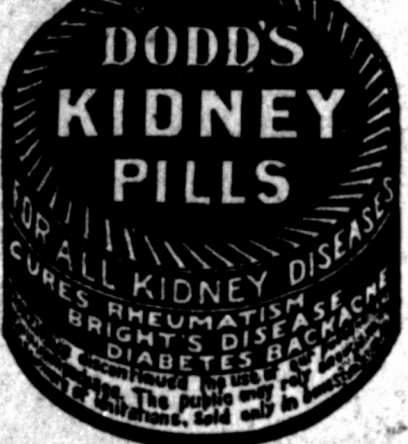
