City obtains land option for prison

The Dimmitt City Council voted unanimously Monday night to pass a resolution of support for the project seeking placement of a state prison facility here.

67th Year-No. 39

An option has already been obtained on a plot of land about four miles south of Dimmitt on US 385 on the east side of the road. The 320 acres are owned by Edd Wag-

Ed Maxwell appeared before the council to protest placement of a prison around Dimmitt. Also commenting on the project were Dale and Elsie Maxwell. They asked where the money would come from to buy the land, which will be offered free of charge to the state.

Mayor Wayne Collins replied that the council intends to put the matter before the voters of Dimmitt in the form of a revenue bond issue. The bonds would be repaid through the prison's payment to the city for water and sewer services.

Collins also commented that the project has only cost the city \$3,-000 so far, with most of that ex-

"For a minimal up front investment, we have an opportunity to attract a big industry," Collins explained. He added that the city always has the option of dropping out of the project at any time if it begins to look unattractive to Dimmitt or if the bond issue fails.

Ed Maxwell expressed doubt that the prison would provide a "seventime turnover" from any payroll money infused into the local economy. He said he felt many of the people would shop out of town, just as local people do. He also asked whether local people would be given preference in hiring at the pri-

Collins said he couldn't address the prison's hiring procedures, but said he felt any local people who are qualified would be given equal consideration.

Maxwell also asked whether the local water supply could handle the added burden of supplying water for the prison.




The meeting will be held at the Castro County Expo Building in Dimmitt and will begin at 9:30 a.m. A free lunch prepared by members of local Women Involved In Farm Economics will be served to guests.

Carl King, executive director of the Texas Corn Producers Board, said Sarpalius will be a keynote speaker, addressing "critical issues facing agriculture and the general economy."

Also confirmed as a speaker is State Rep. James E. "Pete" Laney of Hale Center, who will touch on key state issues. Also on the agenda will be State Sen. Bill Sims of San

John Ford, a former under secretary of agriculture, will discuss the General Agreement on Tariffs and Trade (GATT) negotiations as well as the North American Free Trade Agreement. Ford also will address federal farm legislation.

King will report on recent corn grower activities, including efforts to obtain Sec. 18 temporary permits


Caballero announces for county sheriff

Texas Corn Growers

The Texas Com Growers Association will hold its 20th annual meeting Tuesday in the Expo Building.

All 19 previous annual meetings of the statewide commodity association also have been held here, for Dimmitt is both the birthplace and the longtime headquarters of this vital statewide growers' organization.

The TCGA was officially chartered Dec. 15, 1975. Carl King of Dimmitt, the father of the TCGA, has served as president ever since it was formed.

As TCGA membership grew in our seven-county major corn-producing area, members and officers realized the need for a bigger financial base to support research, development and marketing programs. The best means of income was a check-off fee. State regulations required that such a fund be administered by a state agency. Through a referendum 10 years ago, com growers approved the check-off fee and elected the 15 charter directors of the Texas Corn Producers Board, an official state agency.

The TCGA and TCPB have worked hand-in-hand ever

In 1980, the Dimmitt-based organization went to the producer-voters again, and the result was an expansion of the TCPB's administrative area to include the entire state of Texas. The Texas Com Growers had become truly a statewide commodity group, and has been important to South Texas corn producers in financing research to help with problems unique to that region.

Four years ago, the TCGA spawned the new American Com Growers Association and American Com Growers Foundation, to provide better representation in Washington and better markets at home and abroad. The ACGA now has members in 24 states and is becoming a major "grassroots" voice for US com producers at the national and international

Through the years, the TCGA and TCPB have had a multimillion-dollar impact on their industry through upgrading of varieties, advocacy of critical pesticides, expansion of domestic and export markets for Texas corn, favorable legislation at both the state and federal levels, and in many other ways.

All this from a movement that was started by a small group

of dedicated growers right here in Castro County. We salute the Texas Corn Growers, a vital and vibrant organization.



SportsNaz tops state-ranked teams to win tourney

The Nazareth Swiftettes served notice to other Class A teams in the state this weekend when they knocked off two state-ranked teams to claim the championship trophy of the Sudan Tournament for the fifth year in a row.

Nazareth's girls creamed the No. 4-ranked team in the state, Anton, by 20 points in the championship semifinals, then knocked the second-ranked Sudan Hornettes by 10 points to win the title.

The annual tournament featured four of the state's top-ranked Class A teams, including the defending state champion Swiftettes, Sudan, Anton and Happy.

"We were very pleased to be able to come in here and compete with these teams, and to win it makes us feel pretty good," said Swiftette Coach Ritchie Tarbet. "We're a little disappointed because we don't feel like we played as well as we could have, but we're hoping this (success in tournament) will be a turning point for us."

After a 2-9 start this season, the Swiftettes rebounded to win three straight games before the tournament, and they extended that streak with four victories in the three-day event.

The Swiftettes opened the tournament against Farwell last Thursday morning, and although the team played poorly, they managed to pull out a 44-31 win. Aside from being outscored 13-8 in the second quarter, the Swiftettes dominated the Lady Steers behind Peggy Huseman's 20 points and Jill Pohlmeier's 15.

Then the Swiftettes turned around and played Portales, N.M. last Thursday night. Portales man- when we played Anton this time.

the first, third and fourth quarters, just feel like our defense made up fense quite as well, and she can but Nazareth's defense virtually shut down Portales' offense in the second quarter, and outscored the Ramettes 15-4 in the stanza. That 11-point margin was enough to overcome the Ramette leads in the other three stanzas and the Swiftettes pulled out a narrow 44-40 win.

Nazareth sealed the game down the stretch by nailing 73% (8-of-11) of its charity tosses in the last three minutes.

After the second quarter Nazareth held a 24-15 lead and they expanded on that lead at points throughout the second half, but Portales always battled back. With three minutes left in the fourth quarter the Ramettes tied the game at 34, then hit a three-pointer to overtake the lead for the first time since early in the second stanza.

Pohlmeier was fouled inside and hit two free throws, then Huseman canned a bucket to reclaim the Swiftettes lead with under two minutes left. Nazareth hit 6-of-9 charity tosses in the waning minutes to seal

The Swiftettes had beaten Anton 56-53 in overtime on Dec. 20, but this time the game was all Nazareth's.

The Swiftettes jumped out to a 12-6 lead, then coasted to a 48-28 win. Pohlmeier tossed in 22 points and Huseman added 13 for the Swiftettes.

the difference. Also, in the first game against them, Peggy (Huseman) went down with a sprained ankle early in the second quarter and that hurt us offensively and defensively," Tarbet said. The championship game Saturday pitted Nazareth against longtime rival Sudan, and the Swiftettes prevailed, 60-50.

Nazareth never trailed the host team and an 18-7 Swiftette lead at the end of the first quarter set the pace for the game.

Nazareth opened with a trapping full-court press and forced Sudan into turning the ball over several times. But the press also caused the Swiftettes to pick up early fouls, and that created problems down the stretch.

Nazareth recorded 21 fouls during the contest, and although no one fouled out, several key players were forced to spend time on the bench with three and four fouls.

"When we started, our defense was playing well and we were off to a good start," Tarbet said. "Then we started just standing around and we weren't moving our feet. That's when we got into foul trouble. In the first half Sudan had 23 points and 11 of those came from free throws. You can't afford to put cause they'll beat you."

Despite allowing Sudan so many privileges at the line, the Swiftettes were still on top 32-23 at halftime, and were up 40 - 34 after three periods.

"We changed our offense up a little bit. We put Jodi (Johnson) in a post rotation and worker her inside. That helped us out because she played well in there. Normally she is matched up against a wing or guard who can't play the post de-


But six points was as close as the Homettes would come to Nazareth, which held on for the 10-point win.



I'm one-up on him now. Wonder what he'll do to me next?





Mrs. Temple died Dec. 31 at 7:20 p.m. in the Muleshoe Area Medical Center after an illness.



Vision Cable TV. The city is seeking authorization to regulate the franchise's rates and signal quality, and the company has largely ignored any such moves by the city.

Edwards said he is contacting the city governments of Happy and Hart, the only other Texas cities serviced by MultiVision, to see if they want to join in litigation to force the company to retract a recent rate hike.

Collins noted that the company has sent a letter saying that they will not voluntarily roll back the rates.


Pam Nielson, representing the Panhandle Region 9-1-1 network, reported to the council on the progress of connecting the system in the local area. She said it should be ready to go on line in early to mid March, with installation and testing scheduled for February.

She said the network is also working on systems in other areas of the Panhandle, so if difficulties are experienced in another area, it might delay the local system.

The council voted to accept the health insurance proposal from Blue Cross-Blue Shield, the city's present provider, in spite of an 11% increase in premiums for the coverage year that will begin Feb. 1.

City Manager Reeford Burrous said he had spoken with other insurers who said they could not match the coverage for a comparable rate. He added that 9% of the increase came from legislation that now requires mental health coverage for employees of governmental entities.
