### LIKE THE HOUSE

If anything could forcibly illustrate the law of diminishing returns resulting from increasing costs beyond a reasonable figure, the three-cent letter postage has turned the trick.

Postal revenue has been lost which will never be regained from the same class of mail, for the simple reason that the public has devised ways to use third-class mail instead of first.

The same thing take place with gasoline. As gas taxes are shoved up beyond reasonable figures, smaller cars will be used, or larger cars will be used less, and the volume sold will diminish, thereby producing less revenue for the state.

The same thing will take place with property. Beyond a certain point, the owner cannot pay taxes. When that day comes he will let the city, county or state take it and the tax rolls will be flooded with unsalable property, and tax deficits will mount.

The public is no different than the horse. You can lead the horse to water, but you

can't make him drink. You can tax the public beyond its ability to pay, but you can't make it pay.

The political subdivisions of this nation, from the smallest hamlet to the Federal government, should readjust the tax bill and public expenditures to fit the ability of the people to pay.

The papers are filled with reports of meetings of tax experts state tax commissions and other organizations of "tax spenders" who are in a large measure to blame for the present taxation problems of the people. As advisers on the financial affairs of the people, they have for years taken the easiest course, acquiescing in public demands for extravagant public expenditures without raising their voices in protest or showing where exorbitant spending was leading the people.

Even today, most of the "tax experts," instead of recommending drastic cuts in public expenditures, are hunting ways and means to increase existing taxes or find new methods of taxation.

The same thing is going to happen to every city, county, state and the nation itself, that has happened to millions of families—they are going to have to get along on less money than they thought was possible a year or two ago. Instead of increases in taxes or new methods of taxation to balance public deficits, there is going to have to be decreased taxation and decreased public demands on a balanced scale, which will eventually wipe out the deficits.

**FARM NOTES**

"During the six years I have owned a steam pressure cooker, canned peas have paid the doctor, the groceryman, the blacksmith, the beauty parlor operator, and even for my husband's tabbaco", declares Mrs. Solon Lea, president of Mitchell Home Demonstration Club in Haskill county. "By boarding 11 cotton pickers out of my pantry this year I have paid for a piano. When I need the chicken yard grubbed, hot bed made, or garden work done, I pay for the work with canned products."

Fifty-one farm yards were beautified in Travis county last year by home demonstration club women at an average cost of \$5.00 per yard.

Ten Bexar county farm women acting as wardrobe demonstrators in their home demonstration clubs found they could dress becomingly for an average of \$32.71 last year. It took plannig and wise buying to do it, they explain, but declare the result is worth the effort.

Five Kaufman county farmers who conducted pasture demonstrations last year on 189 acres have made returns averaging \$8.15 per acre for an average investment of less than 50 cents per acre.

Seventy 4-H club boys who fed pigs in Childress county last year made slightly less than \$1 per animal for their labor and investment even though they produced pork at the low feed cost of 2.2 cents per pound. Fifteen boys who raised litters of pigs made an average of \$17.01 for their labor and investment.
