Two Railway Detectives Killed in Gun Battle

TWO ESCAPED CONVICTS ARE BEING SOUGHT

COLORADO CITY, Colo., April 17.—Search for two convicts who escaped here yesterday in a daring break was intensified today as officials became convinced they would not have travelled far through a night through a cordon of guards stationed around the town. Raymond Perry and Claude Lewis, both sentenced from Colorado cities for robbery, were members of a group of five prisoners who forced a guard to accompany them outside the walls of the penitentiary at the point of a knife. Marvin Green, Roy McVey and William Crosby, all serving long sentences, were in solitary confinement cells today after having received six lashes each last night for their part in the escape. Green and McVey were captured after a desperate hand-to-hand encounter with a prison guard and Canyon City residents. Crosby was walking back to prison when guards caught

Illinois Pipe Line Employees Hold a Safety Meeting

Employees of The Illinois Pipe Line Company under the supervision of Mr. J. R. McLaughlin and Mr. B. E. Rigby held a very interesting safety meeting at their pump station and office on Eastland highway last evening, April 16th, at seven o'clock. Meeting was called to order by A. L. Burch, Safety Engineer of The Mid-Kansas Oil and Gas Company, Tulsa, Okla., after a very interesting talk introduced J. P. Sutton, Director of Safety of the Industrial Relations Board of the Ohio Oil Company and its subsidiaries who was the speaker of the evening. Mr. Sutton, whose office is in Findlay, Ohio, a man of great personality and a forceful speaker, discussed at length upon safety in general and the oil phase of safety in particular, stressed special emphasis upon the necessity of safe driving of automobiles and trucks upon the highways of our country; especially in this necessary at the present time with the trend in automotive manufacturing where speed seems to be the factor. Mr. Sutton's territory extends from the Eastern part of Ohio to the Pacific Coast and from Canada to the Gulf, therefore he does not get to visit this territory but about once each year; however we were all very glad to have him. The meeting was attended by forty employees of the Illinois Pipe Line Co., coming from Weatherford, Desdemona, Mingo and the local force, including H. W. WASHINGTON, April 17.—The \$488,000,000 tax bill was sent to conference between house and senate today after administration leaders decided against any efforts to re-open the measure to eliminate the controversial coconut oil tax. President Roosevelt is opposed to the oil tax as an unfriendly gesture toward the Philippines.

Trotsky Seeking Haven In United States, Friends Say

PARIS, April 17.—Leon Trotsky, exiled Soviet leader, was informed today that he must leave France, and he began at once to try to obtain refuge in the United States or elsewhere in the western hemisphere. The cabinet decided Trotsky must leave France after it had been informed that "refuge here as a political exile under a pledge of neutrality, he was trying to form a fourth internationale to foment revolutions throughout the world." Trotsky's followers feared there was no chance after the revelation that any European country would accept him. The former co-dictator of Soviet Russia communicated with friends and asked them to determine whether he might find a haven in North or South America.

BRECKENRIDGE, April 17.—The Mid-West District Christian Endeavor convention, in session here Friday, Saturday, and Sunday, came to a successful climax and close Sunday afternoon. Registrations for the session totaled 350. The Cisco delegation was successful in winning the 1935 convention. The Randolph College orchestra and quartet aided the Cisco visitors in making a strong bid for the next session. The crowning climax was brought by Dr. David F. Tyndall, president of Randolph College, when he delivered the closing address of the Sunday service. Dr. Tyndall brought one of the most interesting and instructive discussions concerning the "Witnessing for Christ in International Goodwill" phase of the Christian Endeavor program. Dr. Tyndall brought many startling statements to the audience of young people concerning the many conflicts between various nations of the world which resulted in wars.

Hectic Trading Is Seen In Grain Pits

CHICAGO, April 17.—The grain pit of the Chicago board of trade was thrown into turmoil today with the most hectic trading of the year. Prices sank to new low level for 1934. Wild scenes, approaching the pandemonium of last July, when wheat skyrocketed to \$1.29 a bushel, prevailed in the pit. Traders, stumbling over each other as they sought to execute selling orders, battled and shouted.

Trio Is Questioned In Slaying of Girl

SHREVEPORT, La., April 17.—All-night questioning of three men and a woman arrested in connection with the brutal slaying of Mae Griffin, 16 year old Shreveport girl whose mutilated and abused body was found Sunday, failed to reveal any clue as to the identity of the slayer today. Officers, however, concentrated their questioning on a man arrested yesterday in Northeast Louisiana, although the girls mother identified another as the one who lured the girl from home last Thursday.

ROOSEVELT IS SPEAKER AT TEXAS SPECIAL

WASHINGTON, April 17.—President Roosevelt told a delegation of Texas editors and business men today that he hoped to visit their state next year to have Vice President Garner prove some of the fish stories he has been telling. "Next year I hope to go down to Texas and prove some of these fish stories of John Garner's. You know, John has taught me how to tell fish stories," the President said. Mr. Roosevelt praised the purpose of the delegation visit and its tour of the country to study economic conditions. As part of the ceremony, Lowry Martin, Corsicana, presented a Texas flag to the President. Mr. Roosevelt said he would place it in his study next to the flag he used when assistant secretary of the navy.

Johnson Orders a Wage Allowance on All Retail Prices

WASHINGTON, April 17.—An order has been signed by National Recovery Administrator Hugh Johnson fixing the allowance for labor, which must be included in the price of merchandise sold at retail, at 10 per cent of the cost of the article. This is to become effective April 19. The order, which does not cover drugs and toilet preparations, pertains to the provision of the retail code banning loss leaders form of unfair trade practice. "Pursuant to the provisions of Article VIII, Section 1, of the code of fair competition for the retail trade, as amended by order number 8, dated Dec. 4, 1933, and having found that in order to effectuate the policies of said Article VIII, Section 1, declaring the use of the loss leader to be an unfair trade practice, an allowance for actual wages of store labor must be included in the selling price of articles sold. "Now, therefore, I, Hugh S. Johnson, administrator for industrial recovery, upon recommendation of the National Retail Code authority, hereby fix said allowance for wages at not less than 10 per cent of the cost to the merchant of the article sold, and order that the selling price of all articles under said code (except drugs, medicines, cosmetics, toilet preparations, drug sundries and allied items as defined in schedule A, section 1) shall include with the cost to the merchant of the article sold said allowances for wages of store labor. "Cost to the merchant, as used in this order, means the actual net delivered cost, less all discounts, or current replacement cost, which ever is lower. "This order shall become effective the 14th day after the date hereof. It is provided, however, that any retailer or group of retailers shall, upon application to the administrator, be given opportunity, after due public notice, to show cause why said allowance should be, as to any individual or group, higher or lower than the allowance fixed by this order, and that the administrator may, if justice requires, stay the operation of this order as to any individual or group pending the determination by him of such issues."

Air Mail Body Is Roosevelt Plan

WASHINGTON, April 17.—President Roosevelt today pointed a way out of the troubled air mail situation with a suggestion that congress name a commission to study the entire aviation problem during the next year and draft a general aviation policy. The president recommended pending air mail legislation be revised so that contracts could be awarded for only a year. Meantime the proposed commission could complete its investigation and report to congress. His proposal will be offered immediately in congress by Chairman Kenneth McKellar, Democrat, Tennessee, of the senate post office committee, and chairman James Mead, Democrat, New York of a similar house committee. Gas Station Strike Called at Cleveland

CLEVELAND, April 17.—A virtual tie-up of automobile and truck traffic faced Cleveland today as 2,000 members of the gasoline station union walked out on a strike. Only stations operated by independent dealers were unaffected by the walkout, voted almost unanimously early today at a mass meeting. Twenty major distributing and refining companies, and firms operating chains of stations, were left without attendants. Union officials said the strike was called when demands were not met. These include union recognition and higher wages.

Hostess at "Red Plot" Dinner Is a Witness at Inquiry

WASHINGTON, April 17.—Miss Alice Barrows, hostess at the famous dinner party at which Dr. William A. Wirt said he heard rumblings of a brain trust revolution, was the first witness today as the special house investigating committee resumed its inquiry of the "red plot" charges. A crowd almost as large as the one that heard Wirt detail charges of the red plot a week ago, filled the room. Before Miss Barrows was called the committee refused to call six additional witnesses, including Secretary of Agriculture Henry A. Wallace. The action indicated the committee intended to wind up the inquiry after hearing the six originally called.

Jake the Barber Held For England

CHICAGO, April 17.—John (Jake the Barber) Factor, wanted in England on charges of swindling investors of \$7,000,000 in a stock company venture, today was ordered into custody of U. S. Marshal H. C. Laubheimer for confinement pending extradition. The one-time barber who became a multi-millionaire, will be taken at once to the county jail at Sycamore, Ill.

H. H. Lee, Retired Cisco Farmer, Is Dead at Age of 67

CISCO, April 17.—Funeral services were held here at 1:30 Monday afternoon for Harfrey Holland Lee, 67, longtime Cisco resident and retired farmer who dropped dead at his home, 304 East 18th street, about 4 p. m. Sunday. The services, conducted by the Rev. John W. Reynolds, Cisco Fundamental Baptist pastor, were held at the residence and the body was taken to Rising Star for burial in the family cemetery plot. Mr. Lee was born in Angelina county, Texas, March 6, 1866. He and his wife, Mary Minnie Lee, were married in Bosque county in 1888. In 1900 they moved to Eastland county, living for a time at Rising Star, and moving to Cisco in 1911 where they made their home for the remainder of Mr. Lee's life. Besides Mrs. Lee, two sons, Thomas Harris Lee and James H. Lee, both of Cisco, and a stepdaughter, Sara Alma Hickerson, of Eastland survive. Two daughters and two sons are dead. Death of Mr. Lee was attributed to apoplexy.

WARRANTS ARE PREPARED FOR N. D. GOVERNOR

BISMARCK, N. D., April 17.—United States District Attorney P. W. Lanier, today prepared to serve warrants of arrest on Gov. William Langer and eight others, including state officials, who were named in indictments charging a conspiracy to solicit funds from federal relief workers. The indictments were returned by a federal grand jury after a week long investigation, during which 140 witnesses testified. Langer was removed from the position as head of federal relief activities in the state recently after charges that subscriptions to his party organ, The Leader, were being forced on relief employees. Langer denied the charges and characterized the prosecution attempt as a political frame-up. The investigation was ordered, he said, "because I am the only republican governor west of the Allegheny Mountains."

Mr. and Mrs. Delaney left Friday for Colorado on a trip for his health. She is accompanying the body back here. No funeral arrangements will be known until Mrs. Delaney arrives Tuesday morning.

THREE NEGROES BEING SOUGHT BY OFFICERS

Hand-to-Hand Encounter on Top of Freight Train In Missouri.

ELDON, Mo., April 17.—Two railroad detectives were shot to death early today as they fought a pistol duel at close quarters with three negroes. The scene of the fight was the top of freight cars as a Rock Island train rolled along between Bland and Eldon. The detectives were J. W. Whitted and E. C. Shane. The negroes left the train before it reached here. They had placed the body of Whitted atop one of the cars where it was found. Shane, who was wounded earlier in the fight, rolled from the train. His body was found beside the tracks. Police detained six itinerants found on the train. All told the same story and laid the blame for the slaying on three negroes. Police throughout the Ozark region were notified to watch for the suspects. The tramps said Shane and Whitted boarded the train as it left Bland. They had seen the negroes tossing merchandise from one of the cars. The negroes saw the officers and started to flee along the top of the cars. The officers followed. Then the firing started. The tramps were unable to say how many shots were fired. Whitted apparently continued the fight single-handed after his partner rolled from the train.

Texas Federation Completes Plans for 'Woman's Day'

AUSTIN, April 17.—Executives of the Texas Federation of Women's Clubs today completed their plans for the state-wide observance of "Woman's Day" by theatres all over the state. The Federation, under the direction of Mrs. Volney W. Taylor of Brownsville, president, is to participate in the receipts of hundreds of theatres on April 26. The co-operative arrangement unprecedented in the history of show business, were completed by Karl Hobbittzelle, president of the Interstate Circuit, and Mrs. Taylor. Under this co-operative plan, practically every major theatre in the state will assist the Federation in liquidating the indebtedness of the Federation clubhouses in Austin affected will be turned over to the Federation. After pledging his theatres, Mr. Hobbittzelle arranged with other theatre owners in the state to contribute to the idea. The Hobbittzelle theatres in San Antonio, Austin, Dallas, Fort Worth, Houston, El Paso and Galveston will join with theatres operated by the Pashall-Texas Theatres, Jefferson Amusement Company, the Robb & Rowley Circuit, members of the Theatre Owners of Texas and the Independent Theatre Owners. HOME LOAN MEASURE ON THE WAY

Democratic house leaders made certain an amendment objectionable to the party in power "did not get into the home loan bank bill." A reminder that the senate had put such an amendment in the bill declaring that party affiliations should not be considered in selecting employees for the corporation. Well, the senate amendment was tossed aside. There was only one dissenting vote—Rep. Kennedy of New York. Republican leaders declared they would make a party issue if the senate bill was not enacted in its entirety. It is largely a question of spoils. Democratic members insisted that democrats should be given the preference in the naming of employees of the home loan setup nation over. Republicans wanted a free-for-all in the selection. When the reins of government are held by the republicans, republicans are given the plums. This is a long time record of republican control of the nation. Now the democrats are in control and there are thousands of hungry democrats who are clamoring for "loaves and fishes of victory."

The senate as well as the house measure guarantee the principal as well as the interest of bonds issued by the home loan corporation. Most house members, it is said, believed the senate would send the bill to conference and the house later would accept "the non-partisan stipulation which had the endorsement of the President of the United States when the senate measure was framed and adopted and then sent to the house of representatives. "Since the close of the war between the states three democrats have been called to the office of chief magistrate. Many republicans have been called to that office. All republicans were governed by the policy enunciated in the early history of the republic that "to the winners go the spoils of office."
