Egypt May Break Relations With Britain Formally

CAIRO, Egypt, Dec. 10 (UP)—The Egyptian cabinet announced today that it will meet tomorrow—normally an official holiday—to consider breaking diplomatic relations with Britain.

Acting Foreign Minister Ibrahim Farag disclosed the purpose of the extraordinary cabinet session, which falls on the anniversary of the birth of the prophet Mohammed.

Asked whether a decision on a diplomatic break might be announced after the meeting, he said: "Such a study needs time, and this time cannot be specified."

Reliable sources said the cabinet might decide on a step-by-step program rather than a sudden and complete severance of relations. This would enable the Egyptians to hunt new outlets for their exports and new sources for imports while progressively reducing their age-old ties with the British.

The possibility of a break with Britain first was explored by the cabinet last night, but members were reported divided.

The Anglo-Egyptian dispute was brought to a new crisis by Britain's weekend destruction of part of an Arab mudhut village on the outskirts of Suez to build a 500-yard bypass road around a sniper-infested section of the route between the British garrison and its main water plant.

Peter Webb, United Press staff correspondent in Ismailia, reported that all was quiet throughout the Canal Zone during the past 24 hours except for a few stray shots in Ismailia during the night. No casualties were reported.

Negro Makes Top Ten On FBI Most Hunted List

WASHINGTON, Dec. 10 (UP)—John Thomas Hill, a stocky Negro with "no compunction about killing any person to further his own interest," today became the first of his race to be put on the FBI's list of "10-most hunted fugitives."

Hill, 48-year-old native of Chester, Md., is wanted by Maryland police for a holdup-murder and by Virginia police for a vicious icepick attack on his estranged wife. The FBI wants him for unlawful flight across state lines to avoid prosecution for murder.

Hill replaced Raymond Edward Young on the FBI's list. Young, a three-paroled bandit who shot a California policeman while fleeing from a prison gang, was captured by FBI agents in Denver, Nov. 17.

Reds Accused Of Blackmail At Truce Talk

PANMUNJOM, Korea, Dec. 10 (UP)—The United Nations accused the Communists today of blackmail "a thousand times more repulsive" than that of the lowest gangsters and demanded the Reds begin talks tomorrow on an exchange of war prisoners.

Vice Admiral C. Turner Joy, head of the UN truce delegation, couched his demand for prisoner discussions in terms approaching an ultimatum.

But Brig. Gen. William P. Nuccio, spokesman for the delegation of anti-administration southern Democratic senators were reported today to be exchanging ideas about taking a walk near if President Truman is re-nominated.

How and whether they would follow through will depend on intervening developments, particularly the presidential choice of the Republican National Convention which will be held three weeks before the Democrats meet to pick their man.

In any event, evidence available now indicates that the threat of a bolt by southern senators will be greater in 1952 than it was in 1948 if Mr. Truman is a candidate again.

When the States Rights Democratic Party was formed in the south in 1948, only the Mississippi Senators were actively identified with it. Election mechanics barred Alabama's senators from supporting the Democratic national ticket even if they had wished to do so.

Since 1948, however, both Sens. Lester Hill and John J. Sparkman of Alabama have made public demands that the south carry on its fight within—not against—the National Democratic party.

Some anti-administration southern Senators have talked of making public statements opposing Mr. Truman's reelection if the president runs again. Like other southern revolt strategy, such moves would depend in part on future developments.

Endorsement of the republican presidential nominee has not been ruled out in these discussions. Southerners who have talked about the question believe it would be easier to endorse Gen. Dwight D. Eisenhower as the GOP nominee.

Sen. Henry Cabot Lodge, Jr., (R-Mass.), chairman of the Eisenhower-for-President movement, predicted yesterday that the general "soon" will announce his candidacy and will be chosen on the first ballot at the GOP National Convention.

17-Year-Old Boy Watches Four Companions Drown In Lake Texoma

POTTSBORO, Dec. 10 (UP)—A 17-year-old boy told today how he clung to his capsize duck boat for nine hours and watched four of his companions slip one by one into the icy waters of Lake Texoma.

Robert H. Davenport of Deadezona, was treated for shock and exposure while officers of Texas and Oklahoma and members of the Army Engineer Corps set out on a methodical search of the huge lake for the bodies of his hunting companions.

A fisherman yesterday found Davenport collapsed on a 15-foot sandbar five miles from shore. Taken to the hospital, he told officers of the Saturday accident in which the boat he and four companions were riding to an island duck blind was capsize by the stiff wind.

Davenport told of watching his four companions release their grip on the upturned boat and dropping, one by one, into the chill water after tortuous hours of trying to spot land.

Those still missing were identified as Jerry Herrod, Robert Reed, and Shirley Thomas, of Odessa, and Harry Kirkin of Abilene.

Davenport told authorities he and his companions set out early Saturday from a cabin owned by C. E. Thomas, father of one of the boys, planning to go to a duck blind they had erected on one of the lake's many islands.

About 30 minutes out, he said, a gust of wind turned the boat over. By daybreak, he said, only he and two others were left clinging to the boat and "after a while they just gave up."

The youth said he was still clinging to the boat when he spotted the sandbar about 3 p.m. Saturday. He was so exhausted, though, he was unable to push the boat ashore ahead of him and had to swim the distance.

He was found by Dr. W. C. McCaskill of Dallas. Texas Game Warden Hill Lawrence said several large boats and possibly spotter airplanes would be used in today's search. The giant lake is located on the Texas-Oklahoma border.

CAUDLE'S NAME LINKED WITH ATTEMPTED \$500,000 FRAUD

WASHINGTON, Dec. 10 (UP)—House investigators recalled ousted assistant attorney general T. Lamar Caudle for questioning today as President Truman was reported considering a bipartisan method to clean up the scandals that have rocked his administration.

The House Ways and Means subcommittee which has dug up tax irregularities all across the nation wanted to question Caudle

at 10:30 a.m. EST) about charges that a friend used his name in an attempted \$500,000 tax shakedown while Caudle was chief government prosecutor of tax frauds.

Mr. Truman cut short his vacation in Key West, Fla., after the subcommittee abandoned plans for a temporary recess and summoned a cabinet officer and three former high officials for questioning this week.

Attorney General J. Howard McGrath and perhaps former Internal Revenue Commissioner George J. Schoeneman will be questioned tomorrow. Charles Olinphant, who resigned last week as chief counsel of the Internal Revenue Bureau, will testify Wednesday.

Mr. Truman was reported considering a bipartisan clean-up program run by one Democratic and one Republican prosecutor in an effort to get the public confidence in the tax-collecting agency. Such a setup would be similar to the independent group which president Coolidge used in the Teapot Dome scandals.

Republican Reps. Robert W. Kean of New Jersey and John W. Byrnes of Wisconsin members of the subcommittee agreed that the tax scandal investigation would continue even if Mr. Truman makes some "dramatic" move to clean up the Internal Revenue Bureau.

"The subcommittee is doing its job by exposing some of this graft and corruption," Byrnes said. "The rest is up to the president."

Kean said internal Revenue Commissioner John B. Dunlap was "completing" at first, but now is making "good efforts" to clean up his agency.

Dunlap said today in a copy-righted interview with the new magazine U. S. News & World Report that "there is no setting for the things that have happened."

"They must be corrected and are being corrected and will continue to be corrected until every sore spot has been taken out of the picture," he said.

Government To Issue Another Cotton Report

WASHINGTON, Dec. 10 (UP)—The Government today issued its December report on the size of the nearly-harvested cotton crop, with indications pointing to still another drop in the crop estimate.

Private forecasters guessed that the government's estimate (at 11 a.m. EST) would range anywhere from a 14,857,000 (M) bale crop to 15,300,000 (M) bales. The crop reporting board last month estimated the cotton crop at 15,771,000 bales—a 1,160,000 bale reduction from the previous estimate. It warned, however, that the sharply-reduced estimate did not include the effects of November freezes in central cotton belt states, which "caused some loss in production."

That warning along with the million bale "miscalculation," sent cotton prices soaring the permissible daily limit of \$10 in the cotton exchange the day the report was made.

The big reduction in government estimates last month drew loud complaints from cotton growers who charged they could have been selling their crop at higher prices if the government figures had been more accurate.

Before the government estimate Nov. 8, cotton on 10 spot markets was bringing an average price of 39.57 cents a pound. The closing price was 41.45 cents. Current prices are averaging about 42.91 cents a pound.

The reduced estimate also brought demands for a congressional investigation of the crop board's methods in gathering crop statistics.

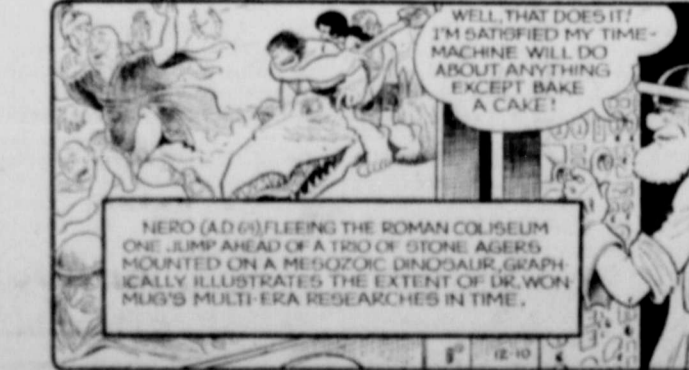

High School Football Race Narrows Down

Lubbock and Temple, favored for weeks to become the state's Class AAAA and AAA schoolboy football champions, got their supreme chance this week, but the final hurdles loom as the highest they have encountered down the long trail since the September starting gun.

The undefeated-untied Westerners never looked sharper as they bounced Fort Worth Arlington Heights 42-0 last week, but potent Baytown looked like anything but a pushover as the Gators humiliated Corpus Christi Ray 34-0 to gain the other finals slot.

While Lubbock and Baytown are meeting at Dallas and Temple and Breckenridge at Abilene, the state's Class AA and A survivors will be cracking heads in their own semifinals contests to set up next week's championship games.

In AA, it will be Anson against Arlington at TCU Stadium in Fort Worth and La Vega against Donna at Alamo Stadium in San Antonio, both Saturday.

In A, Wink defends its No. 1 rating at home against Newcastle Saturday, while Giddings tackles Vanderbilt at Gonzales.

Every one of the play-off contests loom as explosive offensive battles with Lubbock, Anson, La Vega, Wink, Newcastle and Giddings seeking to remain unbeaten and untied. The Wink-Newcastle tilt is the only one matching perfect record teams.

Lubbock and Temple will be favored, but only slightly, while Arlington, La Vega, Wink and Giddings will get the nod in the other games.

The AAAA final will pit Baytown's strong running trio of Fred Ernst, Kevin Lunsberry and Farrell Stroud and the passing of Gerald Orton against Lubbock's flashing rushing artist, James Sides, and the throwing of Charlie Brewer. Defensively, Baytown may have the edge.

The AAA final looms as a great aerial battle between Temple's Doyle Traylor and Breckenridge's Ken Ford. Traylor passed for six touchdowns against Brownsville, Ford for four against Grand Prairie.

New Eruption Of Mt. Hibok-Hibok Sprays Ash-Lava

ABOARD EVACUATION SHIP OFF CAMIGUIN ISLAND, Philippines, Dec. 10 (UP)—A new atomic-like eruption of Mt. Hibok-Hibok today sprayed more lava and ash over the deserted, devastated countryside where 1,000 to 2,000 inhabitants perished last week.

All survivors of the initial eruptions already have been evacuated from the area, but the big new explosive eruption and several smaller ones kept back rescue parties seeking to recover bodies.

The volcano belched forth smoke and flame six times in the short space of an hour and 15

minutes this morning. The fiercest and biggest eruption came at 8:55 a.m., sending up a huge, fiery column which mushroomed at a great height as though from an atomic bomb explosion.

The eruptions were clearing visible from this Philippine Navy landing ship which is carrying 21 severely-burned victims of earlier eruptions and 700 other refugees from Camiguin Island to Cagayan De Oro on the north shore of Mindano Island, just to the south. The main eruption was second only to that which blew the top off Mt. Hibok-Hibok last Tuesday.
