Communist Demonstrators Attack American General

RIOTING REDS HIT AMERICAN HOUSING AND BATTLE POLICE

OSAKA, Japan, June 25—Communist demonstrators threw acid at an American general, attacked an American housing compound with a "Molotov Cocktail" and battled police Wednesday in clashes marking the second anniversary of the Korean war.

Japanese police announced 58 persons were arrested in connection with the rioting. Thirty policemen were injured.

Extra guards were stationed near American installations, including the Itami Air Base, as well as at plants producing goods for the United Nations, to guard against the possibility of further outbreaks.

Riots of Protest
The demonstrations were staged by Korean and Japanese Communists to protest an agreement letting the United States have air bases in Japan and to protest the Korean war. Some demonstrators carried placards reading "Crush and Itami Air Bases"

Brig. Gen. Carter W. Clarke, U. S. Army commander in the Osaka area, was slightly burned when a demonstrator hurled a bottle of acid at his car as he was driving to his office Wednesday morning. The bottle broke the right front windshield, splattering some of the acid on Clarke's face. He was treated for superficial burns, after which he proceeded to his office.

The incident took place at Suita City, about five miles south of Osaka. The man who hurled the bottle was not identified.

Incident At Air Base
Several hours before, a small group of Reds gathered around the American Air Force family housing center at Itami Air Base outside Osaka. Marine and Air Force troops came on the double to re-inforce the guard.

About 20 to 30 demonstrators surged toward one of the houses. One man in the mob tossed a "Molotov Cocktail" gasoline bomb into the compound. A Marine guard fired over the heads of the mob. The demonstrators fell back and broke up.

No one was injured on either side. The fire bomb was put out. It caused no damage to the housing area.

Mrs. Michaud testified Tuesday that she masterminded one of the biggest robberies in history because "I loved Redfield."

"If you want to cure a smoker you take away his cigarettes," Mrs. Michaud testified, "if you have a man who worshipped pennies you take away his pennies."

The attractive, dark-haired woman unfolded her side of the fabulous story before a packed courtroom which was cleared of all minors when the testimony became so spicy. Once, she said, she lived with Redfield as man and wife for "several days."

Crazed Husband Kills Wife, Self Near Carthage

CARTHAGE, June 25 (UP)—A crazed husband shot his ex-wife in the back as she fled from him, then sent a rifle bullet through his own heart as she lay dying.

An aunt of the 21-year-old wife was critically wounded when she tried a few moments earlier to shield her niece from the husband's rampage.

The victims were James T. Thornton, 29, a Panola county man, and Mrs. Iloha Joyce Thornton, who had divorced him only 3 weeks ago and was the mother of two small children.

Mrs. Jewel Price Lee, Mrs. Thornton's aunt, also was shot and was in critical condition at a Carthage hospital.

Verdicts of suicide, murder and attempted murder were returned by Justice of the Peace Hardy Pitts of Carthage.

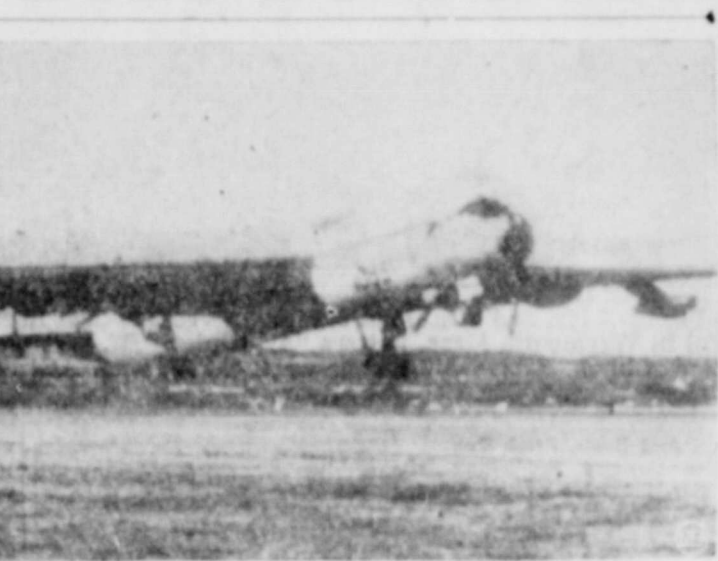

Seventeen new cases of poliomyelitis, meanwhile, were reported Tuesday alone at Houston, the worst single day for polio in the city's history. One San Antonio hospital simultaneously reported three new polio deaths, all adults.

Dr. George W. Cox, state health director, said a total of 917 cases of poliomyelitis have been reported so far this year, compared with 824 for the same period of 1950, the epidemic year.

Midwest Lashed By Tornadoes, And High Winds

All Talk And No Results On Korean Truce

PANMUNJOM, June 25 (UP)—Red truce negotiators, in their first reference to devastating Allied air raids on North Korean power plants, said Wednesday the United Nations could not intimidate them into accepting its armistice terms.

North Korean Gen. Nam Il, chief Communist delegate, also accused the UN in an angry 18-minute barrage of trying to extend the war by "dangerous steps."

"Your side is reminded," he said, "that no provocative actions taken by your side outside this conference will alter the reasonable and unshakable position of our side."

Although he did not mention the Allied air attacks Monday and Tuesday on Yalu river and northeast Korea power plants, it was clear that these were the "provocative actions" to which he referred.

Maj. Gen. William K. Harrison, chief UN negotiator, said afterward Nam sounded even more beligerent than usual.

"I must remind you," Nam said, "that your way of speaking as if your side were a victor is a great insult to our side and is entirely improper in the present armistice negotiations conducted by both sides on an equal footing. I demand that your side withdraw such insolent statements."

Harrison, who for weeks has heard Nam malign the United Nations and the United States as "murderers," snapped back:

"You used the word demand. Words such as 'demand' have no significance if they cannot be enforced by military power."

Harrison also accused the Communists of disagreeing with Russia's public stand on repatriation of prisoners. He again reminded the Reds that the Russians once offered German troops in World War II the right to refuse repatriation to their homeland if they surrendered.

Mrs. Michaud told in detail how she and the eccentric gambler-financier "sealed the bargain" whereby she would be allowed to steal the safe loaded with cash, securities and jewelry from his Reno home last March.

Government prosecutor Bruce Thompson asked the stormy Wednesday if Redfield had actually given his consent for her to pull the fantastic burglary.

"Yes," she replied.

"Did you then decide to go ahead with the burglary?" Thompson asked.

"Yes, I certainly did," Mrs. Michaud answered. "He gave me permission to do so."

Mrs. Michaud, rattling off her testimony so fast it became incoherent at times, said Redfield agreed to the strange method of making her a millionaire when she suggested it would "explain" their relationship to his wife.

The Quebec-born defendant told dramatically and with gestures how she sat on a bed in Redfield's home when his wife was away and "persuaded him in about 10 minutes" to let her take the money.

"I made up my mind that as long as I was LaVere Redfield's sweetheart I would never again be without the price of a room," she said.

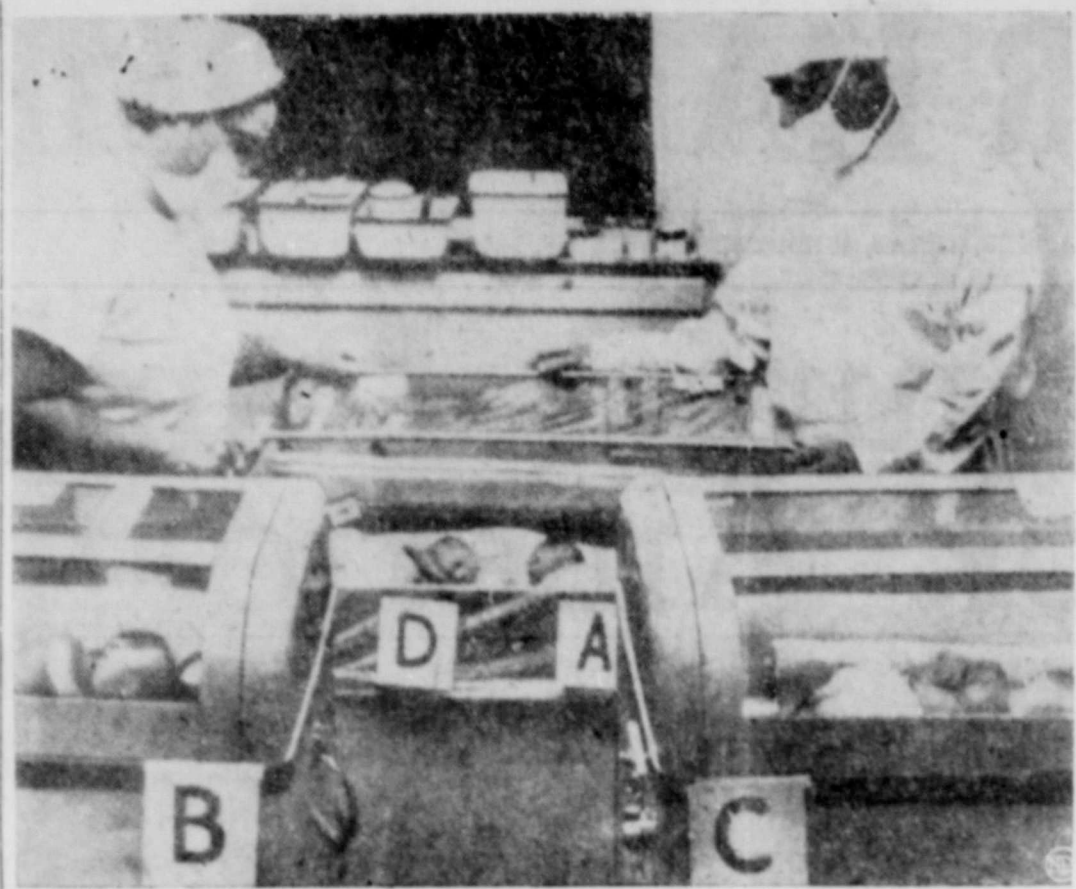
Seidman Uses 'Slud'

VA Lifts Credit Restriction On GI Auto Loans

WASHINGTON, June 25 (UP)—The Veterans Administration Wednesday lifted all credit restrictions from GI loans for automobiles.

The move enables World War II veterans for whom a car is a business necessity to get government insured loans for periods longer than the previous 30-month maximum. The only restriction is that the term of the loan may not exceed the economic life of the automobile.

The basic law covering GI business loans for car purchased remains unchanged. No down payments are necessary, but the veteran must show that a car is essential to his job or business.

METALS CONTROLS RELAXED

WASHINGTON, June—All but the biggest manufacturers were freed Thursday from direct government controls over copper and aluminum consumption. In an extension of its self-allocation program, the National Production Authority gave manufacturers and builders in most categories permission to buy increased amounts.

tion, billed as the biggest in history, will be held Friday. Dr. John R. Steelman, acting director of the Office of Defense Mobilization, will speak.

Steelman also will be presented with a special plaque in recognition of services rendered by informing American communities of the need for, and development of, the national defense program.

After new officers are elected Friday, Sen. Estes Kefauver of Tennessee and Sen. Richard Russell of Georgia, both candidates for the Democratic presidential nomination, will speak at the inaugural banquet.

Wednesday's pause for business won't be too tough on the delegates. There was a Colorado chuck wagon dinner, a "real Texas rodeo" and old-fashioned square dancing scheduled immediately afterward in that order.

Thursday comes the heralded all-states parade, when each delegate must present some special stunt. Nevada Jaycees, for example, will throw silver dollars—15,000 of them—to Dallas citizens viewing the parade.

Then there will be a four-hour progressive party during which delegations from nine states—

Oklahoma, Virginia, South Carolina, Florida, Kentucky, Louisiana, Illinois, Wisconsin and Missouri—will serve delicacies of their respective regions. These range from chicken legs to hot dogs and shrimp, and from mint juleps to beer.

The resolutions committee met Tuesday and decided that four major resolutions would be presented to the convention.

One favors aids for better government and calls for curtailment of federal grants and loans. Another demands more effective operation of the Veterans Administration. The third favors statehood

for Hawaii and the fourth opposes intervention in private enterprise by the federal government.

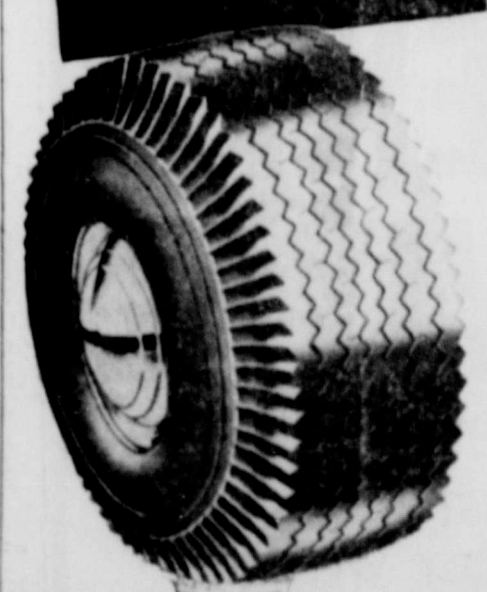
