Flight Safety Course Planned In Area Cities

AUSTIN — John G. Uranga and Laddie J. Roark, Flight Safety Supervisors from the Texas Aeronautics Commission, will conduct Flight Safety Refresher Courses at Graham and Breckenridge during the month of October.

The meetings at Graham are scheduled to be held at the Texas Electric Service (Ready Room) on October 21, 22, 23, and 24, from 7:00 p. m. to 9:00 p. m.

At Breckenridge, the meeting will be held at the terminal building of the Stephens County Airport on October 28, 29, 30, 31 and November 1st, and will begin at 7:30 p. m.

These Flight Safety Refresher courses are designed to offer the pilot an opportunity of upgrading his knowledge and pilot skills, and to promote overall flying safety.

General subjects to be covered are: Aviation weather... Air traffic control... Navigation radio aid... Safety techniques in the operation of single, multi-engine, and rotor-wing aircraft... An analysis of current charges in Civil Air Regulations.

All pilots, and anyone interested in aviation safety, are invited to attend. There will be no charge.

J. L. Fox Rites Held Last Sunday

Funeral services for James Lafayette (Uncle Fate) Fox, 94, of Olden, were held Sunday, at 4:30 p. m. in the Hamner Funeral Chapel in Eastland. Burial was in the Merriman Cemetery, south of Ranger.

Mr. Fox died Saturday, October 12, 1963 in the Greenacres Nursing Home in Eastland, where he had been a patient for one month.

A resident of Eastland County for 80 years, Mr. Fox was born in Hill County, Texas, February 10, 1869, and was a retired farmer. He married Roxie Gullett in 1887 in Eastland. He was a member of the Church of Christ.

Surviving are his wife; two daughters, Mrs. Hazel Reese of Fort Worth and Mrs. Roby Hughes of Olden; three sons, Woodrow of Grand Prairie, Lloyd of Clyde and Adra Lee Fox of Olden; one sister, Mrs. Rosie Bishop of Ranger; one half brother, Sam Fox of San Angelo; 11 grandchildren and nine great-grandchildren.

Selection of Jury Begins In Hussey Case At Palo Pinto

Dual Plea Seen For Defendant

Testimony in the Nathan Curry murder trial was expected to begin by 1 p. m. Wednesday in the 29th District Court in Palo Pinto. The first two witnesses to take the stand for the state will be the Rev. Jesse E. Cassie, pastor of the First Baptist Church in Cisco, who discovered the beaten and stabbed body of Mrs. Florence Hussey, church secretary, on the morning of June 28, 1961, and Dr. Charles L. Hallow, Cisco physician who performed the autopsy.

Defense Attorney John Watts of Odessa, in questioning members of the jury panel, said that the defense would plead not guilty by reason of not having committed the crime or, as an alternative in case the jury does not agree, the defense will also plea not guilty by reason of temporary insanity.

Two prospective jurors were disqualified Monday because of prejudice against a plea of temporary insanity. One member of the panel was disqualified because of his prejudice against the law which allows a person to be tried as an adult for a crime committed as a juvenile.

When court adjourned Tuesday afternoon, 24 prospective jurors had been qualified. In accordance with a request by Mr. Watts, which was granted by Judge W. J. Oxford Monday morning, 32 prospective jurors will be qualified before state and defense will use their preemptory challenges to remove ten each from the jury panel.

Attorney Watts also questioned prospective jurors to find if they were prejudiced against a suspended sentence being given on a murder conviction, and if they would be ruled by the law which says that if the state fails to prove even one element of the indictment, the jury must acquit the defendant.

Assistant prosecuting attorney Sam Cleveland reminded each member of the panel that the state is obligated to prove only the charge alleged in the murder indictment, and if the state should fail to answer every question in the mind of the jurors, still a verdict of guilty must be returned if the murder by the defendant is proved beyond a reasonable doubt.

Business Outlook Good Retail Sales Show Promise

The area business outlook for the final quarter of 1963 is "highly promising," according to Don A. Yarbrough, cashier of Commercial State Bank.

Retail sales are expected to soar to seasonal highs during the coming pre-Christmas shopping period, the banker said. Yarbrough also lauded what he described as "an inspiring impetus in community enthusiasm" during the first eventful nine months of 1963.

An improvement of the overall economy of Ranger and surrounding area during the past year is verified by latest statement of condition of Commercial State Bank. The financial summary was issued as of Sept. 30 in compliance with the customary call of the comptroller of the currency.

Deposits of the institution on that date totaled \$2,707,889.49 — a substantial gain over the previous quarter and also above the comparable figure for the same date a year ago.

The bank's deposits on June 29 were \$2,628,963.89, and the total as of Sept. 28, 1962 — a year ago — was \$2,618,812.63.

Also noted was an increase in loans and discounts during the past 12 months. Latest current total was \$1,143,797.76 compared to \$1,040,932.78 one year ago.

Undivided profits similarly swelled during the same period — from \$146,016.80 one year ago to \$155,181.80 as of Sept. 30.

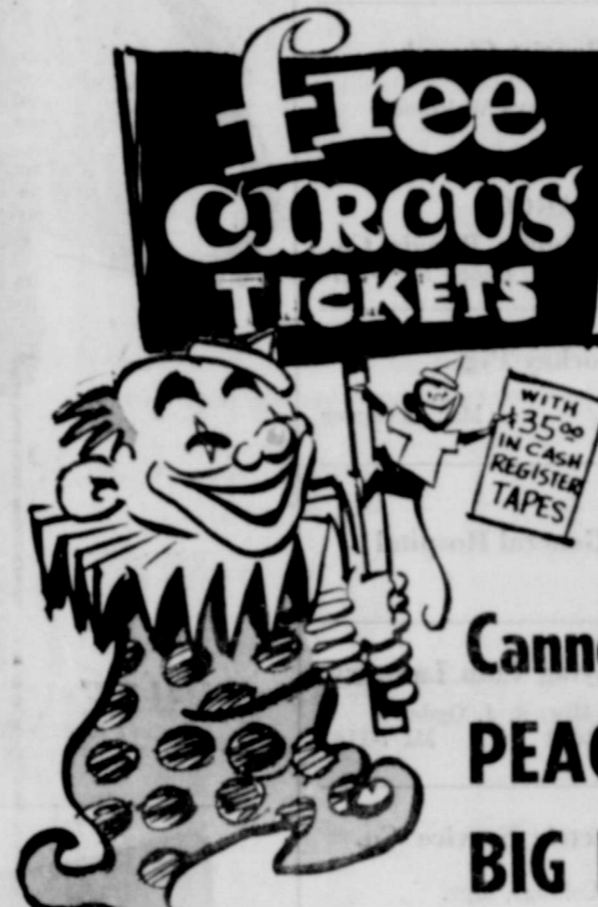

highway, connecting large cities from coast to coast. Mrs. Henderson's question was this: "If the concern is for the removal of bottlenecks, then what about the road between Ranger and Weatherford?"
Including the road to Weatherford and our neighbors to the West and on to Abilene, "Of the four situations, will the real bottleneck phase stand up?" "It is not Ranger," he noted.
Mr. Haun's reply "The Abilene area construction is ahead of the Eastland area." Fort Worth district plans to reach Eastland County by 1966, he stated.
The answer to Morris Campbell's question, "What happens if the Ranger bypass is com-

pleted and the portion from here to Weatherford is not," was that all Interstate 20 is to be completed by 1972.
Dick Henderson had another question. "In Eastland County of the three towns that are to be bypassed, which will be done first?"

Question: "Why?"
Answer: "Because it is the smallest of the proposed projects, therefore will take less time to complete."
