Ranger High School.

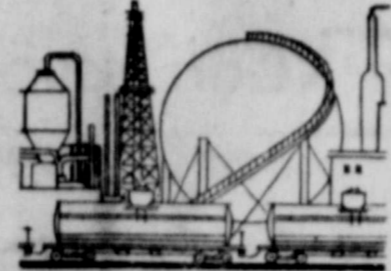
As a matter of fact, the

'Ruth Bragg Fund' Is Lagging; Contributions Desperately Needed

Contributions to the "Ruth Bragg Fund" continue to come in to help defray the heavy medical expenses for the gunshot victim, Mrs. Ruth Bragg, who is reported to be somewhat improved but still dangerously ill in the Ranger General Hospital.

Mrs. Bragg was shot twice in the chest by her estranged husband, John F. Bragg, early Saturday morning, Aug. 22, and he killed himself seconds later with the same weapon, a .380 caliber automatic revolver. The shootings occurred at the Ranger Hill Cafe where Mrs. Bragg worked as a waitress.

Her thin thread of life has hung precariously on numerous blood transfusions and large quantities of oxygen. Her critical condition requires constant care. Three special nurses — each working eight-hour shifts — care for her 'round the clock. These expenses plus the many other medical expenses must be taken care of and sympathetic Rangerites initiated the "Ruth Bragg Fund" for the purpose of helping to defray the heavy medical expenses.

Mrs. Bragg is the mother of three children, Johnny Lee, 15, Jerry Wayne, 11, and Kathy Sue, 10. The children are of a previous marriage and were adopted by the late Mr. Bragg in February, 1963. The couple were married in Eastland on May 9, 1961.

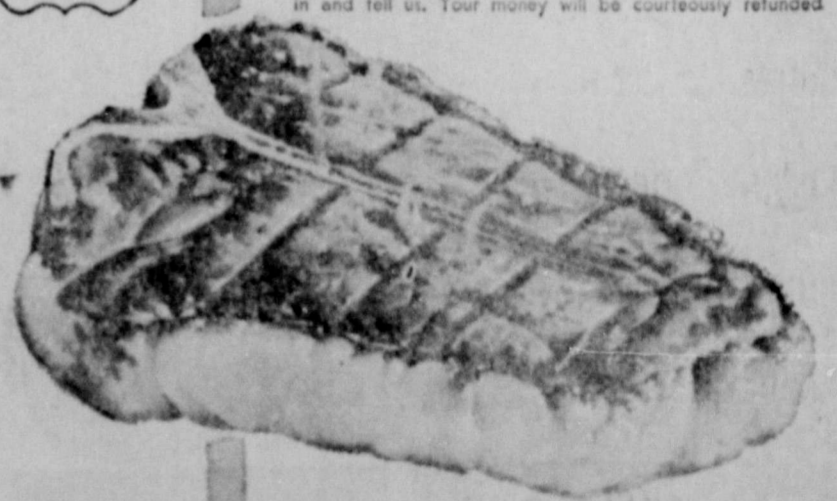

Allergens, such as dust of all kinds, molds, and animal fur, aggravate symptoms during the hay fever season. Some people move to another part of the country, where the pollen count is at a minimum. Your physician can obtain from the American Academy of Allergy listings and maps which give the pollen count indexes for different parts of the country. Any location with an index of 10 or above is not recommended for those allergic to ragweed. In most of Alaska the count is 0. Lowest in the continental United States is Cape Coral, Fla., with .19. Lexington, Ky., on the other hand, has an index of 156.

County Farms Yield \$7,425,000 in 1963

For Eastland County's farm population, 1963 proved to be a better year, by and large, than it was for farmers in many parts of the country.

Although some local operators barely held their own in the year, others, especially those with well-equipped, commercial-size farms, ended up on the plus side.

They were able to raise more livestock and produce a larger volume of crops than before, despite the smaller amount of land under cultivation.

Much of this gain was offset, however, by the drop in prices for farm products and cattle.

Details on the year's operations, for the local area and for all other sections of the United States, are contained in the annual survey report released by the Standard Rate and Data Service.

It shows that Eastland County farmers accounted for gross revenues of \$7,425,000 in 1963. This is a gross figure — before taxes, and before deductions for operating costs.

Included in it are the cash proceeds from farm marketings. Government payments and "income in kind," which is the value of products grown and consumed on the farm.

An estimated 39 percent of

the income from the marketing of farm goods came from the sale of livestock, poultry and dairy products.

While the average American farmer has been able to boost his production and thereby increase his gross receipts, he has not succeeded in turning this gain into added net income. The price squeeze has been against him.

As a result, he has failed to share in the prosperity enjoyed by the country as a whole. Only because there are fewer farmers than before to share in the income has per capita earnings gone up.

For the farm population of Eastland County, the gross income, \$7,425,000, was at the rate of \$2,153 per capita.

Despite the difficulties connected with farming, it continues to be the nation's largest single industry, providing jobs for more than 6,500,000 people.

Gross income from farming and ranching in the year amounted to over \$41 billion.

Conservation District Seeks To Meet Land, Owner Needs

By Soil Conservation Service
A complete conservation plan of operations to meet the needs of the land and the economic needs of the farmers and ranchers of Eastland County is the goal of the Upper Leon Soil Conservation District.

The Soil Conservation District Supervisors assisted by local agricultural agencies are furnishing assistance to landowners and operators, in the form of technical assistance, equipment rental, and cost share assistance in working toward complete treatment of the land.

The Great Plains Conservation Program, activated in 1963 in Eastland County, is one of the cost share programs that is of material benefit in doing this important job. Using a complete conservation plan for a farm or ranch as the blueprint, farmers and ranchers are building, what they hope are weather-proof units, by applying conservation practices, cost-shared through a GPCP contract.

There have been 180 applications for assistance submitted in Eastland County. About 90 of these on some 45,000 acres are active contracts. The climatic hazards of an agricultural enterprise have been evident this year. While a conservation plan applied will not insure adequate rain at the right time every year, it does decrease the risk involved in farming or ranching in Eastland County.

A hearing before the Railroad Commission in Austin is scheduled at 9 a. m., September 4.

Vets Questions And Answers

Q — If a veteran dies while receiving pension under the old pension law, may the widow and minor children be paid under the old law?

A — If the veteran died on or after July 1, 1960, any pension payable to the widow and minor children must be paid under the new pension law.

Q — I was recently hospitalized in a VA Hospital for 30 days for treatment of a service-connected disability. After 18 days, I was released for seven days leave, then returned for five more days. Am I entitled to temporary 100 per cent rating for my service-connected disability during the period of hospitalization?

A — No. To meet requirements for temporary 100 per cent rating, you must have received continuous treatment for a period of 21 days. Passes of more than four days within the first 21 days will be considered as interrupting the continuity of treatment.

Q — As a so-called peacetime veteran am I entitled to any disability compensation from the VA?

A — Yes, such disability compensation is generally 80 per cent of the wartime rates. However, if the disability occurred under extra hazardous conditions wartime rates apply.

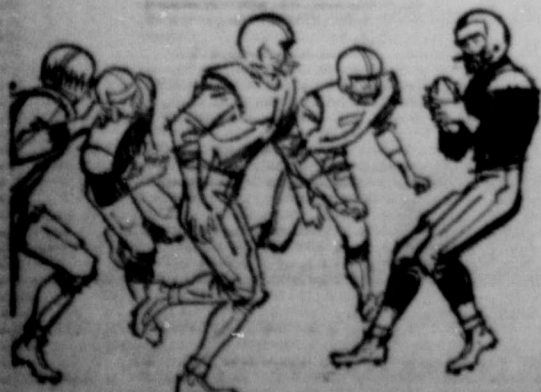
