# Dimmitt tackles top team today at state

"There is nothing more I want than for me to be at the free-throw line with a one-andone with one second left and us behind by a point. That's the way I want it to be. There's no doubt in my mind that we'd come home the state champions." —Warren McDonald.

Last year, the Dimmitt Bobcats were fighting Cleveland for the State Class 3A championship, and the Indians sent McDonald to the line three times with a one-and-one in the last 2:37 of the game. Each time, Warren missed the front-end shot, and felt responsible for Dimmitt's eventual 57-56 loss.

When the chartered bus rolled into the Dimmitt High School parking lot the next afternoon, McDonald jumped off the bus, walked into the gym and made the first two free throws he tried.

"I can't explain how much I want to win the state championship this year," McDonald said. "I want this more than I have ever wanted anything. I just can't explain how badly I want

McDonald and his Bobcat teammates get a chance at winning the state title today at 2 p.m. in the Super Drum in Austin against a 34-0 veteran Hughes Springs team that features four starters back from a team that fell in the semifinals to Cleveland, 61-53, in last year's state tourney.

"I really wish it was Cleveland (now in 4A) again," said James Alexander, another veteran of last year's game, "so we could get some revenge on them like we did on Seminole last year. But Cleveland is running track or whatever they're doing, and we're playing basketball, so we'll go down there and just try to beat whoever we play."

Those teams they've got ranked up there above us, they're winning by two or three points, and we blew out the No. 4 team by 19 Friday night and won by what, five, Saturday. They gave us some respect by ranking us with the record we had, but we don't care what the poll says now as long as March 14 comes around and we're No. 1. That's what matters."

"This is a dream come true for my senior year," said Marc Bennett, one of just three seniors on the Dimmitt squad and the probable lone senior starter. "I would kind of like to go to The University of Texas, and to play my final two games in high school at the Super Drum is just great.

"This is just as exciting for me as it was the first time we went in 1967," Dimmitt coach Kenneth Cleveland, who is leading his ninth bunch of Bobcats to the state tournament, said Saturday after Dimmitt's 63-58 win over Marlin in the regional tournament in Lubbock.

The game will feature two experienced ballclubs. Hughes Springs features four returning starters from a 30-5 team that has gone unpressed through the playoffs and has been the state's top-ranked 3A team since the first of the season.

# Beer burglars shoot policeman

A Dimmitt policeman was shot early Monday morning when he foiled an attempted burglary at the Arrow Beer and Wine Store at 608 N. Broadway.

Officer Garold McDaniel of the Dimmitt Police Dept. was wounded in the left shoulder by a round fired by the burglars from the store. He was in good condition at presstime Wednesday at Deaf Smith General Hospital in Hereford, where he was taken after inital treatment at Plains Memorial Hospital in Dimmitt.

The shooting occurred about 4 a.m. Monday when McDaniel, on routine night patrol, spotted an open door at the store. As McDaniel approached the building, at least one of the burglars opened fire on McDaniel. Three of the rounds struck the patrol car's windshield, and at least one other round shattered the glass of the driver's side window. It is believed a round that went through the window is the one which struck McDaniel in the left shoulder.

McDaniel was reported to have been wearing a bullet-proof vest at the time of the shooting, but the would offer no protection in the area where McDaniel was

Police Chief Gary Thurman said McDaniel returned fire before being hit, but did not think any of the burglars were struck. "We have no indication of that," Thurman said, "but there is a possibility one of the

burglars was struck" by McDaniel. Thurman said McDaniel was able burglars, and said he had not seen the burglars before, leading police to believe the burglars were not from Dimmitt.

Thurman said Tuesday there are no suspects in the case, but police are checking several leads, including the possibility the burglars may have stopped at Allsup's Convenience Store and asked for beer earlier Monday morning.

> Thurman said he didn't think the burglars were connected with a Monday morning break-in at Killingsworth True Value Hardware or an armed robbery in Clovis that occurred about 5 a.m. Monday.

"There is the time factor and too many differences," Thurman said.

# Police investigate burglaries

Two separate burglaries at Killingsworth True Value Hardware in Dimmitt netted the burglars in excess of \$1600-worth of goodsmostly firearms.

At 3:23 a.m. Friday, a patrolman spotted a broken-out door on the northeast side of the building. At 7:27 a.m. Monday, the narrow glass panel beside the front door was discovered broken out.

In the first incident, items taken included a Blue .44 magnum, a Crossman air gun, a Timex watch, two Farnam knives, and a Red Head gun case.

# Dimco grant going to state

Castro County Commissioners approved, for the third time, the pursuit of a \$500,000 grant from the Texas Dept. of Community Affairs that would, in turn, be used as an operating loan to Dimco Industries of Dimmitt.

# We Salute

### A New DHS Record

With the Bobcats' appearance at the state tournament this weekend, Dimmitt High School will break its own record.

This is the 14th Bobcat team to advance to the state boys' basketball tourney—the most times of any Conference AAA school.

The first DHS boys' basketball team to make it to the state tournament was in 1944, under Coach John Blaine. Blaine's 1948 team also went to state, and his 1951 team went undefeated and won the school's first state championship in boys' basket-

Coach Johnny Ethridge took two Bobcat teams to state, in 1960 and 1961. Both of those teams finished as the state runners-up.

This is Coach Kenneth Cleveland's ninth Bobcat team to appear in the state tournament. His first was in 1967 (state runners-up), and since then he has coached teams to Austin in 1971, '75, '78, '82, '83, '84, '86 and '87. His first state championship team (and the school's second) was in 1975. His 1982 Bobcats also won the gold, and his 1983 team duplicated the feat of the 1951 Bobcats by posting an undefeated season (38-0) while capturing the state championship.

These records, as impressive as they are, still don't tell the whole story. Many long-time Bobcat fans can remember four, five, six or more great DHS teams that missed a trip to state—or a state championship—by a single basket. Many of the times the Bobcats have not made it to the throne room, they were knocking on the door.

During these years, 32 Bobcats have been named to the all-state teams.

The Bobcat tradition continues, and grows. Last year Johnny Hampton (Nazareth) became the first former Bobcat to win a state championship as a coach. This year another former Bobcat, Rocky Rawls (Bronte) will have his team at the state tournament.

Those are enviable records, and a special source of pride for Dimmitt's high school and its people.







# Exemptions May Reduce Your Taxes!

### **HOMESTEAD EXEMPTIONS**



# CAN LOWER THE PROPERTY TAXES ON YOUR HOME

A homestead exemption lowers the property taxes on your home by lowering its taxable value. For example, if your home is valued at \$50,000 and you receive a \$5,000 homestead exemption, your home will be taxed as if it were worth only \$45,000.

You qualify for a homestead exemption if you owned your home on January 1 and used it as your primary residence on January 1. It doesn't matter whether your home is a house, a condominium or a mobile home.

**Exemptions** are available to all homeowners to lower their school taxes. Additional exemptions are available to homeowners who are is April 30, 1987. Contact your disabled or age 65 and over. Other exemptions may be offered you need more time. to homeowners by school districts, counties, cities, and special districts. All taxing units offer exemptions to disabled veterans.

Apply to your local appraisal district office at the address shown below for all exemptions you may qualify for. Application forms are available there.

If you received a homestead exemption on your present home in 1986, you won't need to apply again for 1987 unless your chief appraiser requires you to reapply.

However, if you passed your 65th birthday or became disabled before January 1, file a new application to receive the additional exemptions.

If you haven't received an exemption on your present home, or if you've moved to a new home, make a new application for 1987.

# **PRODUCTIVITY** VALUATION



### THE PROPERTY TAXES ON YOUR FARM, RANCH OR TIMBERLAND

Texas law provides farmers and ranchers with a way to lower their property taxes, known as productivity valuation.


If you qualify, your agricultural land will be taxed on its capacity to produce crops, livestock, or timber, instead of its value on the real estate market. Productivity valuation can lower the taxable value of your land, and lower your property taxes as a result.

If your land has never received productivity valuation, you must apply to the appraisal district by April 30 to get tax benefits for 1987. You can choose from two types of productivity valuation.

If your land already receives open-space or timber (1- d-1) valuation, you don't need to reapply unless the chief appraiser requires you to. But remember, you must apply every year for ag-use (1-d) valuation.

# PROTECT YOUR RIGHTS AS A TAXPAYER

A rendition is a report to the appraisal district that lists all the taxable property you own or control on January 1, 1987. You may also give your opinion of the property's value, if you wish.

You must file a rendition if you own tangible personal property used to produce income-such as the machinery and equipment used by a business.

The appraisal district may require any taxpayer to file a rendition by sending the taxpayer a written notice and a rendition form.

You may want to file a rendition, even if you aren't required to file, to preserve some of your rights as a taxpayer: You put your correct mailing address on record so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.

 You can put your own opinion of your property's value on

record. If the appraisal district then places a higher value on your property, it must notify you in writing of the higher value and explain how you can protest that value to the appraisal review

 By filing a special type of rendition called a report of decreased value, you can notify the appraisal district of significant damage to your property that occurred in 1986. The district will send someone to verify the damage and take it into account when assigning a 1987 value to your property.

File renditions with your local appraisal district at the address shown below. Forms are available there.

The deadline for 1987 renditions is March 31. You can get an extra 30 days if you ask for it in writing before the March 31 deadline.





# Police issue drug warning

Local police have issued a reminder warning to parents and children to watch out for drug-laced tattoo sheets, which have been seen recently in Haskell County, according to a news item from Rochester.

A common form of the tattoo is called "Blue Star," and is sold all over the United States. The blue tattoos in the shape of stars are on a white sheet of paper. The stars, about the size of a pencil eraser, can be removed and placed in the mouth. The LSD usually present in the tattoos can also be absorbed through the skin simply by handling the paper.

The tattoos have also been known to appear in shapes resembling postage stamps, featuring pic- ations, severe vomiting, mood tures of Superman, butterflies, clowns, Mickey Mouse and other cartoon characters. These stamps are usually packaged in a red cardboard box wrapped in foil.

Other forms include a red stamp called "red pyramid," "micro-dots" in various colors, and "window pane" which has a grid that can be

Police caution that children should be advised not to handle anything that may resemble these types of tattoos, adding that these drugs are known to react very

quickly and some are even laced with strychnine.

Symptoms may include hallucinchange, and change of body temperature. Victims should be taken immediately to a hospital, and the

police should be notified.

"A young child could happen upon these and have a fatal 'trip,' or could be given a free 'tattoo' by older children who want to have some fun or who want to cultivate new drug customers," police warn.

A local spokesman for the Sheriff's Dept. says none of the tattoo sheets have been seen locally, yet, but, "that's not saying it couldn't happen," he added.



The mobile screening unit of the Texas Breast Screening Project of the American Cancer Society will be in Dimmitt Saturday at Plains Memorial Hospital to perform mammography tests on selected participants for a reduced fee of

Any women wishing to participate in the screening may call the hospital for an appointment. To be eligible, women must be at least 35 years old, not pregnant and not nursing a baby. For women ages 35 to 39, they must not have ever had a mammography, and for ages 39 to 50, they may not have had one within the last year.

Local ASC chapter president Val Davis said that women who called in to the special phone banks set up for this project and received information packets may still use their coupons, but an appointment must be set up for Saturday by phoning the hospital.







# 'Cats maul Marlin, dump Decatur in regionals

Facing the No. 3 and No. 4 ranked teams in the state, the tenthrated Dimmitt Bobcats defeated Decatur 62-43 in Friday's semifinals and Marlin 63-58 to grab the Region I-3A title Saturday at the Lubbock Municipal Coliseum.

James Alexander and Warren McDonald, who had 39 and 26 points, respectively, during the tournament, were named to the alltournament team.

### Dimmitt 62, Decatur 43

The Bobcats shut down the highly-touted inside game of Decatur's Lance Aldridge to ease to a 19point win in Friday's regional semifinal game.

"I think I played the finest defensive game I've ever played," said Dimmitt post man Marc Bennett, who blocked three Aldridge shots and held Aldridge to just 12 points. Bennett hit 12 points for the

"It looked like either he lost confidence in himself or the whole team lost confidence in him," Bennett said. "I hope those three blocks and my defensive play had something to do with that."

"Marc Bennett played probably his best game for us all year," Dimmitt coach Kenneth Cleveland said after the easier-than-expected win. "We had heard they were a much better team, a better shooting team, than this."

The Bobcats, though, held Decatur at bay as the Eagles shot just 33%, 16-of-48. The Bobcats made 24 of their 54 shots.

Bennett was joined in double figures by James Alexander, who led all scorers with 17 points, and Jeremy Warren and Warren McDonald, who each scored 16 points.

Decatur never led in the game. Bennett hit one of two free throws with 6:16 left in the first quarter to give the Bobcats a 1-0 edge. Dimmitt soon built a six point lead, 9-3 on a McDonald bucket with 2:09 left, before two Dimmitt tumovers allowed Decatur to cut the gap to 9-7 with 26 seconds left in the quar-

Dimmitt led 11-7 at the end of the quarter as the Bobcats furiously tipped the ball around the rim before Bennett tipped the ball in just before the horn.

away in the second quarter before the Tigers fought back from an 11point deficit (26-15 with 3:44 left in the half on a Warren basket) to cut the gap to six at halftime.

"We didn't play very well during that stretch," Cleveland said. "We made some mistakes in there, turned the ball over, did some things you can't do against good teams in the playoffs, and we let them back in the thing. I'm just proud of the kids for responding like they did in the second half and playing better basketball."

Decatur could never get closer than six points, 36-30 with 6:02 left in the third quarter, before the Bobcats hit six of their last eight shots of the quarter. Dimmitt led by 14, 50-36, at the end of the quarter when Alexander forced in a 10-foot jumper with three seconds left.

Bennett blocked two Decatur shots in the period as the Bulldogs shot just two-for-nine in the quarter and made just four of their 21 second-half shots, and became an offensive force in the fourth quarter, hitting seven of the Bobcats' 12 points in the period.

"I thought we all played pretty well," said Jeremy Warren after the game. "I really thought they would be much better than this, but we all played pretty well."

### Bobcats 63, Marlin 58

Working like finely-skilled surgeons working on a delicate patient, the Bobcats cut away at a five-point deficit to defeat Marlin for the regional championship.

Dimmitt trailed 48-43 after three quarters and Marlin looked to have

The Bobcats almost put Decatur all of the momentum a team could want, Marlin had held the lead since late in the first quarter.

The Bulldogs, however, opened the fourth quarter with possession of the ball and opted to go into a four-corner stall. After passing the ball around for over a minute, Marlin's Derrick Scott missed on a 12-foot jumper. Alexander ripped down the rebound and went to work for the Bobcats.

Alexander had hit just two of his nine first half shots, but responded with one of his biggest explosions of his three-year high school career.


"You know and I know that James is capable of doing that," Cleveland said, "but I was beginning to wonder when. He hasn't performed like that in our three previous playoff games, but when we needed it he went to work."

"I just know we needed to do something quick," Alexander said. "We didn't have Warren (McDonald) out there at the end, but he helped us a lot. We really just played together."

The Bobcats couldn't miss, canning their first eight shots of the final quarter while Marlin's point production looked like a team still in the stall game. Marlin hit just two of 13 field goal tries in the last period.

"I don't know why their coach did it (go into the four corners)," Cleveland said. "I know I've done it myself before, and sometimes it has cost us. If it works it's great, and when it doesn't it's terrible. I personally hate to have a lead and then try to sit on it. But, it got our momentum going and it probably won the game for us. I really hate to say that about another coach, but they sat on it. If they had sat on it







When Alexander rebounded Scott's miss, he went down the floor and hit a 17-footer to cut the lead to 48-45. Marlin missed again, and McDonald, saddled with four fouls, scored two minutes into the quarter to cut the gap to 48-47.

"I was just sitting on the bench rooting my teammates on," McDonald said. He picked up three fouls in the first half, sat out much of the third quarter after picking up his fourth personal, then fouled out with three minutes left.

# Insecticide planning

With corn planting only a few weeks away, many growers are considering the need for an atplanting insecticide. The narrow profit margin on corn requires that all crop inputs, including insecticides, be carefully considered to determine if economic returns will be realized.

At-planting insecticides are the most effective means for controlling pests that attack corn seedlings. Fortunately, damage to corn from these pests, such as corn maggots, white grubs and cutworms, is uncommon in this area. The risk of stand loss due to these pests alone probably does not justify the additional cost of an at-planting insecti-

Also, the application of insecticides at planting is clearly not an economical way to control foliage feeding pests. This is because, when used at economical and labelled rates, at-planting insecticides do not persist long enough to provide the lethal concentration necessary to control mites and corn borers when they appear in June and July.

The most common soil pest of corn in this area is the western corn rootworm, but even economic infestations of this root-feeding pest are uncommon.

Rootworm larvae feed on corn roots in June and July. Attacked plants may be stunted and often lodge due to destruction of the root system. Infestations typically develop in fields planted in continuous corn. This occurs because the female beetle lays eggs in the soil of corn fields in late summer. Eggs hatch in the spring and if corn roots are not available to the newlyhatched rootworms to feed upon, they die. As there is only one






