WATER WORKS FOR STATE

Representative Murray of Wilson yesterday morning introduced a bill in the house appropriating \$150,000 for the purpose of buying the old water company's plant from the city of Austin for the purpose of providing water and light to the various state institutions here at Austin.

STATE DEPOSITORIES

The old proposition of having state depositories come up in the house again yesterday morning in the way of a bill introduced by Representatives Love and Mays providing that the state's money shall be placed in these depositories by the state treasurer on the 1st of each month.

WOULD RESTRICT VOTING

A prohibition bill was introduced in the senate yesterday morning by Representative Willacy providing that in districts where local option is voted on once that no election for the same purpose shall be held in that district for the ensuing two years.

AFTER SLEEPING CAR RATES

Over in the senate Senator Paulus introduced a bill stipulating that in future sleeping car fares shall be materially changed. He desires that upper berths be reduced to 11 cents per night, and that where berths are occupied for a period of eight hours or less only one half of the above rates shall be charged, and further that for a seat in the sleeper a charge of not exceeding 10 cents per hour shall apply.

ARKANSAS WANTS A FORTY MILE STRIP

LITTLE ROCK, Ark., Feb. 4.—Senator John P. Logan, of Benton county, has offered a concurrent resolution in the senate providing for the restoration to the state of a strip of land forty miles wide and 300 miles long, now a part of the Indian Territory, and containing about 7,000,000 acres.

SOUTHERN PACIFIC SWITCHMEN GET INCREASE. The switchmen in the Houston and Beaumont yards of the Southern Pacific road have secured a considerable increase in salary as a result of the conference their grievance committee has been holding during the past few days with Manager Van Vliet in Houston.

The increase in pay will range from three to four cents an hour for the switchmen and \$10.00 a month for the assistant yardmasters.

The new scale agreed upon is as follows: Day foremen 31 cents per hour. Night foremen 33 cents per hour. Day helpers 28 cents per hour. Assistant yardmasters 120 per month.

AN OLD TIME TEXAS CHARACTER IS DEAD. VICTORIA, Texas, Feb. 4.—C. L. Thurmond, Sr., familiarly known as "Old Zip," a noted character of this county, died here yesterday of liver trouble. The deceased was born in Lauderdale county, Tenn., Nov. 13, 1833. He came to Victoria about 1852 and has lived here ever since with the exception of three years, when he lived in Lavaca county. He was bitter-ly opposed to the civil war and was an outspoken union man. One of the deceased's brothers, Alfred E. Thurmond, participated in the Texas revolution, and was taken prisoner by the Mexicans and for some time acted as interpreter for them.

The increase in pay will range from three to four cents an hour for the switchmen and \$10.00 a month for the assistant yardmasters.

The new scale agreed upon is as follows: Day foremen 31 cents per hour. Night foremen 33 cents per hour. Day helpers 28 cents per hour. Assistant yardmasters 120 per month.

AN OLD TIME TEXAS CHARACTER IS DEAD. VICTORIA, Texas, Feb. 4.—C. L. Thurmond, Sr., familiarly known as "Old Zip," a noted character of this county, died here yesterday of liver trouble. The deceased was born in Lauderdale county, Tenn., Nov. 13, 1833. He came to Victoria about 1852 and has lived here ever since with the exception of three years, when he lived in Lavaca county. He was bitter-ly opposed to the civil war and was an outspoken union man. One of the deceased's brothers, Alfred E. Thurmond, participated in the Texas revolution, and was taken prisoner by the Mexicans and for some time acted as interpreter for them.

AMENDMENT TURNED DOWN

CONSIDERATION OF HOGG IS TERMINATED THE COMMITTEE REPORTS

By a Vote of 9 to 1 Recommendation Made That It Do Not Pass in the House—Other Business that was Transacted

AMT. Feb. 4.—Consideration of the Hogg amendment was suddenly and unexpectedly terminated by the house committee on constitutional amendments Tuesday afternoon, when that committee by a vote of 9 to 1 ordered the measure to be reported with the recommendation that it do not pass.

After a long discussion stenographers' bill was recommitted. The house considered the bill by Mr. Robertson of Williamson providing that immaterial misrepresentation in the application for insurance policy on the part of the holder of a life insurance policy shall not invalidate the policy.

Several amendments, with a view of making the bill stronger, were adopted, and further action on the measure was postponed until Wednesday morning.

On motion of Mr. McKam in the senate the surplus newspapers of senators were ordered sent to Confederate home.

Senator Wilson secured suspension of the rules and final passage of his bill correcting errors of codifiers in many cases.

Senator Faubus secured suspension of the rules and final passage of his bill authorizing the Missouri, Kansas and Texas Railway company to purchase and operate the Granger, George town, Austin and San Antonio railroad.

Senator Harbison secured suspension of the rules and final passage of his bill permitting the Missouri, Kansas and Texas Railway company to purchase and operate the Denison and Washita Valley railroad.

Mr. Hodges introduced in the house a measure relating to permits granted to foreign corporations desiring to do business in Texas.



PASSED TWO. STOPPED FIGHT. HOBSON'S CASE.

Interstate Commerce and Army Appropriation Bills Go Through. Washington, Feb. 4.—The senate passed without objection or discussion the Elkins bill further to regulate railroad transportation. It is one of a number of measures presented in this congress concerning corporations and has particular reference to railroads. The text of the bill and the amendments made in committee have been published heretofore.

The army appropriation bill was passed for two hours and a half without concluding. The provision establishing a general staff was eliminated. Later the independent measure, identical in its provisions with the general staff section of the army bill, was passed after having been reconsidered to permit the incorporation of an amendment by Mr. Berry placing the chief of staff exclusively under the direction of the president. The bill now goes to conference.

Mr. Quay's continued his remarks in opposition to the statehood bill. He spoke for two hours and a half without concluding.

Mr. Quay inquired what had become of his two amendments to the sundry civil and agricultural appropriation bills embodying the statehood bill, which had been reported by his committee.

Mr. Beveridge characterized the action of Mr. Quay as an extraordinary proceeding.

Mr. Quay remarked that there was nothing unusual about it.

There was no answer to Mr. Quay's question, and at 4:26 o'clock the senate on motion of Mr. Cullom went into executive session and at 6:50 adjourned.

DEALT WITH CLAIMS. House of Representatives Spent Practically All of Tuesday on Them.

Washington, Feb. 4.—The house spent practically the entire day Tuesday on claims coming over from last week.

Mr. Payne, the floor leader of the majority, fought them all but succeeded in defeating only three bills. One of these was a measure to pay the widow of Samuel A. Muhlman, one of the victims of the Ford Theatre disaster \$5000. After the claims measure were disposed of the general debate on the postoffice appropriation bill was resumed and Mr. Robb of Missouri addressed the house on the trust question. At the conclusion of his remarks the house at 5:05 adjourned.

Referee Early's Action Surprising to the Spectators at Bout. Memphis, Feb. 4.—A special to the Commercial Appeal from Hot Springs, Ark., says: Cyclone Kelly of San Francisco, gave Champion Tommy Ryan a surprise when the two met Thursday night at the Whittington Park Athletic club, and but for Referee Pat Early's queer action in stopping the fight just as the gong sounded for the end of the seventh round, Kelly might have scored a knockout. He was on the floor when the gong sounded as the result of a hard right to the solar plexus, but was not in distress and indeed had been doing most of the fighting in the fifth, sixth and seventh rounds. The referee stopped the fight, declared Ryan the winner and gave as his excuse that Kelly was almost out and would be knocked senseless in another round. The decision was not favorably received. Kelly insisted on continuing and seemed as strong as his adversary, but the decision had been given and the fighters left the ring. Bert Kehler, who manages Kelly, was displeased with the decision.

CONTRAST OF NAVIES. Diagram That Has Been Submitted to the Emperor of Germany.

Berlin, Feb. 4.—The vice president of the Reichstag, Count von Stollberg-Wernsdorff, in calling that body to order, said the emperor had presented the house with a diagram in his own hand contrasting the British and German navies. The drawing, which probably will be hung in the lobby of the Reichstag as an object lesson to the members, shows that Great Britain has forty-two battleships and Germany 12; that Great Britain has fourteen armored cruisers and Germany two; that Great Britain has 102 protected cruisers and Germany seventeen; that Great Britain is building twelve battleships and Germany six; that Great Britain is building twenty armored cruisers and Germany three; and that Great Britain is building eight protected cruisers and Germany six.

The Navy Department Does Not Wish the Alabamian to Design. Washington, Feb. 4.—The navy department is unwilling to allow Constructor Hobson to retire from the navy ever upon resignation outright and the abandonment of the privilege of going upon the retired list. The reason for the unwillingness is the pressing need of the construction corps for the service of just such young officers as Mr. Hobson, and the effort will be made to induce him to remain on active duty. The construction corps has lost the services of four able officers during the past year, and with the rapidly increasing amount of constructing work the navy department feels it must stop the drain.

Government Troops Victorious. Caracas, Feb. 4.—The government troops under General Alcantara, a graduate of West Point, have defeated a force of rebels numbering 6000 on the revolutionary General Ducharme, on the Guanaguay river about fifty miles south of Caracas. The rebels were routed, their ammunition and 200 prisoners were captured. On the receipt of the news of the victory prices on the stock exchange jumped four points.

Warrior Appointed. Memphis, Feb. 4.—The appointment of C. J. Warwick as traveling freight agent of the Rock Island railroad, with headquarters at Oklahoma City is announced. Mr. Warwick has been city passenger and ticket agent of the Choctaw railroad at Memphis for four years. The appointment is effective at once.

A REPORT ON LESSLER MADE

TWO REPORTS SUBMITTED BY NAVAL COMMITTEE

EVIDENCE WAS SUSTAINED

A Majority Holds that the Charge Made by Congressman That An Attempt at Bribery Had Been Made is Correct

Washington, Feb. 4.—The house committee on naval affairs reported to the house its findings in the matter of its investigation into the Lessler bribery charges. Conclusions of majority of committee:

1. That the charge made by Mr. Lessler that an attempt had been made to corruptly influence his action respecting proposed legislation is sustained by the evidence, such an attempt in the opinion of the committee having been made by one, Philip Doblin on his own initiative and responsibility with the idea of making money for himself if he should find Mr. Lessler corruptly approachable.

2. That there is no evidence to sustain the charge of an attempt by Lemuel L. Quigg to corruptly influence a member of the committee.

3. That there is no evidence to sustain the charge of an attempt by the Holland Submarine Boat company or any of its agents to corruptly influence a member of the committee on naval affairs representing proposed legislation before said committee and the house.

In view of the foregoing we recommend that the clerk of the committee be directed to certify to the attorney general of the United States a copy of testimony taken at the hearing with a request that he take such action as the law and the facts warrant.

The minority report then states the circumstances of the resulting investigation and submits the conclusions of the minority, the first of which is as follows:

That the charge that an attempt was made to corruptly influence a member of the committee on naval affairs respecting proposed legislation pending before the house is not sustained.

The minority differs with the majority only in its first conclusion.

BILL OF SLAYDEN.

It Provides for an Investigation of the Bubonic Plague.

Washington, Feb. 4.—A bill was introduced in house by Representative Slayden of Texas providing as follows:

"That to prevent the spread of the bubonic plague now prevalent on the Pacific coast of Mexico, the president is authorized and directed to send a commission of three medical officers of the army and navy to investigate and report the conditions as to the disease there prevalent.

The bill carries an appropriation of \$50,000 to aid the Mexican authorities in their efforts to stamp out the plague and to prevent its spread to the United States.

Conferred With Bowen. Washington, Feb. 4.—Baron Sternberg was an early caller Tuesday at Mr. Bowen's office, and an hour later he was joined in Mr. Bowen's room by the British ambassador. They spent half an hour in joint conference with General's representative, the British ambassador leaving first. It is certain that attempts to reach a compromise here by to means been abandoned and that this conference was devoted to that object.

Talk of Compromise. Washington, Feb. 4.—There is now much talk of Oklahoma and New Mexico being admitted as states and that Arizona be united with New Mexico until she has 200,000 people; that Oklahoma be admitted as she now stands and at some definite time in the future the Indian Territory shall be added to Oklahoma.

Favorable Report. Washington, Feb. 4.—Senate committee on foreign relations will favorably report treaty with Colombia for building isthmian canal.

CABINET SESSION.

The Meeting Tuesday Lasted Two and One-Half Hours.

Washington, Feb. 4.—President Roosevelt and all the members of his cabinet were in session for an hour and a half Tuesday, at least two subjects of importance occupying their attention. It is known that the Venezuelan question was under consideration for some time, but at the conclusion of the meeting no member of the cabinet would discuss for publication this phase of the meeting. It can be said that this government while deeply interested in the pending negotiations has taken no part in the controversy. Both the president and his cabinet are entirely hopeful of an early adjustment of the difficulty, although it is realized fully that serious obstacles remain yet to be overcome.

The cabinet discussed the award of bids recently received for the armored cruisers Tennessee and Washington. A decision was reached, and at the conclusion of the meeting Secretary Moody made public the following statement:

The navy department has decided upon the award of contracts for the two 14,500 ton armored cruisers Tennessee and Washington. The bid by William Cramp & Sons of Philadelphia for two vessels at \$4,025,000 has been accepted for one vessel with the stipulation offered that the plans of the government shall be followed.

Has Been Misinterpreted. London, Feb. 4.—Routier's Telegram company says it is officially informed that the attitude of the allies regarding the so-called propriety claims against Venezuela has been misinterpreted thus causing complications. It is said the allies do not insist upon the precedence of their claims over others, but insist that they shall be regarded as separate to be dealt with directly by each themselves and Venezuela. Until specific arrangement is made for the satisfaction of their claims they are determined to continue the blockade.

Money All Raised. Atlanta, Ga., Feb. 4.—A Jackson, Miss., special to the Journal says: At a meeting of the Beavry committee of the Sons of Confederate Veterans held in this city \$10,000, the amount required for the purchase of Beauvoir, the old home of Jefferson Davis, was subscribed. It is stated that the deed will be delivered by Mrs. Davis as soon as the amount can be paid over.

Postmasters Confirmed. Washington, Feb. 4.—Following postmasters were confirmed: Oklahoma, C. S. Walker, Bridgeport, P. C. Hughes, Burch; G. W. Sherwood, O'Keefe; J. S. Ashbury, Lexington; J. R. Tate, Blackwell.

Cyclone in Dallas County. Dallas, Feb. 4.—A cyclone struck the town of Seagrave, this county, Tuesday morning. The residence of J. W. McClung and the public school building were wrecked. Four persons were injured. Property loss is about \$2000.

Sherman Selected. Dallas, Feb. 4.—The next encampment of the Odd Fellows will be held at Sherman. Considerable routine business was done.

One of the Worst. Chicago, Feb. 4.—One of the worst storms of recent years raged in this city Tuesday, and has caused much damage to telephone and telegraph wires. The storm commenced with a heavy fall of rain, which changed to snow, and changed back to rain which froze as it fell. A gale of forty miles an hour blew.

AFFAIRS OF THE INDIANS WELL MANAGED

CRITICISM OF CONGRESSMAN BURTON CAME AS A SURPRISE

Washington, Feb. 4.—(Special.)—It was something of a surprise when Representative Burton of Ohio began criticizing the management of Indian affairs in the United States, especially as he represents a city district which never comes in contact with the red men, but it has been shown that men from the far east, whose interest in the Indians is little more than sentimental, have often been most active in matters pertaining to Indian legislation. The fact is that during late years the Indians have been better managed than ever before, and under the efforts made in the direction of breaking up the tribal relations in the allotment of lands to individual Indians and in educating the Indians to be of some use to themselves, have progressed as never before.

Lacking Proper Respect.

Eulogies over deceased members of the house now take place on Sunday, and every Sabbath day is occupied with these ceremonies. On the last occasion there were three men to whom tribute was to be paid, and there assembled in the hall of the house perhaps thirty members, with fewer than ten people in the galleries. It demonstrated the absurdity of setting apart time for delivering the eulogies. The house should take one step further and provide that on one day in the session there should be issued a special edition of the Record which would contain the eulogies of all who wanted to say something about the deceased member.

A Fearless Senator.

Senator Hale of Maine fears no one, nor does opposition of one kind or another disturb him in the least. No man is more successful than he in getting through appropriation bills. He steers them along with great ease and care, accepting amendments when they are pressed in a manner to indicate trouble if they are opposed, always with the reservation that they will be dropped out in conference. But outside of the fact that he is successful in this line he never hesitates to say what he thinks, and a senator, whether of his own party or of the opposition, never escapes criticism by Hale when the Maine senator thinks it is deserved. Quay is not the first man who has complained of being "hounded and lectured" by the Maine senator, but the complaint never ruffles Hale, who goes serenely on as if he were being complimented. Hale was one of the men who dared to oppose the clamor for a war with Spain and also oppose the acquisition of the Philippines as a result of that war.



## GOOD PRICES IN SPRING IS LIKELY

CONDITIONS JUSTIFY BELIEF THAT CATTLE WILL BE HIGHER WITH END OF COLD WEATHER

Denver Record Stockman: Of course, it is rather early yet to talk about spring prices in Texas, but the Texas man usually talks early and this year the conditions seem to justify the expectations of good prices. In the first place the supply is not nearly as large as it was last year. Then quite a number are preparing to ship their cattle to northern ranges in Montana and even up into the British possessions. This movement will take many more cattle than generally supposed. A new element will make its appearance this spring among the buyers of Texas cattle, and that is range men from Canada and the great northwest country north of Montana. It is reported that there will be some big buyers in the field, and while they are talking strongly of going on south into Mexico for supplies it is a fair guess that most of them will not pass the panhandle cattle without picking up a few bunches. Last year Colorado took fewer panhandle cattle than before in years. It is likely that during the coming season Colorado will be a good buyer and the Dakotas will take less than they have been buying. But it all depends upon the weather, and while the owners like to talk over the bright side of the situation they cannot help shivering as they think of the many weeks left yet before grass comes.

### WARM WORDS FROM THE STOCKMAN


West Texas Stockman: Size up the crowd that is howling for the abrogation of the state quarantine line and you will find the same old bunch that has long clamored for the abolition of the lease law and the summary cancellation of all existing leases. The prime object to be attained is the undoing of the cattle industry in west Texas, the opening up of the range country to the speculators—the more favored country to be acquired from the spoils wrung from the west in the crucifixion of her one permanently prosperous industry. That is the real issue in the bitter fight that is being precipitated before the state legislature, and the result will be that the right will prevail. ## UNCLE SAM REPORTS ON TEXAS CROPS

WASHINGTON, Feb. 4.—Frequent showers occurred throughout the state of Texas during the month of January and kept the soil saturated with moisture to such an extent as to limit the breaking of land for planting and seeding to favored sections, until near the close of the month, when mild temperature and abundant sunshine dried the ground and permitted rapid progress to be made in this line. While this work continues greatly in arrears in nearly all parts of the state, on account of the excessive moisture, correspondents are unanimous of the opinion that the condition of the soil as regards the water supply betokens an exceptionally fine crop year. No temperature injurious to growing crops prevailed in any section of the state during the month, though frosts and falls in temperature to slightly below the freezing point were frequent in the northern and central parts of the state. The winter so far has passed without a freeze in the coast district, and in that section the extensive truck industry is in a thriving state, and at this date large shipments of vegetables, such as cabbage, cauliflower, lettuce, onions, etc., are daily made. Strawberry beds continue to give promise of a fine yield, and shipments of berries on a minor scale have been made throughout the month.





## SANTA FE TRYING TO ENTER NEW ORLEANS

Fort Worth May Have Another Direct Line to the Crescent City—Officials There Last Week, Inspecting Harbor Facilities and Interviewing Real Estate Men

Fort Worth will have another direct line to New Orleans if the Santa Fe succeeds in gaining an entrance to New Orleans. That officials of the system are making an effort in that direction developed last week, while a number of them were in the Crescent city ostensibly on a pleasure trip.

In the party were Paul Morton, vice president of the Santa Fe; E. A. Potter, T. P. Shontz and Joy Morton, heavy stockholders in the company. They gave it out while there that they were taking a little vacation, but at the same time it was intimated that they had some deal in hand. Sunday it transpired that this deal was the securing of an entrance into the city and terminal facilities there. While the Santa Fe men were in New Orleans they held several conferences with real estate men and made a thorough inspection of the river front and the harbor facilities. It is said that a party of engineers has already been ordered there to go over the ground and make recommendations.

At present the Texas and Pacific is the only direct line from Fort Worth to New Orleans. The Frisco, however, is seeking entrance into the latter city and so is the Shreveport and Red River Valley road. The Santa Fe at present gets no nearer New Orleans than Beaumont, and it is probable that the extension of the line to the Crescent city would be either from that point or from Sibley, a few miles north of Beaumont. Such an extension would make the Santa Fe a direct line from Fort Worth to New Orleans, and would place the road in a position to compete for the export business of the packing-houses and other concerns of Fort Worth through that port.

## ONLY TWO TRAINS LATE IN THREE WHOLE DAYS

Marked improvement in the operation of trains has been shown during the present week on all roads entering Fort Worth. For the first time in many weeks trains have arrived and departed on schedule time. In the past three days only two trains have been far enough off their schedule to be posted late.

The Rock Island train No. 11 was thirty minutes late yesterday morning, and Cotton Belt No. 5 was four hours late this morning.

Monday there was not a late train on any line into Fort Worth, and the two mentioned were the only serious cases yesterday and today.

## KATY WILL HAVE SHORT LINE TO SAN ANTONIO

The Texas legislature has finally passed the bill authorizing the Missouri, Kansas and Texas railroad to acquire the Granger, Georgetown, Austin and San Antonio road, and thus form a short line from North Texas to San Antonio.

It is authorized to buy the Katy to buy the Denison and Washita Valley road, a short line out of Denison, was also passed. This line is already controlled by the stockholders of the Katy, but they will now consolidate it with the larger system.

## RAILROAD NOTES AND PERSONALS

A. T. Canfield, assistant engineer for the Kansas City, Mexico and Orient road, with headquarters in Kansas City, was in the city this morning, visiting old friends.

Mr. Canfield is a son of the late A. T. Canfield, who was for years connected with the auditing department of the Texas and Pacific in Fort Worth and Dallas.

J. A. Kinney, who has been operator for the Texas and Pacific in East Dallas for about fifteen years, has been promoted to ticket agent at the same place, succeeding S. J. Tackett, who has gone to the Rock Island.

The Denver and Rio Grande has voluntarily increased the wages of its machinists, blacksmiths, boiler-makers, tin workers, car repairers, inspectors and helpers 2 1/2 to 5 per cent. The demands of the engineers, firemen, conductors and trainmen for a 20 per cent increase is still ungratified, and the grievance committee of the engineers and firemen is still in session in Denver.
