BUSINESS CORRESPONDENCE

The correspondent of an eastern financial journal writing from the Philippines calls attention to the length of time required in getting an answer to a letter sent from a New York business firm to one in Manila.

It would seem that our new relations with the Philippines have offered a timely warning against a tendency that has taken possession of the business world today—that of writing rapid, concise letters, with occasional obscurity in meaning, merely because of carelessness or lack of time.

Far enough back for the older merchants of today to remember as a boyhood experience, letters were laboriously copied by clerks who wrote legible, neat script. By the time a letter on some business matter had been duly copied and answered, sufficient time had elapsed to give the modern business man gray hairs because of the delay.

Two factors have contributed to the modern style of rapid letter writing, one of which, the typewriter, has made a great improvement in legibility. The use of stenographic notes is not, as many suppose, one of the modern aids to rapid correspondence, being a comparatively old device and dating back many centuries.

The other factor which has contributed to the present rapid correspondence is the increased speed of mail trains and the quickness with which a reply can be obtained. Less than a week is required for an answer to a letter written by a Fort Worth merchant to one in New York and for correspondingly nearer places, the time is much less.

The facility with which a business man can dictate replies to his correspondents and the certainty of knowledge possessed that he will receive a reply within a short time, has resulted in carelessness of style that is deplorable as it is wasteful.

The familiar and unseemly vulgar form of starting a business letter: "Dear Sir:—Replying to your favor of recent date, beg to state, etc." is so common that its crudity never occurs to us and the utter meaningless words of the phrase seldom strike the busy man who rattles them off to a stenographer so accustomed to their use that they are recorded at lightning speed.

The real business of letter writing; to either give positive information or clearly that it cannot be misunderstood, or to ask intelligent questions in a manner that will at once become plain to the reader is oftentimes in the haste for speed, entirely forgotten.

And yet it is little wonder that such letters are daily written when one considers the pressure under which the average business man of today works and the circumstances under which he is compelled to dictate his replies or queries.

A common plan is to allow a stack of letters to accumulate on a desk until a convenient breathing spell from the ordinary business rush, and then dictate the whole set of answers in rapid succession as quickly as possible.

There are even business men so pushed that they have systematized their correspondence to the point where they can dictate letters to a stenographer while they themselves are busy at some entirely different work. Such cleverness is one of the achievements of the twentieth century but it is not a commendable one.

We read of the head of a great corporation dictating his correspondence while eating luncheon, of another doing the same work while riding and of a third with a stenographer by his side, admirable examples of speed but by no means enviable ones.

The time of the thoughtful, courteous, and intelligent business letter seems for the present to have been replaced by the rush and hurry of the day. Men of little education or skill in the use of clear and explicit English have risen by virtue of indomitable energy to positions of trust and honor and the result has been that while gifted with executive ability and the power of management, they are not fitted for some of the duties of their position that should have been preceded by years of careful study.

It is easy to explain a misunderstood letter by a telegram or a telephone message, but the habit of writing such letters betokens a weakness of letter-day methods and a tendency that is discreditable among the splendid achievements of modern business methods.

The man whose letters are models of careful composition and thought is the man whose correspondence will most powerfully convince those to whom it is directed and the care exercised will be worth more than the time expended in the returns of confidence and trust that will result.

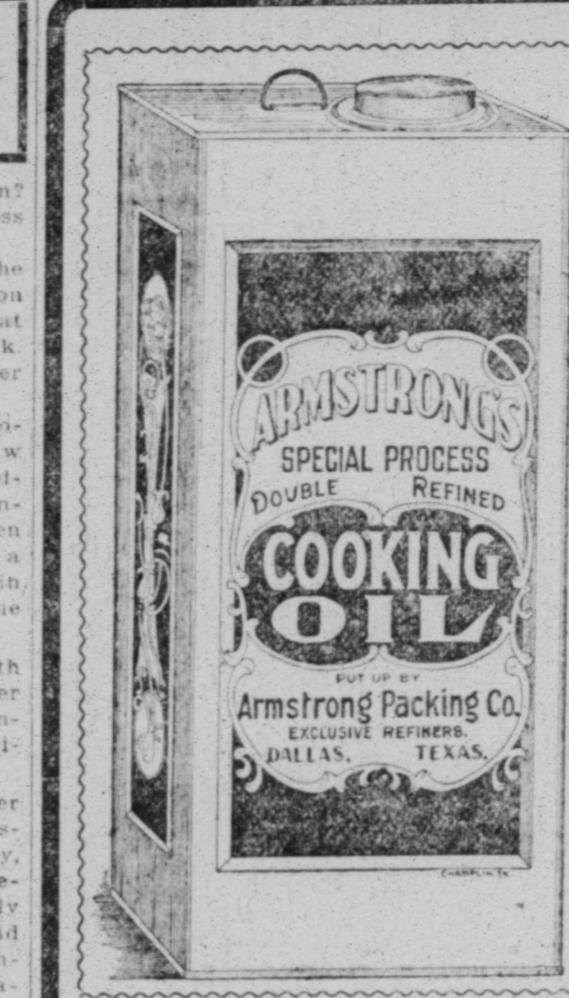
