'Funding bill is wrecking us'

Schools challenge Bivins' figures



School officials are challenging State Sen. Teel Bivins' claim that local districts will come out better financially under the new school funding bill.

The legislature's new funding scheme for public education will actually cost local districts whopping amounts, they say.

That's because the legislature, in the same funding bill, mandated big salary increases for teachers over the next two years but didn't appropriate the money to pay for them. That puts the Burden of the pay raises onto local school districts and will force a substantial increase in school taxes, school officials say.

"The Texas Education Agency now says the Dimmitt Independent School District will receive \$117,-000 more in state funds in 1989-90 (instead of \$124,000, as reported in last week's News)," Supt. Robert Ryan said. "Now, the kicker is that the finance bill has a salary increase of \$1,800 per year built into the bill. For us to implement the salary increase, it will cost an estimated \$307,500.

"Then when we look at the second year of the biennium (1990-91), the state pay scale will increase again by \$1,140 per year," Ryan said. "That's going to cost the DISD another \$150,000, and we'll be getting only \$6,900 of new money that year. "So the bottom line is that, based upon the best figures that TEA can provide us with now, the salary increases alone over the biennium are going to be \$457,000 and the new money over the biennium will be \$242,000, which means that it's costing us \$215,000!" Reporting from a summer TEA workshop for school administrators in Austin this week, DISD Business Manager Gene King said, "70% to 80% of the people we're talking to here are facing a massive tax increase, forced by the legislature. They're really wrecking us." In reporting on the regular session of the legislature, Sen. Bivins told the News that he was one of only three in the Texas Senate who

voted against the school funding bill because he thought it would hurt schools in his area. But he said Dimmitt's, Hart's and Nazareth's school districts would come out well since they'll be receiving substantially more money under the new funding scheme than they did previously.

Bivins noted that the legislature had allocated \$450 million more for public education, and added that he was pleased that the legislature "lived within its means" and didn't allocate any more funds than the state would be receiving under the current tax rate.

But local school officials said Bivins didn't tell the News the whole story.

"They (legislators) are saying how great the session was, how they put \$450 million into school finance," King said. "But what they didn't say was that they forced the state's public schools to spend \$900 million more. The legislature may have lived within its means, but it forced the school districts to live beyond their means."

"People are going to wonder why we're raising taxes when Sen. Bivins has said we're going to get all this extra money," Ryan said. "Sen. Bivins goes off wearing a white hat and gets re-elected. We're left with the black hats and our school board members have to run for the county line instead of for re-election."

Dimmitt School Board President David Schaeffer said that when the board takes up the 1989-90 budget in its meeting tonight (Thursday), it will be forced to look at major cuts in non-salary expenditures and a substantial increase in the tax rate to pay for the teacher pay raises.

"I don't think anybody has any quarrel with paying our teachers decent salaries," Schaeffer said. "Texas ranks 31st in teacher salaries. "But for the legislature to mandate these salary increases and then put the burden on the local school districts to come up with the money, that isn't fair."

Although the county would need to hire or designate a person to apply herbicide on county rightsof-way, Harmon said, "It's best for the district to put the burden of herbicide application on the farmer rather than hire someone to do the applications on private property."

Herbicide labels are a major frustration in the program, Harmon added. One herbicide may be the same chemical formula as another and may cost only half as much, but may be labeled only for industrial, rather than agricultural or general, application. And another herbicide will be labeled as safe around one crop but not around another.

in hit-and-run death

A Hereford man has been charged in the hit-and-run death early Sunday morning of George R. Sifuentez, 83, in Dimmitt.

Mr. Sifuentez was hit by a car as he was walking across East Bedford Street north-to-south at 1:30 a.m. Sunday, city police said. The fatal accident occurred near the Dimmitt Agri Industries offices.

Police have charged Clayton Noland, 19, of Hereford, with failure to stop and render aid (felony) in connection with the accident.

Two witnesses who saw the accident went to the Sheriff's Office at the courthouse, where they reported to a city policeman that a man had been hit by a car and that the vehicle had left the scene. They gave a license plate number and a general description of the suspect car.

The witnesses told police that the car was going west when it hit Mr. Sifuentez, that it traveled a short distance down the street after the impact, then pulled to the side of the street, then left the scene, still going west. Two persons were in the car, they said, and neither got out to check on the victim.

Police said the second person in the car was Noland's wife, Carla, who reportedly was asleep when the accident occurred.

After tracing the car's registration number to Noland, local officers issued an all-points bulletin through the state's interagency law enforcement communications network.

Meanwhile, city and state officers called out Justice of the Peace Marshall Young, who pronounced Mr. Sifuentez dead at the scene. Officers said his body was on the stripe that divides the inside westbound lane and the left-turn lane, near the center of the street, lying 114 ft. west of where they found his baseball cap, and that his cigarette lighter, pack of cigarettes and left shoe were scattered along the street between his cap and body.

With the cooperation of the Hereford and Friona police departments, Noland was traced to his mother's home in Friona, Police Chief Gary Thurman said. Friona police arrested him there Sunday and he was transported to Dimmitt, where he was formally charged and arraigned. He is now free on \$4,000 bond pending Grand Jury action in the case.

Funeral services for Mr. Sifuentez are scheduled for today (Thursday) at 11 a.m. at the Immaculate Conception Catholic Church.





Aural was also taken to a play, "Orpheus and the Underworld," a spoof on opera, a very entertaining





You'll probably be as surprised as we were to learn how wellstaffed our entire county is for medical emergencies.

There are more than 40 persons in our county who are trained as Emergency Medical Technicians (EMT), paramedics (EMT/P), Emergency Medical Technicians with Special Skill (EMT/SS), and Emergency Care Attendants (ECA). Plains Memorial Hospital and all three volunteer fire departments have certified personnel who respond day or night to medical emergencies anywhere in the county, using three ambulances and three specially-equipped fire department emergency vehicles.

When there's a highway accident, fire, industrial accident or medical emergency of any kind, these highly trained, dedicated people prolong and save lives.

All of them have taken special training to earn the initials after their names. They take up to 250 hours of classroom training and up to 100 hours of clinical training to earn their certifications.

At Plains Memorial Hospital, Ricky Hunter is the only fulltime paramedic, and coordinates the hospital's emergency medical teams. Other specialists who serve as drivers and attendants when needed are James Killough, EMT/SS; Ricky Hargrove, EMT/SS; Lonnie Strickland, EMT; Lee Schilling, EMT; Done Moke, ECA; and Anthony Mays, ECA.

Many of the hospital's nurses also are certified as EMTs and ECAs, and travel with the ambulances to emergency scenes and on patient transfers. The recently passed Texas Agricultural Hazard Communication Act (Right-to-Know), requres that employers in compliance with the law must offer ag chemical safety programs for their employees.

The Texas Agricultural Extension Service conducts these training programs and makes an Extension Agent available for the training sessions.

Agricultural employers who store or use 55 gallons or 500 pounds of one active chemical and have a seasonal/migrant payroll of \$15,000 or permanent annual payr-


oll of \$50,000, are covered by the law. This would require employers to provide a training session for their employees.

The training program includes discussion of crop sheets, material safety data sheets and prduct labels. Information is provided on chemical hazards, potential exposure to chemicals and ways that individuals can protect themselves through good work practices and use of protective clothing and equipment. In addition, the program may be presented in either English or Spanish, with bilingual

assistance from the Extension Agent-Pesticide Safety.

If one is not covered by the law and would like to conduct an ag chemical safety program for their employees, community members, school, organization or any requesting individual, the Texas Agricultural Extension Service is also available to conduct these programs.

Precinct 1 Commissioner Harold Smith was absent from Monday's meeting.




