TWO MORE RUSSIAN SHIPS ARE SUNK BY THE JAPANESE

CZAR'S SHIPS GUARDING HARBOR OF CHEMULPO GO DOWN IN ENGAGEMENT WITH TORPEDO FLEET

RUSSIAN FLEET BOTTLED

Situation Much Like That of Cervera At Santiago, Says Baron Hayashi

VICTORY IS CLAIMED

Unconfirmed Dispatches Received in St. Petersburg Say Chemulpo Has Been Occupied

NAVAL BATTLE AT PORT ARTHUR NEXT

(By Associated Press). LONDON, Feb. 10.—"We were slow in negotiating, so we are making up for lost time by quickness in action," said Baron Hayashi this morning. "The engagements at Port Arthur and Chemulpo were merely in accordance with plans long matured. As soon as our forces land in Korea I look for an important fleet action at Port Arthur. The Russian vessels are not likely to give up the advantage they gained by being under the cover of their land batteries by going to the Chinese side.

However, the Japanese fleet by a high angle fire can drop in shells which should make it very uncomfortable for the Russian ships lying moored close to one another. It is thereby hoped to drive out Viceroy Alexieff's forces. Possibly like Admiral Cervera, he may anticipate his fate and come into the open of his own accord. The present events go to show the utter uselessness of Port Arthur from a strategic viewpoint."

NEWS IS CONFIRMED LONDON, Feb. 10.—Baron Hayashi, the Japanese minister, has received here today official confirmation of the destruction at Chemulpo of the Russian first class cruiser Varlag and the third class cruiser Korietz.

THE SUNKEN CRUISERS LONDON, Feb. 10.—The cruiser Varlag which was built at the Cramp ship yard, Philadelphia, in 1893, was steel and un-sheathed. She had 6,500 tons displacement and indicated a horse power of twenty knots. On her speed trial she made twenty-four knots per hour for eight hours. She was 490 feet long, fifty-two feet in beam and had a depth of twenty feet. The Varlag armament consisted of twelve 6-inch quick-fire guns, twelve 12-pounders (quick-firers), eight 3-pounder quick-firers, two 1-pounders and six torpedo tubes, two of which were submerged. The Korietz was built in Stockholm. She was steel and was 266 feet in length, thirty-five feet in beam, had 1,413 tons displacement and 1,500 indicated horse power. Her speed was thirteen knots.

TODAY'S VICTORY The destruction of the two Russian cruisers guarding Chemulpo gives Japan control of that harbor which is the key to Seoul, capital of Korea, only fifty miles inland. The Russian fleets are at Port Arthur (294 miles from Chemulpo) and Vladivostok (1,000 miles from Chemulpo). A Japanese fleet is conventionally near Port Arthur which is situated on a small peninsula. Back of Port Arthur is the Gulf of Lalo-Tung and in this gulf are many of the Russian ships, making a situation which Baron Hayashi, Russian minister to England, compares to that at Santiago, Chemulpo, which Japan now controls, is the only Korean harbor on the western side of the Korean peninsula. The next logical step as pointed out by Baron Hayashi is a naval engagement at Port Arthur.

RUSSIAN VICTORY REPORTED VLADIVOSTOCK, Feb. 10.—A private telegram received here reports the complete rout of the Japanese by the Russians on the Yalu river. These advices also claim that Chemulpo, Korea, has been occupied by Russian soldiers and marines.

CZAR'S DECLARATION OF WAR WASHINGTON, Feb. 10.—Count Cassini, the Russian ambassador, called on Secretary Hay at noon and left with him the announcement of the czar declaring war on Japan.

BATTLE AT PORT ARTHUR ST. PETERSBURG, Feb. 10, 5:30 p. m.—Some newspapers here print extras claiming a Russian victory at Port Arthur. Three Japanese warships and four torpedo boats are reported to have been seriously crippled. One report says the Japanese battleship Shikishima was sunk. The people are demonstrating but there is no official confirmation of the report and announcement is discredited.

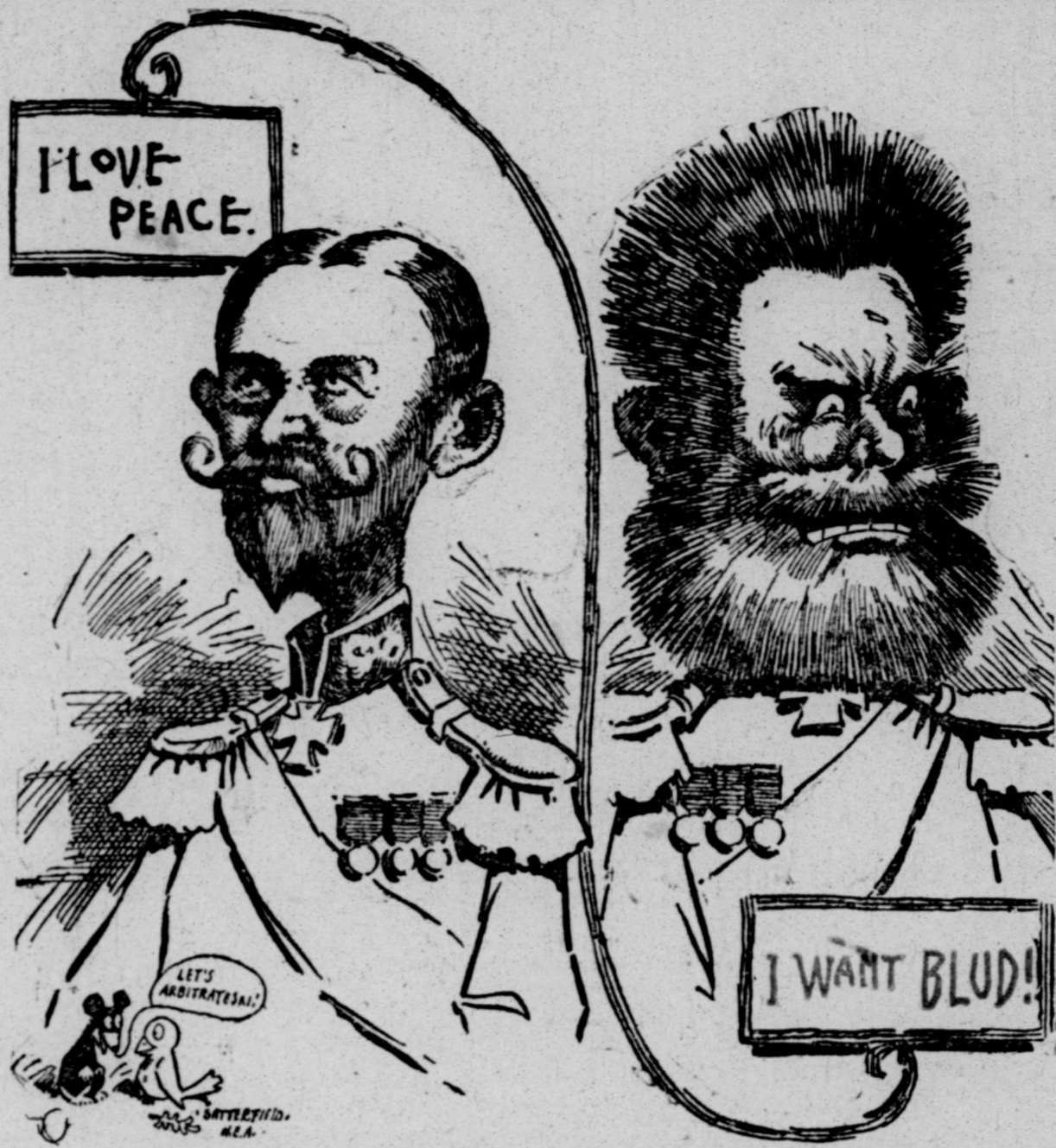

ADMIRAL WISE IS FURNISHED INSTRUCTIONS

WASHINGTON, Feb. 10.—Specific instructions have been cabled Rear Admiral Wise, commanding the training squadron in Dominican waters regarding the protection of American shipping interests there. The firing on the Clyde line steamer as reported in the cable dispatches yesterday this morning has aroused indignation in official circles here and it is said the navy department's probable course of action after such an outrage will be the seizure of a government gunboat by Rear Admiral Wise. BALTIMORE TO ASK ASSISTANCE FOR POLICEMEN

Work of Guarding the Burned District Proving Too Great a Task for Local Authorities

A DROP IN MERCURY CAUSES DISCOMFORT

Two Additional Alarms of Fire Turned In During the Night

(By Associated Press). BALTIMORE, Feb. 10.—At a meeting of the joint committee of the legislature called to confer with the mayor and board of public works, and leading citizens it was unanimously agreed to report a bill today asking the government to send soldiers to Baltimore to police the fire district. The committee also reported favoring an immediate relief appropriation by the legislature. Mayor McLean announced he would appoint an emergency committee of representative citizens to act as an advisory board to the municipal authorities. Financial institutions are today busily engaged in carting their securities and funds to temporary offices outside the confines of the burned districts. The vault of the First National bank was opened today and it was found all the securities and monies of the bank were safe.

TWO NEW ALARMS Night was marked by two new alarms of fire, the fall of a number of walls and conditions of extreme discomfort for the soldiers and policemen on guard, the temperature dropping about 10 degrees and a keen wind blowing throughout the night. The weather conditions it is thought were responsible for the falling walls, the racking of the roof of the burned district and mortar aiding the wind in bringing down several rains. Firemen were called out early during the night by an alarm of fire in the lumber yard of William D. Gill & Son, in the southwestern district. The fire was extinguished after it done small damage. Later an unimportant blaze in the northern residence district again called out some over-worked firemen.

Owing to the need of police to protect the outlying residential sections it is necessary for the officers to put in ten and twelve hours of continuous duty and almost without shelter and the men were thoroughly benumbed when relieved at daylight. Even the soldiers on guard but for two hours at a stretch found this tour in the wind long enough and considered themselves permitted them to shelter themselves in convenient doorways and build small picket fires wherever possible. Three companies of troops were kept on continuous patrol duty in the ruins throughout the night. A conflict with the military was reported last night when one of the mail carriers who was endeavoring to enter the postoffice was halted by a private. In the encounter the carrier was hit over the head with a soldier's rifle but not seriously injured.

TERRITORY REPUBLICANS

Only Man Ever Convicted Under Fugitive Slave Act.



JUDGE RUSH R. SLOANE.

SANDUSKY, Ohio, Feb. 10.—The first man ever prosecuted under the fugitive slave act of 1850 and the only one ever convicted and forced to pay penal damages for its violation is Judge Rush R. Sloane, of this city, who recently went to Europe with his family. Despite his 75 years, Judge Sloane is as strong and active physically and mentally as the majority of men at 50. He manages his large real estate interests in Sandusky, Toledo, Chicago and Boston, looks after numerous investments and finds time to contribute some of the most valuable documents on the history of Ohio which have been printed in recent years. His career has been one of remarkable activity, and can be said to have fairly started with his arrest under the fugitive slave law, which occurred in 1852.

Judge Sloane was then a young attorney and had been called upon to defend some runaway slaves who had been overtaken in Sandusky. By a clever ruse he distracted attention of the pursuers from the blacks, who were in the court room, for a sufficient time for the latter to get away unobserved. They succeeded in getting into a boat and escaping to Canada. Judge Sloane was sued for damages and a judgment of something like \$5,000 was rendered against him. He was unable to pay at the time, but afterwards paid every cent of the judgment with interest. The incident attracted national attention to the young man and was the means of starting him on the way to the large fortune he now possesses.

In 1856 Judge Sloane was a delegate to the republican convention at Pittsburg, which nominated John C. Fremont for president and permanently organized the party. By reason of his seat in that convention Judge Sloane was one of the guests at the Philadelphia convention of 1896, being one of the few survivors of the first convention.

In 1861 President Lincoln appointed Judge Sloane general agent of the post-office department, in which position he served for several years. Later he reorganized the old Mad River railroad, which his father had been instrumental in building, and was for some years its president. The road is now the Sandusky branch of the Big Four system. He also

built that part of the Big Four which connects Columbus and Springfield. He was associated with Thomas A. Scott and others in building the Texas and Pacific line, now a part of the Southern railroad system.

It was Judge Sloane who first suggested the name of Hon. John Sherman for United States senator from Ohio, and it was largely due to his efforts that Sherman secured his first election to that position.

In later years Judge Sloane has taken much interest in historical research, and he has contributed a number of valuable articles on Ohio history to the newspapers. He is one of the trustees of the Ohio Historical and Archeological Society. He has served Erie county as prosecuting attorney and probate judge, and the city of Sandusky two terms as mayor.

TO ASK FORGIVENESS BEFORE DEATH COMES

In the Texas and Pacific passenger station last evening was a woman about 18 years of age, whose appearance excited the sympathy of all who saw her. She was in the last stages of consumption. The woman came from El Paso and was on her way to New York state, to try and reach her former home and her parents.

The woman told a sad story, of woman's love and man's infidelity. Her narrative was, indeed, a most pitiable one, but nevertheless has a moral to it that all young women could not help but heed. She talked with difficulty, as her voice was very weak.

Two years ago she was a country girl in the Mohawk valley of New York state. Her parents were good, religious country folk. She lived with them in a little town. One day there came a smooth-looking, long-haired chap, who organized a home talent entertainment. He paid more attention to all of the village lassies than he did to the proposed entertainment and, especially, was he attentive to Mary, the girl of the town, now the woman who was at the station last night. Her parents objected to these attentions, and remonstrated with her, but the smooth-tongued villain and his promises of stage life to the girl and the bright and happy future they would have, won the girl from her parents and caused her to elope with the actor. They went to New York city and she wrote back to the "old folks at home," asking forgiveness for what she had done. No answer came from the parents, stern old people who believe in children's obedience. She was married to the man in that city. They went from town to town. Sometimes the two would give entertainments. The man soon nearly forgot her, but she clung to him until last year, when they reached El Paso. Here he deserted her and left her far from home, without money or friends. She knew nothing of the world, having always lived in a little village back in New York state. The woman was never strong, according to her own words, but when deserted she bravely attempted to make a living. She got together money enough to get a wash tub and equipment for doing washing. Her frail physique and desolation were too much to bear with the hard work, and the pining for home and her parents. Consumption soon fastened upon her and the people of El Paso helped her, as much as they could. The doctors told her she had but a short time to live. If she must die her only wish was to reach her home and to be granted the forgiveness of the parents.

El Paso people made up a purse for her and started her north. People here who learned of her condition helped her on her trip. The poor woman was the picture of despair. Her cheeks would flush and her eyes brighten as she told her story, when she spoke of her parents.

The woman claims that she had written them, but no answer to her letters ever came. She now is trying to reach home and to ask for forgiveness before she dies.

POSTOFFICE AT MANSFIELD BURGLARIZED

Robbers Try to Dynamite Grocery Store Safe—Secure Steal Team and Drive to \$800 Worth of Stamps—Fort Worth

The postoffice building at Mansfield was raided during last night by thieves who attempted to blow a safe in the front of the building which was a brick, owned by Marrs & Connard and used as a grocery store and post-office.

The front part of the building is used for the grocery department of Marrs & Connard, while the postoffice was located in the back end of the building. The thieves placed dynamite on top of the safe belonging to the grocery firm, but the explosive failed to respond. Had the robbers succeeded in getting into the safe they would have secured quite a sum of money.

The robbers then went through the postoffice and secured stamps of various denominations, to the value of \$800. No money, it is understood, was taken. The robbery was reported to the sheriff's office early this morning and the force of deputies are scouring the city today for the robbers. It is thought the robbery occurred

The thieves selected the fast one, passed the slow one by and went to the back of the stable and took a fast black horse, making a speedy team.

Night Watchman Amos Morrison says he believes the robbery was committed after 4:30 this morning, when he made his last round and noted nothing unusual at the postoffice.

Bloodhounds from the county convict camp were brought here this morning, but they failed to find a scent.

WASHINGTON, Feb. 10.—Public services of congressmen that do not seem to be given due recognition are rendered by the statesmen in the capacity of guides for visiting constituents. It is a line of duty not written into the law, but it is important, all the same. You can tell that by the extent to which the statesmen figure in the guide business. They are to be seen all over Washington, each with a couple or a group of constituents in tow.

Any day you can see a devoted statesman standing in front of the great historical paintings in the capitol, pointing out their beauties to folks from the "deestric." He introduces them to the wonders of echo hall, where the statues from the states are located, the main rotunda, the expensive bronze doors, and George Washington in a baseball attitude.

This statue of Washington is on the plaza and shows him with his right hand upraised as though calling on an umpire for judgment on a thrown ball. G. W. faces the main entrance of the capitol, where stands Christopher Columbus be-

ing a fair-sized globe in one hand stretched over his head. It is for all the world as though Washington had thrown the ball and Columbus had made a grand stand play by catching it with one hand. By way of an audience is a scantily-clad Indian lady standing beside Columbus and apparently adoring him for his great play. From baseball to the supreme court is a big jump, but the congressional guide and his charges make it gracefully. Then comes a trip to the senate. After that the national museum, Smithsonian Institution, the Washington monument and the department buildings receive attention. It makes a busy day and a wearing one for the congressman, but it is delightful for the visitors.

Market Quotations

NORTH FORT WORTH, Feb. 10.—With a small run of cattle yarded and extremely common quality offered, the market opened slow and dull and by noon showed a decline of fully 10c. The total supply fell short of 1,000 head, but this condition had the desired effect and salesmen were compelled to throw their offerings on the market and accept packers' prices.

One car of medium fed steers represented the entire supply of this class of cattle, and with the indifferent feeling among the buyers, salesmen held on to late trading.

Cows suffered equally with steers, and the day's trading passed over the scales on a slow, dull and irregular market, at a decline of about 10c. One small bunch of good 597-pound fed cows sold at \$1.45 with best car lots of cows, averaging 551 pounds, at \$2.25. Medium butcher stock sold around \$2.25, with the ordinary thin cows and steers at \$1.60 to \$1.75.

Calves sold in small lots at about steady prices, the best bringing \$5, with the medium to good kinds at \$3.50 to \$4.50. Bulls did not show up well and were bought in at steady values.

With the demand in supply, there were enough hogs on the market today to supply the local demand at a proportionate advance with all outside markets. At the opening, 1,050 hogs were yarded, and, armed with advices of higher markets elsewhere, salesmen at the start demanded a 5c advance over Tuesday and on this basis the supply passed over the scales on the morning market. Choice 239-pound Oklahoma hogs topped the market at \$5.15, with the bulk of good weight packer hogs selling at \$4.75 to \$5.00, the common to fair quality light hogs at \$4.15 to \$4.75.

Local salesmen say that the prospects for a 6c advance was never better, and they are predicting the best heavy hogs at \$5.50 within two weeks, with a proportionate advance in all other grades of hogs.

Choice sorted hogs are quoted at \$5.05 to \$5.15, good quality medium weight packers at \$4.50 to \$4.75, and pigs and lights at \$4.45 to \$4.75.

Unless the weather for the next three weeks is severe, commission men look for a revival of the stocker and feeder market, and under favorable conditions the movement of this class of hogs to market will be heavy.

A CITY EMPLOYMENT BUREAU The Telegram recently discussed a state employment bureau, and later a correspondent had a communication in the paper suggesting that a city employment agency be established.

In the current number of "The World Today" a correspondent tells something of the work of Mayor Maybury of Detroit in ridding his city of the idle class of people, the unemployed who are making a pretence at work, and who are not to be classed as vagrants. The Charity of the Poor

Of the flowers that "blush unseen" or little noticed in the rather weedy garden of civilization the fairest and sweetest is the kindness of the poor to the poor.

Miss Caroline Pemberton, in the Philadelphia North American, pays earnest and eloquent tribute to the unheralded heroes and heroines of the humbler walks of life. With the eye of a keen student of social conditions she has observed, and thus records the deductions from her observations:

The charity of the poor to the poor is universal and increasing; it is not confined to any race or creed. If it could be chronicled, deed by deed, and the records gathered in from every court, alley and by-way, and the dimes and dollars counted that are contributed by the poor to the poor, what a magnificent tribute to human nature it would make!

We have become used to thinking of charity only in big figures. Princely donations have dazzled us.

We are apt to forget that the far deeper stream of charity and sympathy, pure and undefiled, flows steadily from the poor to the poor. We may not estimate this self-forgetful charity in material statistics, which would appeal most strongly to a material age, but it is at least good to be reminded of its wide-spread existence.

We know that the great churches of the world are built, not by the millions of the few rich, but by the mites of the many poor. The pastor of one of the richest churches in New York City announced not long since that of the \$18,000 collected annually for the running expenses four-fifths came in weekly sums of dimes and less from the poor who could afford to give no more.

The real Good Samaritan of every impoverished neighborhood is not the rich young woman who—God bless her—goes on her dutiful missions of mercy, but the poor neighbor who has little of material things to offer, but gives her all and her heart-sympathy with it.

We are justly proud of the princely benefactions. But what becomes of the pennies of the poor?

The dollars given in charity are easily traced, but the pennies are lost sight of in the shadows.

But it is good to know that they are performing the sweet function of true charity.

MOVEMENT OF COLONISTS TO THE REPUBLIC

Many Large Tracts of Land in Mexico Are Being Purchased and Settled With Emigrants From the Territories

Henry A. Smith, general agent for the Mexican International, was in the city yesterday on his way to Oklahoma to arrange for the movement of another party of colonists who go to Mexico to locate in the territory of Oklahoma, which will be moved to near Escandora, Mexico, from near Mangum, where they will join the colonists who have preceded them to the number of about 500. Mr. Davis says that there were twenty-five farmers who went to Mexico from Hill county only last week, while F. M. Nickel of Yukon, O. T., has recently closed a contract with General Francisco Narango for 1,250,000 acres of land northeast from Cuatro Ciénegas, state of Coahuila, and will colonize a German colony on the property in the near future. The price paid for the land was ten cents per acre, American money.

The people who will locate on this property will engage in the stock business as well as farming, fruit and truck growing. This is the business that will engage the attention of all the colonists from Oklahoma and Texas.

It is the intention of Mr. Nickel to take 1,000 or more blooded cattle to Mexico for the purpose of stocking up the ranch just bought, and with him will be several prominent business and moneyed men. It is the intention to grow great quantities of fine stock.

E. E. Carpenter of Beaumont, says Mr. Smith has also bought largely of land in Mexico, his purchase being 100,000 acres, for which he paid \$10,000. Stock raising and farming will be undertaken on this property. In connection with this deal is a copper mine proposition.

These purchases are in the same country where James Brown Potter owns a great tract of 400,000 acres, all of which are under the control of Mr. Potter, who has on his place a mill and makes cotton oil, meal, etc., and uses the hulls for fuel. He plants cotton once in three years and is said to have the largest cotton plantation in the republic. Mr. Potter has constructed a line of narrow gauge railroad which traverses his entire 400,000 acres in order to facilitate work of different kinds to be done upon the place.

Speaking of railroad matters in the republic, Mr. Smith stated that the Mexican International Railroad Company will soon construct a line from Durango to Mazatlan, a distance of about 200 miles, and has prepared and is now in the hands of the officers and directors in New York City. Mr. Smith thinks that the extension will be made to the Pacific ocean during the present year.

The International Mexican also has another extension in contemplation from Durango to Guadalajara. This extension will be about 400 miles in length.

ARIZONA CONDITIONS

Stock Interests of That Territory Generally Suffered During the Month of January, Though Grass Is Generally Reported Quite Plentiful.

There was a decided deficiency of precipitation during January, though the drouthy condition was not so marked as during the few months preceding. Over a large portion of the territory the amount of precipitation was too small to benefit vegetation materially. In parts of the northern portion of Gila county, however, there was sufficient snowfall to cause some improvement, and this is also true of a few other localities. The dry weather has caused a continued diminution in the supply of water. During a portion of the month the weather was moderately warm, but generally it was quite cold. There has also been considerable wind during the month, which caused some injury to vegetation.

Stock interests have suffered during the month. Though dry grass is generally plentiful, there are many sections where it has become scarce, so that cattle have difficulty in obtaining a sufficient quantity of feed. In the northern portion of the territory feed is generally reported to be more abundant than in the southern portion, though it is fairly plentiful in Santa Cruz county, and in portions of the other southern counties. Some improvement in the ranges in northern counties resulted from snowfall, but the improvement was slight. The supply of available feed is constantly diminishing. Rain or snow is badly needed to put ranges in condition to furnish pasturage during the approaching spring. Stock water is decidedly deficient, and the grazing area has been contracted by stock leaving those localities where water is unobtainable for other localities where conditions are more favorable.

There was some temporary relief from the unfavorable conditions by snowfall in the more elevated portions of the territory, and in the northern portions of Gila county the situation was considerably improved, but the snowfall was generally too light to be of any considerable value, so that the condition of water supply at the end of January was less favorable than at the end of December, 1903.

There has been considerable cold weather during the month, and this has caused stock to suffer to some extent, but the absence of wet weather has been favorable, so that the injurious effects have had a less injurious effect upon stock than might have been expected when taken into consideration with other unfavorable conditions. Damage from severe weather is greater in some localities than in others, the greatest damage being reported from parts of Apache and Cochise counties. In some sections stock is still reported to be in good condition, but generally there has been deterioration during the month, and the general condition is much less favorable than at the end of December, 1903. The outlook for stock interests at the present time is rather discouraging. Good rains or snows are needed to bring about a good condition of the ranges and water supply, and unless these occur serious loss appears unavoidable.

NORTH SIDE AND ROSEN HEIGHTS City Council Meets and Passes on Important Questions— Notes and Personals Nash Furniture Company The city council of North Fort Worth met in regular session last night with Mayor Farmer presiding and all aldermen answering to the roll call. The partial report of several committees were made and upon their request were granted more time in which to prepare more extensive reports. The street and alley committee was authorized to make arrangements for the draining of the old lake on the south end of Gould avenue near the cemetery. The water will be drawn from the lake to Trinity river bottom. An ordinance was passed by the council granting the North Fort Worth Townsite Company permission to replat and survey a portion of the company's property which lies in the neighborhood of the old Carpenter place in the northwestern part of town. Boyd Clark was given permission to move the old Fair building which is located on Main street back to Ellis avenue. The lot upon which the building now stands is now being sold. The entire building and upon its removal to its new position one corner will extend eighteen inches over the property line in Ellis avenue. Attorney Lassiter for the North Fort Worth Water Company whose franchise was vetoed by the mayor at a recent special meeting of the council, presented the claims of the company with an amended clause omitting the sewerage connection which the company had originally contemplated laying with the general water system. After a lengthy discussion by the aldermen the matter was passed over until the next regular meeting of the council. The question upon which an agreement could not be reached was the matter of fixing a price on water to the city for fire purposes. The extent of time asked for by the company also met objection from the aldermen and mayor. The entire matter was referred to the street and alley committee with instructions to make a thorough investigation of the various questions involved. An ordinance was passed ordering an election to be held on April 5. The following municipal officers will be elected: Mayor, five aldermen, city marshal, city attorney, city secretary, city treasurer and a city engineer. The street and alley committee was granted an extension of time in which to meet and confer with J. B. Grogins, manager for Swift & Co., on the proposition submitted by Glen Walker & Co. relative to the improvement of Twenty-third street. None of the aldermen were in a humor to raise the street car question, which is still the source of much criticism among the residents of the North Side, and the matter remains unchanged. N. Harding, city treasurer of the city of North Fort Worth, submitted the following report to the council on the report of the city from January, 1903, to February 4, 1904, inclusive: Amount of warrants paid, \$8,970 97 Amount of interest paid to Fort Worth National bank 170 47 Total \$9,141 44 Amount of receipts from all sources \$7,548 59 Balance due treasurer 1,592 85 Total \$9,141 44 A number of bills were presented and the secretary instructed to issue warrants for the payment of same.
