# Underwood, Johnson, Flowers sport top champions

David Underwood, Cutter Johnson and Kelton Flowers will remember this year's Castro County Junior Livestock

Show for a long time to come. That's because the three took home Grand Champion honors for the show.

Underwood did so with his steer, a 1,280-pound Exotic model. It sold for \$2.50 a pound. to the Dimmitt Buyers Club.

As for Johnson, his Light Heavy Cross swine, weighing in at 250 pounds, was sold to Keeter's Meat Company of Tulia at \$4.25 per pound. Johnson, incidentally, had the

grand champion steer a year ago.

Flowers, who had the grand champion lamb, sold his for \$5 per pound to the Dimmitt Buyers Club. The Mediumweight Medium Wool animal weighed 115 pounds.

For the second year in a row, Dennis Underwood sported the reserve champion steer. This year's model, an Exotic weighing 1,335 pounds, sold for \$2.25 per pound to the Dimmitt

Raynee Bradley also earned the same award for the second year in a row as her lame earned reserve champion status. A Medium Wool, it weighed 125 pounds and sold for \$8 per pound to North Gin.

Then there was Tyler Cornett, who earned Reserve Champion status with his swine. A Heavy Cross, it weighed 261 pounds and brought in \$3 per pound from the Dimmitt Buyers Club.

These weren't the only champions. Goats were judged for the first time and Molly Bradford took home Grand Champion honors while Jinna Wright earned Reserve Champion with her goat.

There was a jackpot for the goats, which were not part of the sale. Bradford earned \$500 for her goat and Wright \$250 for hers.

#### County in waiting mode over proposed re-districting plan By JOHN HASSELMEIER amendment to the evacuation

Castro County Judge Irene Miller informed the Castro County Commissioners Court at Monday morning's meeting that the county was currently in a waiting mode concerning the

Judge Miller said that she was waiting to hear from attorney Portia Bosse from the firm Allison-Bass, the law firm representing Castro County during the re-districting process concerning a conversation she was slated to have with San Antonio attorney Judith Castro. That meeting was to have taken place Tuesday.

During a specially-called meeting last Tuesday, Judge Miller said that, as she understood it, if Castro approved the proposed redistricting plan, it would then be sent to the Department of Justice in Washington D.C. Castro was involved in the county's 1994 re-districting lawsuit.

In other business, the commissioners approved an plan for the second floor of the courthouse.

Delbert Morris, the county district attorney/investigator, told the court that the state required for a designated person to assist any disabled secondfloor employees in the event of a necessary evacuation.

The court elected to declare a local agricultural emergency. The declaration, which originated from Sherman County, wanted to push the legislature, when it meets again, to help farmers. Precinct 3 Commissioner Bay Baldridge first presented the document at last Tuesday's specially-called

The 2002 salary grievance committee has been selected. It will consist of Juan D. Martinez, Paul Torres, Roger Malone and Billie G. Davis.

Judge Miller explained that the names were taken from the last Castro County grand jury.

The judge also reminded the court that training for the bloodborne pathogen kits would be in

She also mentioned that Hepatitis "B" shots for jailers and deputies would need to be set up, either in the courthouse or in the doctor's office.

The court also approved bond for Andrea Loyd in the amount of \$3,000. She's an assistant to the juvenile probation officer.

The county also purchased a couple of books for the GASB new reporting model.

Commissioner Baldridge said that, if they're ordered through the Texas Association of Commissioners and Judges, the county can receive a 15 percent discount. The cost of the books is \$78 each.

#### Johnson NISD retirement becomes effective today

By JOHN HASSELMEIER NAZARETH — Today marks the end of era for the Nazareth

Independence School District. That's because the retirement of superintendent Dean Johnson becomes effective today. Johnson resigned last Thursday in a specially called meeting of the NISD board of trustees.

He won't leave without a retirement reception, however. It's set for Sunday from 2-4 p.m. at the school cafeteria. A short program will be starting at 2 p.m. and the event is "come and go".

Johnson has served as superintendent of the school district since the 1989-90 school year. He came to Nazareth from Kelton, located in Wheeler County in the northeastern panhandle.

"No specific thing made me decide to resign," Johnson said.

"I've been a school superintendent for (approximately) 30 years and I have 36 years of experience.

"For the past year, I have been retired and working halftime," Johnson said. "Only a person can decide for (Continued on Page 9)

# People German Texans exhibit to

# be presented in Nazareth

This year, the community of Nazareth will celebrate its 100th anniversary, commemorating its establishment in 1902 by a German immigrant, Father Joseph Reisdorff.

To enrich this celebration, an exhibit created by the Southwest Collection and the Karl May Archives at Texas Tech University entitled "German Texans Settlement on the Llano Estacado", will be on display to the public during the month of February. It will open in Nazareth on Saturday, Feb. 2.

"It is the purpose of this exhibit to offer the public an overview of some of the major topics in German-Texan history, but with a special spin: each panel presents materials which have a connection to the area of West Texas called the Llano Estacado," according to Dr. Meredith McClain, developer of the exhibit.

"Texas Tech University, although only 76 years old, has substantial research materials concerning German settlement of Texas, Information, materials and staff expertise for this exhibit came from the Southwest Collection and Special Collections Library, the National Ranching Heritage Center and Texas Tech Museum."

The 11 panels of this exhibit depict topics that are grouped into three categories to give a broad spectrum of German-Texan settlement of the Llano Estacado.

In the first category, "German Seed in Texas Soil; Settling the Land", four panels indicate the evolution of German-Texan settlement based on four German colonizers with connections to the Llano Estacado; Father Joseph

Reisdoff, Heinrich Schmitt (Hank Smith), Anna Mebus Martin and the Hedwig Hill

A second category of panels, "Principles and Perscutions: Surviving Difficult Times in Texas" features three panels that explore some of problems German-Texans have had with their Anglo-Texan neighbors; the German "Freidenker" (stance against slavery) in Texas, From Klu Kux Klan Attacks to a German-Texan-Catholic Bishop, and the Arrival of the German

Mennonites in Seminole, Texas. A third category of four panels depicts the topic "Texas Seed in the German Soul: The Powerful Myth of the West", through panels examining the works of German writer Karl May, whose western novels were set in the Llano Estacado, and the German fascination with the American Quarter

Later this year, the exhibit will be sent off for a two-year tour of Germany.

The panels depicting the topic of "Principles and Persecutions" will be housed in the Home Mercantile Building. The location of the other panels will be announced soon.



# Do you have a loser's limp?

One time I heard about a football team that had to let their coach go because he had a five and five record. He lost five games at home and he lost five on the road. As a very young man, I made a wonderful discovery that has helped me tremendously over the years. I discovered that you could play on a team that lost most of its games and still not be a loser in the game of life. When our forefathers established this nation many years ago, they created something called the "sovereign citizen" concept. This means that our government officially recognizes the worth and dignity of every citizen in this country. These words can be found in the Declaration of Independence: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness." Article XIX of the United States Constitution also extended these rights to women. Along with these rights came the opportunity for every person to share in the blessings of our system and to achieve some measure of personal success.

One of the greatest psychological barriers to using our full potential and becoming an outstanding success, however, is a condition called "Loser's limp." In reality, loser's limp is a condition that affects almost everyone to some degree. When you get right down to it, "loser's limp" is a crutch. It's whatever we use to justify why we aren't doing any better with what we've been given. While this is not meant to be personal, I think it's something each of us should

consider from time-to-time.

At this point, let's consider some possible loser's limps. Of course, there are the old standards like, "I was born poor", "I didn't get a good education", "My father or mother was an alcoholic", "I'm too short or too tall", "I'm not attractive", "I was born too early or too late", and "We lived on the wrong side of the tracks." There are countless other excuses or crutches of this type that people use to justify where they are and why they are not doing any better. To be more specific, however, we must decide what we really want out of life and what goals we wish to achieve. Something that's good to keep in mind is that our goals are usually set, based on our perception of what we can achieve, not on what we may actually be able to do. Most of the time, our real loser's limp comes along when things happen or circumstances develop that cause us to back off, change directions or just plain quit.

In relation to these thoughts, here is something that has helped me over the years and it's appropriately titled Don't Quit: "When things go wrong, as they sometimes will, when the road you're trudging seems all uphill, when the funds are

low and the debts are high, and you want to smile but you have to sigh; rest if you must, but don't you quit. Life is queer with its twists and turns as everyone of us some time learns; and many a failure turns about when he might have won had he stuck it out. Don't give up though the pace seems slow - you may succeed with another blow. Success is a failure turned inside out, the silver tint of the clouds, no doubt. And you are near when success seems far, so stick to the fight when you are hardest hit. It's when things seem worse that you mustn't quit."

The message here should be clear. There are times when we should quit, but more often than not, we will win if we just have the faith and the courage to stick it out. If you have a "loser's limp" that's holding you back, why not tie a rock on it and throw it in the nearest river?

Ask for a raise when you think you've earned it.







She was born Nov. 15, 1932 in Montague County and married Elroy Wisian on Dec. 16, 1950 in Earth. She was an insurance agent.


Her husband preceded her in death in 1989.

# Social Security

Concerns about Social Security's long-term solvency have generated a wide range of proposals that would introduce individual savings accounts as part of, or in addition to, Social Security. For a number of these proposals, workers would make voluntary contributions to their accounts.

How many workers are likely to participate in these accounts if they are voluntary? Are some workers more likely to participate compared to others? A paper published in the year 2000 by Social Security looked at participation rates in three existing voluntary accounts — individual retirement accounts (IRAs) 401(k) plans and the Federal Thrift Savings Plan (TSP) — to come up with possible answers.

The three plans allow taxdeferred savings. The traditional IRA is available to all workers — but not all workers are eligible to make tax-deductible contributions. In 1993 a 401(k) plan was available to 31 million workers. Other salary reduction plans are 403(b) plans for the nonprofit sector and 457 plans for state and local governments. The TSP is a voluntary contribution plan for federal employees.

The study concludes that several factors influence participation in voluntary plans — but significantly, even workers with lower earnings do participate when the is employer-sponsored.

Regardless of how the Social Security program\*may evolve over the next decades, it will continue to be an important part of a worker's retirement income. But proper planning is needed to ensure that it is well-supplemented by pension income, savings and investments.




