

# Harvest halted by recent rains

This week's rains may have brought corn harvest to a screeching halt around the county, and some areas haven't even had the chance to get started, according to area elevator operators.

Corn harvest is still about two weeks away at Easter, and their recent rainfall totals of nearly three inches haven't brought that date any closer, according to Easter Grain manager Eddie Matthews.

Flagg Grain reported that they had been getting corn for about

three days when the rains hit. Now, with another two inches of moisture in the ground, things have come to a standstill, according to Flagg Grain manager J. R. Brown.

Sunnyside has received well over two inches in four days time, said Rickey Byers, manager of Sunnyside Grain & Supply. Byers said fields around Sunnyside are so wet that most farmers haven't been able to get started with their harvest yet.

Farmers Grain of Hart had taken in about ten loads of corn

before the rain, according to manager Jarrell Sewell. Sewell said they had received over an inch of rain since last week.

Nazareth has received two inches of rain according to Rocky Wilhelm of Dimmitt Agri Industries Farm Store. Bill Clark of Dimmitt Agri Industries reported that they had been receiving corn for about a week. Clark said they had gotten some corn from Flagg and from south of Nazareth, but he added that Tuesday's rain would probably stop things for awhile.

## NWTF seeks change, needs continued support

Second of a two-part series

"Stopping a monster" is an exhaustive and expensive undertaking, but it's the stated goal of the Nuclear Waste Task Force, Inc. (NWTF), headquartered here.

The "monster" in question is the Nuclear Waste Policy Act, a concept that originally was aimed at safely isolating hazardous radioactive waste from the environment. But members of the NWTF feel the act has gone awry — that it has taken a political turn straight toward the ruin of water, land and lifestyle in the High Plains.

National attention has fallen on the Panhandle as the U. S. Dept. of Energy and local residents have locked horns in a deadly serious struggle that will ultimately determine if the Panhandle inherits high-level radioactive waste which opponents say is highly toxic and could pollute the air, land and water of the region and ultimately destroy parts of the region's agriculture industry.

DOE wants to "characterize" a site on farmland north of Hereford in Deaf Smith County over the next several years to determine if it's suitable as a waste dump location. During the characterization, high-level nuclear waste could be lowered into test shafts bored through the Ogallala and Santa Rosa aquifers.

That possibility, among others, has many Panhandle residents working to support NWTF. And NWTF is hoping for all the support it can get as it gears up for what could prove to be its most important fund-raising effort ever.

NWTF has operated on free-will donations from individuals, organizations and corporations since its

formation in February 1986. The Task Force has been hard-pressed to do battle on a budget of less than \$250,000 a year, however.

Despite the limited budget, NWTF has had notable success in the political arena. DOE suffered a budget cut for fiscal year 1987 that hamstrung its deep-shaft drilling activities in Texas, due to NWTF efforts in Washington. The Task Force's efforts also helped prompt legislators to introduce bills calling for a moratorium on further testing for a dump site until an independent blue-ribbon commission could review the whole site - selection procedure being followed by DOE. These measures are now pending in Congress.

NWTF members are convinced that diligent effort in Washington could make the proposed independent review commission legislation a reality. Lois Wales of Dimmitt is first vice-president and financial committee chairman for NWTF. She says the independent review commission legislation "could let us rebuild the whole Nuclear Waste Policy Act in the manner it should be, instead of just stopping this runaway monster."

Castro County representatives of NWTF are now making calls on businesses and individuals, seeking signatures on bank draft cards that would allow NWTF to automatically draw a specified amount from the donor on a monthly basis.

"We've struggled through a lot of feast-and-famine times with NWTF. We hope that our bank draft drive will help stabilize our cash flow situation and allow NWTF to mount the efforts it must to bring about a sane solution to the nuclear waste issue," Mrs. Wales said.

Task Force President Delbert Devin of Tulia credits NWTF's Washington presence as playing a key role in obtaining the fund cut for DOE, as well as the filing of current legislation favored by NWTF.

"NWTF feels that it is fundamentally irresponsible for the federal government and private industry to continue to produce nuclear waste without safe and proven disposal technology, Devin said. DOE's contractual obligation to nuclear utilities for federal acceptance of waste by 1998, whether or not a repository is available, is in viola-

tion of the letter and spirit of the Nuclear Waste Policy Act.

"We support on-site, dry cask storage of nuclear waste at the source of generation. This would allow adequate time for development of safe nuclear waste disposal technologies," Devin said.

"We oppose any action by federal, state, local or tribal governments, organizations or individuals which promotes premature siting of dangerous nuclear waste facilities in any state, and we oppose DOE having responsibility for the nuclear waste repository program," he added. "DOE's efforts ignore the requirements of the Nuclear Waste Policy Act. We support legislation that would remove the nuclear waste program from DOE and place it under an independent agency solely responsible for activities described in the Nuclear Waste Policy Act."

NWTF maintains that location of a nuclear waste dump in the Panhandle could jeopardize the quality of life and damage the unique environment of the High Plains.

"So long as DOE remains in this area, attempting to characterize a nuclear waste dump in the Panhandle, a cloud hangs over the well-being of our entire region," Mrs. Wales said. "With potential radiation contamination looming on the horizon, we can't expect to lure any new industries to this area. Adverse impacts from the proposed dump include reduction of the tax base of the region. Economic burdens of this ill-conceived scheme far outweigh any benefits."

She added, "Right now, we have in our hands the fate of future generations. Radiation poisoning of our precious resources is no legacy to leave."

## City to hold budget hearing

Dimmitt's City Board of Aldermen will hold its final public hearing and adoption of the city budget for fiscal year 1988 Monday evening.

The hearing will begin at 6:30 p.m. in the city hall meeting room, and is open to anyone wishing to attend or to make a budget request.

"We're not anticipating any tax increase at all," City Manager Reelford Burrous said.

## Local cancer crusade is named top in state

The Castro County Unit of the American Cancer Society is working to educate county residents about cancer and wants to let people know they "should feel free to call on volunteers for help."

"Education is our extreme goal," said Val Davis, president of the local ACS unit. "A lot of people don't know what we have available and what we can do. If we can't do it, we can find someone who can."

"We are going to try and get programs going in the Dimmitt, Hart and Nazareth schools this year," she said.

"We want to encourage groups and organizations to sponsor educational programs. They can contact me (Val Davis) at 647-2131.

The ACS provides cancer patients with service and rehabilitation options at no charge to the patient.

It operates on money raised through fund raising events and the majority of the money raised stays in the county.

ACS volunteers in the county raised over \$19,000 during the last fiscal year, according to Davis.

The biggest fundraiser of the year was the first-time *Night in Santa Fe*. Held at the home of Stanley and Geneva Schaeffer in Dimmitt, the

event featured an art auction, art exhibits, door prizes, fajita dinner and country and western dancing.

*Night in Santa Fe* raised over \$12,000 and earned the county unit top billing in ACS's Texas Crusade Bulletin. The unit was named the top Crusade unit in the state last year.

"Last year's Crusade was far above our expectations," Davis said. "People responded above and beyond the call of duty and it shows the love and concern of the people in the county. We really have a giving and generous group of people living here," she said.

The local unit is planning its annual golf scramble Sept. 26 to kick off the 1987-88 Crusade drive.

Anyone can play in the 18-hole scramble to be held at the Country Club in Dimmitt. Anyone wishing to sign up should call Betty McClure at 647-4502.

Entry fee is \$25 and includes a golf cart and meal furnished by ACS volunteers. "\$6 out of the \$25 will go for rent on the cart and ACS gets the rest," Davis said.

"We are also planning to hold another informal tea and style show — probably in December," she added. "We are going to try and plan another event based on the same concept as *Night in Santa Fe*, but it will be different."

## Area residents linked to hospital by Lifeline

In times of emergency it is sometimes hard to get to a phone, but for 20 Castro County area residents, reaching the phone is not a problem. They have a Lifeline.

Lifeline is a program offered by the Plains Memorial Hospital Auxilliary (PMHA) to area residents which connects them directly to the nurses station at the hospital. The Lifeline unit hooks into a subscriber's phone lines. In an emergency, the subscriber can push the "help" button on his or her unit or activate the unit by pushing the "personal help button" that subscribers wear.

When either button is pushed, an alarm sounds both in the home of the subscriber and at the hospital nurses station. The nurses will then call the subscriber. If the subscriber is unable to answer, the nurses will begin calling a list of responders. A responder is sent to the home of the Lifeline subscriber to check on the situation.

The responder will push the reset button on the Lifeline unit to alert the hospital to his arrival. Then the hospital calls the home to determine if an ambulance should be sent.

This process takes place very quickly and enables the responder to concentrate on the needs of the subscriber, rather than having to worry about calling for help, said Nell Ingram, director of the PMHA Lifeline program.

Subscribers must push the reset button on their unit twice a day or it will go off automatically. So, if a subscriber has an emergency and can't push the button, they will be checked on, Ingram said.

Ingram can cite several success stories with the local subscribers.

"The people that have them are really proud of them, because help comes so fast," Ingram said.

The local program is staffed by volunteers, and there is only one other volunteer Lifeline program in Texas. All others are paid programs, Ingram said.

The cost of the program is \$16 per month. PMHA volunteers install the units free of charge, Ingram said. Sometimes the wiring on a subscribers phone system must be changed, and there is a charge by the phone company, she added.

The "personal help button" can be worn around the neck, waist or wrist. There are special types of

units for people with special handicaps, such as quadraplegics and others unable to use their hands, Ingram said.

Ingram emphasized that the Lifeline program can be a life-saver for anyone, regardless of their age. For more information about Lifeline contact any member of the Plains Memorial Hospital Auxilliary.

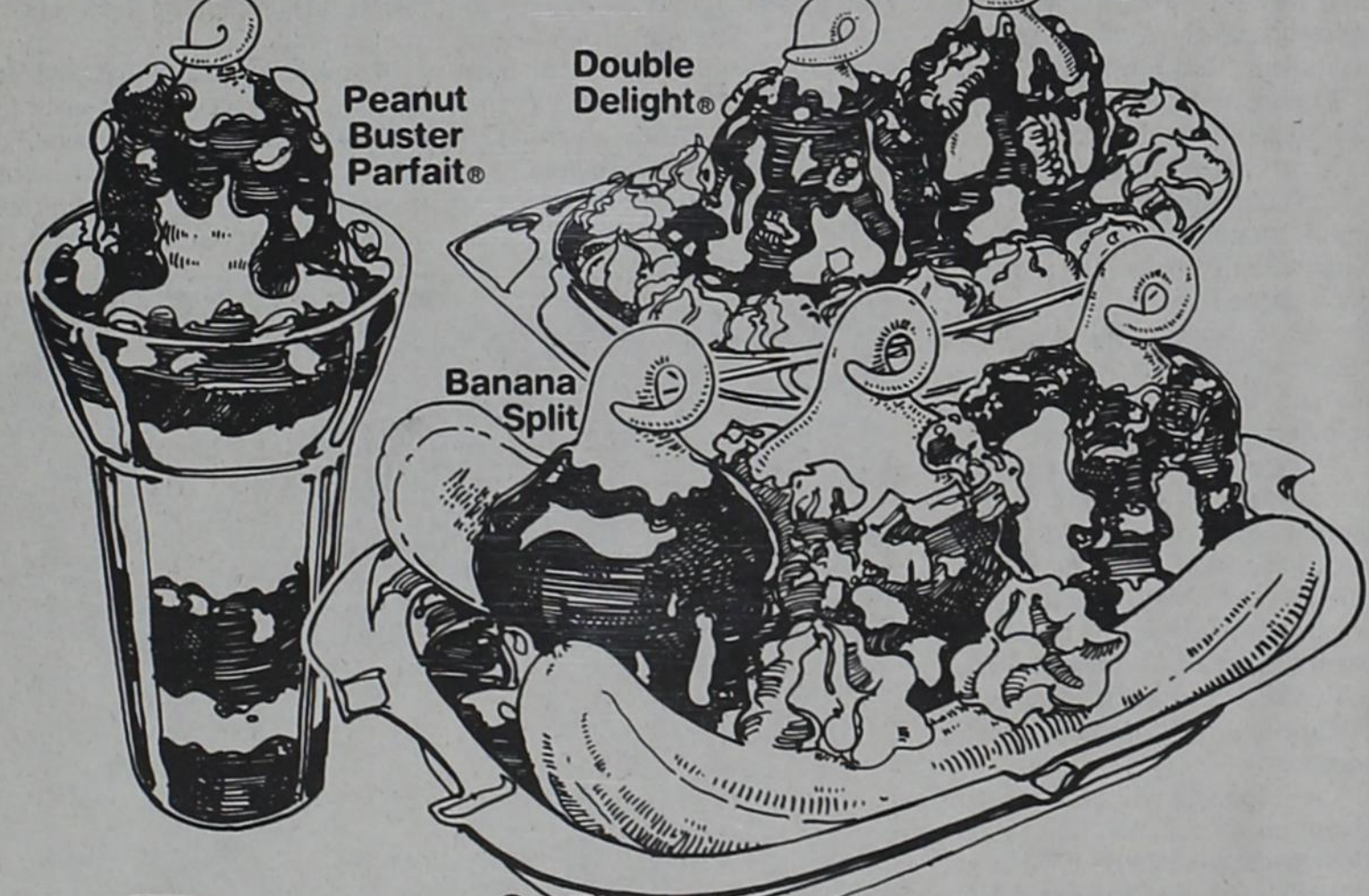

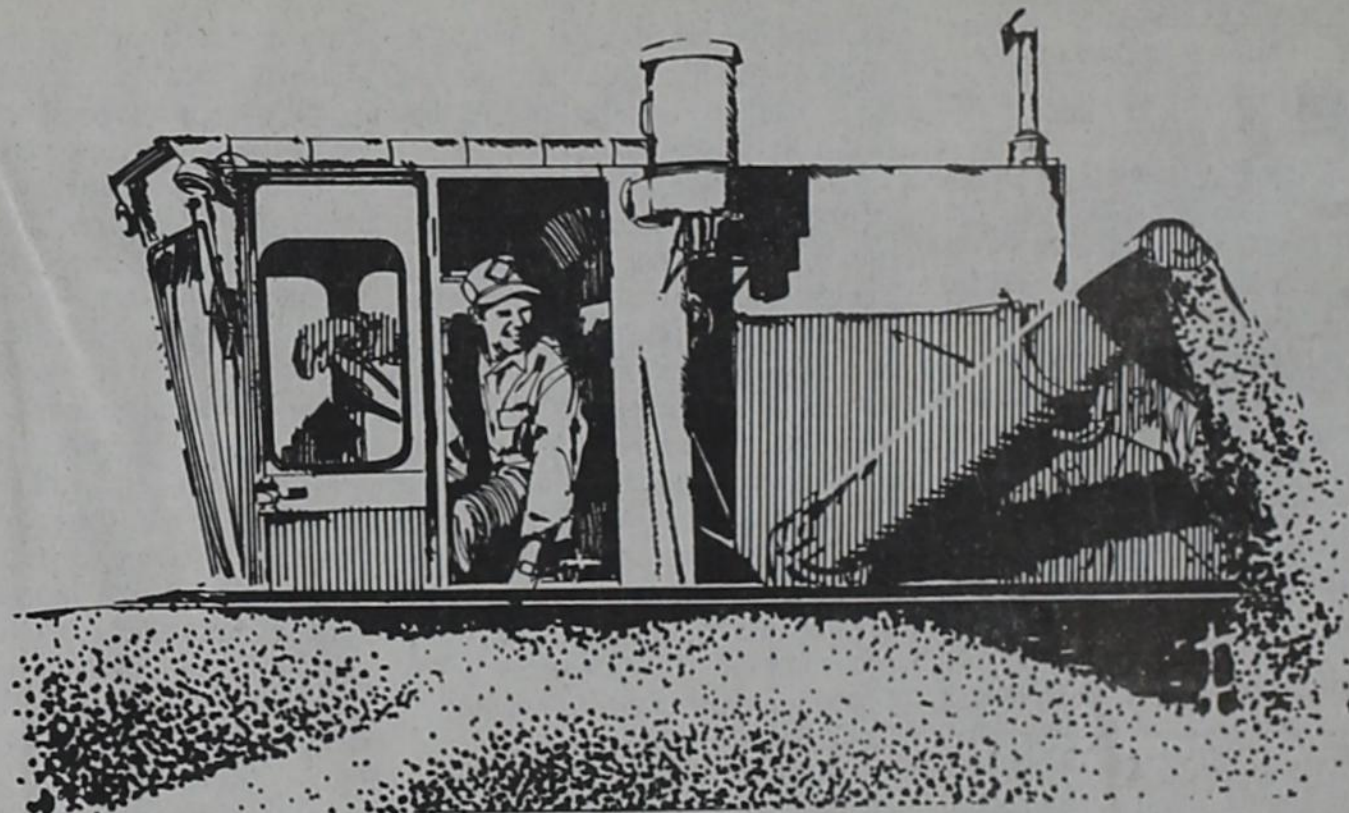

## Bobcats will take show on road Friday

It will be "life on the road" for Dimmitt's Bobcats the next three weeks. They'll open their traveling show Friday night at Slaton, with an 8 o'clock kickoff.

The Bobcats and Tigers both will be looking for their first win. Coach Steve Parr's Tigers, the fourth-ranked team in District 3-AAA, lost their opening game to Colorado City, 14-6, while the Bobcats were dropping their season opener here to Roosevelt, 27-18.

**Social Security in Castro County**  
By Terry J. Clements

People in the local area who receive supplemental security income (SSI) payments have a very important responsibility to report any change in their circumstances that could have an effect on their eligibility for or the amount of their payments.

A person who does not report a change may get too much money and have to pay it back. Or, on the other hand, the person may miss out on money if the change would raise the payments.

A person must report any change in a savings account, Christmas club, certificates of deposit or any other account. A person whose name is on any other person's account must report this, too, even if he or she does not use the money in the account.

Annuities, pensions, workers' compensation, any benefit check, interest, prizes, gifts, awards, insurance money, support, alimony, strike pay or other union benefits, inheritances, rental income and sick pay must also be reported.

If anyone gives the person money, food, clothing, free housing or pays any bills or rent, it must be reported.

If the person enters or leaves an institution such as a hospital, nursing home, county home, halfway house, jail, prison or any other kind of institution, he or she must report it to the Social Security office.

## Cats fall, 27-18

It was a game that Dimmitt's Bobcats would probably like to play again.

After falling behind 20-0, the Bobcats scored three touchdowns in a row during a furious second-half comeback attempt, only to fall to the visiting Roosevelt Eagles, 27-18, in Bobcat Stadium Friday night.

The season opener lasted almost three hours but ended in a crowd-thrilling flourish, with two touchdowns in the final eight seconds.

The Eagles, defending champions of District 3-AAA, showed a lot of authority early as they built a 14-0 lead in the first quarter. After a scoreless second stanza, Roosevelt recovered a fumble in Dimmitt's end zone for a touchdown early in the third to extend its lead to 20-0.

Then the Bobcats—who hadn't earned a first down yet—got their act together. They struck for a touchdown late in the third, followed with another early in the fourth, then punched across a third TD with just eight seconds left in the game. But they were still on the short end of a 20-18 score.

On their final kickoff, the Bobcats tried an onside kick, but it backfired big-time as Roosevelt speedster J. D. Douglas scooped up the ball and raced 48 yards for the Eagles' icing touchdown.

"If we had played the whole game like we played the second half, I think things would have been a lot different," Dimmitt Coach Clifford Smith lamented. "It seemed like our kids in the first half weren't sure we could play with them. Maybe it was because they beat us so badly last year. But after we found we could do some things against them, we woke up and played football."

"No, we didn't make many adjustments in the second half," Smith added. "It was more the kids just deciding they wanted to start playing. We had a little discussion with them at halftime."

The Eagles earned their first TD on their second possession of the game after fullback Felix Arroyo reeled off a 47-yard run off tackle to the Dimmitt 7. Two plays later, tailback Greg Sheppard scored from four yards out. The extra-point kick was no good, leaving

Roosevelt with a 6-0 lead with 3:21 left in the opening quarter.

After the Roosevelt kickoff, the Bobcats drove from their 30 to just shy of the 40 in three plays, and opted to go for it on fourth down, needing just half a yard. After quarterback Matt Bradley plunged over center, the refs spotted the ball, measured, huddled, then ruled that Dimmitt hadn't made it. The ball went over to Roosevelt.

On the next play, Eagle quarterback Mike Richardson heaved a 40-yard touchdown pass to split end Richard Klenke. Douglas ran a two-point conversion to hike Roosevelt's lead to 14-0 with 1:29 remaining in the first quarter.

"That was one of several strange things that happened to us in the game," Coach Smith said. "That fourth-down call was a disputed call—we thought we had a first down. But instead, we had to give up the ball and then they threw that touchdown pass on the next play."

The second quarter was beset by penalties—five against Roosevelt for 46 yards, two against Dimmitt for 10—and fumbles by both teams.

The third quarter was a defensive stalemate until Douglas broke through the middle of the Dimmitt line and raced 45 yards before Chad Davis hauled him down at the Dimmitt 3. Three plays later, Ricky Major knocked Sheppard loose from the ball and Jim Nelson recovered it at the Dimmitt 1.

But the celebration was cut short when the Bobcats fumbled on the next play and Roosevelt all-state candidate Elijah Vasquez fell on it in the end zone for an Eagle touchdown, giving the visitors a 20-0 lead with 5:15 remaining in the third. A two-point conversion run failed.

On their next possession, the Bobcats got their first first-down of the game—and went on to make it three in a row as they marched 62 yards in six plays for a touchdown. The longest gainer of the drive was the first play, when quarterback Clay Lytle hit Nelson with a 33-yard pass to the Roosevelt 30. The Bobcat line opened big holes for good runs by Chad Davis, John Shultz, Emilio Arce and Jason Griffith, then Griffith scored Dimmitt's first TD of the season on a 10-yard burst up the middle with 2:28 left in the third. After a roughing penalty on a wide PAT kick, a Lytle-to-Arce pass attempt for two extra

points failed, leaving the score at 20-6.

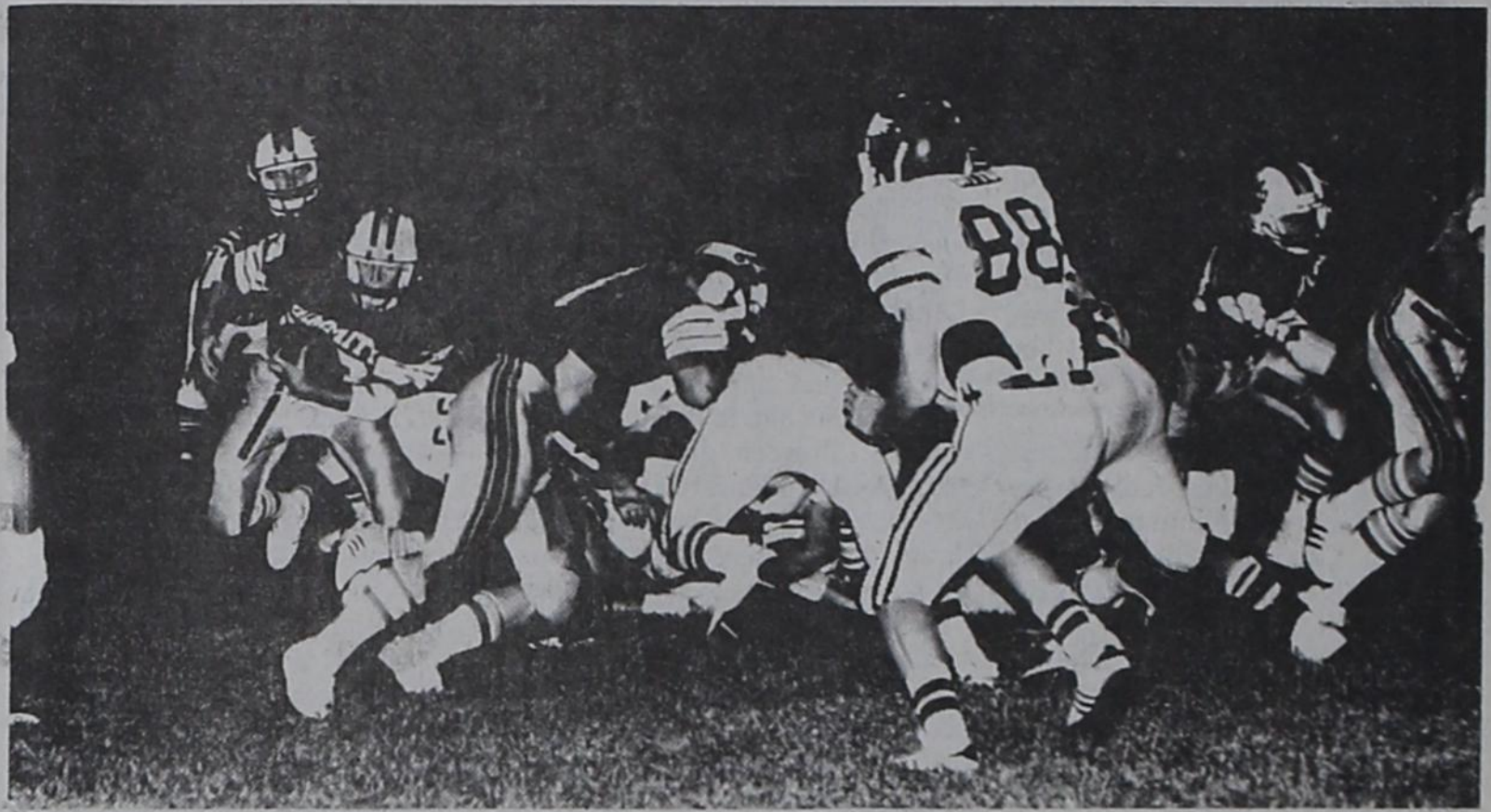
Bradley stopped Roosevelt's next drive with a midfield interception, and later the Bobcat line forced the Eagles into a punting situation at the Roosevelt 27. The snap went over the head of punter J. D. Douglas, and the Bobcats took over at the Eagles' 7 with a first-and-goal.

Four plays later, Griffith scored his second TD of the night with a one-yard plunge off right tackle. The PAT kick was wide, and the score stood at 20-12 with 7:55 remaining in the game.

Dimmitt's final scoring drive started after Chad Davis pounced on a Roosevelt fumble at the Eagles' 40-yard line late in the game. Five plays later, Lytle lofted a pass to Arce, who made a beautiful falling catch in traffic at the 1-yard line with 35 seconds left. Two plays later, Davis punched into the end zone over the right side to bring the Bobcats within tying distance at 18-20 with eight seconds left.

The Bobcats went to the air for the two-point conversion attempt, but the pass fell incomplete.

With their last glimmer of hope, the Bobcats tried an onside kickoff. But the speedy Douglas got to the free-rolling ball first at the Dimmitt 48, eluded three charging Bobcats

# Swifts win, 21-6 in season opener Friday

The Nazareth Swifts, behind the accurate throwing arm of quarterback Chris Schmucker, racked up 21 points in the second and third quarters, to down the Lubbock Christian Eagles 21-6 Friday night in Lubbock.

In an aerial display, Nazareth racked up 353 total offensive yards compared with 182 yards for LCHS.

Schmucker completed 21 of 35 passes for 274 yards and three touchdowns and accounted for 53 of Nazareth's 79 rushing yards to lead the Swifts offensive attack.

But, no passing game is effective

without talented receivers.

Nazareth had no problems in that department. Senior back Gregg Gerber hauled in five of Schmucker's tosses for 100 yards and a touchdown, senior split back Heath Schulte was on the receiving end of six passes for 77 yards and two touchdowns and senior end Brad Hoelting came up with six catches for 66 yards.

"I was real pleased with our passing game," said Rex Minshew, Nazareth head coach. "Our receivers played really well. We are going to have to get our running game going though."

play and was forced to punt the ball after three plays. The punter fumbled the snap, then when he finally gained control of the ball, had the kick blocked by Nazareth defenders.

The Swifts took over on the Eagle 33-yard line and ran four plays before scoring their second touchdown.

Gerber hauled in a screen pass from Schmucker, then raced 24 yards for the touchdown to give the Swifts a 12-0 lead with 7:41 left in the third stanza. Schulte found his way into the end zone for the two-point conversion to extend the score to 14-0.

With just over two minutes remaining in the third quarter, LCHS's Ricky Walters lost control of the pigskin and a Swift defender fell on it to give Nazareth possession at the Eagle 19-yard line.

On the next down, Schmucker hit a wide open Schulte in the end zone for Nazareth's final score of the night. Schmucker added the PAT to give Nazareth a 21-0 lead with 1:50 left in the third period.

Fighting to the end, LCHS substituted freshman quarterback Reagan Crossnoe who hooked up with Stephen Smith from 19 yards out to put the Eagles on the scoreboard with :10 remaining in the game. The Eagles luck wouldn't hold out, as they were penalized for delaying the game before the PAT. The kick failed and the Eagles attempted two unsuccessful onside kicks. Nazareth fell on the ball as time ran out in the game.

## THE Game is Friday

"It's going to be a big game," said Nazareth Coach Rex Minshew. "It will be tough, like always," said Hart Coach Mark Stroebel.

"It" is the annual Hart-Nazareth set-to, which will be played before a standing-room-only crowd Friday night at 8 at Swift Field in Nazareth.

The game dates back almost a generation. In past years it was sometimes a battle for the district championship. The neighboring teams aren't conference foes anymore, but there's still a lot of pride involved in the game.

"There's such a rivalry between the schools," Minshew said. "I think both teams will be ready to play. It will be a good game."

"It's a big rivalry," Stroebel agreed. "It's more with the towns than with the kids, but it carries

over to the kids. It's always a pretty good game."

In his six years as head coach at Hart, Stroebel has beaten Nazareth only once—last year, 31-27. He liked the feeling, and is plotting on how to repeat it.

Stroebel's main worry is how to contain Nazareth quarterback Chris Schmucker.

"He's a super quarterback, and I feel like he's going to do it all," Stroebel said. "It will take all 11 of our players to contain him. But he's their main man. If we put the rush on him, contain him, then we'll win the game."

Minshew's main concern is stopping Hart fullback Junior Washington.

"He's 6-1 or 6-2 and weighs 210. If we don't hit him and wrap him up, he'll kill us."

"The offensive line wasn't so hot in the first half, but they played pretty good in the second half."

"I felt like we should have scored more. We were inside the 20 several times and we probably should have scored at least three or four more times, but we did okay," Minshew said.

"Defensively we played really well — we shut them down," Minshew said. "I felt like Wes Dobmeier and Wayne Wilhelm played an outstanding defensive game. They were all over the field

covering the football."

The Swift defense held LCHS to 11 first downs, gave up 159 yards on the ground and allowed the Eagles to complete just two of 11 passes for 23 yards.

The first quarter and most of the second were as calm as the weather during the game, with the teams trading punts. The Eagles were able to convert only three first downs in the first half while Nazareth tallied seven.

Nazareth's first scoring drive began on the Eagle 47-yard line. The Swifts drive almost ended after three plays, but an Eagle defender jumped offsides on fourth-down, giving the Swifts a first down on the Eagle 38-yard line.

Schmucker connected with Schulte for 12 yards, then scrambled for 20 yards to the four-yard line two plays later. The Schmucker-Schulte duo put the Swifts on the scoreboard combining for a four-yard touchdown pass with 2:15 left in the first half. Schmucker's PAT failed.

LCHS opened the second half of

Hart moved the ball to Anton's 4-yard line, but the drive was halted by a fumble.

With :07 left in the game, Anton had a chance to beat the Horns, but Edgemond's field goal attempt was wide.







## TSBGA says sugar industry under attack

Many state and national sugar producer organizations, including the Texas Sugar Beet Growers Association (TSBGA) headquartered in Hereford feel the domestic sugar industry is being unfairly attacked, according to Bill Cleavinger, TSBGA president.

"The Texas Sugar Beet Growers Association is bitter toward some national magazines and newspapers which are giving consumers false information about our domestic sugar industry," said Cleavinger, who is also vice-president of the American Sugarbeet Growers Association.

"We are also angry with many

Washington-based lobbyists, including some former members of the Reagan administration, who represent foreign countries which export sugar and many other products into the U. S.," he added.

Cleavinger said the attacks are on the U. S. sugar policy, and that such attacks have a direct impact on 300 of the region's farmers and some 500 landowners count on sugar beet production as a major cash crop, he said.

The area sugar industry is operating in the black thanks to the national sugar policy, Cleavinger said. The policy has also helped the

overall domestic industry guarantee a dependable supply of sugar for consumers at prices which have been both stable and below those of most major countries worldwide, he said. And it does all this without costing the federal government a dime in payments to farmers, he added.

Established by Congress in 1981 and extended in the 1985 farm bill, the sugar program provides an 18-cents per pound loan support price to consumers. Import quotas are used to assure that domestic sugar is marketed rather than forfeited to the USDA Commodity Credit Corp.

"With this program, there are no costs to the government other than the nominal clerical costs of administering it," said Cleavinger. "That is the intent of Congress. There are no government payments to farmers. The policy is based on an orderly marketing procedure which which assures a guaranteed supply of sugar to consumers at a reasonable price."

Recent media attention has been on a so called "world sugar price" which Cleavinger said is actually the "dump price" for sugar from countries which provide heavy subsidies to their own sugar industry. Since some countries provide high subsidies, overproduction is abundant, meaning selling prices have been pushed far less than the cost of production, he explained.

The European Economic Community (EC) is possibly the biggest culprit in creating the distorted

"world sugar price," Cleavinger said. The EC dumped 25 million tons of sugar on the world market the past seven years and it continues to subsidize production at the expense of less-developed sugar exporting countries, he said. He added that most U. S. industry representatives believe these artificially-low prices are a threat to the entire industry.

Although the U. S. sugar program is working well for farmers and consumers, the Reagan administration wants to reduce the program's effectiveness by increasing sugar imports and lowering the sugar loan rate to farmers, according to Cleavinger. He also said that major sugar users, such as Coca Cola and other soft drink companies, along with several consumer groups, are also opponents of the sugar program.

Basically, the opponents see the "world sugar price" as meaning lower prices for consumers and industrial users, he said. He added that the administration claims the sugar program is damaging American foreign relations with Caribbean and other sugar producing countries.

Cleavinger said that history has shown that without a sugar program, prices for raw sugar fluctuate wildly — from as low as 10 cents a pound to as high as 65 cents a pound.

The sugar program has changed the picture, Cleavinger said, adding that prices have been stable for consumers and producers, and

supplies have been abundant. "In fact," he said, "during the first five years of the program, USDA figures show that sugar prices actually dropped by more than 8 percent."

"At the same time, prices for sweetener-containing products, such as soft drinks and candy, increased by more than 27 percent. This clearly indicates that a drop in sugar prices doesn't translate into guaranteed lower consumer prices for products containing sugar," Cleavinger said.

"Destroying the U. S. sugar program would, in essence, destroy the U. S. sugar industry," Cleavinger said. "American producers and processors cannot compete with artificially-low world prices which are priced far below the cost of production. And leaving consumers at the mercy of imported sugar

could create a situation similar to that caused by America's dependence on foreign oil — a situation of erratic and high prices.

Cleavinger said that under the Reagan proposal, taxpayers would be out more than \$1.2 billion in farmer subsidies over four years.

"It's important that we maintain our current sugar program," Cleavinger said. "It's good for U. S. consumers and farmers alike. And it's good for the Panhandle-South Plains area."

We have received notice that all CRP bids of \$40 and under were accepted for sign-up number five. The soil Conservation Service has or will develop a Conservation Plan for your farm, which you will need to study very closely to know what is required to stay in compliance. The Conservation plan for your farm must be followed.

Each plan has a weed control provision. 1987 contracts cannot be grazed or harvested in any manner. 1988 contracts can be hayed or grazed through Sept. 30 and growing crops may be harvested.

If you have any questions, please contact this office or the Soil Conservation Service office.

If you have a request for measurement service on a crop and the crop gets ready to harvest before the service is completed, you must measure and certify before harvesting. You who have put up for measurement service and plan to cut ensilage, please check with us before you start.

You are reminded that weeds as well as erosion must be controlled on all leave out ground. If you have a weed problem, please take care of it.

Foreign investors who acquire, transfer or hold interest in agricultural land are required by law to report such transactions and holdings. Land interest acquired must be reported within 90 days. Forms

are available at your local ASCS office.

The recent rains have caused the weeds to do very good. If you have any questions concerning your contract, please contact the Soil Conservation Service office or the ASCS office.

All commodity loans may be obtained at the County ASCS office for 1987 participating forms.

Corn, grading #2 or better is \$2.11 per bushel. Grain sorghum, grading #2 or better is \$3.39 per cwt. Cotton, SLM 11/16 inch is .5230 per pound.

The loan rates are subject to premiums and discounts.

For 1987, LAA-2 (Community C) will elect Community Committeemen for a three year term. A County Committeeman and two alternates will also be elected for a three year term.

will be Tony Price, executive vice president of the Texas Cotton Ginners Association, and Myrl Mitchell, Lenora, president of Plains Cotton Growers, Inc.

Following lunch, participants will tour the Lubbock cotton classing office and discuss new classing procedures.

# Bobcat JV, Freshmen win season openers

Dimmitt High School's Junior Varsity and Freshman Bobcats both won their first games last Thursday at Roosevelt.

The JV took a 14-8 victory behind the running of Oscar Velasquez and the kicking of Masatoma Itonaga.

Roosevelt got on the scoreboard first, recovering a Dimmitt fumble in the end zone and running a two-point conversion when the game was just four minutes old to take an 8-0 lead.

Velasquez scored Dimmitt's first TD on an eight-yard run with 51 seconds left in the second quarter. Itonaga, DHS's exchange student from Japan, kicked the extra point to cut the Eagles' lead to 8-7 at halftime.

Dimmitt got its winning touchdown late in the game when Velasquez plunged across the goal line from one yard out with 1:56 remaining, and Itonaga again added the extra point.

Velasquez paced the Dimmitt JV runners with 97 yards on 23 carries for a 4.2 yards-per-tote average. Barry Hill added 37 yards on six carries (6.2 average) and Brian Stewart carried once for eight yards. The Bobcat JV averaged four yards per carry overall.

Top defensive plays were turned in by Craig Heller with a fumble recovery and James Flores with a pass interception.

In the freshman game, Dimmitt's Filiberto Alafa caught a six-yard touchdown pass from Freddie Martinez to cap a 43-yard scoring drive on Dimmitt's second possession. Miguel Ontiveros kicked the extra point.

As it turned out, that first-quarter TD was all the Freshman Bobcats needed as the defense held Roosevelt scoreless. But the defense added icing to the cake in the second quarter by sacking a Roosevelt runner in the end zone for a two-point safety.

"Ontiveros' kicking was a big factor in the game," Coach Alan Steidle said. "He punted four times for an average of 30.1 yards, and had one 50-yard boomer. He kept them backed up all night. And our defense played super."

Top rushers for Dimmitt were Henry Rocha with 60 yards on 16 carries (3.75 average), John Ortegon with 43 yards on three carries (14.3 average) and Ontiveros with 31 yards on five carries (6.2 average). Ortegon also intercepted a Roosevelt pass.

Dimmitt quarterback Freddie Martinez completed five of 15 passes for 65 yards and a touchdown. His main receiver was Scott Acker with four receptions for 59 yards.

Dimmitt gained 134 yards on the ground and 65 in the air for a total yardage of 199 and an average of 6.2 yards per play.

## CONSTITUTIONAL AMENDMENTS

SPECIAL ELECTION

NOVEMBER 3, 1987

### PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 104 proposes a constitutional amendment to allow the legislature to provide a guarantee for the Texas grain warehouse self-insurance fund. The guarantee of the fund may not exceed \$5 million, and when the fund reaches \$5 million, the guarantee will cease.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide for the surety of a grain warehouse fund to be established by the grain industry for the protection of farmers and depositors of grain in public warehouse facilities."

"The constitutional amendment authorizing agreements between the State Department of Highways and Public Transportation and the Texas Turnpike Authority and the governing bodies of counties with a population of more than 400,000, adjoining counties, and cities and districts located in those counties to aid turnpikes, toll roads, and toll bridges by guaranteeing bonds issued by the Texas Turnpike Authority."

### PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 4 proposes a constitutional amendment to allow the legislature to establish three separate development funds. A Texas product development fund could be established to aid in the development and production of new or improved products in the state. The amendment would authorize the issuance of up to \$15 million of general obligation bonds to provide initial funding for the program. A Texas small business incubator fund could be established to foster and stimulate the development of small businesses in the state. Small businesses operating under the program would be exempt from ad valorem taxation. The amendment would authorize the issuance of up to \$10 million in general obligation bonds to provide initial funding for the program. A Texas agricultural fund could be established to promote the production, processing and marketing of agricultural products produced primarily in Texas by small Texas agricultural businesses. The amendment would authorize the issuance of general obligation bonds in the amount of \$100 million outstanding at one time to carry out the agricultural fund program. The legislature could require review and approval of the issuance of bonds and the use of bond proceeds.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to raise the maximum property tax rate that may be adopted by certain rural fire prevention districts, but only if approved by the districts' residents."

### PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 60 proposes a constitutional amendment to permit rural fire prevention districts in counties with populations over 400,000 to levy a tax at a rate not to exceed six cents (\$.06) per \$100 property valuation for the district, if the voters of the district approve the tax.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to raise the maximum property tax rate that may be adopted by certain rural fire prevention districts, but only if approved by the districts' residents."

### PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 48 proposes a constitutional amendment to extend the school ad valorem tax exemption for elderly persons to the surviving spouse of a person receiving the exemption. If a surviving spouse is at least 55 years old at the time of death of the person receiving the exemption, ad valorem public school taxes could not be increased as long as the homestead remained the residence homestead of the surviving spouse.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to limit school tax increases on the residence homestead of the surviving spouse of an elderly person if the surviving spouse is at least 55 years of age."

### PROPOSITION NO. 4 ON THE BALLOT

House Joint Resolution 5 proposes a constitutional amendment to allow the legislature to create programs and make loans and grants of money for development and diversification of the economy, elimination of unemployment and underemployment, stimulation of agricultural innovation, promotion of agricultural enterprises, and development of transportation and commerce. Bonds or other obligations payable from ad valorem taxes must be approved by the voters in the political subdivision seeking such funding sources.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to provide assistance to encourage economic development in the state."

### PROPOSITION NO. 5 ON THE BALLOT

House Joint Resolution 65 proposes a constitutional amendment to permit the State Department of Highways and Public Transportation to contract with the Texas Turnpike Authority and to contribute money to the costs of turnpikes, toll roads and toll bridges of the Authority. The amendment would authorize the governing body of a county with a population over 400,000, a county adjoining such county, and any city or district located in or partially in such county to make agreements with the Texas Turnpike Authority and levy ad valorem taxes to pay part or all of the principal and interest on Turnpike Authority bonds and to pay maintenance and operating expenses of the Turnpike Authority, if the voters approve the tax.

The proposed amendment will appear on the ballot as follows:

### PROPOSITION NO. 7 ON THE BALLOT

Senate Joint Resolution 55 proposes a constitutional amendment to authorize the legislature to provide for the issuance of \$400 million in general obligation bonds to be used for loans to local governments for acquisition, construction, repair, renovation, and equipment of public facilities or for grants to local governments for planning public facilities. The amendment would also permit the issuance of revenue bonds for the same purposes to be repaid from excess revenue from repayments of loans made under the amendment and from other revenues pledged to the retirement of revenue bonds. The amendment also authorizes the legislature to provide for review and approval of the issuance of the bonds and the use of the bond proceeds.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the issuance of general obligation bonds to finance certain local public facilities."

### PROPOSITION NO. 8 ON THE BALLOT

Senate Joint Resolution 56 proposes a constitutional amendment to allow the legislature to authorize the issuance of up to \$500 million in general obligation bonds to be used to acquire, construct, and equip new correctional institutions and mental health and mental retardation institutions or to repair existing institutions. The amendment also authorizes the legislature to provide for review and approval of the issuance of the bonds and the projects to be financed by the bond proceeds.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the issuance of general obligation bonds for projects relating to corrections institutions

and mental health and mental retardation facilities."

### PROPOSITION NO. 9 ON THE BALLOT

Senate Joint Resolution 9 proposes a constitutional amendment to provide that a state legislator is eligible to serve in another state office even if the compensation of the office was increased during his legislative term or even if the appointment is made in whole or in part (including Senate confirmation) by the legislature. The legislator could not, however, receive the increased compensation approved during his legislative term.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide that a member of the legislature is eligible to be elected or appointed and to serve in a different state office but may not receive an increase in compensation granted to that office during the legislative term to which he was elected."

### PROPOSITION NO. 10 ON THE BALLOT

Subsections (d) and (e) of Section 1 of Senate Joint Resolution 12 propose a constitutional amendment to allow the legislature to exempt from ad valorem taxation all tangible personal property except structures which are used as residential dwellings and property held or used for the production of income. This exemption would be in addition to the personal property homestead exemption already established by the constitution. If the legislature authorizes the exemption of additional personal property from taxation, under this amendment, local political subdivisions may pass resolutions providing for taxation of such property unless the property is exempt from ad valorem taxation under another law.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow the legislature to exempt from ad valorem taxation certain personal property not held or used for the production of income."

### PROPOSITION NO. 11 ON THE BALLOT

Section 1, Subsections (f) and (g) of Senate Joint Resolution 12 propose a constitutional amendment to exempt from ad valorem taxation goods, wares, merchandise, and ores other than oil, gas and petroleum products. These items would be exempt from taxation only if they originated outside the state and were located in the state for a period of 175 days or less for purposes of assembly, storage, manufacture, processing, or fabrication. Such property could be taxed by a county, school district, or municipality if the governing body of the political subdivision took official action to provide for the taxation of the items while they were located in the political subdivision. If the governing body of a political subdivision took official action to tax the items before January 1, 1988, the tax would be effective for the 1988 tax year. If the action were taken after January 1, 1988, and before April 1, 1988, the tax would become effective January 1, 1989.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the exemption from ad valorem taxation of certain property that is located in the state for only a temporary period of time."

### PROPOSITION NO. 12 ON THE BALLOT

Senate Joint Resolution 35 proposes a constitutional amendment to allow a married couple to agree in writing that all or part of their community property will become the property of the surviving spouse if one spouse dies.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment permitting spouses to hold community property with right of survivorship."

### PROPOSITION NO. 13 ON THE BALLOT

Senate Joint Resolution 27 proposes a constitutional amendment to authorize the creation of special districts to provide emergency services. The commissioners court in a county participating in a district could, upon approval of the voters, levy an ad

valorem tax of up to ten cents (\$.10) per \$100 valuation of the property located in the district.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow for the creation and establishment, by law, of special districts to provide emergency services."

### PROPOSITION NO. 14 ON THE BALLOT

Senate Joint Resolution 34 proposes a constitutional amendment to allow the state a limited right to appeal criminal cases. Under current law, only criminal defendants are allowed to appeal. This proposed amendment would allow the legislature to pass laws granting state prosecutors the right to appeal in limited circumstances.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment giving the state a limited right to appeal in criminal cases."

### PROPOSITION NO. 15 ON THE BALLOT

House Joint Resolution 35 proposes a constitutional amendment to abolish the office of county treasurer in Gregg County and transfer the duties of that office to the county auditor or an elected official designated by the commissioners court. The amendment would also abolish the office of county treasurer in Fayette and Nueces counties if a majority of the voters in those counties vote in favor of the amendment. In Fayette County, the functions of the treasurer would be transferred to the county auditor or the officer succeeding to the auditor's functions. In Nueces County, the powers, duties, and functions of the treasurer would be transferred to the county clerk.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide for the abolition of the office of county treasurer in Gregg, Fayette, and Nueces counties."

### PROPOSITION NO. 16 ON THE BALLOT

Senate Joint Resolution 6 proposes a constitutional amendment to allow the commissioners court in a county with a population of more than 150,000 to establish more than one Justice of the Peace court in each Justice of the Peace precinct, i.e., to provide for the election of more than one Justice of the Peace in each Justice of the Peace precinct.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing that certain justice precincts may contain more than one justice of the peace court."

### PROPOSITION NO. 17 ON THE BALLOT

Senate Joint Resolution 26 proposes a constitutional amendment to allow the legislature to define by law those municipal functions that are governmental and those that are proprietary. This authorization would apply to laws passed by the 70th Legislature, 1987, and by future legislatures in regular or special session. A municipality is liable for damages arising out of acts committed under its proprietary functions, but not its governmental functions. Definition of such functions by the legislature would clarify the liability of a municipality in civil lawsuits filed against it.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to define for all purposes the governmental and proprietary functions of a municipality."

### PROPOSITION NO. 18 ON THE BALLOT

House Joint Resolution 18 proposes a constitutional amendment to authorize the legislature to provide for the creation, operation, and financing of jail districts. Financing of a jail district could be accomplished through the issuance of bonds and other obligations, or by levy of an ad valorem tax on property located in the district if the qualified electors of a district approve an ad valorem tax or bonds secured by a property tax.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment relating to the creation, operation, and financing of jail districts."

### PROPOSITION NO. 19 ON THE BALLOT

House Joint Resolution 88 proposes a constitutional amendment to authorize the issuance of \$500 million in general obligation bonds, the proceeds of which will be used to establish a superconducting super collider fund. The fund would be used to provide economic incentives for the superconducting super collider research facility, and the agency administering the fund would be authorized to grant land or property to the United States government for undertakings related to the facility.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the issuance of general obligation bonds to fund undertakings related to a superconducting super collider research facility sponsored or authorized by the United States government, and to make appropriate grants for such undertakings."

### PROPOSITION NO. 20 ON THE BALLOT

House Joint Resolution 96 proposes a constitutional amendment to allow the legislature to provide ad valorem tax relief for mobile offshore oil and gas well drilling equipment. The tax relief would be limited to equipment that is being stored while not in use in a county that is adjacent to the Gulf of Mexico or on a body of water that is adjacent to the Gulf of Mexico.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the legislature to provide ad valorem tax relief for certain offshore drilling equipment that is not in use."

### PROPOSITION NO. 21 ON THE BALLOT

Senate Joint Resolution 17 proposes a constitutional amendment to provide for legislative involvement in the executive branch of government by permitting the legislature to include the speaker of the house of representatives in the membership of an agency or committee that includes officers of the executive branch of government and performs executive functions. Under current law, the legislature is not allowed to exercise any powers in executive matters under Article II of the Texas Constitution, which provides for the "separation of powers" into three distinct departments.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment permitting the legislature to include the speaker of the house of representatives or the speaker's appointee in the membership of an executive agency or committee."

### PROPOSITION NO. 22 ON THE BALLOT

Senate Joint Resolution 53 proposes a constitutional amendment to allow the legislature to limit the term of office of a gubernatorial appointee to a vacancy in a state or district office to a partial, temporary term if the appointment is made on or after November 1 of the last year of the governor's term and the governor is not reelected. Under this amendment, the legislature may provide that the tenure of such an appointee would end sooner than the term would normally expire.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow the legislature to limit the authority of a governor to fill vacancies in state and district offices during the end of the governor's term if the governor is not reelected."

### PROPOSITION NO. 23 ON THE BALLOT

Senate Joint Resolution 54 proposes a constitutional amendment to authorize the Texas Water Development Board to issue an additional \$400 million in water development bonds. Of the \$400 million authorized, \$200 million would be designated for conservation and development of water resources, \$150 million would be designated for water quality enhancement, and \$50 million would be designated for flood control. The amendment also authorizes the legislature to provide for review and approval of the issuance of the bonds and the use of the bond proceeds.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the issuance of an additional \$400 million of Texas Water Development Bonds for water supply, water quality, and flood control purposes."

### PROPOSITION NO. 24 ON THE BALLOT

House Joint Resolution 83 proposes a constitutional amendment to allow a county to use county equipment and personnel to perform work, without compensation, for another governmental entity if the commissioners court finds that the work will not interfere with the performance of county work and approves performance of the work. The governmental entity must be located wholly or partly in the county, and the governing body of the governmental entity must file a written work request with the commissioners court.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to permit a county to perform work, without compensation, for another governmental entity."

### PROPOSITION NO. 25 ON THE BALLOT

Senate Joint Resolution 5 proposes a constitutional amendment to allow the Legislature to authorize Randall County to levy a tax for the benefit of the Amarillo Hospital District. Any such tax could be levied only on property located outside the City of Amarillo and outside the South Randall County Hospital District. The tax could not be more than 75¢ per \$100 property valuation and would be effective only upon approval by the voters in the area to be taxed. If the tax is authorized by the Legislature and approved by voters, the Amarillo Hospital District is to serve residents of part of Randall County. If a tax is levied under this provision, Randall County must repay the State for the cost of publication of this amendment.

The proposed amendment also permits the legislature to authorize a hospital district to change its boundaries or jurisdiction if the district was created or authorized by a constitutional provision that includes a description of the boundaries or jurisdiction of the district. Any change in the boundaries or jurisdiction of such a hospital district would become effective only upon approval of the voters in the district.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to permit the Amarillo Hospital District to serve certain residents of Randall County, to authorize Randall County to provide financial assistance to the district, and to authorize certain hospital districts to change their boundaries or jurisdiction with voter approval."

### EXPLANATORY STATEMENT FOR STATEWIDE REFERENDUM NO. 1

Senate Bill 86 submits to the voters the question of whether the 15 members of the State Board of Education should be appointed instead of elected. If the proposition passes, the Governor will appoint a member of the board for each district, with the consent of the Senate. If the proposition fails, the members will be elected from these districts.

The referendum will appear on the ballot as follows:

"The State Board of Education shall be composed of members who are appointed from districts instead of elected, with equal representation throughout the State of Texas."

### EXPLANATORY STATEMENT FOR STATEWIDE REFERENDUM NO. 2

The Texas Racing Act submits to the voters the question of whether pari-mutuel wagering should be legal in Texas on a county-by-county local option basis. If pari-mutuel wagering is adopted by the voters statewide, a county must also pass a separate proposition on pari-mutuel wagering at an election held in the county before any such wagering may be conducted in that county.

The referendum will appear on the ballot as follows:

"The legalization of pari-mutuel wagering under the Texas Racing Act on a county-by-county local option basis."
