

Stock show banquet honors local 4-H, FFA youth

She beat three other contenders by selling \$1,593 in memberships. A total of \$3,028 in memberships was sold by Janet Himes, Floydada 4-H Sweetheart; Kerrie Pitts, Floydada FFA Sweetheart; Loretta Turner, Lockney FFA Sweetheart; and Jennifer Fortenberry.

A full house gathered February 7, in Lockney Elementary cafeteria, to enjoy the meal sponsored by the Floyd County Farm Bureau and honor those who have participated in the 45th annual Floyd County Junior 4-H and FFA Junior Livestock Show.

The coveted Sweepstakes award was received by Dean Smith, son of Choise and Kay Smith of Floydada. The honor is based on all around involvement in the stock show. Smith was recognized for his good leadership and character, and for always being willing to help younger individuals develop showmanship responsibility. Besides receiving \$100.00 from the Dusty Bursleson Memorial Scholarship, Smith also received a plaque and the traveling trophy.

The livestock sale was deemed a big success with over \$111,000, not counting lamb floor bids, received.

A highlight of the evening was the presentation of the senior and junior showmanship and herdsman award. An anonymous committee selects youngsters who do the best job of presenting and handling the animals for showmanship honors and for those who maintain their pens or stalls in a neat, tidy manner for herdsman honors. Board renews contracts

The Lockney Independent School Board met in regular session Thursday, February 9 in the board room at the school office.

Board members approved the extension of the contracts of three school principals and renewed the contract of the athletic director.

The contracts of James Poole, high school principal, Terry Ellison, junior high principal and Joyce Evans, elementary school principal were all extended through June, 1991. Athletic director

and head coach Jim Clarks contract was also renewed for one more year.

In other action board members approved calling for an election to seat three trustees on the school board. Lisa Mosley, Paul Glasson and Dickie Lambert hold the positions which will expire this year.

Individuals may place their names on the ballot beginning March 6 at the school business office. The trustee positions are for three year terms. **Continued On Page 2**

Council sets May 6 city election

With two councilmen and the mayor's terms to soon expire, the Lockney City Council voted February 9 during the regular meeting, to call for an election on May 6.

Councilmen Kenneth Wofford and Jerry Johnson's at large positions along with Mayor Dan Smith will be voted on in the next election. Neither Wofford, Johnson, or Smith made any comments on whether they would run again.

Anyone wishing to run for mayor or city council must file his intentions between February 20-March 22nd. Applications may be picked up at the city office. Every candidate must meet the following qualifications: (1) Be a U.S.

citizen (2) Have been a resident of Texas for at least 12 months as of the deadline for filing for the office (3) Have resided in the city for at least 12 months next preceding election day (4) Have a current voter registration certificate (5) Be 18 years of age or older upon the commencement of the term to be filled at the election (6) Not advocate overthrowing the governments of the U.S. or the state of Texas by force or violence (7) Not have been convicted of a felony for which he or she has not been pardoned or had full rights of citizenship restored by other official action and (8) Not have been deemed mentally incompetent by a court.

Landfill options were discussed at the meeting, since the decision has been made to close the landfill to county residents. Options discussed included: should the city keep the landfill open at all; will the city buy a backhoe to pack and bury or should they take bids from a private contractor to pack and bury. Before making a final decision on the outcome of the landfill the councilmen voted unanimously to call for bids to get the landfill in shape so the city could pack and bury themselves and also will call for bids for a private contractor to pack and bury.

The council agreed that they wanted to keep the landfill open at least one day a

week, on Saturday.

After meeting with a computer salesman from Incode in Lubbock, the city councilmen voted to advertise for bids on one single user computer that will be capable of expanding to a multi-user system. The city is considering using computers for utility billing, general ledger, accounts payable and payroll.

The current billing is done through computers at Lockney Co-op, which the city is billed for. No decision was made on going to the computer system at this time, only to look at bids for consideration.

A proposed jail contract was presented to the council from the county **Continued On Page 2**

Williams to display calf won in scramble

The heifer he will show was bought with a certificate sponsored by J. W. Bates of.

Williams, the son of Mary Williams, will compete in the Calf Scramble Heifer Show and the Junior Breeding Heifer Division at the Houston show between the dates of February 16 and March 5.

252 certificates were awarded at the 1988 Rodeo. The calf scramble involves 28 youngsters who are turned loose in the astrodome arena with half as many wild calves. Those who manage to cap-

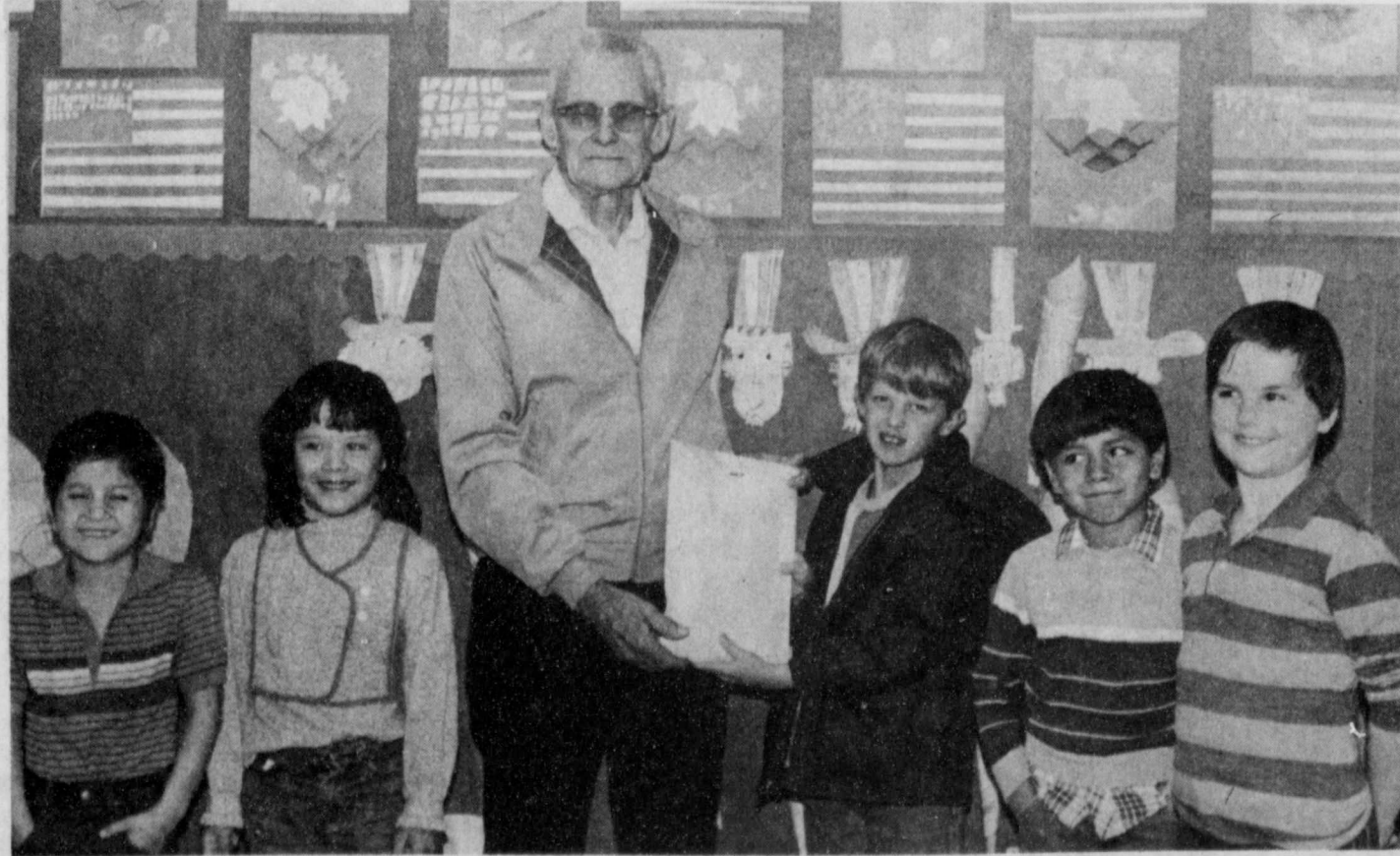
ture a calf, halter it, and drag it across the finish line receive a \$600.00 purchase certificate.

The certificate, donated by a sponsoring firm or individual, is used to purchase a registered beef or dairy heifer.

Each project is supervised by the vocational agriculture teacher or county extension agent.

Accurate financial records, along with a scrap book of essays and photographs detailing the project, are submitted.

Williams showed his calf scramble heifer at the Lockney Livestock Show and was awarded the Grand Champion Heifer ribbon. He placed third in the heifer division at the Floyd County Junior Livestock Show.

asking for the city to pay for all prisoners brought to the county jail, until they were arraigned. This would include medical treatment payments and liabilities. City attorney Paul Lyles then read an article concerning the same type of discussion that had been going on between the city of Lubbock and Lubbock county in which the city of Lubbock had asked for a ruling from the attorney general's office. The article stated that the attorney general's ruling stated that anytime the city arrests anyone, except on strictly city ordinances, they become the county's prisoner and the county is completely responsible for them, including liability. The ruling was based on state laws already established which sets the guidelines that jails have to operate under. Under the advisement of Attorney Lyles the council agreed to wait on a decision until he had a copy of the attorney general's opinion.

Councilmen also considered a contract from the county which released the county from any liability for work done on dirt roads in the city limits. The city of Lockney would then be responsible for picking up the liability on maintainers when inside the city limits.

Councilman Jerry Johnson stated that he had been told by a county commissioner that their insurance does not cover them inside the city limits and that it was illegal for them to grade the streets.

Council agreed that the city of Lockney could not afford to assume the liability. Mayor Smith agreed that he would ask for a copy of the county's insurance from Judge Hardin, for Attorney Paul Lyles to study.

Mayor Smith presented a request from the state that the nine manhole covers on Locust Street needed to be raised before they could seal coat the street. Council agreed to incorporate the expense (\$105.00 each) into next year's budget and fix the manholes.

All bills were paid by the city and financial statements were reviewed.

The council voted unanimously to amend the resolution which transferred Cable TV franchise to Mission Cable Co., accepted a contract for assessment and collection services with Floyd County Central Appraisal District, and passed a resolution stating that a tax will be levied on personal property on the 1989 City of Lockney Ad Valorem Tax Roll.

SPECIAL CALLED MEETING New Landfill Regulations

In a special called meeting on Monday, February 14, council agreed on a motion by Kenneth Wofford and seconded by Gary Marr, that the city landfill would remain open for three days a week. The days of operation will remain the same; Tuesday, Thursday,

and Saturday.

To eliminate confusion on who could use the landfill, a motion was made by Gary Marr and seconded by Jerry Johnson that only city residents residing in the city may dump trash generated in the city. No farm or county trash will be allowed.

Mayor Smith distributed a copy of the Information Guide on County Government, concerning county authority within city or town. Questioning whether it was illegal for the county to work on dirt roads inside the city limits, Mayor Smith referred the council members to Art. 6702-1; Sec. 2.010 (a) The commissioners court of a county may expend county funds to finance the construction, improvement, maintenance, or repair of a street or alley located in the county within the limits of an incorporated city or town if the work on the street or alley is done with the consent and approval of the governing body of the city or town. (c) The construction, improvement, maintenance, or repair may be done or financed: (c1) by the county through the use of county equipment; (2) by an independent contractor with whom the county has contracted or by the county as an independent contractor with the city; or (3) by the city or town, with the city or town to be reimbursed by the county.

The insurance policy regarding the county's liability inside city limits had not been studied by the city attorney at this time, but Councilman Wofford made a motion that under no conditions should the city assume the county liability. This was seconded by Ronnie Aston and passed unanimously.

The council then entered executive session to discuss the budget.

The drivers education fee was set at \$75.00 for in-district students. Students outside the district will be accepted on a spot available basis. Their fee will be \$175.00.

Athletic Director Jim Clark met with the board to discuss the purchase of athletic equipment that needs to be ordered now in order to be here when it is needed next fall. The board approved the expenditure. The money for this equipment is included in next years budget.

The board approved the contract with the appraisal district for the collecting and assessment of taxes on property through December 31, 1991.

In the superintendents report W. H. Hallmark reported that the storage building was up at the elementary school but that the floor is not finished as yet.

He reported on the various activities the teachers had been involved in. They have completed two in-service days on the gifted and talented program and the drug awareness program. Several teachers attended a gifted and talented workshop in Amarillo. Four English teachers will be attending a language workshop in Austin that is coming up soon.

Each school board member is required to have twenty hours of training and a six hour update each year. All board members attended the legislature network workshop that was held in Lubbock. Each received their six hours of training at this workshop.

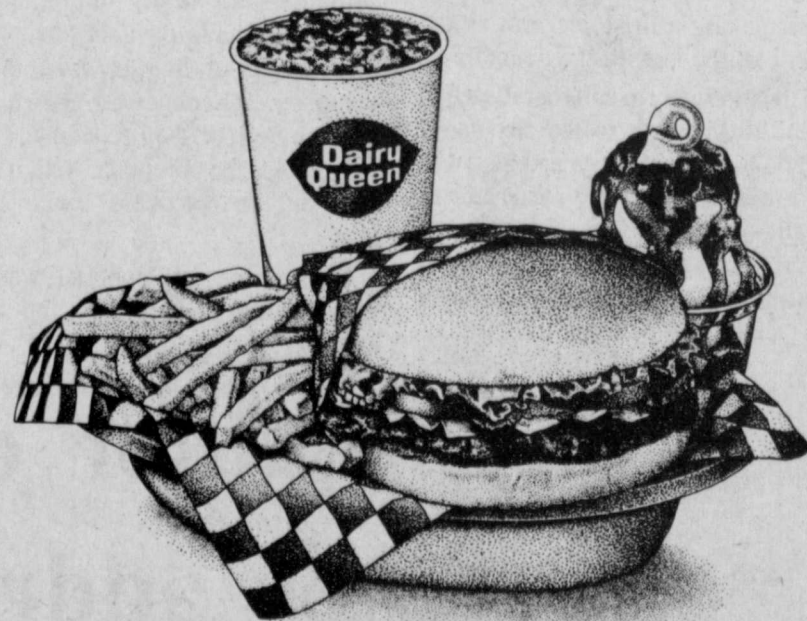
In routine action the board members approved the payment of current bills, making investments, the tax report and the minutes of the previous meeting.

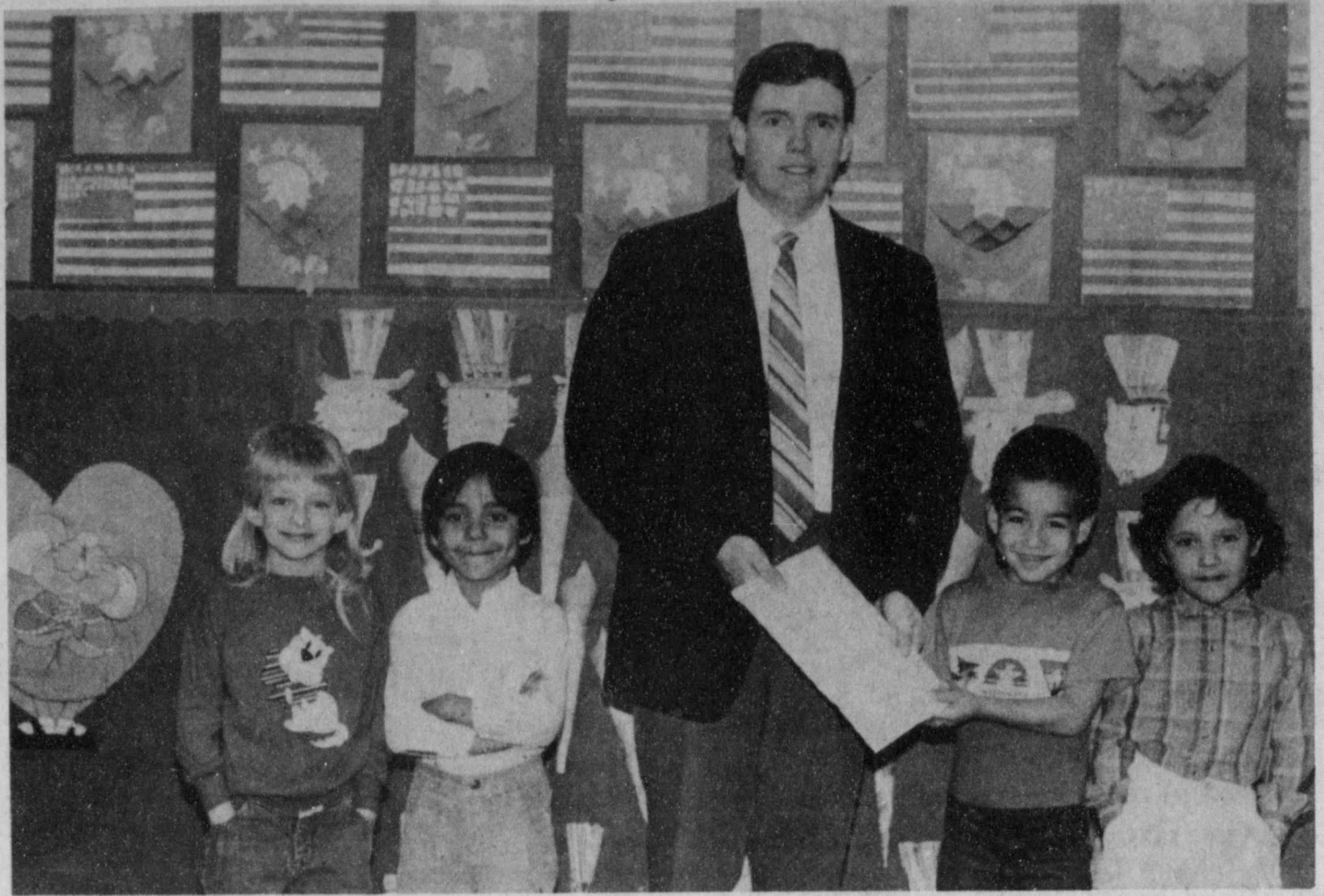

Methods of avoiding measles exposure

Are you concerned about the recent outbreak of measles in the Lubbock community? If so, a quick lesson in the control of communicable diseases might be in order. According to Donna Snow, R. N., nurse epidemiologist at Methodist Hospital, the most important thing to know about the measles is that an infected person may be contagious for several days before the rash appears. This contagious period could be exposing others without being aware he or she has the disease.

"The best prevention against contracting measles is still vaccination," says Snow, however, she adds that it is imperative that those who are less than 33 years-of-age who received the vaccine before 1980 be revaccinated. This precaution should ensure immunity to the disease. Another rather logical prevention is to stay away from crowded areas, especially places crowded with

those who have possibly been exposed to the disease.

Some common symptoms of the measles include: a runny nose, fever, watery or sensitive eyes, a sore throat, and finally, on about the fourth day, a red, itching rash. "If you have any of

these symptoms it would be a good idea to stay out of contact with others for a few days," advises Snow. If you have not developed a rash within four or five days, you can be relatively sure that you have only met with another, less serious culprit, the common cold.

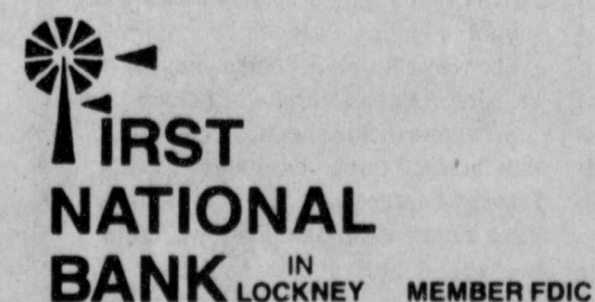
