



been done. Then, it is too late.

Surely, Congress will recognize that the recommendations of the Church Select Committee are foolhardy. As former Secretary of Defense Laird wisely points out, this is a time to strengthen and improve our intelligence system, not destroy it.

#### Wondering About Welfare

The subject of welfare inevitably raises hackles. Granted, there are some individuals in our society who genuinely need public assistance through no fault of their own. Few among us would deny them such assistance.

For those able-bodied adults in our society living off the majority of us who are wage-earners, however, our sympathy quickly comes to a screeching halt. What does welfare really do to such persons? And what does it do to a society that fosters lax handouts as a substitute for economic growth and real job opportunities?

These questions were met head-on recently in Washington when social philosopher Irving Kristol, a professor at New York University, spoke at at welfare conference. The conference was sponsored jointly by the American Enterprise Institute and Stanford University's Hoover Institution.


Kristol explained that New York City has abolished poverty, statistically, with a welfare family of four there now receiving \$7,000 annually in cash and in-kind transfers such as food stamps, medicaid, and subsidized housing. "So why hasn't anyone noticed?" asked Kristol.

"The reason for the paradoxical situation in New York City is that, for the non-aged and non-infirm, the way in which you abolish poverty turns out to be more important than whether you statistically abolish it, " he said. "What we have rediscovered in New York, " Kristol continued, "is (that); dependency tends to corrupt, and absolute dependency corrupts absolutely.

Kristol, who is also a journalist and author of numerous articles, said New York's welfare population in general, though no longer impoverished, "has sunk to various depths of social pathology." It is a "demoralized population" with higher rates of crime, alcoholism, drug addiction, juvenile delinquency and teen-age pregnancy than before the high benefits.

"We have redistributed income in New York all right, but it has not helped the poor one bit, " said Kristol.

His answer to the welfare dilemma is one we cannot argue with: Instead of welfare handouts, which tend to kill both self-initiative and self-pride, government and society should concentrate on giving the private sector the freedom and incentives necessary to expand businesses and create jobs. Furthermore, government should remove the able-bodied from the welfare rolls, and force them onto the job rolls.



Several homemakers have asked about ideas that will make spring cleaning easier. This weeks column will feature ways to save money on home cleaning products.

Cleaning on a shoestring can be approached two ways--from the standpoint of time or money. It is possible to create your own home-care products or to purchase commercial products. Home-created products often are less expensive but require more time to make.

Many cleaning products available today are basic ingredients that have been premixed, perfuned and packaged in aerosol cans or attractive bottles. These products may be more expensive but require less time for preparation.

When selecting commercial products, read the labels carefully since many products are abrasive and damage surfaces. Try creating your own homecare products. You may like them better.

Several basic ingredients are used frequently in home-care recipes. These include ammonia, vinegar, baking soda, washing soda, whiting, kerosene, turpentine, linseed oil and soap jelly. Look for them at supermarkets and paint, hardware or drug stores.

Remember: Never mix chlorine bleach or any cleaner with chlorine as an ingredient with ammonia or any other cleaner.


To make soap jelly use: 1 c. shaved bar soap or soap flakes

1 qt. boiling water Dissolve shaved soap or soap flakes in boiling water. When entirely melted or dissolved, pour into wide mouth jar. Let it stand in a cool place

until it jells. Try this homemade cleaner: 2 tblsp. ammonia 2 tblsp. liquid detergent 1 qt. water Mix and use for general household cleaning.

Try one of the following solutions to clean windows and mirrors:

(a) Add 4 tblsp. household


heat is upon us for several months, the daylight saving time provides an extra hour in the early morning for more out door garden-

During this time the watering problems is the most difficult to cope with. By the time the day is over, plants look as though it only as fast as the soil they had not been watered at all. Inspect your watering equipment to be sure it will be adequate for summer or as shrubs in the yard, watering needs. Some may need to be repaired or replaced. You may need a different type sprinkler, hose, coupler, or nozzle. Perhaps a perforated hose or soaker would perform certain tasks better, particularly when it is advisable to keep foliage dry. Where water pressure is adequate, a hose coupler

adds efficiency in supplying more coverage at one time. Is an oscillating, rotating, or stationary sprinkler adequate for your needs? Proper watering often depends on the use of the right nozzle or pressure breaker. For some jobs, such as washing dirt and spider mites from leaves, a heavy, powerful stream of water is required. Other jobs, such as wa-

tering plants in hanging baskets, need a pressure breaker to restrain the flow of water or reduce water pressure. Apply as much water as possible to do a thorough job, but apply is able to soak it up.
