Grisly scene processed

Authorities await forensic results

Officials with the Big Spring Police Department say an FBI evidence recovery team has wrapped up its part in the investigation of human remains discovered Tuesday and now it's a matter of waiting.

"That's basically the end of their involvement in the case," Sgt. Tony Everett, public information officer with the BSPD, said. "They come in, process the scene and then leave. Now the evidence has been sent to the medical examiner's office in Tarrant County and is in the hands of the pathologists."

Unfortunately, there's no way to know how long it will

take to receive results, Everett said.

Law enforcement officials were called to the grisly scene — located near the 2500 block of Apron Drive on McMahan-Wrinkle Airpark — Tuesday afternoon when employees of Desert Tank made the discovery.

"Dispatch received a call that human remains had been found in a pasture. The remains were found by workers in the area," Everett said. "Investigators have confirmed the remains are human, however, due to the condition of them, nothing else can really be established at this time, including age or gender."

"The area where the re-

mains were found was fenced and gated, but it could have been accessed. The body was obscured, but at least part of it was visible, which is what the workers saw, causing them to call 911. It was an area that isn't often traveled."

Everett said the lid from one of the large tanks at the scene was placed over the remains shortly after the discovery was made.

"We knew there was a storm coming in and we needed to protect the scene as much as possible," Everett said. "The lid was placed over the remains until the FBI team from Dallas could arrive."

Voter registration cards in the mail

As the maelstrom surrounding state redistricting begins to come to a close and the May 29 date for the political party primaries looks more

and more like it will be a reality, officials with the Howard County Elections Office continue to get ready.

County Elections Administrator Saundra Bloom said her office will likely be mailing out voter certificates by the end of this week, cards that would have normally been in the hands of Crossroads voters months ago if not for the recent hold up in Washington due to conflicts regarding newly drawn state district lines.

"Voters should receive them in the mail no later than the

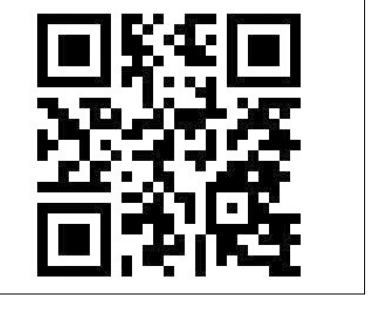
Snakes may be scarce

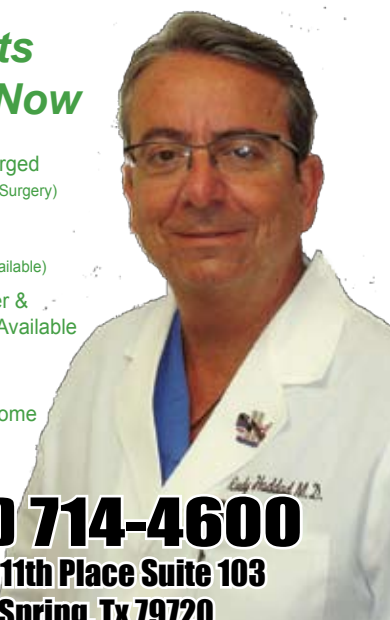

There are at least three high-profile missing person cases in the Crossroads area, all three of which are being thrust into the media spotlight with word of Tuesday's discovery.

Arlin Bynum, who was 40 years old at the time of his disappearance, was last seen Aug. 14, 2003, in the vicinity of the San Franciscan Bar and Grill, located in downtown Big Spring. According to police reports, witnesses claim he left the establishment late in the evening, supposedly accompanied by another man who has never been identified.

Bynum's truck was later found near the bar.

Repeated searches of Big Spring fields, pastures and scrublands have yet to turn up any indication what happened to Bynum, according to Big Spring police officials.

Also missing is Hailey Dunn of Colorado City, who was 13 at the time she disappeared. The teen was last seen in Colorado City on Dec. 27, 2010, when she told a family friend — former Big Spring resident Shawn Adkins — she was going to her father's home nearby and then on to spend the night at a friend's home.

According to investigators, she did neither. Billie Dunn, the girl's mother, said she last

saw her daughter at home the night of Dec. 26, nearly two days before she was reported missing.

The oldest of the three cases, is that of Bobby Marquez Jr., who has been missing approximately 14 years. In December 2006, the Texas Rangers, assisted by the BSPD and other law enforcement agencies, excavated a cement slab in the 1000 block of N.W. Second Street in hopes of recovering Marquez's remains. However, no body was found during the search, according to BSPD officials.

While numerous news outlets across the Permian Basin have already linked the discovery of the human remains Tuesday with the Dunn

missing person case, Everett said it is too early in the investigation to make any kind of conclusion regarding the identity of the remains.

"There is simply no way to know right now," Everett said. "We don't know what gender the remains are, so to speculate whether or not they are Hailey Dunn is pointless. Until the pathologists give us more information to go on, trying to say these remains belong to any of these missing persons is merely speculation."

middle of next week," Bloom said. "It's quite a relief for us to finally be able to get these to our local voters."

The U.S. Supreme Court on Jan. 20 threw out judge-drawn voting districts for this year's state and federal elections in Texas in a ruling that may help Republicans keep control of the U.S. House of Representatives. The justices unanimously told a lower court panel comprised of U.S. District Judge Orlando Garcia and two other judges to create maps more similar to the Republican-controlled state Legislature's plan.

The dispute stems from maps drawn last year by the Republican-controlled Texas Legislature after the 2010 census. Gov. Rick Perry signed the maps into law. The U.S. Supreme Court ruled Jan. 20 that federal judges in Texas overstepped their authority by drawing up interim voting plans.

In the meantime, Bloom said area residents should keep an eye on their mailboxes for their voter certificate — sometimes referred to as a voter registration cards — to make sure they are prepared for the primaries.

"If they don't receive them, they should call us so we can check the status," Bloom said. "Also, if they receive a card for someone who no longer

resides at that address, they should mark it 'return to sender' and mail it back. This is how we clean up the registration rolls."

Bloom said the redistricting issues aren't likely to have an effect on Howard County come election day, although at least one key piece of legislation has changed since this time last year.

"Last year, when folks were coming in to vote we were told to inform them about the Voter ID law, which was set to go into effect in time for these elections," Bloom said. "It would have required voters to present a photo ID before they could cast their ballot, and we wanted to prepare our local voters so it wouldn't come as a

big surprise this year.

"However, the Department of Justice has since rejected the state's Voter ID law, meaning it will not go into effect. Voters will be able to cast their ballot in the same manner they did last year. They are still required to register, as before, but the requirement to present a photo ID will not be in place."

Seats up for election in the 2012 election include 118th Judicial District Attorney, currently held by Hardy Wilkerson; Howard County sheriff, currently held by Stan Parker; county attorney, held by Joshua Hamby; tax assessor collector, held by Kathy Sayles; Precinct 3 county commissioner, held by Jimmie Long; and Precinct 1 county commissioner,

held by Emma Brown.

Parker has filed to run for re-election, as have Long, Green and Wilkerson. Parker has drawn an opponent in local resident M.O. Horton. The two will face off on the Republican ticket, according to election officials.

Brown has drawn a trio of challengers, as Howard County Jailer Larry Torres, former Big Spring Council member Oscar Garcia and Ed Ware, who has attempted to unseat the longtime commissioner previously, will face off for the Precinct 1 seat on the court.

Brown will face Torres in the Democratic primary, while Garcia and Ware will have to compete for the Republican nomination for

the seat.

Longtime Tax Collector and Assessor Kathy Sayles announced she will not be running for re-election. However, Diane Carter, an employee of tax collection office, will be running unopposed for the office on the Republican ticket.

Also running unopposed are Long, Green and Wilkerson. All three are running on the Republican ticket.

Barns. The show, held in the east barn, will be running from 10 a.m. to 6 p.m. Saturday and noon to 5 p.m. Sunday. It's the 48th edition of the event.

AMBUCS will be purchasing rattlesnakes all day Friday and on show days until about 4 p.m. Sunday. The process is pretty simple, according to long-time club member Dub Day.

"Hunters bring them in and we weigh them and put them in the holding pen," he said.

The payout this year

is \$9 a pound for anything longer than four-foot and \$6 a pound for anything shorter. The club also awards prizes of \$100, \$75 and \$50 for the biggest snakes and \$100 for the snake with the most rattlers. To enter, however, the snakes must be donated.

Organizers are anticipating a slow year this time around.

"We don't have the hunters like we used to because no one is picking it up as the hunters get older," said Day. "We usually just have two or three who bring them in anymore."

Day has been with the club and part of the roundup since 1980.

"One year we had

6,500 pounds of snakes but we've had as few as 200 pounds," he said. "This year, Sweetwater got way lower than they normally get and Brownwood was down, too, so I anticipate a down year.

That won't have any impact on the shows, though, Day assured.

"Oh no. We'll have plenty of snakes. We put on a good show. It's really something to see if you haven't been before," he said.

Jackie Bibby, "The Texas Snake Man," will be providing entertainment for those in attendance. He holds several world records, including being in a bathtub with the most snakes

and holding the most snakes in his mouth.

On an educational level, club members will be explaining what to do and what not to do when encountering a snake, as well as giving (venom) milking demonstrations.

Those attending will be able to purchase snake skins, mounted snakes and even snake meat, cooked up on the spot.

Tickets will be available at the door and are \$5 for adults and \$3 for children age 4 to 11.

An arts and crafts show will be held adjacent to the snake show and is free to the public.

One other important fact for anyone con-

sidering bringing in snakes to make a little extra cash — a hunting license and a non-game permit are required. They are available at Wal-Mart.

I don't like the memorial for Ike

When they decided to honor Dwight Eisenhower with a memorial in Washington, they did it up right. They hired perhaps our most famous architect, Frank Gehry, to design it. They picked out a place in the middle of the National Mall to put it. They bankrolled it at a cool \$112 million. Top shelf all the way.

The project only has one flaw: Nobody likes it.

The Eisenhower family in particular takes offense at the fact that its only statue of Ike portrays him as a young boy in Abilene, Kansas.

I can see their point. Eisenhower wasn't merely a two-term president, he was the military commander who led the Allied forces to victory over Nazi Germany — and he was the president of Columbia University, for crying out loud. And the best you can come with for his memorial is a statue of him as a kid?

My main objection to the project, however, is its size. It's big. It's hard to tell from the drawings, but it looks as though it's going to straddle the Mall down at the Capitol end, right around the Air and Space Museum.

The design calls for transparent woven metal tapestries that portray the Kansas plains to be hung between 80-foot columns,

sheltering young Ike as he dreams of future accomplishments.

It sounds like schlock to me, but it might be better than it sounds. Gehry really is a great architect, famous for his designs for the Guggenheim Museum Bilbao in Spain and the Walt Disney Concert Hall in Los Angeles, among other works.

But if you're going to do something that big, don't put it on the Mall, which is in danger of falling victim to grandiosity. As a matter of fact, it's already fallen.

When I came to Washington in the 1970s, there were three major monuments on or near the Mall — the Washington, the Lincoln, and the Jefferson. They were all big, yes, but not that big.

There were many smaller memorials scattered around the area — statues of Ulysses S. Grant, James Garfield, George Mason, John Paul Jones, as well as a World War I monument that was no bigger than a backyard gazebo — but the big three were dominant.

Then we remembered that we hadn't paid much attention to Vietnam vets when they came home, so they built the gorgeous Vietnam memorial in the shadow of the Lincoln Memorial: a long, black marble tombstone with the name of each American who died in the war. It remains the most moving memorial on the Mall or anywhere else.

But many felt it short-changed the contribution of women to the war, so they added a Vietnam Women's memorial nearby —

again a very good piece of work, resembling Michelangelo's Pietà. But that didn't satisfy the men, who demanded and got a handsome statue of soldiers in combat, also nearby.

Well, you can't honor Vietnam veterans and forget about Korea, can you? No. The Korean War Memorial was next, featuring a black marble wall, statues of a patrol of wary troops, and a reflecting pool. Each well done, but the effect is a little busy.

"What about us?" World War II veterans said. "World War II wasn't chopped liver, you know." So a huge Albert Speer-like plaza was plopped down at the end of the Lincoln reflecting pool, breaking the sight line between the Lincoln and Washington memorials.

Soon gigantic memorials you can land an airplane in were built down the block from the Jefferson to honor President Franklin D. Roosevelt and Martin Luther King, Jr.

Stop already. Does the Mall really need yet another monument the size of Pittsburgh?

Eisenhower was a great man, no question. But couldn't we make do with a nice, tasteful statue in a nice, quiet glade?

I shudder to think what they'll come up with when they get around to honoring Ronald Reagan.

Former FLDS leader's trial starts

MIDLAND, Texas (AP) — The bigamy trial of a former lieutenant to polygamist sect leader Warren Jeffs is set to begin.

Wendell Loy Nielsen is charged with three counts of bigamy. Opening arguments are scheduled for Thursday morning in Midland. Nielsen was one of 12 members of the Fundamentalist Church of Jesus Christ of Latter Day Saints who were indicted after a 2008 raid on their West Texas compound.

Nielsen faces up to 10 years in prison if convicted.

Nielsen was once FLDS president and counselor to Jeffs, who is now serving a life sentence after being convicted last year of sexual assault.

FLDS teachings hold that polygamy brings exaltation in heaven. The mainstream Mormon church abandoned the practice of taking multiple wives more than a century ago.

Court upholds ban on Texas immigrant housing law

DALLAS (AP) — A federal appeals court Wednesday upheld a lower court ruling that stopped a Dallas suburb's ban on illegal immigrants seeking housing.

The 5th U.S. Circuit Court of Appeals ruled that Farmers Branch overstepped its authority in 2008 when it passed a law calling on the city's building inspector to check the immigration status of anyone wanting to rent an apartment who wasn't a U.S. citizen.

Under the law, illegal immigrants would have been barred from rental housing, and landlords who knowingly allowed them to stay could have their rental licenses barred.

The appellate court said the city was seeking to exclude illegal immigrants, particularly Latinos, under the guise of policing housing.

"Because the sole purpose and effect of this ordinance is to target the presence of illegal aliens within the City of Farmers Branch and to cause their removal, it contravenes the federal government's exclusive authority over the regulation of immigration and the conditions of residence in this country," the court's opinion stated.

The city had appealed the decision of U.S. District Judge Jane J. Boyle, who ruled two years ago that the law is unconstitutional after a lawsuit was filed by apartment owners and tenants.

William Brewer, the lead attorney for the plaintiffs, said he sensed a "strong undercurrent" throughout the appellate court's decision that Farmers Branch was engaged in discrimination. The ruling is particularly meaningful because the 5th Circuit has a reputation for conservatism, he said.

Brewer noted that the ruling affirms Boyle's decision that Farmers Branch must pay the plaintiffs' attorney fees, which before the appeal were nearly \$2 million. He called that portion of the decision "a strong deterrent" against other cities seeking to pass similar laws.

"Clearly, both the trial court and the appellate court recognize that this ordinance was discriminatory," Brewer said.

Police: Suspect in killings planned mass shooting

WALLER, Texas (AP) — Authorities said Wednesday that a 22-year-old man charged with the fatal shootings of his parents and brother in their southeast Texas home had been planning a Columbine-style attack at a local school.

Houston television station KHOU reports (<http://bit.ly/GFKTFC>) that investigators said Trey Sesler confessed to killing his family members in the town of Waller because he didn't want them to be ashamed of what he planned to do.

Sesler was taken into custody Tuesday evening following the discovery earlier in the day of the bodies of his family members. He is being held in the Waller County Jail on \$3 million bail.

Authorities said Sesler claimed he had been shooting livestock to build up courage for the mass shooting he was planning. Investigators did not say what school Sesler was allegedly targeting and they were looking into whether he had any supporters or accomplices.

Waller police did not immediately return phone calls from The Associated Press.

Sesler maintained an active YouTube account on which he posted reviews of Japanese animation in which he called himself "Mr. Anime." There were also several videos that showed Sesler firing weapons.

"If you come to that point, what do you have on your mind?" Waller County Sheriff R. Glenn Smith told the television station. "I certainly don't think it was something that just happened, all of a sudden, in one bad argument. These kinds of things, probably something had been going on with this young man for a while."

Authorities were called to the family's home Tuesday afternoon after relatives grew worried because they hadn't heard from family members.

Police officers found the bodies of three people who appeared to have been killed by shots from a high-powered rifle, authorities said.

Waller Police Chief Phil Rehak said there was a tremendous amount of damage inside the home.

The victims were identified as Lawton Ray Sesler, Rhonda Wyse Sesler and 26-year-old son Mark Alan Sesler.

Waller is located about 40 miles northwest of Houston.

Liberty County standoff: 1 arrest, ammo seized

CLEVELAND, Texas (AP) — Officials say a standoff at a Southeast Texas mobile home has ended with one man arrested and the seizure of ammunition.

The Liberty County Sheriff's Office says the standoff near Cleveland ended peacefully Wednesday night. Sheriff's Capt. Rex Evans says a sweep of the residence turned up ammunition, wires and pipes.

Officers negotiated for a few hours to get several people in the residence to come out. Authorities then arrested one man on a felony warrant.

Further details on the warrant were not immediately available.

Moonshine operation broken up in East Texas

NEW CHAPEL HILL, Texas (AP) — Investigators say an alleged moonshine operation has been broken up in rural East Texas.

Smith County authorities on Wednesday confiscated two stills at a site near the town of New Chapel Hill and questioned a property owner. Authorities seized about 50 gallons of suspected homemade alcohol, propane tanks and glass containers.

Constable Dennis Taylor says a pint jar of moonshine sells for about \$100.

The Smith County Sheriff's Office did not immediately provide further information Thursday on any charges against the property owner.

The investigation began four months ago when a teenager was found passed out on the side of a road after allegedly drinking moonshine. Authorities say a tip led to some property where the stills were discovered.

New Chapel is located 100 miles southeast of Dallas.

Ex-South Texas deputy gets 11 years in drug case

McALLEN, Texas (AP) — A former sheriff's deputy in South Texas has been sentenced to 11 years in prison for trying to acquire and sell marijuana.

A federal judge in McAllen on Wednesday sentenced 41-year-old Heriberto Diaz of San Juan.

Jurors in October convicted the former Hidalgo

County sheriff's investigator of conspiracy to possess with intent to distribute marijuana.

Authorities say Diaz lied on numerous offense reports to hide his drug activity. Prosecutors say he also stole more than 350 pounds of marijuana from an alleged dealer by threatening to expose the operation.

Santorum to speak at San Antonio insurance company

SAN ANTONIO (AP) — Rick Santorum is taking a breather from furious campaigning in Louisiana to address an insurance company and hold a fundraiser in Texas.

The former Pennsylvania senator and Republican presidential hopeful is holding a series of Louisiana events ahead of that state's Saturday primary.

But he's heading into neighboring Texas today to address USAA in San Antonio.

USAA is a financial services and insurance giant that primarily serves military veterans and their families.

Santorum also has a fundraiser scheduled in Dallas before heading back to Louisiana.

White supremacist gang member guilty in beating

HOUSTON (AP) — A member of the white supremacist Aryan Brotherhood of Texas has been convicted of racketeering and aggravated assault charges in connection with the 2008 beating of a prospective gang member.

David Harlow and 11 other members of the brotherhood were accused of participating in the beating at the home of a gang leader. The other 11 pleaded guilty to violent crimes in aid of racketeering.

U.S. District Judge Ewing Werlein Jr. found the 43-year-old Harlow guilty Wednesday after a bench trial. Authorities say Harlow faces up to 20 years in prison.

Authorities say the Aryan Brotherhood of Texas was a prison gang formed in the early 1980s.

Southeast Texas man dies on flooded road

ORANGE, Texas (AP) — A 75-year-old man has died after driving off a road in Southeast Texas and into a ditch filled with water.

Beaumont television station KFDM reports that Appleton Lonnie Stroud is believed to have driven off a road in Orange sometime between Tuesday night and Wednesday morning.

The road and a nearby ditch were filled with water after storms that covered much of the state with rain.

Orange police found Stroud's car Wednesday morning. After relatives called to report him missing, authorities began searching for him and found his body about 100 feet away from his car.

Orange is about 110 miles east of Houston.

Students facing felony charges over alleged prank

EL PASO, Texas (AP) — Authorities say seven teenagers near El Paso face felony organized criminal activity charges after they allegedly broke into their high school dressed in penguin costumes and vandalized the building as part of a senior prank.

El Paso sheriff's office spokeswoman Eileen Lopez says six teenagers were arrested Monday and a seventh Tuesday.

A spokeswoman for the Clint school district says surveillance video captures the pranksters dressed as penguins, drawing graffiti on walls and putting glue in doors and light switches.

The students are charged with organized criminal activity-burglary of a building related to breaking into the school because the act involved three or more participants. Lopez says each student faces up to three years in prison, but a judge could impose stiffer sentences.

All the students are free on bond.

President in New Mexico to visit oil fields

MALJAMAR, N.M. (AP) — President Barack Obama traveled to the outskirts of a no-stop-light town in solid Republican territory Wednesday evening to promote his administration's commitment to continued increases in domestic oil and gas development.

Flanked by an idle oil pumpjack on federal lands in southeastern New Mexico's Permian Basin, Obama told a crowd gathered in a cold wind that his administration has opened millions of acres of public lands in 23 states to production, has increased access to potential offshore resources by 75 percent and recently approved drilling of a field in the Gulf of Mexico that has the potential to produce 400 million barrels of oil.

"If you hear anybody on TV saying that somehow we are against drilling for oil, then you'll know that they either don't know what they are talking about or they are not telling you the truth," he said. "We are drilling all over the place."

The president, who was accompanied by Interior Secretary Ken Salazar, also reiterated his commitment to bringing down gas prices through an "all-of-the-above" energy strategy that includes an increased focus on renewable energies.

But he said there is "no connection between the amount of oil and gas we drill in this country and the price of gas" because global demands from countries like Chi-

na are behind the rising prices.

Rep. Steve Pearce, R-N.M., and others disputed Obama's assertion

that his policies have increased production on federal lands.

"While oil production on private lands has in-

creased, according to the Institute of Energy Research, oil production on federal land was down 11 percent in

2011," Pearce said. Obama made the stop en route from a tour of the nation's largest solar plant in Nevada.

News in brief

French terror suspect shot in head by police

PARIS (AP) — A French prosecutor says that a gunman who claimed responsibility for a radical Islam-inspired killing spree was shot in the head by police.

Francois Molins says Mohamed Merah, a 23-year-old Frenchman of Algerian origin, filmed all three of his attacks in recent days that killed three Jewish schoolchildren, a rabbi and three paratroopers. Molins said Thursday that "everything was done to try to arrest him alive."

Police entered his apartment following a 32-hour standoff. Molins says the gunman came out of the bathroom shooting wildly and aggressively and was shot in the head as he jumped out of the window.

'Stand Your Ground Law' in Fla. gives people leeway to use deadly force; law being questioned

MIAMI (AP) — Florida is among 21 states with a "Stand Your Ground Law," which gives people wide latitude to use deadly force rather than retreat during a fight. The self-defense law helps explain why a neighborhood watch captain has not been arrested in the shooting death of an unarmed teenager.

The Florida law lets police officers on the scene decide whether they believe the self-defense claim. In many cases, the officer's defer to making the arrest, letting the courts work out whether the deadly force is justified. In this case, however, police have said they are confident they did the right thing by not charging 28-year-old George Zimmerman, a white Hispanic.

The shooting's racial overtones have sparked a national outcry and debate over whether the shooting was warranted. And like many self-defense cases, two sides of the story have emerged.

Zimmerman told police he was attacked by 17-year-old Trayvon Martin after he had given up chasing the boy and he was returning to his truck.

He had a bloody nose and blood on the back of his head, according to police. Martin's family questions Zimmerman's story, and believes if their races were reversed, there is no doubt a black shooter would be jailed, even if he claimed self-defense.

Americans, feeling pain at the gas pump unsure who to blame but want a government solution

LOS ANGELES (AP) — Families canceling vacations. Fishermen watching their profits burn up along with their boats' gasoline. Drivers buying only a few gallons of gas at a time because they can't afford to fill the tank.

From all corners of the country, Americans are irritated these days by record-high fuel prices that have soared above \$4 a gallon in some states and could top \$5 by summer. And the cost is becoming a political issue just as the presidential campaign kicks into high gear.

Some blame President Barack Obama. Some just cite "the government," while others believe it's the work of big, greedy oil companies. No matter who is responsible, almost everyone seems to want the government to do something, even if people aren't sure what, exactly, it should or can do.

A Gallup poll this month found 85 percent of U.S. adults believe the president and Congress "should take immediate actions to try to control the rising price of gas." An Associated Press-GfK poll last month showed 71 percent believe gas prices are a "very" or "extremely" important matter.

U.S. says 5 nations have cleared out their stocks of weapons-grade uranium ahead of Seoul summit

WASHINGTON (AP) — The U.S. has helped five nations completely clear out their stocks of highly enriched uranium since President Barack Obama outlined his plans for securing all weapons-usable materials worldwide, officials say, citing it as progress in the administration's efforts to prevent nuclear weapons from getting in terrorists' hands.

Anne Harrington, the National Nuclear Security Administration's nonproliferation chief, said that since Obama's April 2009 speech in Prague announcing his plans, the U.S. has helped remove enough material from about a dozen countries to make almost 30 warheads.

She added that several global leaders are expected to use a nuclear security summit in Seoul, South Korea, which starts Sunday, to announce similar advances.

Arms control experts say the most difficult part of building an atomic bomb is acquiring the weapons-grade uranium or plutonium needed for the explosive core of the weapon.

Locking up or eliminating these materials is crucial to preventing nuclear-armed terror.

Harrington said that's the administration's top national security concern: "Issue No. 1 ... above anything else, keeping this material out of the hands of terrorists," she said.

Over the past three years, officials say, the U.S. has helped Romania, Libya, Turkey, Chile and Serbia completely clear out their stockpiles of weapons-usable uranium.

They join 13 other nations that did so previously — Brazil, Bulgaria, Colombia, Denmark, Greece, Latvia, the Philippines, Portugal, Slovenia, South Korea, Spain, Sweden and Thailand.

Standoff between Egypt, Hamas leads to Gaza's worst energy crisis in years

GAZA CITY, Gaza Strip (AP) — A dispute between Egypt and Gaza's Hamas government has produced the worst energy crisis here in years: Gazans are enduring 18-hour-a-day blackouts, fuel is running low for hospital backup generators, raw sewage pours into the Mediterranean Sea for lack of treatment pumps and gas stations have shut down.

The fuel and electricity shortages, which have escalated over the past two months, are infuriating long-suffering Gazans who say their basic needs, perhaps more than ever, are being sacrificed for politics.

Unemployment applications hit 4-year low

WASHINGTON (AP) — The number of people seeking U.S. unemployment aid fell to a four-year low last week, bolstering the view that the job market is strengthening.

The Labor Department said Thursday that weekly applications dropped 5,000 to a seasonally adjusted 348,000. That's the lowest level since March 2008, just months into the Great Recession. The four-week average of applications, a less volatile measure, dipped to 355,000, matching a four-year low.

Applications have steadily declined since last fall. The drop has coincided with the best three months of hiring in two years. From December through February, employers added an average of 245,000 jobs per month. That's pushed down the unemployment rate to 8.3 percent, the lowest in three years.

The report suggests that employers added a similar level of jobs this month. This week's figures cover the same week that the Labor Department surveys companies about hiring in March.

Applications are slightly lower this week than in February's survey week, which points to more job growth.

"U.S. employment growth looks to have continued in March at a respectable pace," Jennifer Lee, an economist at BMO Capital Markets.

Companies are hiring more because the economy is picking up. The economy grew at an annual rate of 3 percent in the final three months of last year. That was better than the 1.7 percent rate in the previous quarter.

Opening lead — four of hearts.

Assume you're in six spades and West leads his singleton heart. You win East's nine with the ace and cash the A-K of trumps, hoping to find the suit divided 2-2. In that case, you could concede a heart and easily make the rest of the tricks.

But when East shows out on the second trump lead, you have to abandon this method of play because you

would automatically go down one after East took the heart at trick four and returned a heart, allowing West to score a trump trick.

One way of trying to salvage the contract would be to lead the queen of clubs at trick four, hoping West had the king and would be kind enough to take it. This would create a club entry to dummy's beautiful diamonds. But when you consider that West will almost surely see through your scheme and duck the queen, you should dismiss that idea.

Another possibility is to lead a low club toward dummy instead of leading the queen. This would succeed if West also played low, but if he put up the king and returned a trump, you'd eventually find yourself down three.

By far the best possibility, though not easy to think of, is to lead the six of trumps at trick four, purposely conceding a trick to West's ten!

This unusual play — deliberately losing a trump trick that you don't have to lose — has everything to recommend it. It is a perfect Greek gift, since it guarantees the slam. After taking the ten, West is forced to return a club or a diamond. Either way — and no matter who has the king of clubs — you are sure to score the rest of the tricks.

Saints' Payton suspended for season

The New Orleans Saints' crush-for-cash bounty system already cost them head coach Sean Payton for all of next season and general manager Mickey Loomis for half of it, plus two second-round draft picks and a \$500,000 fine.

Former Saints defensive coordinator Gregg Williams, who oversaw and contributed money to the illegal fund, was suspended indefinitely.

Unforgiving and unprecedented penalties Wednesday from an NFL determined to rid its sport of hits that aim to knock opponents out of a game.

Now Commissioner Roger Goodell will turn his attention to possible punishments for two dozen or so defensive players the league's investi-

gation found were involved in the extra payouts that he called "particularly unusual and egregious" and "totally unacceptable."

"We are all accountable and responsible for player health and safety and the integrity of the game. We will not tolerate conduct or a culture that undermines those priorities," said Goodell, whose league faces more than 20 concussion-related lawsuits brought by hundreds of former players. "No one is above the game or the rules that govern it."

The league is reviewing the case with the NFL Players Association before deciding what to do about players who were part of the Saints' scheme from 2009-11.

"While I will not address player conduct at this time, I am profoundly troubled by

the fact that players — including leaders among the defensive players — embraced this program so enthusiastically and participated with what appears to have been a deliberate lack of concern for the well-being of their fellow players," Goodell said.

Targeted players included quarterbacks Aaron Rodgers, Cam Newton, Brett Favre and Kurt Warner. "Knockouts" were worth \$1,500 and "cart-offs" \$1,000, with payments doubled or tripled for the playoffs.

According to the league, Saints defensive captain Jonathan Vilma offered \$10,000 to any player who knocked then-Vikings QB Favre out of the 2010 NFC championship game. The Saints were flagged for roughing Favre twice in that game, and the league later said they should

have received another penalty for a brutal high-low hit from Remi Ayodele and Bobby McCray that hurt Favre's ankle. He was able to finish the game, but the Saints won in overtime en route to the franchise's only Super Bowl.

"The bounty thing is completely unprofessional. I'm happy the league has made it known it won't be tolerated," said left tackle Jordan Gross, Newton's teammate on the Carolina Panthers. "To think that something like that would happen — guys trying to hurt someone to make a few extra bucks — is just appalling. I mean we have a lot of us. ... You don't want to see anyone taken out a game."

All payouts for specific performances in a game, including interceptions or causing fumbles, are against NFL

rules. The NFL warns teams against such practices before each season, although in the aftermath of the revelations about the Saints, current and former players and various teams talked about that sort of thing happening frequently — just not on the same scale as was found in New Orleans.

In a memo to the NFL's 32 teams, Goodell ordered owners to make sure their clubs are not offering bounties now. Each club's principal owner and head coach must certify in writing by March 30 that no pay-for-performance system exists.

Payton is the first head coach suspended by the league for any reason, while Loomis is believed to be the only GM.

Bryant, Gasol too much for Mavs

DALLAS (AP) — The Los Angeles Lakers expect offensive production from Kobe Bryant and Pau Gasol. Now they're learning what newcomer Ramon Sessions can do.

Bryant scored 30 points, Gasol added 27 points and nine rebounds, and the Lakers stopped the Dallas Mavericks' four-game winning streak with a 109-93 victory on Wednesday night.

Sessions contributed 17 points and nine assists in his fourth game since he was acquired in a trade with Cleveland on March 15.

Sessions' ability to penetrate into the heart of the defense led to points for himself and easy shots for teammates.

"The kid Sessions made the game easy for everybody," Lakers coach Mike Brown said. "He had a very good all-around game. You can see how his speed can help us, his ability to ... turn the corner and get into the teeth of the defense."

Gasol said Sessions brings something fresh to the mix.

"He definitely is a point guard that creates a lot of pick-and-rolls, and gets us in transition, too," said Gasol, who went 13 for 16 from the field. "He gets into the lane, and he can knock down the shot himself."

Sessions is learning the Lakers' offense on the fly.

"(Tuesday) night was the first time I was really in the game down the stretch, and I didn't feel I really knew the plays," Sessions said. "I went over them today, and I feel more confident now."

Dirk Nowitzki had 26 points and 10 rebounds, and Jason Terry scored 23 points for the defending NBA champion Mavericks, who fell to 0-3 against the Lakers this season.

The Lakers ended a two-game skid and have won six of eight overall. They were on the second leg of a back-to-back following Tuesday night's 107-104 loss at Houston.

The Lakers broke open the game with a 24-6 spurt in the second quarter, capped by consecutive 3-pointers from Matt Barnes and Sessions for a 51-38 advantage.

Barnes and Bryant added 3-pointers during the decisive run, with the Lakers building a 57-44 halftime edge.

Los Angeles shot 57 percent (25 for 44) in the first half, led by Gasol's 6 for 7 and Sessions' 5 for 6.

Bryant pulled off a spectacular three-point play midway through the third quarter, first spinning in a no-look reverse layup after Gasol's alley-oop pass. He was fouled on the attempt by Jason Kidd, and Bryant added a free throw that put his team in front, 69-55.

Dallas finished the third quarter with a 12-6 run to narrow the deficit to 80-72.

But the Lakers took control by opening the final quarter with a 10-4 spurt, capped by Gasol's 3-pointer with 8:04 left for a 90-76 lead.

"It was tough all night," Nowitzki said. "You give up (58 percent shooting by the Lakers) on your home floor, that won't cut it. Every time we made a little push, they answered."

Woods' health still in question

ORLANDO, Fla. — Three times in talking about his left Achilles tendon, Tiger Woods said he was "good to go."

How good?

Woods said it felt the same as it did before he had to withdraw midway through the final round at Doral two weeks ago, back when his health was not a popular topic. He had closed with a 62 in the Honda Classic. His game was on an upward trend, minus the winning.

How long can he go?

Not even Woods can answer that question.

One week after tightness in his Achilles caused him to grimace in pain, limp and then pull out after 11 holes at a World Golf Championship, Woods teed it up at Augusta National for a practice round. Turns out it was a mild strain, and a few days of treatment had him back to feeling normal.

Then, he played a two-day exhibition at Lake Nona, followed by the pro-am Wednesday at Bay Hill. He begins the Arnold Palmer Invitational on Thursday, and likely will wind up playing eight straight days.

Could the Achilles flare up again on Thursday at Bay Hill? Thursday at the Masters?

"It could," Woods said. "But hopefully, it won't."

The next step starts at Bay Hill, on a course where he has won six times. Woods is playing Thursday

morning alongside Ernie Els, who witnessed his 62 at the Honda Classic, and Hunter Mahan, with whom he shares a swing coach.

Since his return to golf after the crisis in his private life, Woods withdrew from The Players Championship in 2010 with a neck injury, though he didn't miss any time. Then, he spoke of a "minor injury" to his left leg suffered in the third round of the 2011 Masters that caused him to miss Quail Hollow. He returned at The Players Championship, felt problems in his left Achilles tendon on the opening tee shot and withdrew nine holes and 42 shots later.

He wound up missing three months, including two majors.

Woods had his third WD in as many years at Doral. In the previous 14 years on the PGA Tour, he had withdrawn from tournaments only twice — at Riviera in 2005 when he had the flu, and at Pebble Beach in 1998 when he chose not to return seven months later to complete the rain-plagued tournament.

"It was just tight when I was warming up," Woods said about Doral. "And I did my normal warm-up routine in the gym and everything, and everything was fine. I got to the range, started warming up, started getting tight. And as I said before, I've been through this before. I recognize the signs."

What gave him a sense of calm about the most recent calamity is having been down this road before.

Dear Annie: Five years ago, an encounter with a large, vicious dog put me in the ER and left me with lasting scars, physical and otherwise. I'm almost 20 now.

The fact that you can pet and play with small dogs is quite an achievement, all considered. If you regularly encounter larger dogs and wish to work on your fear, please know that low-cost therapy is available. Ask your doctor, and check your church and United Way. You can even search online for tips on overcoming phobias.

Dear Annie: I own property out of state. I use it mostly in the summer, but it's checked on

at least once a month. My neighbor there is married to a woman who is no longer friends with me, but we are civil to each other. "I've had tightness before, but not to that extent," Woods said. "But treatment afterwards always get it right back to where it should be. And that's one of the reasons why

I wasn't really that concerned about it, that I would come back and play these events."

Injuries have been such a big topic recently that Woods caused a stir in his pro-am when he backed off a tee shot on the par-5 sixth hole. He paced behind the ball, grabbed at his lower back and stretched. Then, he took his

hand off the club before finishing his swing, though the ball went long and straight.

The concern didn't last long.

Turns out it was a camera click that made Woods flinch.

"I guess one of the so-called professional photographers took a picture right in the

middle of my downswing," Woods said. "I stopped it, and then felt a pretty good twinge in my back. Walked it off and then tried to hit one down there. Hit it in the fairway, but didn't feel very good. But after a couple of holes, it loosened up. And I'm good to go now."

Woods has never missed

Bay Hill except for when he was returning from the crisis in his personal life in 2010. It typically is his final tuneup before the Masters, where he is a four-time champion.

Another four-time Augusta winner — and the tournament host at Bay Hill — is curious to see if Woods has the game for the first major.

Goodell also suspended assistant coach Joe Vitt for the first six games.

Payton, whose salary this season was to be at least \$6 million, ignored instructions from the NFL and Saints ownership to make sure bounties weren't being paid. The league also chastised him for choosing to "falsely deny that the program existed," and for trying to "encourage the false denials by instructing assistants to 'make sure our ducks are in a row.'"

All in all, Goodell's ruling is a real blow to the Saints, a franchise that Payton and quarterback Drew Brees revived and led to an NFL championship after decades of such futility that fans wore paper bags over their heads at home games.

Brees reacted quickly to the

news on Twitter, writing: "I am speechless. Sean Payton is a great man, coach, and mentor. ... I need to hear an explanation for this punishment."

The Saints now must decide who will coach the team in Payton's place — his suspension takes effect April 1 — and who will make roster moves while Loomis is out. There was no immediate word from the Saints, but two candidates to take over coaching duties are defensive coordinator Steve Spagnuolo and offensive coordinator Pete Carmichael Jr. Spagnuolo has NFL head coaching experience; Carmichael does not, but has been with the club since 2006.

When the NFL first made its investigation public on March 2, Williams admitted to — and apologized for — running the program while in charge of the Saints' defense. He was hired in January by the St. Louis Rams; head coach Jeff Fisher said

Wednesday he'll probably use a committee of coaches to replace Williams in 2012.

Goodell will review Williams' status after the upcoming season and decide whether he can return.

"I accept full responsibility for my actions," Williams said in a statement issued by the Rams. "I will continue to cooperate fully with the league and its investigation and ... I will do everything possible to re-earn the respect of my colleagues, the NFL and its players in hopes of returning to coaching in the future."

While some players who played for Williams elsewhere said he oversaw bounty systems there, too, the league said its interviews didn't find evidence that "programs at other clubs involved targeting opposing players or rewarding players for injuring an opponent." But Goodell could reopen the case if new information emerges.

(sore left knee) and Brendan Haywood (sprained right knee) each missed their third straight game. Dallas is also minus a third starter, Delonte West, who sat out his 18th straight game with a fractured right ring finger.

Marion tried to talk his way back into the lineup, but was overruled by coach Rick Carlisle and team medical personnel. Carlisle said it wouldn't be fair to Marion "to throw him out there against Kobe Bryant" after a layoff.

The Mavericks especially missed Marion's

defense against Bryant. In the first two meetings, Bryant went 11 for 37 from the floor and scored a total of 29 points with Marion as the primary defender.

This time, Bryant went 11 for 18, although Carlisle refused to use Marion's absence as an excuse.

"We can't bellyache about guys being out with injuries," Carlisle said. "It's one of the realities of the season. I'm not into that."

It was another tough night for former Laker Lamar Odom, who finished with one point, one rebound and one assist in almost 24 minutes.

"I'm not going to blame it on anything," Odom said.
