

BSPD detective arrested

Rojo accused of coercing females into compromising situations

The charges

• Sexual performance by a child (first degree felony)

• Indecency with a child (third degree felony)

• Three counts of official oppression (class A misdemeanors)

A Big Spring Police Department detective is free on bond after his arrest on multiple charges, including indecency with a child and sexual performance by a child.

Detective Joel Derek Rojo was arrested Wednesday morning and charged with the above-mentioned offenses, along with three counts of official oppression. He has subsequently been freed on bonds totaling \$90,000, according to an official at the Howard County Law Enforcement Center.

Rojo is charged with using his status as a police detective to induce three different females — on separate occasions between October 2014 and August 2015 — into "compromising and revealing positions," according to a joint statement by 118th District Attorney Hardy L. Wilkerson and Howard County Attorney Joshua Hamby. Two of his alleged victims were juveniles, with one being under the age of 14.

Wilkerson and Hamby convened a special session of the Howard County Grand Jury Monday, at which time the five indictments against Rojo were returned.

The indictments shed light on the exact nature of the charges:

Burglaries result in 5 arrests

Five Big Spring residents were in jail this morning waiting for arraignment after Big Spring Police were able to recover stolen items from two businesses Wednesday.

Around 6:30 a.m. Wednesday morning, Big Spring police officers responded to a call of a stolen vehicle at K.O. Construction located at 704 W. Third St.

"It was reported that someone had burglarized K.O. Construction ... and had stolen property and one of their company vehicles," stated Detective Sgt. Tony Everett in a news release. "The vehicle was equipped with G.P.S and with the help of company employees, officers were able to locate the vehicle and arrest the subject driving it." Adrian DeHoyos, 23, was arrested on a charge of unauthorized use of a motor vehicle "The stolen vehicle was a one ton truck with a flat bed and oilfield equipment was found to be missing from the truck," Everett said. "Again with help from company employees, officers used the information from the G.P.S and located stolen property in the 1400 block of W 5th." The investigation led to a search warrant for a travel trailer located in the 1400 block of W. 5th St. "While waiting for a search warrant, officers learned that A-1 Lock and Key at 812 W. 3rd had also been burglarized,' Everett stated. "Once the warrant was obtained officers found five subjects in

Chase suspect surrenders to authorities

The man who allegedly led Big Spring police on a search and pursuit for several hours in the Kentwood Addition turned himself into police custody Thursday.

Derrick Todd Drake, 30, of Big Spring remains in the Howard County Detention Center while he awaits arraignment on a warrant for evading arrest.

The incident occurred last Thursday around 8:40 a.m. when a Big Spring police officer was patrolling the area of 18th and Nolan. The officer noticed a black Jeep parked in the east alleyway of the 1600 block of S. Johnson, the release said.

When the officer approached the vehicle, two people, who were later identified as Drake and Victoria Diane Mendez, 24,



• Sexual performance by a child — On or about June 4, 2015, Rojo is accused of inducting a child younger than 14 years of age into exhibiting her breasts.

• Indecency with a child — On or about June 4, 2015, Rojo is accused of causing a child under the age of 17 to expose her genitals.

 Official oppression — On three occasions between June 2014 and August 2015, Rojo, "acting under the color of his employment as as a public servant," is accused of sexually harassing females by requesting to take photographs of a sexual nature.

If convicted of the firstdegree felony offense of sexual performance of a child charge, Rojo could be sentenced to between five and 99 years - or life — in prison. Official oppression is a Class A misdemeanor, punishable by up to a year in county jail, while indecency with a child is a third degree felony, punishable by up to 10 years in state prison.

Rojo's arrest came following a months-long investigation by the Texas Rangers at the behest of BSPD Chief Chad Williams.

The investigation was launched in August 2015, according to information released by the department.

"On (Aug. 20, 2015), during the afternoon hours, Chief Williams was contacted by an individual informing of allegations of possible misconduct by Joel Rojo," the BSPD statement reads. "The allegations were of such a serious concern, a preliminary investigation was immediately conducted at the request of Chief Williams by his administrative staff."

Rojo was placed on paid administrative leave the following day. Also that day, BSPD provided Texas Rangers with all information collected during the department's initial investigation.

During the course of a BSPD internal investigation into the matter, information surfaced in October 2015 regarding a second, similar accusation of misconduct by Rojo. A third allegation against the detective came to light soon afterward, BSPD noted.

Rojo has remained on leave administrative while the investigations continue.

BSPD officials declined any further comment on the matter.

Last week, for example, Clinton bragged about providing \$10 billion in grants that helped put 100,000 or so additional police officers on the streets. In 2014, "Washington Post" fact checker Glenn Kessler gave Clinton's claims about that program's impact "three Pinocchios," saying it "was not the primary or even secondary factor in the dramatic reduction in crime during the 1990s."

What about the crime bill's ban on so-called assault weapons, which expired in 2004? That year, a report commissioned by the Justice Department concluded that "we cannot clearly credit the ban with any of the nation's recent drop in gun violence."

Clinton also mentioned the 1993 Brady Bill, which required background checks for people who buy firearms from federally licensed dealers. According to research by Duke University criminologist Philip Cook, a gun control supporter, that requirement "made no discernible difference" in gun homicide rates.


Clinton did not cite incarceration as a factor in falling crime, because he was bending over backward to distance himself from that aspect of the 1994 bill. He said the bill's punitive provisions, which included new mandatory minimum sentences and subsidies for state prison construction that were contingent on passage of "truth in sentencing" laws (which limit or abolish parole), were forced

on him by Republicans. According to Clinton, Vice President Joseph Biden, then chairman of the Senate Judiciary Committee and the crime bill's main sponsor, told him, "You can't pass this bill, and the Republicans will kill it, if you don't put more sentencing in." Yet as first lady, Hillary Clinton cited tougher sentencing rules as one of the bill's main advantages, and after it passed, the administration bragged about making prison terms longer.

It seems likely that increased imprisonment did help reduce crime, if only by incapacitating people inclined to commit it. But the effectiveness of that policy depends on locking up the right people for the right amount of time, and Clinton now concedes that the sentences he supported as president went too far.

"I signed a bill that made the problem worse, and I want to admit it," he said during another visit to Philadelphia in 2015. "In that bill, there were longer sentences, and most of these people are in prison under state law, but the federal law set a trend. And that was overdone; we were wrong about that."

Clinton was in a less apologetic mood last week. Perhaps he was tired of overheated criticism that exaggerates his role in the explosive growth of the U.S. prison population, a trend that began a decade before he took office and occurred mainly at the state level. But if Clinton wants less blame, he should stop taking so much credit.



Anyhow, three days later, a Wisconsin circuit court judge struck down an anti-union law backed by Walker. The law ended unions' right to require that private-sector workers benefiting from their negotiations pay dues or an equivalent sum.

The ruling was hailed as a "victory for unions," but that victory will almost certainly be short-lived because the matter now heads to a divided state Supreme Court. As a Supreme Court justice, Kloppenburg could have helped save it.

Sanders can't directly take the rap for this. He, in fact, had endorsed Kloppenburg.

But the Sanders campaign rests on contempt for a Democratic establishment that backs people like Kloppenburg. It sees even the normal give-and-take of governing as thinly veiled corruption. Liberals involved in the necessary horse trading are dismissed as sullied beyond repair.

TV comedy news reinforces this cartoonish view of what governing entails. The entertainers deliver earnest but simpleminded sermons on how all but a chosen few folks in Washington are corrupt hypocrites. (I find their bleeped-out F-words so funny. Don't you?)

Snapchat liberals tend to buy into the "great man" theory of history. So if change comes from electing a white knight on a white horse, why bother with the down-ballot races?

Hence the irritating pro-Sanders poster: "Finally a reason to vote."

Oh? Weren't there reasons to vote all these years as tea party activists stocked Congress with crazy people? Wasn't giving President Obama a Congress he could work with a reason to vote? (The liberal savior in 2008, Obama saw his own Snapchat fan base evaporate come the midterms.)

When asked whether he'd raise money for other Democrats if he were to win the nomination, Sanders replied, "We'll see."







Coahoma at .500 in district after loss to Sonora

The Coahoma Bulldogs have beaten every team in their district so far this season. The problem? They've also lost to every team in their district.

The Bulldogs (11-9, 3-3) fell to the Sonora Broncos (5-9-1, 3-3) 11-3 Wednesday, giving them a win and a loss against each team in a district that also includes Reagan County and Colorado City. The game started on Tuesday, but play stopped with rain coming down and the Broncos up 6-3 in the fourth inning, which is where the game picked up Wednesday.

"We put ourselves behind the eight ball a little bit yesterday," Coahoma head coach Bryan Jacobs said. "I wasn't disappointed in our performance today. I thought we struck the ball pretty well. I thought we pitched pretty well. We were just a little too far behind and put ourselves in too big of a hole to climb our way out."

Coahoma's biggest issue in the loss was contact. Sonora pitcher Caleb Galvan struck out 13 Bulldogs and held Coahoma to just five hits in 25 at-bats.

"Their pitcher did a great job and he's one of the best in the district. He really changes it up and mixes it up well and I was just glad to see us hit quite a few balls hard today. A little bit here or there and those are line drives instead of popups," Jacobs said.

He continued, "I really like what some of our kids are doing at the plate, but we're still striking out too much and still failing to put the ball in play on a regular basis. And it's not a good formula for us because it seems like every time we get something going, there's a strikeout looming. And we have to overcome that."

Sonora's ability to put the bat on the ball was a big reason they were able to break through with 11 runs. The Broncos didn't always square up the bat with the ball, but the contact alone resulted in many bloop singles that were able to start and extend rallies.

"When there's a ball in play, you always have a chance. Whether it's looking for a second baseman to make an error or flipping the ball over the shortstop's head, or cheap hits. We did have good contact hits today, but we didn't have any cheap hits because we're either hitting the ball hard or we're striking out. It seems like there's no middle

ground," Jacbos said.

In total, Taylor finished with five innings pitched, giving up five earned runs on 10 hits while striking out six. Biddison pitched two innings, giving up two earned runs on four hits.

At the plate, Coahoma's five hits came from Braden Pearson, Logan Franklin, Jon Bermea, Zach Clark, and Andrew Martinez. Franklin and Bermea also finished with an RBI each.

Coahoma's next matchup will play a big role in

Golden State became the first team to win 73 games in a season, Warriors guard Stephen Curry scored 46 points and topped the 400 3-pointer mark to cap what will almost certainly be his second straight MVP campaign. Kobe Bryant's career with the Los Angeles Lakers ended in

"I think this has been an amazing day for sports fans, basketball fans in particular," Bryant said as he wore his Lakers' uniform about an hour after the game, not quite willing to take it off for the final time. "It's been a great day with them setting such an unbelievable record — you think about that, 73 wins, that's ridiculous. And then obviously what happened here tonight, it's been a great night in basketball history."

The Warriors beat the Memphis Grizzlies 125-104, finishing the season

lasted 20 years as the NBA's all-time singleseason standard. Steve Kerr played for that Bulls team, and was the one who went on to coach these Warriors to a level not even that club could reach.

Jordan congratulated the Warriors in a statement released after the game. He also said, "The Warriors have been a lot of fun to watch and I look forward to seeing what they do in the playoffs."

Curry made 10 3's to get to 402 for the season, officially wrapped up the NBA scoring title, and sent a message to the rest of the league going into the postseason — that the Warriors are far from satisfied, with Curry saying he was happy that all the team needs to worry about now is getting 16 postseason wins.

Somehow, the Warriors' 73-win record — "the new Golden Standard," the team called it - almost seemed overshadowed.

"Nobody really cares about the 73 wins it was all about Kobe today," Indiana guard C.J. Watson wrote on Twitter.

That's how impressive Bryant's last game was.

"There's no way I could possibly imagine this happening," Bryant said.

60 Bryant scored points and took 50 shots, the most of any game in his career — a total that came with the blessing

"Whoever paid those crazy ... prices for those tickets y'all got y'all money's worth tonight," Lakers guard Jordan Clarkson tweeted.

"The team held itself to a high standard throughout the season, playing with purpose every night and captivating fans around the world with its free-flow-

ing style, spectacular shooting and flair for the dramatic," Silver said. "Kudos to the entire Warriors organization."

Not long after Silver released his statement, the NBA put out its schedule for the first round that starts Saturday. The confetti that flew in Oakland was swept up, the champagne that was sprayed on Bryant after his finale had long dried.

The night was over.

The playoffs await for the Warriors, but not Bryant. His career is done, and his last act on the floor at Staples Center was a two-word farewell to Lakers fans:

"Mamba out."







World Bank pledges \$2.5 billion for teenage girls' education

WASHINGTON (AP) - The World Bank on Wednesday pledged \$2.5 billion to educate and empower adolescent girls in low-income countries as a way to improve their well-being and fight poverty.

Speaking at the spring meetings of the World Bank Group and the International Monetary World Bank Fund, President Jim Yong Kim said that enabling girls to attend school helps them delay marriage; have fewer, healthier and better educated children; get better jobs and earn money.

The funds will be allocated by 2020 and 75 percent of the money will go mostly to countries in Sub-Saharan Africa and South Asia.

"Unleashing the full economic potentials of half the population can drive the growth and prosperity of nations," Kim said. "Investing in girls and women is not only the right thing to do for them as individuals. It's also the smart thing to do for economies.
