Commissioners' Precinct Boundaries Challenged

Coke County commissioners were confronted with certified letter when they met Tuesday suggesting that commissioner precinct lines need to be redrawn in order to comply with the one person one vote principle. The letter further suggests that the precinct lines are "malapportioned as well as minimizing the impact of the Mexican American community in the electoral process.

The letter was addressed to County Judge D.W. Sims and was sent by Southwest Voter Registration Education Project. Signer of the letter was Rolando L. Rios, Director of Litigation. Also connected with the above-named organization is the Mexican American Legal Defense and Education-

The letter states: "To avoid any costly litigation to redistrict the commissioner precincts before the 1980 election process commences, we are placing our organizations at your disposal to assist you in adopting a redistricting plan which complies with the one person one vote principle and will provide Mexican Americans with greater access to the political process."

Judge Sims said he and the four commissioners have every intention of complying with the law as it regards commissioner boundaries and the rights of citizens. However, he said they all agreed that they would make no move to redistrict until they have been shown where they are not in compliance with the law.

County Attorney Bob Owen called the organization and reported the commissioners' court's position on the matter. Judge Sims said he has no reply, adding, "We won't take any action until we hear from them and until we are shown where we are not in compliance with the law."

In other business the commissioners:

* Tabled a request from General Telephone Co. for using county right-of-way for installation of telephone lines near Blackwell. The matter will be discussed again Monday and, in the meantime they are expecting a report as to exactly where the lines will be installed.

* Discussed an inquiry from a firm in Lancaster about building some hangars at the county airport west of Robert Lee. The commissioners passed an order for Judge Sims to investigate the matter before a decision will be made.

* Paid bills.

The court did not meet until Tuesday this week because of the Labor Day holiday. Second meeting of the month will be held Monday.

"We're trying to cut the red tape in this office, and we believe these face to face sessions with taxpayers help do just that," Bullock added.

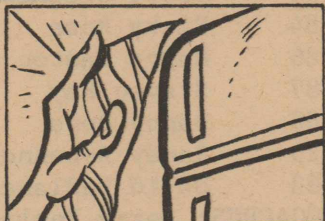
The San Angelo office, headed by Thomas M. Goff, serves San Angelo and surrounding counties.

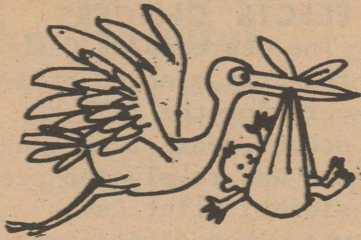

The chapter agreed to make a donation to the Tommy Bryant fund. The club also accepted the Cancer Drive as one of its service projects for the coming year.



QUARTERBACK CLUB ELECTS OFFICERS

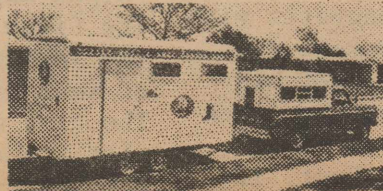

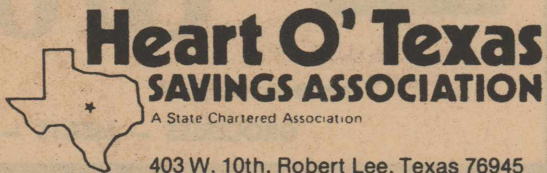

PUBLIC NOTICE

Senate Bill 621 as passed by the 66th Texas Legislature changes the property tax administration, mandated by the legislation on both State and local levels.

Effective January 1, 1980 an appraisal district is established in each county. Each appraisal district is governed by a board of five directors, serving two year terms beginning January 1 of even numbered years.

The governing boards of the school districts and incorporated cities and towns participating in the appraisal district will elect the directors under a system of cumulative voting.

The county commissioners, with the approval of the tax assessor-collector has the option of joining in the appraisal district and participate in the election of the district directors.

Under Sec. 6.03, which governs the selection of the board of directors certain duties are imposed upon the county clerk in determining who will be participating in the counties appraisal district, and to determine the voting entitlement of a participating taxing unit it is necessary for the county clerk to know the total dollar amount of property taxes imposed for the year 1978 by each political subdivision entitled to vote.

The following is a list of the political subdivisions entitled to vote and the dollar amount of property taxes imposed by each unit, which has been received by the county clerk of Coke County:

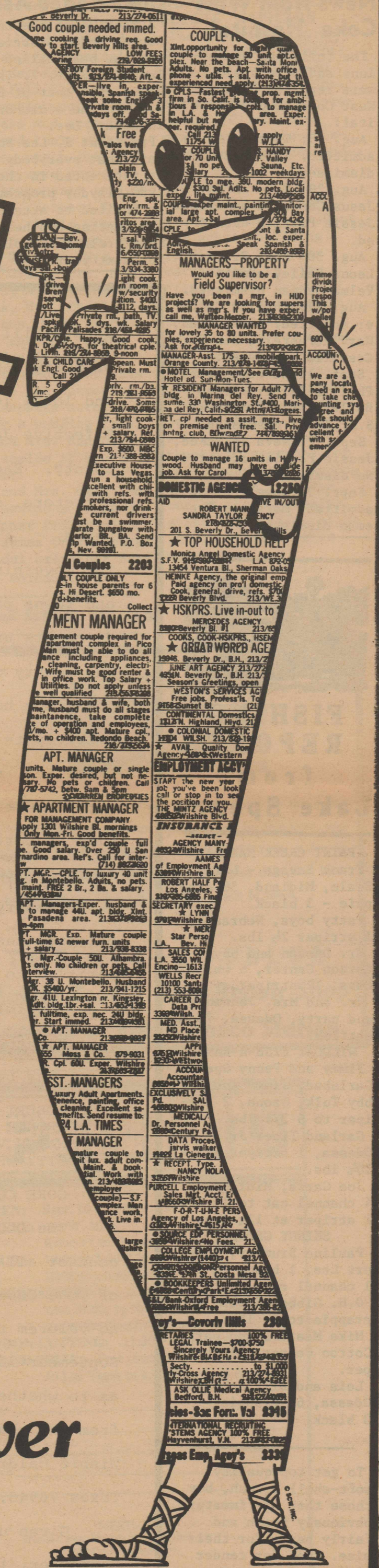

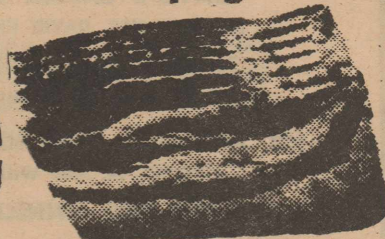
