## Star Lites

**IF YOU HEAR** strange, beeping noises these days when you come home from work, which sounds like ships from outer space have landed in your living room, that's a pretty good sign that your household was the recipient of one of the new video games this Christmas.

The Atari and other similar video games seem to have been among the most popular games this year for the gift-givers.

Kids of all ages (even those entering their second childhood) can play the games, although admittedly some of these, usually the younger and older ones, can't play them quite as well as others.

Virtually everywhere this writer went during the week or so following Christmas, people were talking about their new video games. "Have you played such-and-such on the video?" they would ask.

We had been hearing a lot about the new type of video pinball machines which have been sweeping the arcades across the nation. Apparently, the new home version of the games are a result of this earlier craze.

So, it may be that you'll have to get used to these new noises in the house. And if your game isn't quite as good as your young teenager's, perhaps you could sneak into the house the first time you have some free time and sharpen up your skills.

**THE RE-APPORTIONMENT** of the county, in order to get the four precincts as nearly equal, according to population, is causing considerable problems for our county commissioners' court.

Part of the problem lies in the fact that Precinct 1 (Friona's precinct), has roughly half of the county's population, and yet Friona isn't exactly near the geographical center of the county.

The first solution advanced by the law firm which the commissioners retained to re-draw county lines, was a situation which split the city of Bovina's voters and gave half of them to the Farwell precinct, and the other half to the Lazbuddie precinct.

Commissioner Jack Patterson, currently representing Bovina, would have had to annex the western part of Friona, and would have lost all of Bovina, under this original plan.

The Lazbuddie precinct, meanwhile, would have been roughly 50 per cent larger in size, in order to get this needed population, as decreed by Supreme Court decisions.

Another plan currently under study by the court, would leave all of Bovina intact in its voting precinct, and add a smaller portion of Friona to Patterson's precinct.

The Lazbuddie precinct would come up and take in a portion of the east side of Friona, in order to get its needed population. The Farwell precinct would be the least changed.

In order to keep the commissioners from having to add great chunks of road areas which they would have to maintain, the new proposal would allow the precinct line to follow a highway into towns, where the needed population would be annexed.

Under this second proposal, Friona would find itself included in three different voting precincts.

There are problems involved in redrawing the precinct lines, any way you go about it.

## Chamber To Conduct Membership Drive

The Friona Chamber of Commerce & Agriculture is kicking off a membership drive, in an effort to involve more people in the chamber's work, and at the same time help finance the chamber's programs.

In its meeting this week, the chamber board of directors listed the projects which the organization had sponsored during the calendar year 1981. It included:

The annual Chamber of Commerce banquet, including providing plaques for the outstanding citizens; the city's annual spring clean-up campaign; coordination of the city's July 4th program, including donation of \$898.90 to the fireworks fund.

Also, coordination of the Maize Days Festival, which included main sponsorship of the queen's pageant,

parade and barbecue; sponsorship of the Christmas lighting contest, in which prizes of \$325 were given; having Santa Claus in Friona, and providing Christmas ribbons to members.

In addition, during the year, the Chamber sponsored a "Meet the Candidate" program for school board and city council races, which proved very beneficial; board members attended two medical seminars in an effort to secure a doctor for Friona; correspondence was made with three prospective doctors; approximately 50 letters were answered during the year which sought information on Friona; and an additional 25 outside decorations were bought to supplement the city's Christmas decorations.

## Roberts Announces For Re-Election

Porter V. Roberts, who is in his third year as Parmer County Judge, announced this week that he would be a candidate for re-election, subject to the Democratic primary in May.

Roberts said in his statement:

"I am seeking re-election as County Judge of Parmer County. I have served one year as appointed County Judge and am now starting my second year after being elected to an unexpired term, so by the end of the year I will have served three years as County Judge of Parmer County."

"I was born and raised in Oklahoma, attended grade school in

Maud. The family then moved to Ada where I graduated from high school. After approximately three years in the Army, I attended East Central State College also at Ada. Since coming to Texas in 1949 I have worked for Southwestern Public Service Co. and Service Pipeline Co. I operated a furniture store for four years then worked 13 years as Tax Assessor-Collector for the Friona Independent School District and 2½ years with Gary Cook Oil Co., Inc. before being appointed County Judge upon the retirement of Judge Paul Fortenberry.

"My wife, Jean, and I have lived in Friona nearly 22 years. We have one daughter, Patricia, who now lives in Houston, and one son, Mike, who now lives in Dimmitt. We are members of the First Baptist Church of Friona.

"I am a member of the Friona Volunteer Fire Department, the Friona Lions Club (Evening), the Friona American Legion Post and the Friona Chamber of Commerce and Agriculture.

"In seeking re-election as County Judge of Parmer County, the only promise I will make is to try to do the best I can for the good of Parmer County. Your vote and influence will be greatly appreciated."

## Caution Is Urged In Re-Mapping

Parmer County Commissioners will meet at 11 a.m. Monday to finalize the re-drawing of the county's voting precincts, in order that the four precincts will have more equal population and all residents will be more equally represented.

However, the proposal which has been accepted by the commissioners has drawn fire from local political leaders.

Division of the city would possibly triple the expense in conducting elections, besides creating confusion as to which voting boxes the voter lived in.

Residents who are interested in the re-apportionment issue are urged to attend Monday's meeting.

What the proposal does is divide the city of Friona into three parts, with part of the city going to Precinct 2 (Jack Patterson), and a small part, on the eastern edge, going to Precinct 4 (Raymond McGehee).

After a prolonged discussion of the proposal on Monday, the court approved the proposal, but later discovered that the population as divided did not fit the requirements. Monday's meeting is designed to allow the commissioners to amend the motion.

County Judge Porter Roberts says that the re-apportionment issue is being pushed by a group which is plugging for minority interests.

The court needs, then, to be aware of the rights of the MAJORITY, as well as those of the minorities, while re-shaping the precincts.

There are definitely problems involved in re-drawing precinct lines, and the overall well-being of the county and its voters needs to be the overriding concern in the issue.

## City Awards Contract For Water Reservoir

The City of Friona awarded a contract on a 1,000,000 gallon water reservoir tank, to be located at the city's new water field 1½ miles northeast of the city limits, at a meeting of the City Council January 11.

Six bids were received on the project, with the one from Tank Builders, Inc., of Euless, Texas, accepted. The successful bidder was the lowest of the six, at \$148,884. Bids ranged up to a high of \$218,750.

The new reservoir is to be completed by July 1, 1982. It is part of a million-dollar water improvement program for the city, as approved in a 1979 bond issue.

In other business, the council approved the annual audit of the city's books, by Bernie Gowens, and payment of Gowens' fee was approved.

Carl White, manager of Friona Cablevision, appeared before the council, and explained that the recent increase in cable TV rates from \$8.95 to \$9.50 per month was necessitated

by increased costs of FCC copyrights. The expansion of HBO to 24 hours also brought an increase in fees from the originating company.

At the same time, White pointed out that the local cable television company had added ESPN, the full-time sports network, so subscribers are receiving an additional channel for their price increase.

Ordinance number 561 was read and approved, increasing the charges for burial spaces at Friona Cemetery, opening and closing a grave, and establishing special charges for burials on Saturdays, Sundays and holidays.

Nelson Welch, president of the board of governors of Prairie Acres Nursing Home reported that the nursing home had had an average occupancy of 59.26, or near capacity for the past month.

In an executive session, three applicants for the position of city manager were interviewed. Another applicant was interviewed on Wednesday, January 13.

## 55 YEARS AGO—JAN. 14, 1927

Material is on the ground, and workmen are employed at the erection of a new building in the south part of town. The new building will be used as a blacksmith shop, and operated by a man named Sylvester. Mr. Sylvester comes here from near Bovina.

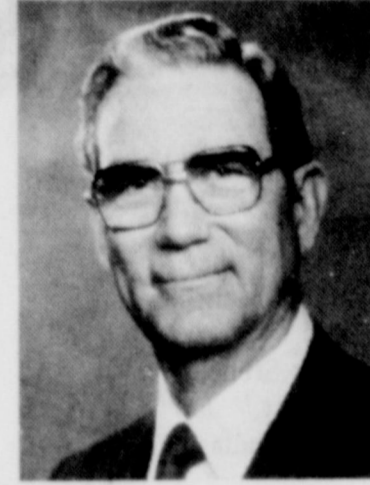

## SPS Names New Board Officials

Southwestern Public Service Company's board of directors today elected Berl M. Springer as chairman and chief executive officer. Bert Ballengee was named president and chief operating officer.

Springer succeeds Roy Tolk, who will remain as a member of the Company's board. Prior to his promotion, Springer had served as president since 1976 and was named chief executive officer in early 1981. Ballengee had served as executive vice president since 1979.

Springer is a Memphis, Texas, native and industrial engineering graduate of Texas Tech University. He started his SPS career as a draftsman in 1948. He later became a statistician-engineer, rate engineer, and rate manager, before being elected vice president of rates and budgets in 1969. He was named executive vice president in 1972, and joined the board of directors in 1974.

Springer has been active in many civic and business affairs and has served as president of the Amarillo Chamber of Commerce, co-chairman of the United Way, member of the President's Council at West Texas State University and at Texas Tech University, and a director of the National Food and Energy Council. Springer received the "Distinguished Engineer" award from Texas Tech in 1975.

An Amarillo native, Ballengee earned a business administration degree at the University of Texas, and began work at Southwestern as an accounting department clerk in 1949. In 1951, he was advanced to chief clerk, and was appointed personnel manager in 1957. With the acquisition of the Company's first data processing capability in 1961, Ballengee became Southwestern's first director of data processing. He was named director of finance in 1972, and assumed the responsibilities of financial vice president in 1973.

Ballengee's activities in community and business affairs have included: executive board member of the Boy Scouts of America and of the Amarillo United Way, member of Amarillo Community Council, and

the administrative board of the Polk Street Methodist Church. He was elected to the First National Bank of Amarillo board of directors in November, 1981.

Also in its meeting, after the annual shareholders meeting today at the firm's headquarters in Amarillo, Texas, the board declared a regular quarterly dividend of 37½ cents per share on the Company's common stock and regular quarterly dividends on all series of preferred stock.

The common stock dividend is payable March 1, 1982, to holders of record at the close of business on February 16, 1982. The preferred stock dividends are payable May 31, 1982, to holders of record at the close of business on April 20, 1982.

Southwestern Public Service primarily provides electric utility service to a population of more than 1 million in a 45,000-square-mile area of the Panhandle and south plains of Texas, eastern and southeastern New Mexico, the Oklahoma Panhandle and southwestern Kansas.

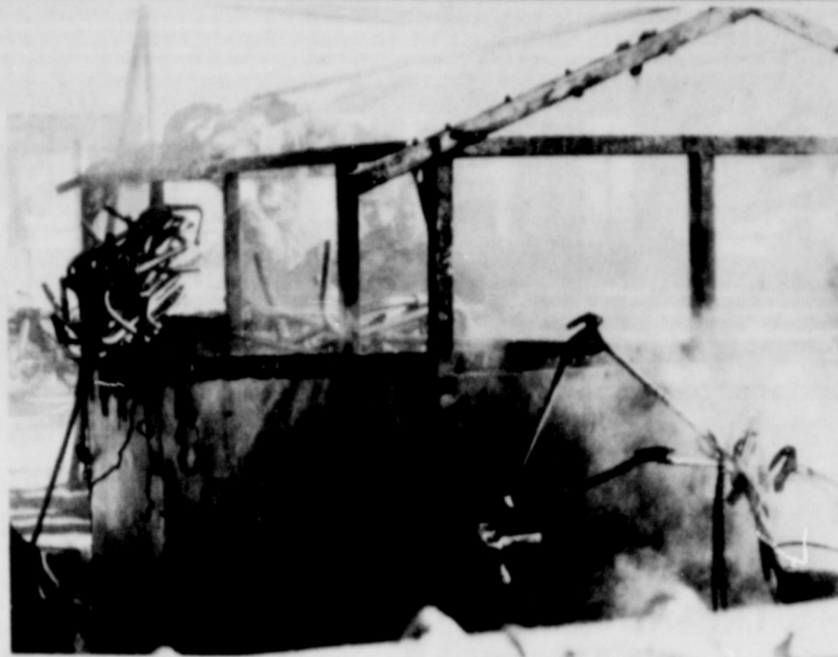

## Appraisal Dist. Begins Tax Collection Feb. 1

The Parmer County Appraisal District will start collecting delinquent taxes February 1, 1982, for the following Taxing Units: County of Parmer, City of Farwell, Farwell Hospital District, City of Bovina, Bovina I.S.D., City of Friona, Friona I.S.D., Lazbuddie I.S.D. and High Plains Underground Water District.

The date to start collecting for the Farwell I.S.D. will be July 1, 1982.

Effective January 1, 1982, taxes which become delinquent will incur a penalty of up to 12 per cent and interest at a rate of 12 per cent per annum. Exemption; Implements of Farming & Ranching Exemption; Solar & Wind powered energy Devices Exemptions; Cemeteries Exemption; Historic Sites Exemptions; Miscellaneous Exemptions under Sec. 11.23 Property Tax Code; and 1-D Agricultural Land Exemptions.

## Water Level Is Subject Of HPWD

The High Plains Water District has begun its annual program of measuring the depth to water levels in more than 900 observation wells scattered throughout the fifteen county District area.

Parmer County irrigators may see a blue and white Water District vehicle in the vicinity of their property in the coming weeks while Ken Carver and Jerry Funck of the District staff measure the 97 wells in the District's observation network in Parmer County.

Since most of the wells to be measured are operational irrigation wells, the month of January was chosen to begin observations in order to allow for a dormant period and well recovery from the cone of depression developed during the pumping season. Wells will be measured to find the depth to "static" water level. After measuring, each well will receive a red District identification tag for the owner's information.

Data gained from this program is used for decline rate projections, determining the amount of water left in storage, and very importantly, as a basis for the income-tax depletion allowance claims on landowner's tax returns.

The annual measurement program is expected to be completed in February, weather permitting. Data on individual wells will be available within a few days of completed readings, but tabulated data on the entire network is not expected until mid-year.

Neill broke a scoring drought for

Friona with a pair of free throws with 1:19 showing on the clock to give Friona a 47-44 lead.

Both teams went a full minute without scoring, setting up a frantic final 30 seconds of the game. Shepherd scored with 15 seconds left to cut the lead back to one at 47-46. Neill missed a chance to ice the game with 11 seconds left when he missed the front end of a 1-1 free throw opportunity.

However, Chisom did the same thing after being fouled by Brady on the rebound, or Bovina could have taken the lead. That left it up to Brady to make a pair of free throws with five seconds left, for a 49-46 edge. Friona then let the Ponies score an uncontested basket at the buzzer for the final margin.

Neill's 16 points paced the Chiefs, with Brady and Caballero adding eight apiece. Chisom scored 18 and Ricky Shepherd 16 for the Mustangs.

As an interesting sidelight, Friona began its scoring by hitting a technical foul shot brought about by the visitors having an incorrect number listed for one of their starters. In the final analysis, this point turned out to be the difference in the game.

## Hance Warns Of Potential Ag Disaster

U.S. Rep. Kent Hance (D-Tx.) has predicted a major depression in the West Texas agri-business economy if the Farmers Home Administration (FmHA) takes certain actions over the next few months.

"It is rumored that almost 1,000 potential farm foreclosures or liquidations will be activated in West Texas farming communities," said Hance. "This could trigger similar actions in other agriculture financial areas to double this number of foreclosures or liquidations and make the farm picture extremely bleak for the next two years."

"For those of us who understand agriculture, this will affect virtually every business and family in West Texas. We could easily experience a situation like the great Depression and the President needs to take immediate action to attack the

problem as such."

"The President knows I am unilaterally opposed to his line of reasoning regarding the farm program," Hance said. "But the way the picture looks now there is little hope of help from the President. The Farm Bill which Congress is considering is a total disaster. I voted against it in the House and unless the President can be urged to reconsider his stand I will strongly oppose the farm bill on final passage."

The Texas congressman was especially critical of the recent efforts by the Administration to increase foreign aid and food stamp appropriation while maintaining a hard line regarding farm policy; all within four weeks of abandoning a goal of a balanced budget by 1984.

"The President and his advisors opposed us on an amendment by Congressman (Charles) Stenholm which would have provided for a mandatory crop set-aside program, without subsidy, and would have saved almost \$2 billion in 1982 in addition to helping the farm economy."

"The present farm policy of the President has only added to the problems brought on by the farm policies of the past three Presidents in which a cheap raw materials line of reasoning has been favored at the expense of our farmers. Every major agricultural country in the world protects its farmers better than does the United States under the present line of thinking. We have not had an adequate farm program in the past five years and under the present thinking in Washington the prospects for any improvement in the foreseeable future are dim."

"One of the ways we can solve our budget problems is by creating a strong farm program whereby our farmers can make a decent living by supplying food and fiber for the world. When the farmers are operating at a profit they pay additional taxes and this would also greatly help in balancing the budget."

"The FmHA officials have assured me they are going to try to work out financial programs with the good management farmers to help keep some of them in operation," Hance added. "But the picture looks very bleak unless we can change farm policy thinking with the President and his major advisors."

Kookaburras are thin cookie wafers with caramel in between and are covered in chocolate. Hoedowns combine peanut creme and chocolate with a cookie crunch. Also, Mints, Savannahs, Scot-teas, Dutch-n-Such, and Chocolate and Vanilla Cremes will be sold again this year. Each box of cookies will sell for \$2.00.

All money collected from the cookie sale remains in the Council. It will help support seminars, workshops and other troop and council sponsored activities. 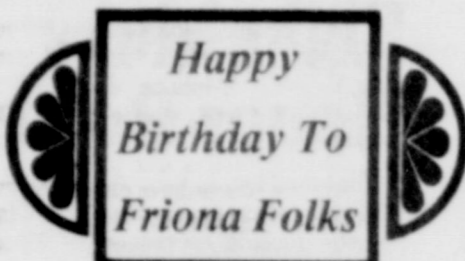

## Max Sherman Seeks Attorney General Post

Former State Senator Max Sherman has announced that he will seek the office of Texas Attorney General subject to the May Democratic primary.

Sherman represented the 26-county Panhandle district in the Senate from 1971 to 1977. He resigned from the Senate to become president of West Texas State University. He will resign that position effective January 16.

In seeking the office of Attorney General, Sherman has pledged "to run the best law office possible" and "to remember that the goal of this office is to serve the people and not add to the burden of government."

Sherman's tenure at West Texas State University near Amarillo has been characterized by efforts to streamline the administration, cut costs where possible, and promote efficiency; these same efforts are those which he stated he will pursue as the state's top legal office-holder.

As a result of Sherman's leadership at West Texas State, the University was recognized as one of the universities in the nation best able to meet the challenges of the 1980's. Under his administration, the University stabilized enrollments and established several scholarship programs aimed at promoting academic excellence.

While president of West Texas State, Sherman served as chairman of

the Governor's Higher Education Management Effectiveness Council. He has chaired the Governor's Energy Advisory Council, the Texas Mining Council, and the Texas Law Review Association. He is also chairman of the American Association of State Colleges and Universities Committee on State Relations.

As a state senator, Sherman was noted for his fairness, hard work, and level-headed approach to legislation. He chaired the Natural Resources Committee and served on the Jurisprudence and Finance Committees. *Texas Monthly* magazine named Sherman one of the Ten Best Texas Legislators in 1973, 1975, and 1977. In 1977, the magazine called him "the unanimous choice as the best member of the Legislature."

Sherman is a graduate of Baylor University and the University of Texas Law School. His legal career began in Amarillo, where he was an attorney and partner with a law firm; here he concentrated on trial and appellate work. He has remained active in the State Bar Association and serves as a member of the Board of Visitors at the University of Texas School of Law.

He has also been active in many church and civic activities in the Amarillo area.

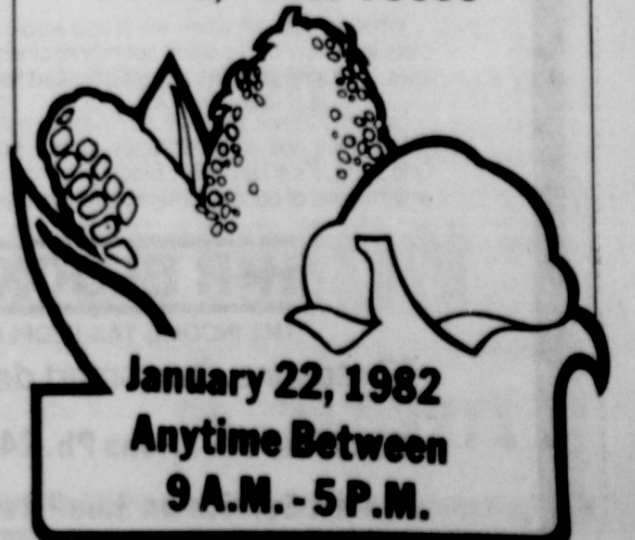

### Estimated Tax Installment Due

The fourth, and final, installment of estimated Federal tax payments on 1981 individual income is due by January 15, 1982, the Internal Revenue Service says.

This installment should be paid using declaration voucher number four found in the Form 1040-ES package, "Declaration of Estimated Tax for Individuals."

Taxpayers whose anticipated income changed during 1981 may have to file an amended declaration. Space is provided in the estimated tax package to compute an amended estimate.


