

Novel Ideas Are Demonstrated In Making of Salads

Do you know how to make a Ruggedy Ann salad? The Dougherty Home Demonstration Club learned how to make this and several other salads in a demonstration given by Mrs. Harry Morckel at a meeting held July 16, in the home of Mrs. Robert Ward.

Mrs. Morckel began her demonstration by giving the club a few facts about salads. She stated that today a salad is a must and is a handy way of providing variety and nutrition to our meals.

The four types of salads she gave were: appetizer or cocktail; meal-in-one salad; accompaniment salad; and the dessert salad.

After cleverly demonstrating these Mrs. Morckel prepared an unusual Ruggedy Ann salad plate. In this salad plate a boiled egg was used for the head, a tomato for the blouse with olives for buttons, salad for petticoat, ham for a skirt, cloves for eyes, mustard seeds for the nose, pimento for the mouth, asparagus or pepper for the arms and legs, and grated cheese for the hair.

This salad is a cute idea for a children's party.

Mrs. Morckel had prepared a "rainbow cake" salad which makes an attractive and colorful dessert salad.

She also told the club of some various helpful hints she had encountered.

After Mrs. Morckel's demonstration, Mrs. Claude Ring explained three different ways to freeze cantaloupes. She brought cantaloupes prepared the three ways, so the club could choose which they liked best.

THE COUNTRY EDITOR

ONE OF THE most vital races in Saturday's Democratic primary is that of State Senator. There is much more involved than mere personality. Since the issues have been clouded by gossip, slander, false rumors and even defamation of character, the voter has a tremendous personal responsibility to sift truth from fiction, prejudice from objective appraisal, and fact from fancy.

WE ARE NOT supporting Senator Andy Rogers, the incumbent, because we think he is perfect, because he has pleased us all the time, because we think he is the only resident of the 30th Senatorial district capable of serving with ability and integrity. We are supporting him because he towers head and shoulders above the two men who now seek his place in the Senate. So completely objectionable are the other two men, in our opinion, that we would have to scratch both names if the name of Senator Rogers did not appear on the ballot.

HERE ARE SOME of our reasons for having to support Rogers. He is the incumbent, having served only one complete term in the senate, and it is our belief that an incumbent deserves re-election unless there is a good reason why he should not be re-elected. In the case of a Senator, seniority is of utmost importance. It would be extremely unwise for a district to throw its seniority in the Senate to the wind. Senator Rogers already has the job. We owe nothing to a person, even a friend, who covets the job of his neighbor.

Secondly, anyone who studies Rogers' record carefully will soon find that he thinks like the typical resident of the 30th district. We have not always seen eye to eye with Rogers on every issue that has come up, in fact, on occasion we have attacked some of his decisions editorially—but we have approved his actions in a huge majority of cases. In voting, our choice is not to select the perfect candidate, according to our own specifications—our choice is to vote for the man who most nearly reaches perfection.

While Senator Rogers' batting average in the Senate is high, in our opinion, the voting records of his opponents are completely unpalatable in too many instances.

ONE OF ROGERS' opponents has represented big business interests, including the utilities monopoly, much more effectively than he has represented the farmers and smalltown businessmen of the 30th district.

The other man in the race, when he was in the Legislature, voted for exempting utility companies from the license fee (required of other appliance dealers) for the privilege of selling gas and electric appliances, parts and repairs in towns of 2,000 or less. He voted for a two per cent gross receipts tax on soft drink bottles which Gov. Shivers offered. It was adopted 15-16, so his was the key vote. Later, the Senate reversed itself and killed this tax. He also voted to table Aiken's effort to reduce this bottle's tax to one per cent. Then Aiken tried to exempt milk from the bottle's tax and this candidate voted not to exempt milk.

THIS CANDIDATE introduced a bill to give the state a first lien on any property owned by old-age assistance recipients and to require that it be foreclosed on their deaths and the state welfare department would get back all they had been paid. This idea has been pushed by anti-pension folks ever since. He also introduced a bill requiring sale, distribution or possession of oleomargarine which hurts every cotton farmer. And most objectionable of all, he supported a two per cent state income tax proposal!

THIS MAN who is Senator Rogers, the incumbent, is much better qualified to serve an agricultural district than either of his opponents. Ask any informed farmer who is familiar with REA and other major farm problems. Ask informed leaders of any farm organization who have had occasion to make trips to Austin in the interest of farm problems.

IN THE THIRD place, we would have to vote for Andy Rogers because the special interest groups, the gas pipeline group, the ut-

ilities monopoly, the anti-farm group, those who would like to have federal and state control of underground water, those who consistently try to keep the lid on Austin scandals, those who do not want practitioners of the healing arts controlled or licensed by the state, those who have proved themselves enemies of the Farm to Market road program, those who abhor independent thinking, those who try to tell legislators to get on their team or else they will have to smear them, all have combined to try to move heaven and earth to defeat Senator Rogers. Rogers has been threatened by these interests which warned him not to run. He was told to be a good boy, to go back to Childress and settle down, and he wouldn't be hurt by the character assassins and gangsters who have a great deal of influence in Austin.

Perhaps Rogers would have retired to go back to Childress and make a living for his family had he not been threatened as he was. But there is something in a red-blooded American that causes him not to yield to gangster tactics. So Rogers defied the warnings.

We need more men like Rogers in Austin, men who will put principle above politics, men who will not sacrifice honor for expediency. Men like Rogers are and will be in a minority for some time, but at least they will speak out against corruption so we can hear. This race, from the time it started with the mailing of anonymous smear literature, has been one of the filthiest races in the history of Texas politics.

We have had "Port Arthur" type stories in circulation almost weekly since early spring. Some of the false stories planted here and there have been petty. Others have been outright libelous. They include, for example, the testimony of a former medical doctor who lost his license, who has served numerous terms in the penitentiaries in several states including Florida, Maryland and Oklahoma, who is at present under indictment for performing an abortion in a Dallas tourist court, who perjured himself when under oath he voluntarily made statements a week apart in direct conflict, who was convicted three times for being a confidence man.

Yet there are those having an interest in getting Rogers out of the Senate who produce a completely false statement signed by this character in trouble up to his neck which they expect people to believe in preference to the word of Senator Rogers, other members of the Legislature, official records in Austin, and even newspapers and public officials who have not been particularly friendly to Senator Rogers. And, strangely enough, one of the men attempting to unseat Senator Rogers served on the House investigating committee and would have had access to the official records which, had they contained information adversely affecting the senator, would have made a perfect rope with which to hang Rogers. Yet, instead of bringing about the prosecution of Senator Rogers, had there been any basis for doing so, he does nothing about it. Either this man is guilty of negligence of duty or the whispered charges against Senator Rogers are complete fabrications.

ALL OF THESE false stories, planted and distributed, appeal only to "the moron vote" because of their utter absurdity.

As a Tulla pastor told us when we showed him some of the smear literature now in circulation against Senator Rogers, "When I see something like that, it spurs me on to vote for the man who has been slandered and wronged."

ARE WE TO assume that Rogers' opposition has so little to offer the voters of this district that they must base their campaigns on such things as the testimony of an ex-con, and a several-times loser, and also other stories of equal veracity?

Andy Rogers' life is an open book. If there exists adverse information concerning his character not available to the public, certainly it has been available to those trying so hard to discredit him. They have proved during this campaign that they have keys to many doors in Austin.

The issue in this race is Andy Rogers and his record vs. a cesspool full of slanderous accusations. Let all honest men and women of the district turn a deaf ear to vile gossip brought out during the closing hours of a political campaign.

Floydada Fire Boys Attending School at A&M

Production of a training film for firefighters and a course in fire pump maintenance are new features of the 24th annual Firemen's Training School under way this week at Texas A. and M. College. The school, sponsored by the State Firemen's Extension Service, Texas A. and M. College System, is geared to handle some 1,500 firemen and fire marshals from 435 Texas cities.

Billy Jo Baker, Elvis Warren, O. F. Smith, members of the Floydada Fire Department, and Lowell Bliley of the Lockney Fire Department, are at the school for training firemen. They left Saturday and plan to be home Saturday.

The film, which will show proper techniques in approaching, entering and extinguishing residential-type fires, will be in color and will run about 14 minutes.

Courses offered include general basic firefighting, advanced firefighting, fire officers training, industrial fire protection, armed services fire protection, basic fire marshals, advanced fire marshals and instructor's courses. All courses will be 30 hours of instruction. Each

firefighter will select a course and will receive instruction in all phases of that particular course. Visiting firemen will be using some of the latest equipment available. A new fire entry suit will permit a fireman to walk directly into 3,000° heat without any discomfort. The firemen also will watch a 1,300 pound container of dry chemical powder wipe out a 600 square foot gasoline fire in a matter of 3 or 4 seconds.

Firefighting training will include airplane fires, remote control elevated ladder nozzle, a fixed fire protection system with the alarm operated with CO₂, oil and gas fires, residential fires and chemical fires.

STATE CAPITAL Highlights AND Sidelights

Focus of interest in house -- wherever a man stands in a little pasteboard booth with a piece of paper and a blunt pencil. In the booth is a man who looks like an average, un-important sort of guy. Chances are he's not very rich, not very interested in politics, as a rule. But John Q. Poll-Tax-Fayer is the most important man in Texas this week. With a few strokes of his pencil Saturday, he'll decide who'll be who in Texas for the next two years or more.

When John Q. glances down the ballot, he may see a number of names he's never heard of. He'll pause, scratch his head, wonder which name "sounds best," finally shrug, make a mark and go on. Such a possibility gives office seekers the cold shivers. For fear their names may yet be unknown to some, they'll try to be everywhere, at once this week.

In addition, a lot of people will be pleading with John Q. to come back to the polling place Saturday evening for his Democratic precinct convention. Gov. Price Daniel, supported by moderate-conservative party officials, is asking him to come and vote for "majority rule."

Opposing the governor are the liberal Democrats of Texas who want John to join their drive to assure that "only real Democrats shall participate in Democratic party affairs."

Nobody can positively predict what John will do. Past records show that some years he feels liberal; some years, conservative. And some years, both ways at the same time.

Oil Quota Up Again -- Texas oil allowable for August will be 328,185 barrels a day more than for July -- a hopeful sign for an industry that's been "in the dumps" for more than a year.

Railroad Commission set next month's allowable at 2,976,068 barrels daily. Number of producing days will be increased from 9 to 11. Last month production rose from 3 all time low of 8 days.

Reason for the increase was not a much the disturbance in the oil-producing Middle East, said one commissioner, as the fact that Texas had finally reduced its excess oil stocks to correct levels.

Insurance Board Upheld -- State Insurance Board finally scored a technical knock-out in its prolonged out with an Austin district judge.

Texas Supreme Court ruled that Judge Charles O. Betts did not have authority to name V. F. Taylor receiver for insurance cases in his court. High court says the receiver must be the state liquidator appointed by the Insurance Board.

Board had appointed C. H. Lang-deau as state liquidator. Judge Betts said he did not regard Lang-deau as acceptable. He named Taylor receiver for cases in his court.

Supreme Court also ruled void Betts' action in raising salaries of liquidator attorneys working on cases in his court.

Division of authority between the courts and Insurance Department over insurance company liquidation has been a source of dissension for years.

50-50 Plan -- State Highway Department will reimburse cities and counties half the court costs of securing land for state and U. S. highway building.

Up until last year costs of obtaining right of way were borne solely by local governments. Last Legislature passed a law authorizing the state to share the cost 50-50 with cities and counties. At first this was construed to mean the state would pay half the cost of purchasing the land. Now it has been expanding to include half court costs and appraisers fees.

More Prison Cotton -- An increase of 10 per cent has been ordered in the Texas Prison System's cotton acreage allotment.

Officials of the Texas system had been actively dissatisfied, contending the prison farms had been dealt a bigger-than-average cut. Less production means less money for operating the prisons, they pointed out, and, hence, greater cost to Texas taxpayers.

On their behalf, the Texas Attorney General's Department appealed to the Agricultural Stabilization Committee and, finally, to federal court.

Adjustment obtained will mean 384 more acres of prison cotton can be harvested. It'll save \$100,000 in tax money, prison officials estimate.

City Tax Proposals -- City officials are laying plans to ask the next Legislature to extend and adjust city taxing powers.

Legislative committee of the League of Texas Municipalities has drawn up a two-pronged proposal to:

1. Allow cities to broaden their tax base and lighten the burden on property owners.
2. Substitute another tax to be collected at time of auto registration for the present "unworkable" School Fund Fight -- A rough-and-tumble time can be expected next year when lawmakers consider just how permanent the permanent school fund should be.

Rep. Louis Dugas of Orange has announced he will introduce a bill which would allow the state to use part of the revenue from school lands for current expenses instead of putting it all into the permanent fund.

Dugas was author of a bill last session to divert 1 per cent of the permanent fund each year to the available fund.

State School Board and numerous other school officials have come out strongly against all moves to lap the schools' multi-million-dollar endowment. They compare it to "sating the seed corn."





Pittard Views Plains Program

COLLEGE STATION — Over one and one-half million dollars is being paid to landowners in the Plains area of Texas through the Great Plains Conservation Program, according to Lynn Pittard, extension assistant soil and water conservation specialist.

"This is a voluntary program which applies to 98 counties in the Plains area, says Pittard. It provides cost-share assistance for any approved soil and water conservation practice. Operators may receive up to 80 percent assistance, depending on the practice. Contracts are signed for 3 to 10 years duration.

Pittard points out that most any practice dealing with soil or water conservation will be approved. Some of the practices now underway are reseeded to grass cultivated land that is actually unsuitable for cultivation, brush control, stubble mulching and deferred grazing.

Since the program started in late February, he says 303 contracts, including 56,814 acres, have been signed. "This means that payments averaged \$2.55 per acre."

The 86th Conservation Service handles the administration of the program. More information about it may be obtained from local county agricultural agents.

LOCAL WOMAN WITNESS TO ELDORADO, KANS. TORNADO

It develops that Floydada had an eye-witness within five blocks of the terrific tornado that swept through Eldorado, Kans., the latter part of June.

Certificates of Taxes Paid Are Honored by City

New property assessed in the City of Floyd will bring total valuations on the city rolls up in an amount to add about \$1,000 in tax money to the city's tax income this year. City Secretary Lewis Norman estimates. Exact figures were not available.

The board of equalization, Fred Batten and Lane Decker, Sixty-odd property owners had adjustments to make in their returns. The board completed its labors early in the month.

The city council in their regular meeting last week adopted a resolution asking the Floyd County Commissioners Court to join them in a plea to the State Highway Department to take over the maintenance of the Twelfth Street paving from its confluence with Highway 207 at Missouri Street, south to 20th Street, north of Highway 70. This 2,700 foot strip of paving is carrying increasingly heavy through traffic. The city is unable to cope with the maintenance problem, the council indicated.

To Honor Certificates

At the council meeting last week the board adopted a minute instructing the city secretary to honor all outstanding certificates of taxes paid issued by the city. Fourteen taxpayers were included in a list who will benefit from this order. The order will also take care of any others who may hold certificates of like kind.

Collections on delinquent tax rolls had shown a total of about \$2,350 the latter part of last week the city secretary's office disclosed. Secretary Lewis Norman said the original delinquent list of approximately \$23,000, is now below \$20,500. The completion of the delinquent tax roll late in May was followed by notices to owners whose property was affected.

The new tax record set up at a cost of about \$650 is expected to be invaluable in keeping current records on all property and reduce errors to the minimum.

Figures as of the first of this week on delinquent water and light bills stood at \$6,135.23, according to the secretary's records.

Must Hold Down State Spending, Declares Ramsey

AUSTIN — Lieutenant Governor Ramsey says holding public spending down is the paramount job in state government during the next few years.

"The future of our state," Ramsey said, "depends upon containing the size of state government to a safe level. We should have no additional or new taxes until the need is absolutely proven."

Speaking in West Texas and the Panhandle, in behalf of his candidacy for re-election, Ramsey said, "We ought to look twice at every dollar we are spending now. We must take three or four close, hard looks," he said, "at any new program that would mean new taxes."

He pointed out that these are times of stress and provoking situations. "It is no time," stated the Lieutenant Governor, "for governmental experiments or for political opportunists in Austin."

On the question of holding down spending Ramsey warned that "Big spending means high taxes. And on that issue, I stand squarely on the side of the taxpayer."

Ramsey, who has received editorial endorsement of sixty-six daily and weekly newspapers, is seeking another two-year term as Lieutenant Governor. "It will be my purpose," said Ramsey, "to draw upon my experience and provide you with calm, steady leadership toward good sound government."



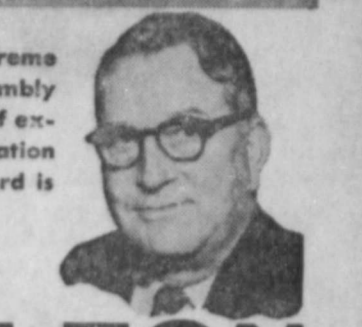
