Feeder Loans Are First To Be Passed Upon By New Federal Livestock Bank

FORT WORTH, Oct. 3. —A loan committee to pass upon applications of the tenth district agricultural credit corporation for funds for livestock feeding and agricultural purposes was named as directors met here recently for formal organization of the body.

The committee is composed of T. R. Yarbrough, regional president; A. K. Thomas, John T. Jones, and Raymond Gee, Fort Worth; and F. F. Florence and Frank P. Holland, Dallas.

Approval of loan applications by the committee will be final with no action by the board of directors or the Reconstruction Finance Corporation at Washington required.

When applications are approved checks for the funds will be issued upon the treasury of the United States.

The directors elected J. R. Pratt Jr., cashier of the Stamford State Bank as secretary-treasurer of the regional corporation. An assistant manager and an assistant treasurer are to be named later.

The corporation is ready to receive applications for loans and will be prepared to issue funds in response to them as soon as offices are installed this week.

The last Friday of each month was set for the date for regular meetings of the board of directors.

Legal counsel for the corporation was announced, will be appointed at Washington.

First relief efforts of the corporation, the directors announced, will be directed at supplying funds for livestock feeding to provide means for disposal of the Fall feed crop without sale on the open market.

Other agricultural loans will be taken up as soon as the corporation is in a position to do so.

The directors emphasized that it is the intention to assist the small livestock feeder, as well as those engaged in feeding enterprises on a large scale, by making money available for finishing small herds of livestock for the market.

SALE OF SCHREINER MOHAIR TWO CENTS ABOVE SPRING CLIP

KERRVILLE, Texas, Oct. 5.—The Schreiner Wool and Mohair Commission Company has sold its entire clip of Fall mohair to Tom Richey, representing Hilliard & Son of Boston, at eight cents for the grown hair and 25 cents for kid hair.

The entire clip amounted to about 1,600,000 pounds. This was an advance in price of two cents a pound over the Spring clip, which brought six and 23 cents, respectively.

Dryden Rancher Victim Of Second Mishap On Horse

Howard Roberts, who ranches near Dryden, suffered a fractured knee-cap Sunday afternoon when his horse bogged down with him on his ranch. Mr. Roberts was out in the pasture several miles from his ranch home when the accident occurred. Aid was summoned from his brother's ranch, Ross Roberts and he was brought into this city for medical treatment.

Due to the heavy roads it was 10 o'clock Sunday night before he reached this city after the accident which occurred that afternoon about 3 o'clock.

He was taken to Del Rio on the early morning train Monday by his brother Ross Roberts, where he will remain until injuries are healed.

X-ray pictures of the break show that the segments of the bone are widely separated, and attending physicians stated that an operation would have to be performed soon as the tissues return to normal.

This is the second fracture of the knee-cap Roberts has had within a year.

MISSING STOCKTON MAN FOUND 'STUCK IN MUD' AT PECOS

FORT STOCKTON, Oct. 3. (AP)—R. E. Ellis, wealthy Fort Stockton business man who had been missing since Wednesday while rewards totaling \$1,000 were offered to anyone who found him, was found placidly waiting between Pecos and Fort Stockton where his automobile was stuck in the mud.

Ellis' automobile was sighted by the pilot of one of two airplanes sent out to search for him. It had been bogged down at the side of a draw about 15 miles north of Fort Stockton. Heavy rains recently had made roads in this section almost impassable.

Ellis was in the best of health and spirits. Friends said he walked to a neighboring ranch house where there was no telephone, when his car stuck in the mud.

NAMED RELIEF CHAIRMAN FOR FEDERAL LOAN

To Furnish Information To West Texas C. of C. On Applications

Joe Kerr has been designated by Wilbur C. Hawk, President of the West Texas Chamber of Commerce, to serve as Governor R. S. Sterling's representative in the preparation and submission of Sanderson's application for funds out of the \$200,000,000 provided by the Federal Emergency Relief and Construction Act of 1932.

The West Texas Chamber of Commerce has been charged by the Governor with the responsibility of naming the chairmen in each town and county in its territory and assembling the applications from the towns. The directors of the affiliated towns have been named as chairmen.

Already application blanks and instructions have gone out to the two hundred towns, cities, and one hundred thirty counties in West Texas from the office of the West Texas chamber of Commerce at Stamford.

Assistance in making out the applications is to be given by the regional organization. General Manager D. A. Bandeen, at Stamford, will devote most of his time during the next two weeks in assisting towns and counties in that part of West Texas in making the applications. The same service will be given to the Panhandle-Plains cities by Assistant Manager Maury Hopkins at Plainview. Jack Holt, Manager of the Fort Worth Chamber of Commerce, will assist at Fort Worth, and Captain E. H. Simons, Manager of the El Paso Chamber of Commerce, in that part of the territory.

Applications for the relief must be made through the West Texas Chamber of Commerce and must be filed by October 13 in order to give the organization time to transmit them to the Governor before October 15. The Governor will make application for the State of Texas on October 15.

The funds to be applied for now are for the months of October, November and December. The amount will be based upon the amounts that have been spent for relief and relief work by the respective applicant cities during the past twenty-one months, or since January 1, 1931.

The wrecked buildings were proclaimed a public menace by Mayor Valdez after several had collapsed, endangering pedestrians.

LIMPIA CANYON FLOODS WIPE OUT ALL HIGHWAYS

FORT DAVIS, Texas, Oct. 3.—Rain fell here Friday. Limpia canyon was reported to be as high in flood as it was a month ago when road damage was estimated at \$8,600. The State appropriated that amount for repairs. Little damage was done this time because the dirt approaches to the new concrete bridges had not been replaced since being washed out in August, and a new road that has been built since was out of the flood's reach. The Davis Mountains country is thoroughly soaked and range grass is luxuriant.

BUREAU CUTS DEMANDED BY ECONOMY BLOC

State Committee To Urge Revision Of Government

AUSTIN, Oct. 3.—Completion of 75 per cent of the extensive work involved in the examination of the 151 distinct agencies of the Texas State Government, including hundreds of proposed recommendations for reducing expenditures, simplifying organization, and replanning activities was announced here today by Harry N. Graves of Georgetown.

Mr. Graves is chairman of the Joint Legislative Committee on Organization and Economy, authorized by the State Legislature in 1931, and his Committee met in Austin Thursday.

The full Committee was present, Carl C. Hardin of Stephenville, Sen. Grady Woodruff of Decatur, Rep. Phil L. Sanders of Nacogdoches, and Rep. J. Turney Terrell of Del Rio. The meeting was one of a series planned to deal with the reports of the Committee's staff.

Mr. Graves pointed out the need for a more simple, modern, and effective plan of organization for the State Government and revealed the determination of the Committee to recommend a plan for financial administration that will meet the crying and immediate need for effective, economical management and proper control of finances and expenditures.

"The Committee has decided to recommend to the Legislature a complete revision of the entire structure of our State Government in the interests of greater unity and economy," declared the Chairman.

"But our final plan, of course, cannot be prepared until all the 151 units of State Government have been fully covered. This is a tremendous job and we are pleased with the progress to the present point. Our technical advisors, Grifenhagen & Associates, aided by a clerical, statistical, and office staff (the latter all from Texas) are rapidly moving forward with the work."

Chairman Graves explained that the expense involved in the study has been materially reduced, as far as the State is concerned, because half of the Committee costs are defrayed by the Spelman Fund, as a free grant to Texas for carrying out such a program in behalf of good government.

"In approaching our task," continued Mr. Graves, "we felt it im-

TRAFFIC OPENS TO SAN ANTONIO ON HIGHWAY 90

All Routes Passable Monday Borderway Open To El Paso

Gov. Sterling Loses Election Contest Suit

AUSTIN, Oct. 5. (AP)—District Judge W. F. Robertson today held he did not have jurisdiction to try an election contest suit filed by Governor Ross S. Sterling to test the right of Mrs. Miriam A. Ferguson to enter the November election as the Democratic candidate for governor.

Judge Robertson sustained a plea in abatement and dismissed the petition.

The judge ruled his temporary injunction restraining Mrs. Jane Y. McCallum, secretary of state, from

AUSTIN, Oct. 5 (AP)—District Judge W. F. Robertson today overruled a motion for a rehearing on his decision, rendered earlier today, in which he held that the Travis County District Court did not have jurisdiction over a contest filed by Governor R. S. Sterling seeking to oust Mrs. Miriam A. Ferguson as the Democratic candidate for governor.

certifying Mrs. Ferguson as the nominee, necessarily falls with his decision that he does not have jurisdiction in the case.

Judge Robertson held the primary election was a part of the whole election and that it would not be complete until after the November election.

His opinion, stated "by express language, the right and power to bear a contest for the office of governor is lodged exclusively in the joint houses of the Legislature. The express terms of the constitution will certainly prevail over a general provision."

M. M. Crane, one of the attorneys representing Gov. Sterling, gave notice immediately that he would file motion for rehearing, stating that it would be ready for filing when court resumed this afternoon.

ON TEXAS FARMS

Sales of "Cuck Wagon Beans" amounting to 3000 cans since early March, have brought a monthly income of \$45 to \$65 to Mrs. P. H. Gilliland, home demonstration club member of Westway Club in Deaf Smith county. She also sells canned black-eyed peas under the "Better 4-H Products" label of the home demonstration clubs.

A profit of \$114.06 from a quarter-acre garden is reported by Gene Harwell, member of the Blalock 4-H club in Cass county. Fresh vegetables used at home weighed out 1276 pounds, and 167 quarts of products were canned.

"Canned goods are worth more to me than money," declared R. D. Burnside of Alief Community, Harris county, as he gave a cash donation to a storm relief committee calling on him for canned stuff from the family pantry.

Fifteen farmers in Dickens county successfully killed and cured 25 hogs last July under refrigeration in a county agent demonstration. Many of the hogs were attractively wrapped for sale under a distinctive "Cap Rock Country Cured" label.

At 12 weeks of age, 10 pigs belonging to R. J. Marshall in Taylor county weighed 994 pounds, having made average gains of 43.7 pounds in 30 days on self feeders. The ration consisted of equal parts of wheat, milo and corn with a protein supplement of equal parts of cottonseed meal and tankage, and 10 pounds of bone meal, three pounds of salt, and plenty of clean water and shade.

In Bowie county 66 farmers have agreed to build home sweet potato curing houses by county agent plans. Ten of these were completed early in the summer.

RECIPES AND MENUS

DENTON, Oct. 6.—The use of bran, of coarse cereal and of Graham and whole flours in breads modifies the color, makes an interesting texture, and varies the flavor. The added bulk is highly valuable in the dietary because it stimulates the process of digestion by giving the digestive tract needed exercise. The addition of dried fruits and nuts to coarse breads imparts richness and interest.

MENUS

Breakfast: Sliced oranges, omelet, bran breakfast stick, apple jelly, coffee.

Luncheon: Toasted whole wheat bread and broiled oyster sandwiches, fruit salad, tea.

Dinner: Boullion, baked fish, bread stuffing, buttered peas, french fried potatoes, bread and butter, cucumber and tomato salad, lemon ice, white cake.

RECIPES

Bran Breakfast Sticks: Mix and sift one cup whole wheat flour, 1-4 t salt, 4 T sugar and 4 t baking powder. Mix in 1 c bran. Beat 1 egg and mix with 1 1-4 c milk; add 2 T melted fat. Add liquid mixture to dry ingredients and stir until the dry ingredients are just moistened. Fill greased breadstick pans 2-3 full and bake in a hot oven at 400 degrees F. about 20 minutes. 1-4 c coconut may be added with the bran.

Prune Bread: Stone and chop 1 c prunes that have been soaked 3 hours and drained well. Mix and sift 1 c flour, 1-4 c sugar, 1 t salt and 5 t baking powder. Stir in 1 1-2 c Graham flour and the chopped prunes. Beat 1 egg and mix with 1 c milk; add 2 T melted fat. Add liquid mixture to dry ingredients. Stir until dry ingredients are just moistened. Pour into well-greased bread pan. Let stand 20 minutes. Bake in a moderate oven at 375 F. for 1 hour.

Bran Doughnuts: Mix and sift 4 c flour, 1 t salt, 3 t baking powder, 1-4 t cinnamon and 1-4 t nutmeg. Add 1 c bran and mix well. Cream 3 T fat and 1-2 c sugar; mix together until well blended. Add dry ingredients and 1 c milk alternately to fat-sugar-egg mixture; begin and end with a portion of the flour mixture. Knead lightly and roll out 1-2 inch thick, cut with small dough-

nut cutter. Fry in deep fat hot enough to brown an inch cube of bread in 60 seconds.

Oatmeal Potato Rolls: Pare 2 medium sized potatoes; cut into cubes and add to 3 c boiling water; cook until soft; put through strainer. Add 2 c scalded milk to the potato. Cool to lukewarm; dissolve 2 T brown sugar and 1 yeast cake in the milk potato mixture. Add 3 c flour; mix well and let rise in warm place to double in bulk. Stir in 2-3 c maple sugar (honey or other syrup may be used) and 2 T melted fat. Put 2 c rolled oats through food chopper. Add oats, 3 c flour, 2 t salt, and 1 c dates—stoned and chopped. Mix well. Add more flour if needed. Place in well greased bowl and let rise to double bulk. Knead for a few minutes. Shape into rolls and when risen to double bulk again, bake about 20 minutes in hot oven at 400 F. The dates may be omitted.

Ferguson Charges Illegal Voting In This County

In answer to the suit filed by Governor Sterling against "Ma" Ferguson attorneys for the Ferguson... 20,000 illegal votes... cast for Gov. Sterling and named the counties in which the alleged illegal votes are in. Terrell county was among the list and Ferguson charges that 162 illegal votes were cast here.

Several comments have been made on the allegation and several members of the board have stated that they believe there is nothing to the charges only a political ruse and that the primary elections were carried on in a strict manner and according to election laws. perative to make first-hand inquiry as to the activities, operating problems, and methods of each governmental agency as the first step in preparing our reorganization proposals. But this was not our only, nor in fact our principle reason for going into these units in great detail. We were specifically directed by the Legislature to make a thorough investigation of State departments and institutions 'of any or all kinds' with a view to ascertaining if they could be operated at greater efficiency or lesser expense to the taxpayers and to ascertain how the affairs of this State might be run in a more economical manner. One of the greatest difficulties encountered in the survey has been the obtaining of dependable information as to actual expenditures of State agencies. The Committee has adhered faithfully to these instructions and to its original program as announced earlier in the year. It will report its findings and suggestions to the Legislature in detail. It has carried its work along five main lines.

The Chairman named them as: First, a detailed analysis of the work, the expenditures, and the opportunities for economy and improvement in each of the 151 units of organization making up the administrative machinery of the State Government;

Second, a replanning of the general organization structure of the State Government considered as a whole;

Third, a revision and modernization of the State's entire system of financial administration in all of its elements;

Fourth, a consideration of certain practices and methods in the management of the State's business affairs applicable to all branches of the State Government; and

Fifth, a general survey of the organization and expenditures of the judiciary.

The Chairman said the 151 governmental units include 41 administrative agencies, 20 educational institutions, 9 eleemosynary institutions not including the 11 hospitals, 3 training schools and the prison system, 14 examining and licensing boards, 44 miscellaneous boards and commissions and agencies, and 7 State parks. These, of course, range in size from such large establishments as the State Highway Department that expends about \$40,000,000 a year, the University of Texas, and the A. and M. College, down to small boards and commissions.

"We are trying literally to do what the Legislature directed us to do," said Mr. Graves. "We are taking up the agencies of the State one at a time. We are considering in each case, its powers and its functions as assigned by law, the actual work being done by it, the policies and practices in effect, the form of internal organization, and the methods of operating procedure, the staffs and the personnel, and finally--and in great detail--the actual expenditures incurred in the course of its work. We shall report our findings on each agency for the use of the members of the Legislature and the public generally.

"As the first step in pointing out opportunities for economy, we shall express an opinion for the guidance of the Legislature as to the usefulness, the value, the essential or non essential character, as the case

may be, of the work of each unit, in whole or in any part. Our recommendations for appropriations are being set up in great detail under a logical, orderly classification of expenditure accounts. Each position and each item is being dealt with. We feel that we have done a budget job for the Legislature that will tremendously facilitate the preparation and consideration of the appropriation bill and prove very helpful to both old and new members.

"We intend absolutely to cover every one of the 151 units before the end of the year.

"In connection with this study the Committee, through its staff, has made a detailed analysis of the form of organization now in effect in twelve of the states and a more general study of a number of other states that have achieved prominence because of the thought they have given to, and the number of changes that they have made in their organization structures in recent years. These states are: California, Maryland, Minnesota, Georgia, Ohio, Illinois, Virginia, Massachusetts, New York, North Carolina, and Tennessee.

"It is the hope of the Committee in devising a plan for Texas to consider the very best that experience and modern thought has developed and to adapt and apply it to the local requirements and conditions of our State."

The Committee has secured technical counsel and assistance through members of the organization of Griffenhagen & Associates, consultants in public administration and finance, engaged for some twenty-one years throughout the nation on work of exactly the kind that the Committee has had to do. Three members of Griffenhagen & Associates are native-born Texans.
