## EAGLES PLAY AT McCAMEY TO-MORROW

### Winner of This Game Will Be Strong Contender for District Championship

#### Parent-Teachers Plan Carnival on Night, Oct. 31st

The annual Halloween carnival of the Parent-Teacher association will be held October 31, beginning at 6:30 o'clock, on the lot between the Loma Alta cafe and the building formerly occupied by Dr. Halbert. This is the second feature of the association's program for fall. The first activity sponsored by the organization was the play "The Cross Roads Store," presented October 10 by the dramatics class under direction of Mr. Kendrick Harrell. Proceeds, less expenses were applied on school debts.

The Halloween carnival is an annual feature and is staged in characteristic Halloween style. Sideshows will be set up, and coffee, doughnuts, hamburgers, popcorn, and peanuts will be on sale. Three booths—the "beano," doll rack and a penny game booth will be sponsored by the football club, and one-half of the proceeds from these booths will be applied to the athletic debt. There will also be a fortune-telling booth. A fee will be charged for entrance to each attraction. There will be no general admission fee.

Mrs. Clyde Higgins, chairman of the P.-T. A. ways and means committee, Mrs. Roscoe Parker, Miss Vera Wade, Mrs. Bustin Canon and Mrs. R. A. Hurst are in charge of carnival arrangements, Mrs. Higgins being general chairman.

The Sanderson Eagles journey to McCamey tomorrow to do battle with the Badgers of that city. It will be a conference game, the third district start for the local squad. Their first two starts in League play left the Eagles with a perfect record, beating Marfa 19 to 0, and Iraan by 9 to 7, in what followers of the game consider an upset, as Iraan's squad, averaged, would outweigh Sanderson by 10 pounds per man.

Observers say, and you correspondent agrees with them, that tomorrow's is the crucial game—a win over McCamey would be taken as prima facie evidence that the Eagles are the strongest team in this half of the district.

That the Eagles go into the game tomorrow is fact. Injuries will keep Mussey, elusive back-field man, out of the game. This will break up what is considered a perfect combination among the backs—"Si" representing speed, Halley, Power, "Locky" and Dick Sullivan, clearing their path. The coordination of these qualities is what has put us on top of the percentage column to date. It has been Mussey's speed that put the Eagles in position to score almost every point they made this season. His absence will be felt in the game tomorrow.

#### Big Attendance On First Day of Highland Fair

The eighth annual Highland Fair and Feeder Sale opened at Marfa yesterday with what was considered a record crowd for the opening day. Marfa was taxed to care for all the visitors drawn by this yearly celebration.

Augmenting the visitors who will remain during the three days of the fair, will be a special train from El Paso carrying some 400 business men and citizens of the Pass City, making a sort of goodwill trip to Marfa.

Plenty of color is added to the fair this year, sadly missing during the past three years. Practically the entire detachment of the 77th Field Artillery is now stationed at Fort D. A. Russell on the outskirts of the city.

Every conceivable form of entertainment is on tap—carnivals, rodeo, two football games, a big dance each night. On Saturday afternoon a football game will be played between Sul Ross Lobos and the Texas College of Mines Muckers. The climax will be a big dance at Hotel Paisano Saturday night.

A convoy of around 39 trucks, autos, ambulances, tractors and other equipment passed through Sanderson last Friday afternoon, enroute to Marfa, and will be used at Fort D. A. Russell, which is being regarrisoned by the 77th Field Artillery.

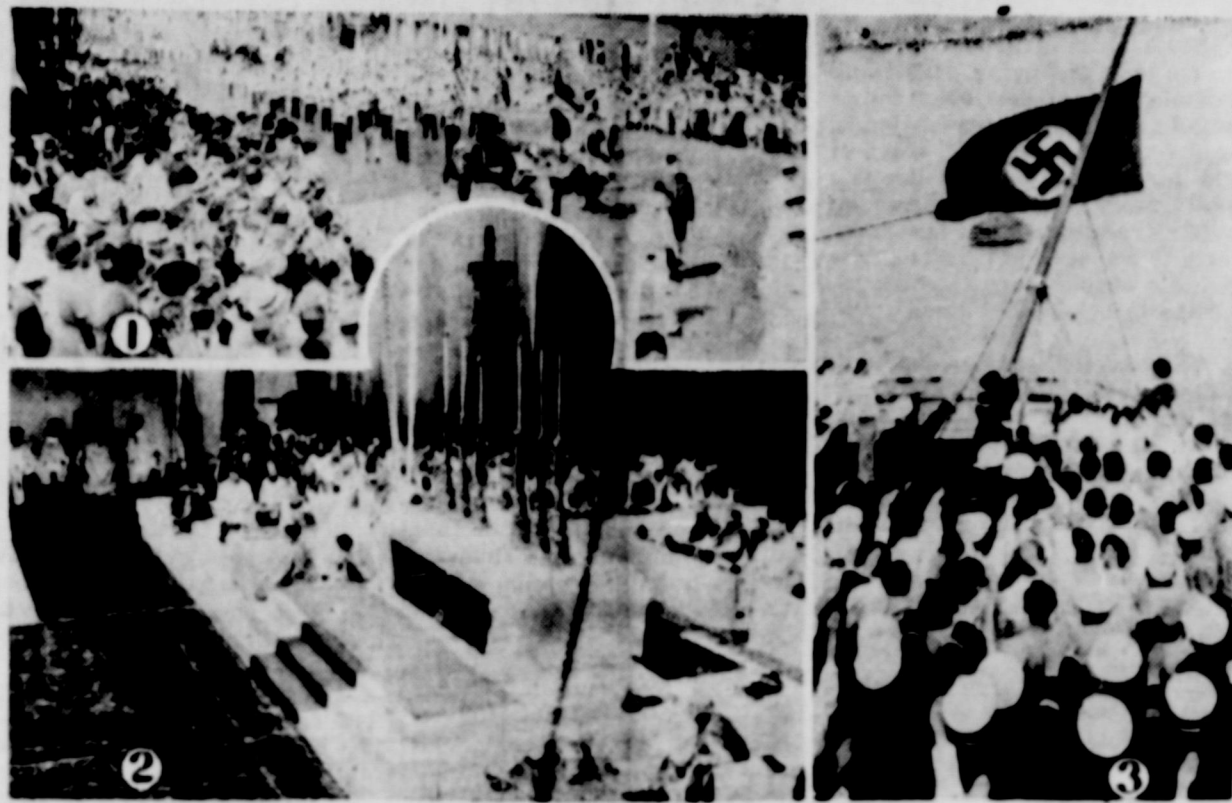

March does the finest work of his career as the unfortunate Valjean and Laughton is superb as Javert. Sir Cedric Hardwicke, the celebrated British stage and screen star, is splendid, making his American screen debut as the kindly Bishop Bienvenu who starts the brutalized ex-convict on the road to a noble and prosperous life.

Rochelle Hudson, as Jean Valjean's ward, Cosette, and John Beal, as her sweetheart, Marius, furnish the love interest which offers a counterplot to Valjean's desperate adventures in his lifelong attempt to evade the relentless Javert. The film is released through United Artists.

"Les Miserables" is magnificent entertainment, full of the color and passion of the novel which millions have read and will enjoy the privilege of seeing so very brilliantly transcribed to the screen.

#### Swindling Cases Dismissed Here At Special Term

A special term of district court was held here last Thursday afternoon with District Judge Brian Montague of Del Rio presiding. Also present was District Attorney Juffan LaCrosse, of Del Rio. At this session, which lasted but a few hours, six cases against L. W. Leeper, charged with swindling, and which had been on the docket of the court since January, 1930, when the indictments were returned, were dismissed on application of the plaintiffs in the case.

#### Hutton Gets Life And 50 Years For Double Slaying

Clarence Hutton received a life sentence in the 34th district court at El Paso last week for the murder of Ray Gillispie and, at a later trial, 50 years for the murder of Hardy Stephens.

According to news dispatches from El Paso, Hutton, on advice of counsel will not appeal.

Gillispie and Stephens were shot to death in the Plaza Club, El Paso, on the night of July 6. Hutton surrendered to officers following the shooting.

TO ALL TO WHOM THESE PRESENTS SHALL COME:

WHEREAS, the State of Texas will be host to many thousands of visitors from over the country during the coming year of our Centennial Celebration, and

WHEREAS, in anticipation of these visitors every effort should be made to put our house in order so that the natural beauty of our state may not be blemished by unsightly elements, and

WHEREAS, such efforts may well be directed toward cleaning up of all rubbish, junk, and other things that may mar the appearance of our highways and roads along which our visitors will gather their first impressions of Texas.

NOW, THEREFORE, I, JAMES V. ALLRED, Governor of Texas, do hereby proclaim the week of October 21st, to 26th, 1935, as

#### CLEAN-UP WEEK

and call to the attention of all communities and individuals the value of such industry as may be necessary on their part to present the best possible appearance of their locality for the benefit of the future travelers who will partake of the hospitality of our state.

IN TESTIMONY WHEREOF, I have hereunto signed my name officially and caused the Seal of the State to be impressed hereon at Austin, Texas, this the 27th day of September, A. D. 1935.

### Senator Connally Off to Philippines For Inauguration

Marlin, Oct. 17.—United States Sen. Tom Connally sailed from Seattle on the 16th for the Philippines to attend the inauguration of the first president of the new island republic. He was accompanied by his son, Ben Connally, an attorney of Houston.

Senator Connally is one of a group of American officials who were invited by the new Philippine government to attend the ceremonies. The party will be headed by Vice President John N. Garner, Speaker Jos. W. Byrns, and Secretary of War, George H. Dern. The group sailed on the S. S. President Grant, and will go first to Yokohama, Japan, from whence they will visit Tokyo and Kobe. Proceeding from Japan the next stop will be Shanghai, and then Hong Kong. The party will arrive in Manila on November 8.



**SENATOR TOM CONNALLY** ber 8. The inauguration is on the 15th, and the American officials will leave Manila on the 20th. On the return trip they will stop at the same ports in the Orient and then visit Honolulu. They will reach Seattle aboard the S. S. President Jefferson on December 14th.

The Texas senator is a ranking member of the powerful Committee of Foreign Relations of the senate, and at present has two other important assignments on sub-committees in the senate that have to do with world affairs. One of these is a sub-committee considering taking the profits out of war, of which he is chairman, the other is the sub-committee which handled the present neutrality legislation in congress.

Upon the return trip, Senator Connally and Mr. Connally will return to Texas and remain in the state until the next session of the congress on January 3rd.

## NOBODY'S BUSINESS

By JULIAN CAPERS, JR.

Austin.—The first called session of the 44th legislature wrote finis to its inglorious record of final enactment of only one major piece of legislation, and was promptly recalled by the governor for a second 30-day try at the job, at a cost of another \$100,000 to the taxpayers. The chain store tax bill—virtually the sole accomplishment of the solons in a month of "work"—is so badly patched up that it is full of legal holes, and must be fought out all over again, as amendments to make it proof against court attacks are submitted.

Some value doubtless attaches to the long-drawn out debate and committee wrangles over liquor regulation, fee officers' salaries, and old age pensions. Whether the legislators can capitalize this and utilize it to speed enactment of these and important tax measures to finance the pensions during the second special session remains to be seen.

Three significant developments occurred last week in the Texas oil situation. They were:

1. The house hot oil investigating committee weathered a very stormy 3-hour debate and came out with its life prolonged to the 1st of April, 1936, and a \$10,000 fund to make a thorough probe of reported abuses in the industry. The house flatly instructed its probes to make its future hearings fair by permitting witnesses to be represented by counsel with the right of cross-examining and with a warning to go after major companies and not confine its probe to a few small operators.

2. General improvements in market conditions of the oil industry whose normal prosperity means millions of dollars weekly to thousands of Texans. War activity in Europe is credited with increasing foreign demand which has firmed American crude markets.

3. Holding of second successful session of the interstate oil states compact commission, where further unanimous steps were taken by representatives of the oil producing states to regulate their oil business under their own constitutional powers. This significant statement was made by Tom Anglin, representing Oklahoma on the commission:

"Other oil producing states are amazed at the very wonderful achievements of Texas in its fair, patriotic, efficient and honest regulation of oil production. All of us can well emulate the example set by Texas, which is a tribute to that state's railroad commission.

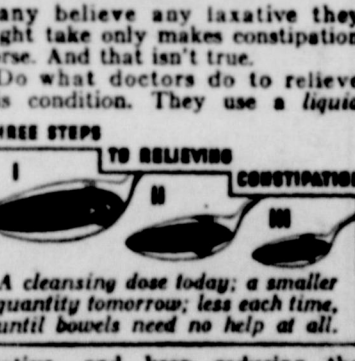
Thousands of unemployed citizens and dozen of communities in Texas, are looking squarely to the engineers' department of the Texas highway commission to see that Texas does not lose any of the \$23,000,000 allotted for extra highway and grade crossing elimination in the state. To get all these job giving millions, the highway engineers must complete plans and let contracts by July 1, 1936. A howl of protest will go up from every community that fails to realize its share if the time limit is permitted to cheat them of their part in this highway work.

four meetings with road-building contractors throught the state, at which B. W. Coulter, of the headquarters engineering staff, and C. H. Newell, representative of the contractors, are interpreting the complicated regulations with which the contractors must comply, as part of this program are being built under five different federal department allocations. The field sessions were held in San Antonio on Oct. 16, Houston Oct. 17, and will move to Dallas on the 23rd and Lubbock on Oct. 24th. Several hundred road-builders and highway engineering men attended each of these meetings.

That Gov. Jimmie Allred will be a large factor in control of the next Democratic convention delegation from Texas—to be selected next summer—is the conclusion of political observers here. The visit of Jesse Jones who was a mansion guest of the Allreds, the growing political friendship between the governor and the two Texas senators, Allred's recent conference with Vice President Garner, his visit with Mrs. Roosevelt in Fort Worth, and President Roosevelt's personal telegram to Allred anent the celebration for Jones, are all given due significance in the minds of those who presume to forecast future political events.

Rex Tugwell, once head of the Roosevelt brain-trust, now relegated to a quiet job as head of the rural resettlement administration, and Senator Tom Connally are indulging in a small but bitter war over location of the Texas-Oklahoma headquarters of RRA in Stilwell, Okla. The RRA recently had 1200 people—mostly ex-school teachers—on its payroll in Texas, and they haven't "re-settled" anything yet, Connally claims. The senator wants the headquarters moved to some central location in Texas, and some results shown for the comparatively large expenditure the RRA has made.

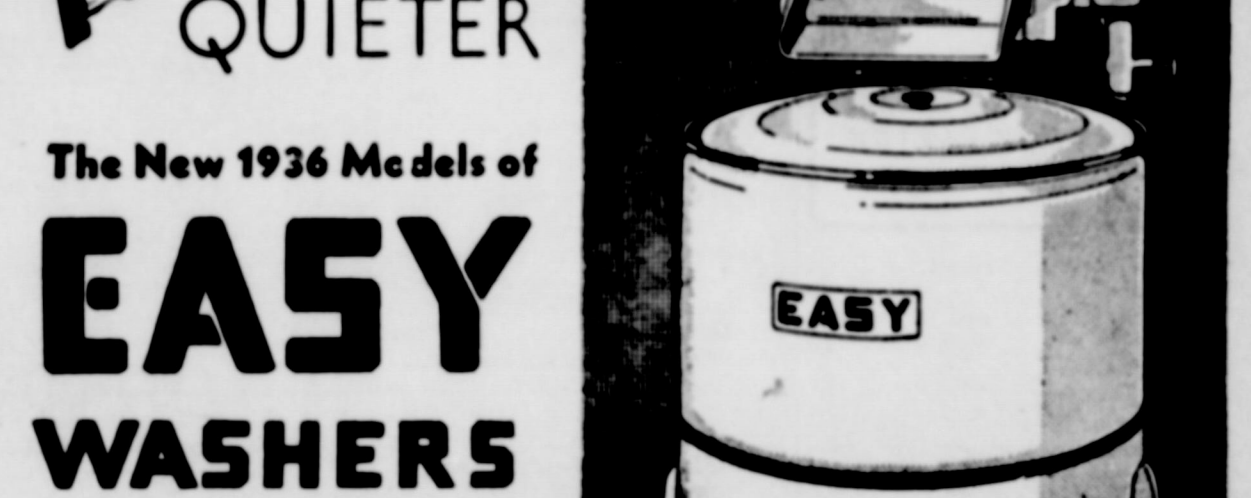

A field goal made during the last fifty seconds of the game caused the Eagles of Sanderson high school to give the Braves of Iraan high school one of the most severe setbacks possible at this stage of the district race Saturday when the teams clashed on the Iraan gridiron. The final score was 9 to 7, favoring Sanderson.

Iraan won the flip and chose to receive. Mussey kicked to the 10 yard line, and Jolly returned it to the 30-yard line before he was stopped by Appel. On the first play they went over right tackle for 40 yards, but were called back on an offside penalty. The Braves advanced the ball to the 20-yard line where they were held for four down.

**Warbirds Score**  
The Warbirds hit the line for a short gain. On the next play Mussey started over tackle and cut back for a 65-yard dash before he was stopped by 4 Braves. The Eagle made 12 yards on a line buck, and then Halley took the ball over the goal line standing up. Halley hit the line for try on extra point, but failed to carry it over.

The game was played in mid-field for the remainder of the half. Iraan made one 86-yard drive that Sanderson finally stopped before the half ended, with the score, Sanderson 6, Iraan 0.

**Situation Changes After Half**  
When the second half started things began to change. The third quarter was pretty well matched, as neither team got close to pay dirt. It was in a stellar play that Allen, Appel, Lea and Halley stopped the Braves in this quarter. Iraan took the ball to the 6-inch line, but the good line-stand of the Eagles' forward wall and the stellar play of the line-bucking Halley kept them from scoring.

**Halley is Removed**  
A few plays later Halley was removed from the game and his place was taken by Black. Iraan took to the air and scored six points. Another pass was good for the extra point. The Warbirds never stopped fighting. Mussey took the kickoff and ran 55 yards before he was stopped by Jolly. Mussey was removed from the game at this point because of a pulled ligament in his knee. Sullivan and Lochausen took the ball down to the 10-yard line where Sullivan, field general called for a field goal. With fifty seconds to play Lochausen kicked a perfect goal to put Sanderson ahead with a score of 9 to 7.

## UNDER THE Eagle's Wing

"Can the Eagles take it?" Yes, they can take and also dish it out. The people didn't believe they could, but if they had been in Iraan Saturday their minds would have been settled. Those who didn't see that game missed the biggest thrill of their lives.

How many people knew why we beat Iraan? I don't believe I can tell you. The boys went into that game with the idea of defeating Iraan. They didn't stop fighting until the gun was fired to end the game. If you were not there you just can't imagine how our little boys really fought. They battled their hearts out.

After Halley and Mussey were removed from the game Sullivan and Lochausen took charge of things. One would carry the ball for one down and give it to the other for the next down. When the backfield took the ball they tucked it under their arms and really drove. The line made a hole just any time they wanted it.

### Iraan Unable to Gain

Iraan was unable to gain thru our line when they really needed it. They made an 86-yard drive in the second quarter, but when they began to get close to the goal line the boys tightened up. They got the ball on the 6-inch line one time in the latter part of the third quarter and had four tries to take it over. On fourth down they put ten men in the line with only one in the backfield. The ball was snapped, and when the whistle blew the boy in the backfield was two yards from the goal line. Halley slipped thru the line and threw him for the loss. The ball went over to Sanderson on the 2-yard line. Halley got back into the end zone to punt, but the ball was passed to Mussey who ran it out to the 15-yard line. Then the Warbirds punted to midfield to get out of danger.

When we had 50 seconds left to play and Sullivan called for a field goal, Lea asked which goal he was going to kick. The ball was on the 18-yard line about 12 yards out from the sideline, and Bobby didn't know which goal was the nearest.

Iraan made more first downs than we did, but we outgained them in yardage. They made 15 first down to our 13, but we gained 310 yards to their 280. The reason they made more first down was due to the fact that we made more longer runs than did Iraan.

### Appel and Lea Are Good

Appel and Lea, midget guards, but tough, played a real ball game. Appel got a tackle on every kickoff. Lea stopped Booth and Jolly several times at the line of scrimmage. They are one of the best pair of guards Sanderson ever had. They did not have much trouble taking out their opponents on offense. Lea was playing in front of a 195-pound tackle that made all-District for the past two years. But Appel was playing in front of a smaller tackle that didn't weigh but 190 pounds. Appel and Lea made these tackles look like a pair of overgrown babies. When the all-District teams are picked it is going to be hard to overlook our guards. They are fast and aggressive and they are out for the fun they get out of hitting a man.

Coach Smith was afraid Iraan would run over our tackles, but those that saw them play know they didn't. James Allen, playing his first full game, turned in one of the best games a tackle could play. He blocked two punts and fell on three fumbles besides the tackles he got and the interference he tore down. It looks like he is going to be hard to handle with another game or two to his experience.

Joe Kerr, Jr., playing his same old steady game, was the cause of several yards that was made. He played in front of Glendenning, a 3-year letterman, who did not really do anything. Kerr would just take him to either side, whichever he was supposed to do. He simply manhandled the ends on defense. Joe is just now getting the feel of football and says he really loves the game, which he showed Saturday.

Bogusch and Smith turned in great games at end. It was due to their blocking that we managed

to circle their ends so easy. Bogusch is one of the neatest open field blockers that I have ever seen. He does not mind rolling his shoulder into a man and then running over him. Smith is just a rough boy that won't be whipped down. He fights 60 minutes and gets a kick out of it. With another game or two experience, he will be hard to get along with.

Roy Deaton, who plays center like a grown person, is unequalled in district competition. One coach in this district said he was the best offense center he had ever seen in west Texas. I don't believe that's enough—I will say he is one of the best defensive ends in the country. It was due to his blocking that the backfield boys made so many yards thru the middle of the line. Roy is a boy that plays for what he gets out of it. He likes the punishment—he can take, and he can dish it out.

### Backfield Perfect Combination

Anyone who saw this game realizes that the backfield needs no mention. Halley seemed to be the boy who dealt them most trouble. He hit their line so hard on offense that he would gain from one to ten yards. As line buckers he is unequalled in this part of the state. He is the hardest tackler that ever played on the Iraan field—so they say.

Mussey is one of the fastest men in the district. He showed that Saturday when time and again he broke into the open, only to be stopped by the safety man. He ran 65 yards on one play, while on the kickoff before that was stopped by Jolly.

Sullivan called one of the smartest games a quarterback could call. And it wasn't any trouble for him to block out an end for Mussey, or be a linebucker for Halley. He made several nice gains through the line, carrying the ball.

Lochausen played a bang-up game at halfback. He met several plays at the line of scrimmage and showed great improvement over his last game. His field goal was as pretty a one as could be kicked.

Dr. James Sharp was very nice to the people from here. He examined "Si" and treated him at the Iraan hospital.

We want to see everyone over at McCamey this week end.
