LISTEN TO LUKE

Just after having written a long spiel about our feelings for the necessity of another candidate announcing for the school board we heard about the announcement of Jack Turner as the fourth candidate for that job.

Our words and type were wasted, it seems, but we can always think of new words.

We think that the four men who have announced are worthy candidates for the school board positions to be filled and feel they are worthy of the support of the voters in the school board election coming up April 2.

Winter continues over most of Texas as freezing temperatures prevail. In this section of West Texas the continuation of cold and damp weather has necessitated delay in shearing goat herds and has been a menace to lambing.

There has been no report of heavy loss of lambs or goat herds freshly shorn, but the danger of such losses has been evident.

Most ranchmen will concede they are ready for warm weather for a while, but the moisture has been most beneficial.

There is some kind of an old saying about March coming in and going out like a lion or lamb. It came in like a polar bear this time and we have no predictions about that freshie entrance.

At last report there was something like 35 new homes at various stages of planning and construction in Sanderson.

Have you thought about what that means to Sanderson and to the economy of this little town?

Most of those houses are of the "shell" variety, but some of them are of greater magnitude in size and cost. There will be lots of building materials bought and sold here and there are to be other necessities purchased, one brings on another, always.

It would be well for the people of the town to look around them and see the many advantages of doing a little sprucing up around their homes and yards.

Many of these new houses are to be built on lots which will be cleared of a present older house. This will be an asset to the town, too, in appearance.

With the planting of pecan trees and about 35 new houses, two new school buildings and other such improvements to the town, we are going to have an appearance of progress and growth here before we know it.

We didn't receive a single reply about the pecan trees last week and we wonder if you readers thought we were kidding.

There is every likelihood that at the extreme top of the new trees there is some dead limb. This should be trimmed off now and should be pruned down to green and live parts of the limbs.

Producers Asked To File For Payment For Wool Incentive

All producers who have sold shorn wool or unshorn lambs since April 1, 1959, or do sell before March 31, 1960, should file their accounts of sales with the county ASC office to be eligible for the 1959 wool incentive payments. According to Clarence Jessup, chairman of the Terrell ASC County Committee, late-filed applications are next to impossible to get approval; therefore every wool grower should review his records carefully and file every eligible document as quickly as possible.

Local ASC personnel are making a concentrated effort to bring each producer's file up to date, and applications will be prepared during April on the basis of documents in each person's file. Many persons will make sales during March of 1960. These people should be very careful to get their sales documents to the ASC Office at the earliest possible moment. No documents can be accepted after April 30, 1960, for 1959 incentive payments.

County totals will be furnished by every county office to their respective state offices at the end of April. From data collected in this manner, the national average price per pound will be determined. Processing the data takes time; therefore, the national average price probably will not be announced until sometime in June. It is expected that, as in the past, incentive payments will be made early in July.

Mr. Jessup advised of several points to be remembered. Trucking expense or freight of any kind paid by a producer to another individual or firm for getting wool to the wool warehouse is a deductible marketing expense and must be reported to the ASC office. Any purchase of lambs which had never been shorn must be reported, in order to prevent duplicate payments on the same wool. Each person must advise the county office of any and all counties where he ranged, fed or pastured sheep during the past 12 months. Producers and traders of livestock must keep records on file for a period of three years following the marketing year for which an incentive payment is made.

Census Enumerator Sought for County

Mrs. Gena S. Fry of Fort Stockton has been named Crew Leader for the U. S. Government Census for 1960 on population and housing for Pecos, Crane and Terrell Counties.

Mrs. Fry is seeking two enumerators for Terrell County and applicants will be given a test about March 12 for qualification.

The test for the enumerators will be given in Fort Stockton and traveling expenses will be paid to the two persons accepted for the posts. Regular pay for the enumerators is \$1.60 per hour and each is required to work for eight hours per day, 40 hours per week. Overtime is straight time — \$1.60 per hour. Enumerators who work ranches are paid seven cents per mile.

Men or women who can pass the written test are acceptable and it is preferred that applicants have the ability to speak Spanish.

Development Of Scholastics To Be Tested Tuesday

Freshmen and sophomores at Sanderson High School will get an objective insight into their scholastic development by participating in the National Educational Development Tests, Andrew J. Riess, principal, said today. The tests will be given at 9 a. m. Tuesday, March 8, at the same time the National Merit Scholarship Qualifying Test will be written by juniors.

Prepared and administered by Science Research Associates of Chicago, the annual three-hour examination provides the scores in English, social studies, mathematics, natural sciences and word usage.

Each student plots his scores to learn how he compares with other students at his grade level.

This evaluation of educational strengths and weaknesses helps students plan their high school and college courses and make career decisions. The tests also enable teachers to spot talented students, so that they may receive realistic guidance and motivation early in their educational career.

Terrell County Certified Free Of Brucellosis

Terrell County has been certified free of brucellosis, according to N. M. Mitchell, who ram-rodded the brucellosis testing program for this county.

Mitchell stated that there were 690 cattle tested in the county and one animal was found to be positive in the tests.

Mitchell stated that the animal had been disposed of and that the ranch would be quarantined for 30 days after which all cattle on the ranch would be tested.

Mitchell stated that he personally appreciated the help and cooperation given him by the ranchers in the county and felt that the program would be beneficial to all stockmen of the county.

Thousands of communities in the United States have World Day of Prayer committees composed of women from each church and organization cooperating in the observance.

Each year the service comes from a different country. The service this year comes from the Women's Inter-Church Council of Canada.

Funds Received On McKee Memorial

Local residents, including children, and several clubs have contributed to date about \$118.00 to the memorial fund in honor of the late Mrs. J. W. McKee. A portable oxygen tent and compressor to cost between \$600 and \$800 will be purchased with the funds and placed in the local clinic.

Filing Deadline Is March 3 For School Board Post

Tonight (Thursday) at midnight is the deadline for filing for a post on the ballot for school board member of the Terrell County Independent School District. Three of the four incumbents whose terms expire are seeking re-election and another candidate, Jack Turner, has also filed for a ballot position.

The three seeking re-election are Herbert Brown, John T. Williams and Jack Hardgrave. The term of W. G. Downie also expires at the same time.

Other members of the board are F. M. Wood, Dudley Harrison and Herbert Cates.

Four candidates' terms expire this year and the three other incumbents' terms expire next year.

Absentee voting is for 20 days prior to the election with the day of the election included as one of the 20 days.

The members to be elected are for a two-year term.

Spencer Well Gas Producer; Corder Hole Has Gas Shows

Humble Oil and Refining Co.'s 1 Spencer well has gas discovery assured and potential was being calculated at latest reports. Location is on section 68, Block B-2.

Testing was through perforations in the Strawn formation.

The project flowed gas at the daily rate of 2,263,000 cubic feet through a 5-32 choke, at the daily rate of 3,065,000 cubic feet through a 7-32 inch choke and at

the rate of 3,550,000 cubic feet daily through an 11-32 inch choke.

The operator was preparing to resume testing.

The project was drilled to 14,618 feet and tested unsuccessfully in the Ellenburger through perforations between 13,956-14,030 feet.

Nearby production is at Humble's 1 Blackstone on section 58, Block B-2 which is a shut-in Albany-Wichita gas discovery which was completed in 1953 and is calculated to produce 310,000 cubic feet of gas daily through perforations between 3,405-35 feet.

A show of gas was logged at 12,236 feet in lime at Mobil Socony's 1 Corder well on section 5 of Block 2 in Terrell County and operator was drilling ahead at the report received the first of the week.

Later reports are that the Spencer hole operator was flowing to clean through the Strawn perforations between 11,371-386 feet which were washed through with 1,900 gallons of mud acid and then acidized with 1,000 gallons. No report was available on the gauge of gas.

The Socony Mobil operator was cutting a core at 12,278 feet.

Graveside Rites Here Saturday For Bernise Halsell

Graveside funeral services will be held here in Cedar Grove Cemetery Saturday at 2 p. m. for Bernise Halsell. His body will arrive by train Friday night.

Mr. Halsell died of pneumonia in a naval hospital in San Diego California, Saturday. He had been in the hospital for several months. A carpenter by trade, he had resided in California for many years, following construction projects.

His brother, Herman Halsell and Mrs. Halsell of El Paso will be here for the funeral rites.

The two brothers, long-time Sanderson residents, operated the service station still known as the Border Service Station in the early 1930s.

Austin — With an eye on the growing cost of government and the need for new taxes, a committee from the Texas Senate has launched an economy study.

Overall state budget for the present two-year spending period is \$328,000,000 more than for the previous two-year period. It was an increase of about 11 per cent. There is every indication that the next legislature will be faced with demands to raise salaries and expand and improve state services in approximately the same proportion.

Some of the cost increase is attributed to sheer quantity. With Texas' population increasing an estimated 26 per cent from 1950-60, there are more youngsters to educate, more patients for state hospitals, more cars wearing out the roads.

More significantly, the percentages of oldsters and youngsters is increasing faster than the percentage of middle-aged people. Older and younger people generally up revenue needs — for welfare benefits and schooling — but contribute less in taxes than income-earning middle-agers.

Some of the increase in costs results from a drive for quality — better schools, hospitals and highways.

With undeniable money needs so great, the Senate committee was set up to seek out any indications of extravagance or waste and "see if we are getting our dollar's worth for the money we are spending".

As a starter, the committee headed by Sen. Ray Roberts of McKinney, agreed to hold its own expenses to the bare minimum.

Marathon Water Hearing. When the subject is water development, Texans always seem to have a few million well-chosen words to exchange.

Hearing before the State Water Board over whether Houston and the Trinity River Authority shall receive a permit to build a new Trinity reservoir is one of the longest ever held. It has been in progress off and on since November.

Main opponent is the San Jacinto River Authority which wants Houston to use its money developing the San Jacinto rather than the Trinity.

SJRA witnesses contend the Trinity water will be inadequate in amount and unsuitable for domestic use.

Oil Flow Cut. Texas Railroad Commission set the March oil allowable at 2,900,568 barrels a day.

This is 120,498 barrels a day less than the February allowable. It continues February's 10-day production pattern.

Most of the industry testimony before the Commission was gloomy. There is an over-supply of oil now, said some spokesmen, and another month of over-production would be "disastrous".

Care for Oldsters. Texas' need for more mental hospital space has focused attention to the number of state men-

tal hospital beds occupied by persons not mentally ill.

In a talk before the Texas Association for Mental Health, Gov. Price Daniel said, "One of our toughest problems now involves those 55,000 hospital patients whose only illness is advanced age."

"Senility is not insanity," said the governor, "and a concerted effort must be made to enable these aged citizens to be cared for in nursing homes or in their own homes."

State Hospital Board Chairman French Robertson called it a "sad thing that people send their own people to mental hospitals when they don't want to take care of them."





The healthy trees that were pruned before planting should have a good healthy green color just under the thin bark. A very slight scratch by a fingernail will reveal this condition.

Personally, none of the people we have talked to have indicated the fact that one or more of their trees are not doing well. We hope this condition is widespread and that all those who planted trees have good luck with them.

Indications and rumors are that there is a slight possibility of work starting within a relatively short time on the carbon-dioxide extraction plant in the Brown-Bassett area. And we say and emphasize that this is rumors and indications. But there are those, for sure.

It seems that there are many ramifications to such projects and plans that we do not know nor would we understand, probably, if we did know.

We do know that many people are interested for many different reasons in proposed plans and anxiously await the actual beginning of that particular project.

The good news of continued successful drilling in this county is encouraging to many different segments.

Integration Of Lamb, Wool Markets Is Proposed

College Station — Lamb and wool production is one of the oldest agricultural enterprises in Texas. The average total annual receipts from marketing sheep and wool in Texas in recent years has been approximately \$2 million dollars. To a large percentage of producers, it has become a way of life as well as a highly organized and profitable business.

Little attention has been paid to the wool and lamb industry as a phase of agriculture that could be adjusted easily to integration, according to Dr. A. B. Wooten, extension economist. Because of the dual products — lamb and wool — which enter different channels of trade in processing and distribution, this type of ranch enterprise would be better adapted to an informal system of improved coordination of production and marketing rather than vertical integration.

In the lamb production phase Wooten said integration has developed in a limited form as to various types of contract feeding. This activity has been in evidence for a long time. When the price situation looks favorable, producers place lambs with feeders to be fed to a desired weight and grade on a contract basis.

The decreasing demand for wool in comparison with competing fibers, is causing producers to search for more efficient marketing practices, the economist pointed out. While the total per capita mill consumption during 1955-57 for the three competing fibers — cotton, wool and man-made — was up 21 per cent, the increase for cotton was 2 per cent and for wool, 7 per cent. During this period, the increase for man-made fiber was 235 per cent. Wooten added that this type of increasing competition could lead to vertically integrated arrangements for wool marketing.
