At the same time and on a second ballot, voters in all four recincts will vote for a county school district trustee-at-large. an office now held by John Harrison, who did not announce for re-election.

Voters in precincts 1 and 3 will be asked to name county school trustees from each of those precincts. Encumbents are: G. E. Babb from precinct 1 and Sid Harkins from precinct 3. neither of whom is asking for reelection.

The indictment grew out of the G. Hardin. fatal shooting of Mrs. Flora Gonzales Chalambaga, 45, his mother-in-law, at her home here on East Pine St. last Thursday night about 9:00. She died only minutes after the shooting.

Mrs. Chalambaga was pronounced dead soon after the arrival of the physician. She was lying near the back door of her home and had a bullet wound in her abdomen near the navel.

Deputy Sheriff Dalton Hogg. Texas Highway Patrolman Carl . Davis, and Justice of Peace J. A. Gilbreath made a preliminary investigation, and after determining that the bullet did not pass through the body, a partial autopsy was ordered by Gilbreath to determine the cause of death. The partial autopsy, performed by a local physician, revealed the cause of death to be massive internal hemorrhaging caused by the perforation of the aorta by a bullet.

The back screen door had been torn loose from the latch and the bullet had been fired through the glass portion of the back door, according to evidence and according to the testimony of Mrs. Marina Flores, daughter of the deceased and wife of the accused in the case. Mrs. Flores was in the room with her mother at the time of the shooting, according to the information given local officers.

Flores' bond was set at \$5,000 by District Judge Roger Thurmond following the indictment by the grand jury and he is being held in the local jail in lieu of the bond.

forcement that they want - to one extreme or another. The type of prosecution they have is also up to them, as well as the type of adjudication.

You can't have strict enforcement, prosecution, or adjudication of laws with lax officials in any one or all three of the departments.
