LISTEN TO LUKE

With the season for legal hunting of deer west of the Pecos rapidly drawing to a close, we feel that we need to have something else to say about deer hunting.

We will do what we can and we will urge others to do what they can in publicizing the availability of whitetail deer here of a different variety, or species, or size, or something different from the whitetail deer found in the lower country. And the hunting is completely different, too.

As long as there are many ranchmen in this area who are trying to lease their country for whitetail hunting there is no reason to let the hunters of the state continue to labor under the misapprehension that shooting a whitetail is something like a man wearing lace on his pants on a deer hunt.

There are some sizeable deer among the whitetail clan and some good trophy horns to be found among the species, too.

While it is absolutely true that the whitetail deer do not become as large as blacktail generally, there is still a sizeable quantity of meat on a whitetail and he is often too big a deer to pack out of some of the terrain in which he so abundantly roams.

The hunting of the two species west of the Pecos is a lot alike and it takes a quick eye to see them in their cover and a sharp reaction to hold the gun on them in their break for the safety of heavier brush, distance, or the top of the mountain.

Not all whitetail hunters come home with a "grandote", nor do all blacktail hunters.

Where the hunter considers the sport and not particularly the matter of only a few pounds of meat, there is nothing about whitetail deer hunting that should not be upheld to the limit to those who come West of the Pecos.

Personally, we have never tried "stand" hunting, nor do we think it would ever be appealing.

It has always been a pleasure with an air of distinct excitement to wonder what's in the next header, or from which portion of the brushy canyon will a deer make his bid for freedom.

We will not belittle hunting the blacktail deer, but we won't belittle the sport of whitetail hunting either.

And speaking of hunting, a lady came into the shop today hunting a small American flag to buy. She said she had been all over town and thought there should be some place to buy an American flag locally.

We agreed with her.

Blood Typing To Be Done On Friday, Dec. 18

An effort to type the blood of every high school and adult person in Terrell County will be undertaken on Friday, December 18, beginning at 2:00 o'clock in the afternoon at the Legion Hall.

The purpose of the blood typing is two-fold, according to officers of the Kiwanis Club of Sanderson, sponsors of the project: so that a person's blood type might be known for his benefit in case of an accident or injury, or to seek donors in case of an accident or injury to some other person of the same blood type.

Technicians from the Brewster County Memorial Hospital in Alpine will be held on December 18 to take a sample of blood for typing. Only a small amount of blood is necessary for typing and there is a minimum of discomfort in the withdrawal of the blood.

It is hoped that as many persons in the county as possible will take advantage of the blood typing for their own information and benefit as well as for the benefit of someone else possibly.

There is no charge for the service and no obligation for those who have their blood typed, the Kiwanis stated.

'High' Expected In Yule Mail

Postmaster J. R. Hodgkins reports that the Post Office Department is confidently predicting the volume of mail during this year's Christmas rush will hit a record high. "Actually", he says, "it's an easy prediction because mail volume has been rising at a rate of nearly three per cent a year for the past several years and this is most strongly reflected around the holiday season."

Well over 12-billion pieces of incoming and outgoing mail are expected to move through the system in December — with about 10 per cent of the year's mail moving in less than three weeks.

The Sanderson postmaster reports that public cooperation is one important reason that post offices around the country are able to handle this huge mountain of mail in such a short period.

"People who shop early and get their cards and parcels in the mails early make it possible for the holiday mail to be delivered on time," Hodgkins stated.

In addition to early mailing, the postmaster has some other suggestions which will help in moving the mail. First, he recommends the use of Zip Codes that help make the handling of the mail faster because of a new transportation and distribution set-up. Zip codes also help clerks identify receiving post offices when addresses are hard to read. During this time of the year, the faster mail is processed the better chance it has to make connections with outgoing trains, planes, and trucks.

Postmaster Hodgkins also recommends that all parcels be wrapped securely, packed tightly and that the address be included inside the package as well as on the outside.

.4-Inch of Rain Falls Locally

A .4-inch rain fell locally last weekend to put some much-needed moisture into the ground. The rainfall was over a wide section of the county with some higher readings reported on some of the rain gauges of the area east of town.

The precipitation began with a light sleet and some small and scattered snow flakes, but the weather moderated to permit only a light rain to fall.

Deer Season To End Saturday

The deer season west of the Pecos River will end at sundown Saturday.

Probably the largest number of bucks ever taken out of this area occurred this year, with the hunters of the state and nation having three weekends for the hunting of blacktail and white tail deer, and javalina.

Several trophy heads have come through Sanderson on cars, but most of the deer killed locally were young deer and smaller than usual.

Ranchmen in Terrell County have reported the bucks to be running with the does in some parts of the county and in other areas the mating season has not yet begun. All of the ranchmen and sportsmen state that the big deer are laying up and extremely difficult to jump out. It has been noted and reported that some blacktail bucks have been seen laying down and shot without making an effort to escape.

In some country that has not been extensively hunted, the deer were seen to be making no effort to be up and around during early morning or late afternoon.

All deer were reported to be in good shape.

Officials of State and Federal water agencies and of river authorities and cities, heard the Texas Water Commission outline the procedures by which it will develop a statewide water plan for Texas.

They gave it their warm endorsement, and pledged to help the state agency in its job of putting all the many regional and river basin plans into a unified whole.

However, spokesmen for cities disagree sharply over the vital issue of diverting water from areas of surplus to areas of need.

In two conferences called by Texas Water Commission, city officials and river authority and district leaders heard eight objectives of statewide water planning outlined. In a third conference on December 10, industry representatives reviewed the proposed program.

TWC Chief Engineer John Vandertulp lists these goals for the planning program:

An adequate water supply for all purposes — flood control, water resources for fish and wildlife, water quality management, ground water recharge, and provisions for navigation, drainage and hydro-electric power.

Coordination of proposals of state, local, and federal agencies with a view to statewide and area needs;

Determination of feasibility of converting sea water and brackish waters into fresh water;

Determining and specifying dams, conduits and other physical facilities needed;

Establishment of a timetable for construction;

Determining agency coordination necessary in operation of projects for maximum benefits;

Division of responsibility between federal, state, and local interests in financing, building, and operating water facilities; and

Recommending means of carrying out the responsibilities.

Rights and property in basins of origin must be protected and assurances given that only surplus waters will be exported, Vandertulp said.

Representatives of areas with rich water resources warned against penalizing their growth and prosperity by tapping their supplies to aid less fortunate regions. Areas of shortage urged consideration of their needs.

John Simmons of Orange, general manager of Sabine River Authority and president of Texas Water Commission, warned against inflexibility and called for a "living plan" that can be brought up to date regularly.

One-House Legislature? Latest of the proposals being prepared for the 1965 Legislature is one from Rep. Will Smith of Beaumont to abolish the State Senate and establish a one-house legislature, such as the one in Nebraska.

Smith's unicameral plan, which he says he'll introduce shortly after the Legislature convenes on January 12, includes proposals to reduce the House of Representatives' membership from 150 to 100 and raise the House members' pay from \$4,800 a year to \$10,000.

The lieutenant governor's job of presiding over the Senate also would be abolished. This is one bill that likely will not make it through either house of Texas bicameral Legislature, much less both.

Courts Speak Third Court of Civil Appeals agreed with trial court that El Paso Electric Co. must pay occupation tax to the sale for electricity sold in Texas though generated by its New Mexico power station. Company had argued that the tax would violate interstate commerce clause of the federal constitution and create risk of multiple tax burden on interstate business.

Third Court also declared unconstitutional an amendment to state liquor laws aimed at regulating export business operating along Texas' border. Decision up-

held Austin district court decision that state could not regulate the exporters handling liquor through customs bonded warehouses.

A Pecos County farmer, James T. Slaughter, won a five-year battle for water rights on Barilla Creek when the State Supreme Court endorsed a ruling that his water rights were secure under the 1895 Irrigation Act, and had not been diminished by passage of a 1913 law.

Welfare Rolls Increase Texans on welfare rolls increased from 260,781 to 264,639 during the last year, Texas Department of Public Welfare reports.

DPW's annual report shows public assistance payments of \$221,100,000. Biggest share \$159,400,000, went to old age assistance for an average of 230,005. Grants ranged from \$5 to \$83 and averaged \$58.16 a month.

Aid to families with dependent children came to \$18,700,000; aid to needy blind to \$4,000,000; and aid to permanently and totally disabled to \$6,500,000. Administrative and service costs were \$10,101,000. Federal government provided 74 per cent of all funds or \$164,600,000.

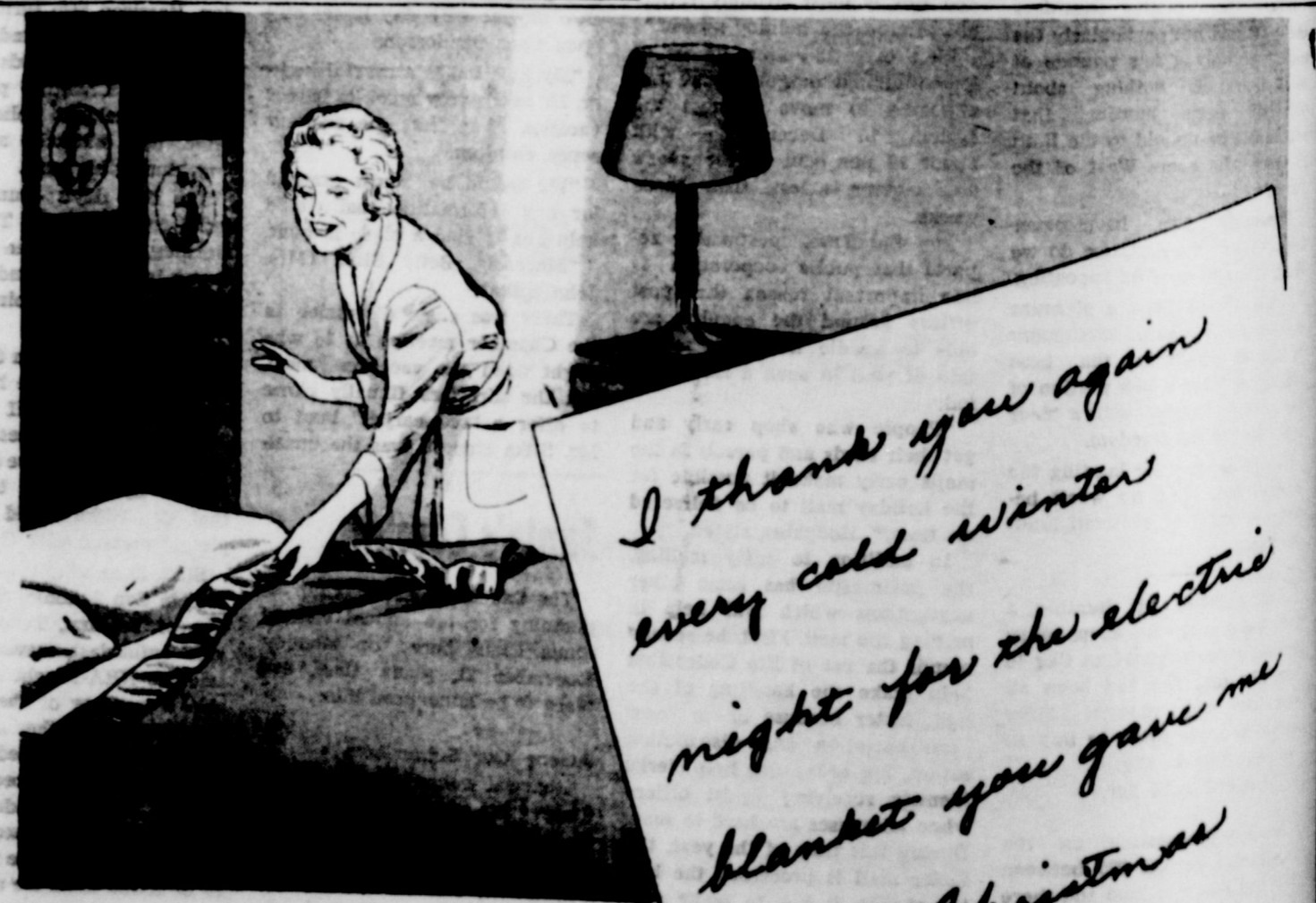

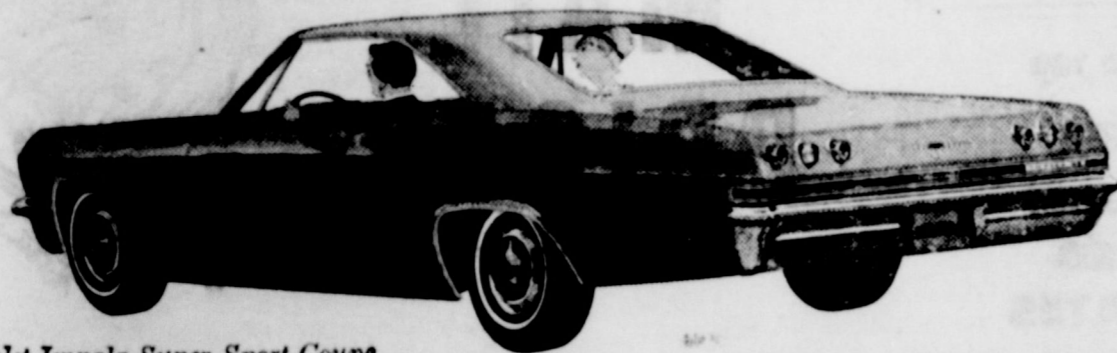

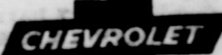
