Seventy-five people were present at the Oasis Restaurant Monday night to hear an explanation of a means of bringing television into Sanderson different from the present system.

Dan Ratcliff, of the marketing department of Southwestern Bell Telephone Co., Odessa, was on hand to explain the method of transmission to the group.

Possible means and methods of obtaining better television reception in Sanderson was said to be the purpose of the organization, according to Mrs. Philip Hanson, who was named secretary of the group. Other officers named include: F. J. Howard, president; Tom Corbett, vice-president.

It was also announced that the group would hold their next meeting at the St. James Parish Hall on Friday, February 4, and on subsequent first Fridays of each month.

A cordial invitation was extended to anyone who was interested in the organization to come to the next meeting.

The snow was in large and wet flakes that put a lot of moisture in the ground -- .60-inch locally, but did not stick on the ground.

There were some reports of heavier moisture east of Sanderson, and almost all reports received were for at least as much as was received locally.

On Monday of this week the temperature dropped to below freezing and remained below 32 all day with a brisk wind blowing.

License Plates Available Feb. 1

The new 1966 license plates for Terrell County have arrived and are ready to go on sale Tuesday, February 1, in the office of Bill C. Cooksey, tax collector, according to Mrs. Tol Murrah, office deputy.

The deadline for getting the new plates for all motorvehicles is April 1.

Terrell County has been allotted approximately 900 licenses for passenger cars. The plates this year are black with white numerals and letters: CYY 10 through 774, CYX 875 through 999.

The demand for the personalized plates was not very heavy in 1965, with only three sold locally. These plates sell for \$10.00 extra.

Pete Snelson Seeks Re-Election To State Senate



State Senator W. E. (Pete) Snelson of Midland officially announced this week that he would seek re-election to a second term in the Texas Senate in the Democratic primary on May 7.

The redistricting act passed by the 59th Legislature resulted in considerable shifting of district boundaries and makes it necessary for all 31 districts to be subject to 1966 elections.

"I now represent a majority of the people placed in the new 25th district and I am delighted with the opportunity of representing all the people in all areas of the new district," said Snelson.

"I greatly appreciate the many friendships which I have already established by personal visitation in Sanderson and Terrell County and I look forward to meeting many others during my person-to-person campaign."

In the Senate, Snelson is vice-chairman of the committee on Cities, Counties, and Towns; and a member of the Committee on Finance; Oil and Gas; Insurance; Water and Conservation; Agriculture and Livestock; Military and Veterans Affairs; and Legislative, Congressional and Judicial Districts.

School Board Extends Contract Of Supt. McAllister

The Board of Trustees of the Terrell County Independent School District extended the contract of Supt. Ken McAllister to July 1, 1968.

Other action by the board included the approval of the contract of Norman Gladson to replace Tommy Lane, who resigned effective mid-term.

Mr. Gladson will graduate at mid-term from Sul Ross College in Alpine with a B. A. Degree in Business Administration. He is married, and a native of Snyder.

The Board approved a part-time secretary for the office of A. H. Zuberbueler, tax assessor and collector. This action was deemed necessary because of the increased work-load because of new legislation concerning the keeping of school records.

Approved the purchase of a second-hand pick-up.

Approved the filing of an application for a Title II, ESEA Library Program. Supt. McAllister stated that this was done in order to try to bring the library up to the standards set by the Texas Education Agency. The application to the Elementary and Secondary Education Act activity loan fund was for \$1,000.00, and is subject to approval on the basis as entered, McAllister said.

He added there was great reluctance on the part of the board to enter into this program, but they felt that it was necessary in order to comply with the standards that have been set.

Low Rate Loans Still Available For Re-Building

Word has been received that low-cost loans, 3%, are available to some persons for rebuilding a home or dwelling that was lost in the flood in June of last year.

According to the information received, if a person was a renter or home owner of a house that was destroyed in the flood, and otherwise is qualified as a borrower, he may borrow money at the rate of 3% for 30 years to rebuild a dwelling.

Interested parties are asked to contact their builder or write to the Farm Home Administration, Del Rio, Texas.

Boys' and Girls' A Teams Lose To Marfa Cagers

Al Dishman Is Named To Head Wool, Mohair Firm

The merger of the Uvalde Producers Wool and Mohair, Inc., and Uvalde Wool and Mohair Co. was announced last week. Becoming effective February 1, the new company formed will be known as Uvalde Producers Wool and Mohair, Inc. Allister Dishman is to be the president and general manager. He is a former resident of Sanderson.

Directors of the new concern state that it will be the largest handlers of wool and mohair in Texas and one of the largest in the United States.

The new concern also announces the purchase on February 1 of the J. D. Varga warehouse at Rocksprings. Dishman and his associate, Charles V. Griffin, founded the Kinney County Wool and Mohair at Brackettville four years ago. The new concern will headquarter in North Uvalde and operate their interests in all of the three towns.

Dishman became associated with Uvalde Producers Wool and Mohair Co. in 1960 when he moved to Uvalde from Del Rio. He had resided in Del Rio for 6 years as the Texas buying representative of Emery Russell and Goodrich, Inc., Boston. Previously he had been apprentice for 8 years and advanced to assistant manager of the Sanderson Wool Commission Co. under J. T. Williams, owner-manager.

IT'S THAT TIME AGAIN . . . TO HAVE YOUR CAR INSPECTED

AUSTIN — Col. Homer Garrison Jr., director of the Texas Department of Public Safety, commended Texas motorists today for their improving compliance with the Motor Vehicle Inspection law.

"Already some 250,000 more vehicles are displaying the new inspection sticker than there were at the same time last year," he said. "This indicates that Texans are aware of the benefits of having their cars inspected early. Not only does it give each driver the assurance that his vehicle is mechanically sound, it also relieves him of the irritating necessity of having to wait in line as the April 15 deadline draws nearer."

During the summer of 1965, the DPS conducted its annual training program for all garage mechanics desiring to be qualified to inspect vehicles at authorized inspection stations. At that time, each mechanic was urged to request permission to inspect any vehicle whenever its owner brought it in for repairs or service. This technique has paid dividends in helping increase the number of vehicles inspected to over four percent of the number inspected at this time last year.

"Those drivers who have not yet had their car inspected should make plans to have it done as soon as possible," Garrison said. "And they should have no trouble locating an authorized inspection station."

Time Difficult For Ranchmen, SCS Men Say

Ranchmen in the Rio Grande-Pecos River Soil Conservation District are now entering into the most difficult time of the year for livestock. The brush has lost its leaves, warm season weeds are dead, winter weeds are practically non-existent and grass is dormant. Now comes the salt and meal, range cubes, cottonseed cake, or other supplemental feed and the pickup and labor costs to put out the feed.

Now let's look at a pasture that was rested last year during the growing season. The sheep in this pasture are holding up real good. There is lots of old grass left on the ground. Winter weeds are growing where the grass stopped runoff from last year's rains. The old grass also shaded the ground and kept down loss of precious moisture by evaporation. Now is the time to plan this year's deferment for next winter's feed.

The hole will be drilled by J. J. Eisner of Abilene to 13,200 feet in the Hunton formation.

The operation is expected to begin within the next few weeks.

"It is easy to see," the DPS director said, "that lines will begin to form as the deadline draws nearer, for if a station inspects only four or five a day during the next month or so, then the load will increase to 15 or more per day as the owner brings his car in later."

In urging motorists to have their car inspected now, Garrison reminded them that when a mechanic asks for permission to inspect a vehicle he is attempting to save time for himself and the motorist.

This column of questions and answers on federal tax matters is prepared by the U. S. Internal Revenue Service and is published by The Times as a public service to taxpayers. The column answers questions most frequently asked by taxpayers.

Q. — Where can I get the form I need to report sick pay which I want to exclude from my taxable income?

A. — Form 2440, Statement to Support Exclusion of Sick Pay, is available at any IRS office. You also may find the tax forms you need in many banks and post offices.

Q. — Do you have to be married to get the head of household income tax rates?

A. — No you don't. On page 4 of the 1966 instructions you will find an explanation of

whether you qualify for these rates. Head of household tax rates cannot be used if you are married and can file a joint return.

Q. — How much can a child earn and still be claimed as a dependent?

A. — If your child is under 19 or is a full-time student, you may claim him as a dependent as long as you provide more than 1/2 of his total support for the year regardless of the amount of income he may have. Otherwise, he may not be claimed as a dependent if he has gross income of \$600 or more.

Q. — I have a disability pension from Social Security. Is this taxable for me?

A. — No. Social Security benefits are not taxable.

Q. — When my widowed father retired he went back to Ireland to live. He has only a small \$500 pension and I supply his chief support. Can I claim him as a dependent even though he is not in this country?

A. — If he is a U. S. citizen and you have provided his chief support then the fact that he lives in Ireland would not disqualify him as a dependent. One of the requirements for a dependent is that he be either a U. S. citizen, or a resident of the U. S., Canada, Mexico, the Panama Canal Zone or the Republic of Panama for some part of the tax year.

Q. — I didn't get a blank income tax return in the mail. Where can I get the necessary forms?

A. — You can get them at any IRS office and at most post offices and banks.

Q. — What can I do with child support payments I am required to make. Are they deductible?

A. — Child support payments are not deductible by you nor are they taxable to your former

wife. However, if you provide more than 1/2 the child's support, then you may claim the \$600 dependency exemption on your return.

Q. — Tips are one of my sources of income. What is the best way to keep track of them? I work as a waitress.

A. — A daily diary is one of the best records you could keep. Every day enter in it the amount of tips you receive that day.

Don't forget that starting this year income and Social Security tax will be withheld from your wages on your tip income. You are required to report to your employer what you receive in tips if it amounts to \$20 or more a month and was earned while working for one employer.

The withholding requirement would not apply if your tips amounted to \$30 a month but were split between jobs with two employers, so that you received less than \$20 from each place you worked that month.

However, the \$30 in tips is taxable income and must be included in your tax return.

Social Security Tax Increase Now In Effect

WASHINGTON--Your pay envelope will be thinner after January 1. The reason: An increase in Social Security taxes, according to the Chamber of Commerce of the United States.

If you earn \$6,600 or more a year, your tax will jump 59 per cent or \$103; you will pay \$227.20. If you earn less, the tax jump will be less.

The tax increase was enacted in the last session of Congress concomitant with Medicare and legislation raising Social Security benefits.

Under the law, the tax will rise periodically to a top of \$372.90 in 1987.

However, if history holds true,

Congress will add more benefits to Social Security, and by 1987 the top tax might be nearer \$1,000 a year.

This prospect is not as farfetched as it might seem. The AFL-CIO convention at San Francisco this month called for a doubling of Social Security taxes to help pay for a proposed 50 per cent increase in benefits.

The Social Security tax has been one of the fastest rising of all our taxes. The top tax on an individual next year will be more than eight times what it was at the start in 1937. It was then \$30.

Effort To Be Made To Clear State Of Sheep Scabies

The Texas Animal Health Commission assisted by the Animal Health Division of the United States Department of Agriculture has launched an extensive inspection of all sheep flocks in Texas.

Dr. W. A. Belcher, Area Veterinarian of Bracketville will supervise inspection of sheep flocks in this area. Dr. Belcher has advised county agent Pete Jacoby that inspection of sheep flocks in Crockett County will start around January 15.

As a result of two outbreaks of sheep scabies within the last year other states have imposed dipping requirements that hamper the marketing of Texas sheep. Relinquishing of these requirements will be considered upon an inspection of all flocks without evidence of scabies being found. Industry cooperation is needed so that the necessary inspections may be conducted in an organized manner with a minimum of inconvenience to the sheep producer.

The County Chairman of the Southwest Animal Health Research Foundation and the Agricultural Extensive Service through the local County Agent are assisting in the cooperative effort.

Dee Davis of Fort Stockton will be the inspector for the western and northern portions of the county while Doyle Daniels of Del Rio will inspect flocks in eastern and southern portions of the county. The county agent and a committee of local ranchmen will assist the inspectors by scheduling the daily inspections.

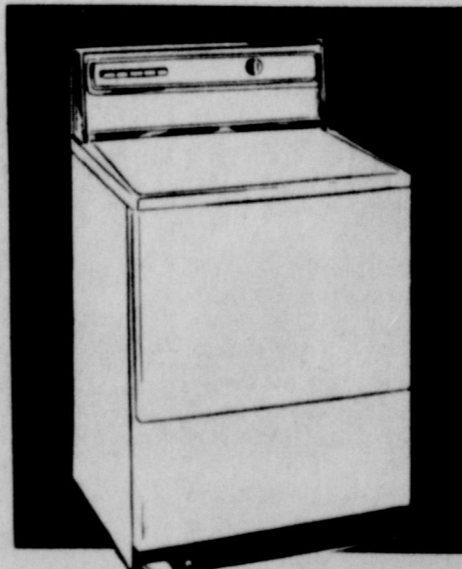


