County Board Has Two Vacancies For April Vote

Trustees to the County School Board from Precincts One and Three are to be named this year on April 2, the same time as the naming of two trustees for the Independent School District Board of Trustees.

The County Trustees now holding the posts are G. E. Babb and G. K. Mitchell from the respective precincts, but neither has announced for re-election.

School Tax Raise Is Due Next Year Due To Change In Economic Index

Terrell County is one of five counties in the state which had an increase of more than 10% in assignments, which means a bigger payment of total expenses by local school taxpayers.

Hudspeth and Jeff Davis counties also had increases of more than 10%.

These figures and facts have a total effect on the local tax

figure of causing an increase of between \$8,000 and \$10,000.

Adoption by the State Board of Education of a revised economic index, required by law, is one of the reasons for the local raise, according to A. H. Zuberbueler, tax assessor and collector for the local school district. Other factors are the county's assessed valuations and scholastic population.

An official of the Texas Education Agency said that assignment of local funds is, by coincidence, up 4.6 per cent, but there's no real relationship, he added.

All the counties with an economic index equal to last year's will have to raise more money this year because of the increase in the Minimum Foundation Program. The legislature has set local school district contributions for 1966-67 and thereafter at 20 per cent of the total cost of the Minimum Foundation Program. Added to this is the difference between the gross local fund assignment and the net from the preceding year as determined by the economic index.

The index figures the local funds available for support of the foundation program.

Only by way of example, the figures for the counties surrounding Terrell are: Brewster has an increase of 5.6%, Pecos up 3.9 per cent; Crockett up 2.3, and Val Verde down 1.1%.

Eagle Tracksters To Run In Crane

Jack Cosby is coaching the Sanderson High School track team this year. They competed in the Comanche Relays in Fort Stockton two weeks ago and in the Ozona Invitational meet last weekend.

Members of the team include Bill and Ray Adams; Dane Elrod, Andrew Riess, Pat Little, Joe Calzada, Vernon Munson, Glen Haynes, and Barney Maples.

There were nine towns represented in the meet: Ozona, the winner; Eldorado, Bandera, Big Lake, Sonora, Junction, Iraan, Sanderson, and Comstock, finishing in that order.

Sanderson's 24-1/2 points came with Ray Adams placing 4th in the 440-yard dash and Andrew Riess tying for 6th; Haynes running 4th in the 850-yard run; Haynes placing 3 in pole vault; Sanderson placing 5th in the 440-yard relay and 6th in the 850-yard relay, and 5th in the mile relay.

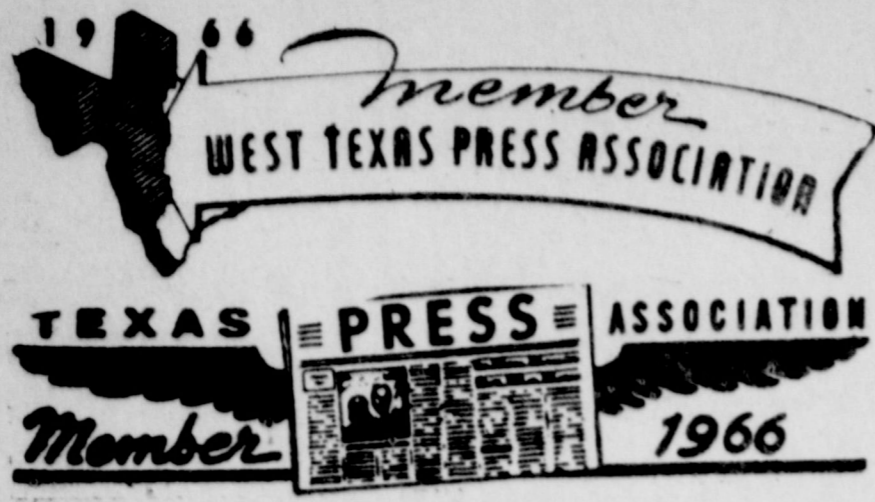

Peeking Into Your Mail

Tipped off by a suspicious mailman, postal agents opened a packet which a woman mailed—first class—to her husband.

Sure enough, the packet contained illicit heroin. But when the woman was brought to trial on a narcotics charge, evidence of the find was thrown out of court and she went free.

The court was not being "soft" on narcotics. What troubled the court was the government's violation of the privacy of first class mail. Such an intrusion was held to be an "unreasonable search and seizure"—forbidden by the Fourth Amendment to the Constitution.

This Amendment grew out of colonial bitterness against the infamous "writs of assistance," under which British officials had free rein in searching private homes.

And, almost a century ago, the Supreme Court made it clear that the Amendment protects not only your residence but your first class mail as well. In the Court's words:

"The right of the people to be secure against unreasonable searches and seizures extends to their papers, thus closed against inspection, wherever they may be."

On the other hand, there is no such protection for mail other than first class. Furthermore, in the interest of combating crime, even first class mail may be searched if authorities first obtain a warrant. Then the search would not be "unreasonable," because the warrant would be issued only if there was reasonable ground to believe the law had been violated.

Moreover, the government may impose what is called a "mail watch" to help in tracking down wrongdoers. In this procedure, a record is kept of the name and return address of everyone who sends mail to the person under surveillance.

Not long ago the mail watch was challenged in court as at least a partial invasion of the privacy of first class mail. But the court upheld the government, saying:

"It was not prying into their secrets to note what the senders had made public on the face of the letters."

And there, generally speaking, is where the law draws the line today. The government may gather the information you place on the outside of an envelope, but must not peek within. That dab of mucilage on the flap, buttressed by the constitutional commandment, is one of the mightiest barriers on earth.

 ery measure that we can get to select the best qualified man for each position that is to be filled, leaving out all personalities, all personal likes and dislikes, all of our own foibles, prejudices, using all of our knowledge and reasoning to name the best man for the post at all costs.

This is a real good ideology. We advocate this type of thinking in the selection of all candidates. But it's all ideology!

Why, otherwise, would a society that advocates such an ideology, press so strongly for the possibility of each person in the U. S. voting without any test of intelligence or knowledge, only the requirement of making his mark ... or registering to vote.

Intelligence in voting is one thing, intelligence in voters is something else.

The society in which we are living makes human prey of a large percentage of the "qualified" voters of this nation. They will be used to every advantage by every conceivable means.

Our society is becoming more and more a nation of laws, all of which - we are told - are designed for the protection of the

"rights" of certain classes. We are having to live by these laws to such a degree that each law makes living a little more tedious and a little more difficult. There was a pattern for the living together of men given which had very few laws that were written or needed to be. This pattern had little similarity to the type of living that is being forced on this nation by continuous laws.

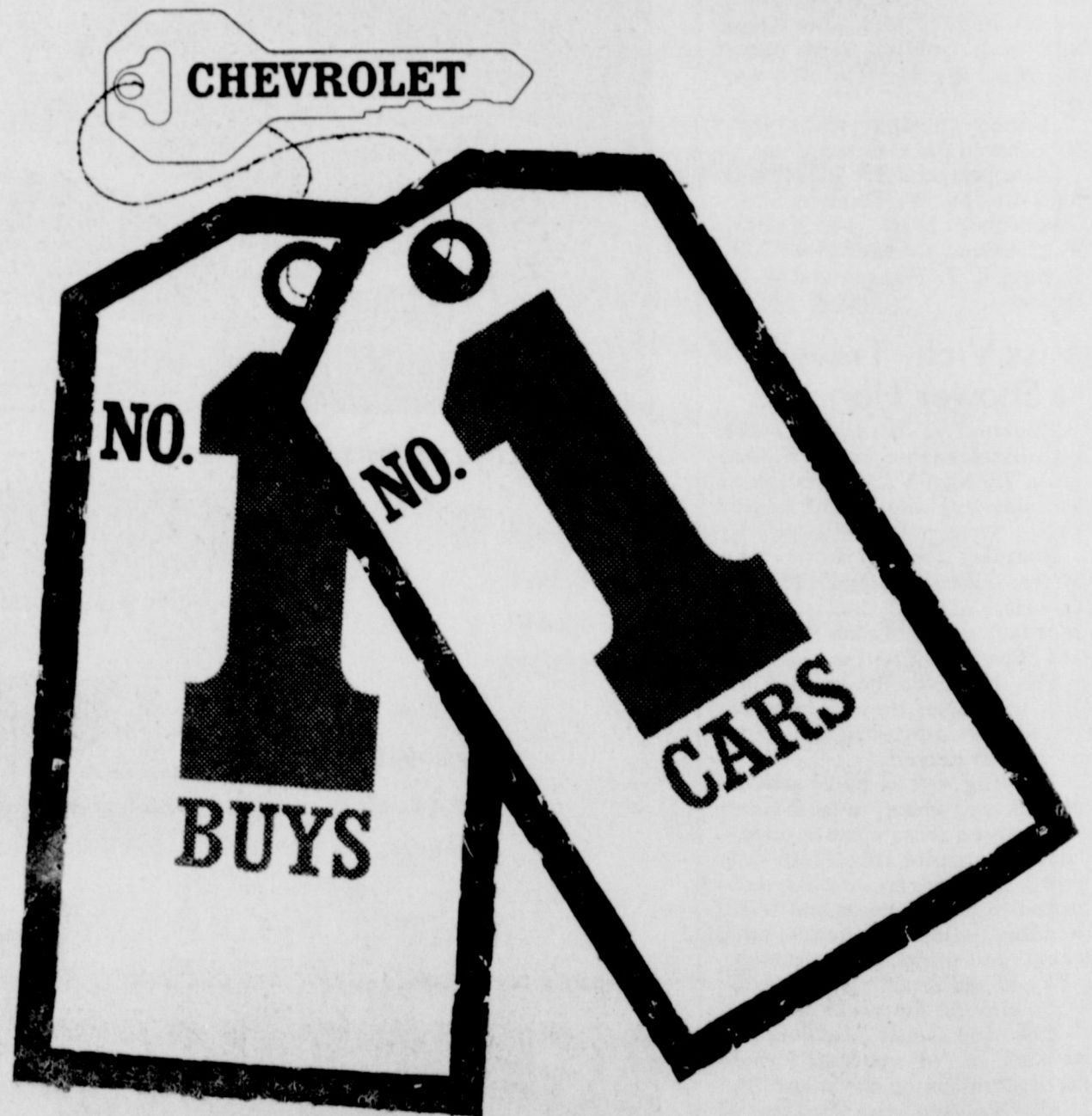
