Sudduth Offered MC Bidg. Contract

APRIL 27, 1967

At a meeting of the executive committee of the Trans-Terrell Medical Center with the building committee Monday night, it was decided to offer the contract for the construction of the medical center building to O. T. Sudduth. Sudduth had the second lowest bid of five bidders and the offering was due to the release of Paul Smetak of Fort Stockton after he failed to meet the terms of the contract.

It was stated that it had been previously agreed that certain conditions must be stipulated in the contract between the builder and the executive committee and that failure to meet all of the requirements voided the contract.

The group is expected to meet with Sudduth within the next few days to negotiate the contract.

The expected starting time for the construction will be revealed as soon as an agreement is reached between the executive committee and Sudduth.

School Board Plans **Bond Discussion** For New Building

The trustees of the Terrell County Independent School District plan to meet with a financial advisor to approve a bond issue budget and to determine financing arrangements for the proposed building program. The tentative date, amount of the bond issue, and details of the plans will be given after it is determined the amount of financing available, feasible, and possible, along with the needs, according to Supt. Enforcement Due, Harrell Warns

Aubry Harrell, who is responsible for the local enforcement of the law concerning dogs, has issued a warning to all dog owners that all of the responsibilities of dog ownership must be met.

Harrell stated that he had reference to that part of the law concerning the chaining or penning of dogs - even though they are tagged - between sunset and sunrise.

Several dogs that have tags have been seen loose at night and this carries a penalty of up to \$100 fine if convicted, according to Harrell, who says that he intends to file on owners of tagged but loose-at-night dogs.

Harrell stated that the purpose of the law was not to sell tags, or to tag dogs, but to establish some control over dogs that had owners and those that are strays and try to prevent the unnecessary slaughter of livestock by any dogs. The tagging of dogs, alone, does not prevent this, he said, and the establishment of ownership by the tags, makes someone liable for the actions of the dog.

The cooperation of all dog owners is urgently and sincerely requested.



Notaries Public Must File, Pay Fee Before May 15

All qualified Notaries Public desiring re-appointment for the new term which begins June 1, 1967 and ends June 1, 1969, must pay the required fee and file a new application, oath and bond with the County Clerk of his residence between May 1, 1967 and May 15, 1967, inclusive.

Notaries Public should not send requests for re-appointment or for commissions directly to the Secretary of State inasmuch as the law specifically requires that the County Clerks approve Notary Bonds and forward copies of the Application to the Secretary of State.

Each person applying for a commission as Notary Public must be at least 21 years of age, a citizen of the United States and of Texas and a resident of the county for which he is appointed. The required Application Forms may be obtained from the County Clerk.

Any person not now a Notary Public who desires appointment for the beginning of the new term should apply to his County Clerk before May 20, 1967.



Postal Savings Cease Earnings On April 27th

"United States Postal Savings Certificates which are on deposit at post offices will cease to earn interest for depositors on April 27, 1967," Postmaster J. R. Hodgkins said this week.

Nationwide, the Post Office Department is holding more than \$90 Million in the now obsolete program which was discontinued by the Congress on March 28, 1966.

As of April 27, a year ago no deposits were accepted by the Department. Certificates whose anniversary dates have been reached since last April 26 have earned their final interest payment. Postmaster Hodgkins said.

On June 30, all remaining funds in the program will be turned over to the Treasury Department to be held in a trust fund until liquidated. There they will remain available for payment without time limitation whenever proper claims are received.

Postmaster Holdgins urged that all Postal Savings depositors close out their accounts and invest their funds in United States Savings Bonds or the new Freedom Shares, which on May 1, will pay 4.75% interest.

Holders of Postal Savings certificates can arrange to redeem them simply by applying at the postoffice where the certificates were issued. The postmaster there will provide guidance and necessary forms to assist in cashing certificates. All transactions can be handled by mail and certificates issued to persons now deceased can be cashed by legal heirs in accordance with state laws governing such distributions. Again, the postmaster at the issuing office will give authorized assistance

Orville Hoge, St. Louis, Mo., died Wednesday of last week and was buried in that city following funeral services.


