Big Bend Books Show Flora, Fauna To Be Colored

A booklet showing sketches of flowering plants native to the Trans-Pecos area of Texas, complete with descriptions of each, has been published by Dr. Barton Warnock, chairman of the division of Science at Sul Ross State College.

Color pictures of the sketches are shown on the outside cover of the booklet, which soon will be on sale throughout the Trans-Pecos area.

Drawings in the booklet were done by Mrs. Betty Walker, wife of James R. Walker, a ranger in Big Bend National Park.

Dr. Warnock, a native of Fort Stockton, explained that all 27 different flowers may be found in Big Bend National Park and that most of them also are plentiful in the Davis Mountain area.

Besides providing sketches and explanations of the historical and economic significance of each plant, the booklet may be colored, with the true colors shown on the cover pictures as guides.





Terrell County Name Is Taken Into Viet Fight

The tank landing ship USS Terrell County has been in action near the demilitarized zone in Viet Nam recently, according to word released by the Commander of the Amphibious Force of the United States Pacific Fleet, with headquarters in San Diego, Calif. The USS Terrell County was commissioned during World War II and has seen action since that time. Following is the story sent by

CAFUSPF concerning the action.

Aboard USS Tripoli Off South
Vietnam, July 11 -- Flight deck
crews, medical teams and boat
coxswains continued to work around the clock aboard the Navy's Seventh Fleet Amphibious
Force ships to keep fleet Marines engaged in a fierce battle

ashore supplied.

As operations "Bear Claw" and "Beaver Track" moved into the seventh and eighth days respectively six miles south of the DeMilitarized Zone, night and day helicopter operations continued from the amphibious assault ships USS Tripoli and USS Okinawa in evacuating the wounded from the field and keeping the embattled troops supplied.

Prior to the medical teams moving to casualty collection stations in the field yesterday, they treated more than 200 casualties in the two amphibious assault ship's medical spaces. The teams put in nearly 48 straight hours working with the wounded through the last two days. Lt. Cmdr. Ronald Bouterie, of New Orleans, the doctor who heads the surgical team on Tripoli, said that none of the doctors or corpsmen felt they could do enough.

Flight deck crews on the Tripoli and Okinawa pumped tons
of fuel into Marine helicopters
to keep them shuttling between
the carriers and the shore. Hot
meals, fresh fruit and juices
along with ammunition and other supplies were delivered to
the Marines.

The Okinawa is serving as the flagship for Capt. P. S. McManus of San Diego, commander of the amphibious task group in Bear Claw.

"We're trying to give them everything they ask for," said Capt. J. L. Lowentrout of Coronado, Calif., the task groups commander for Beaver Track. Speaking of the task group's crews he said, "They are tired, but they are doing their duty without complaining and doing a magnificent job of it."

Meanwhile assault boat coxswains kept moving more troops
and supplies up the Qua Viet to
the Song Bo Dieu River to Dong
Ha. Close by the mouth of the
Qua Viet the amphibious transport docks USS Ogden and USS
Duluth, the landing ships dock
USS Monticello and USS Hermitage, the attack cargo ship
USS Seminole and the tank landing ship USS Terrell County,
cruised as boat havens for the
small craft.

The amphibious flagship USS Eldorado stood by off shore providing communications support.

Eight days ago battle weary leathernecks from the 2nd Battalion, 3rd Marines jumped into the battle south of the DMZ just two days after finishing an amphibious landing 17 miles south of Da Nang... In seven days of fighting in Beaver Track the fleet Marines have accounted for 148 enemy killed.

SP Plans Air Freight Service

Southern Pacific Company said today that it plans to inaugurate a domestic and international air freight forwarding business designed to bring the advantages of air freight to shippers in thousands of communities where it is not now readily available.

The San Francisco-based transportation company, already one of the most widely diversified, has filed incorporation papers for a new subsidiary, Southern Pacific Air Freight, Inc., to carry out the plan, and is asking the CAB for authority to put it into operation.

SP's president, B. F. Biaggini, said his company plans to use the truck fleet of its motor carrier subsidiaries to pick up air shipments in numerous communities they now serve in twelve states, take them to airports, and turn consolidated shipments over to existing air carriers. At destination airports, trucks would pick up the shipments for delivery. The entire transaction would be handled under a single charge.

At cities not now served by Southern Pacific, both American and foreign, SPAF would provide arrangements to handle the pick-up and delivery of air feight shipments.


