The citizens of Terrell County responded in a very generous way to the appeal for clothing and non-perishable food for the relief of victims of Hurricane Beulah. St. James Parish Hall was named as the collection center and everything was sorted, sized, and packed in boxes after any necessary mending was done. After the fourth day, two pick-up loads and a stock trailer load were sent into San Angelo to the Salvation Army headquarters. The workers there were high in their praise of the manner in which the supplies reached them and with no further handling they were sent directly into the flood area. Containers were placed in the businesses for cash contributions and several contributions were handed in at the collection center.

The local Red Cross Chapter is having a drive for cash contributions.

The Baptist Church is collecting articles this week and distribution will be made from Baptist Churches in the Valley.

Bow Hunting To Be Allowed Here For Deer

A letter from a Midland bow hunter Tuesday resulted in Terrell County's being opened up to deer hunting for archers.

The letters from William G. Wright, who holds a hunting lease in Terrell County, complained the county has a larger deer population than any other county West of the Pecos and ranchers and hunters had expected the deer season for archers to be opened this year for the first time.

Commission chairman Will Odom of Austin asked his staff for a briefing on the situation in Terrell County and was told the county was controlled by statute and not by the commission until this year.

SP Service To Be Aired at Hearings

The Interstate Commerce Commission has scheduled a series of five hearings in late November and early December on the adequacy of passenger service on the Southern Pacific Railroad between Los Angeles and New Orleans, the Commission has advised Congressman Richard C. White.

The El Paso Congressman had earlier requested the Commission to investigate the problem after numerous complaints from his District that the railroad had discontinued both Pullman and diner service, that cars were dirty, and that the railroad seemed to be deliberately discouraging passenger service. Formal. complaints were submitted by the State Railroad Commissions of California, Arizona, New Mexico, Texas, and Louisiana, and formal hearings on these complaints are now scheduled.

The El Paso hearing is scheduled at 9:30 A.M., December 1, at room 512 United States Court House, to hear cross-examination of witnesses for the State Corporation Commission of New Mexico and persons in support thereof, as the hearing examiner may direct.

The hearings begin November 27 in New Orleans. Others are scheduled for November 29 in Houston, December 4 in Tucson, and December 6 in Los Angeles.

Meanwhile, Congressman White is receiving complaints from his El Paso constituents over the planned cancellation of the last remaining passenger train to the northeast---the Colden State Limited between El Paso and Chicago. These complaints, too, are being referred to the Interstate Commerce Commission.

During the half-time, bands from both of the schools presented a show for the entertainment of the fans.




