# Mapping of Area Begun by U.S.G.S.

The Topographic division of the United States Geological Survey has opened a temporary field office in the Ferguson Building.

Survey parties working out of this office will do the field work necessary to compile topographic maps of approximately 1,024 square miles.

These topographic maps will be compiled from aerial photographs, using the latest scientific equipment.

Part of the field work will consist of establishing the elevation of certain features that can be identified on each photograph. The latitude and longitude of certain points must also be determined to accurately match the current mapping to mapping done in the past and also to that which will be done in the future. It is also necessary that all parts of the projects be visited to classify the roads or trails as to surface material, condition, etc. Other information that must be obtained in the field to supplement the aerial photographs is stream classification; names of prominent features; and classification of buildings.

The area to be mapped is a square of approximately 33 miles, the east line being about five miles west of Sanderson, the west line at about Lemons Gap. The south line is about eight miles south of US 90 on the east line and the north line about 25 miles north of US 90.

under the direction of William V. Kennedy, District Engineer, and is being supervised by Ken-D. Cox, Project Supervisor. The electronic distance measurements are under Coyle Horton. Other permanent personnel of the Geological Survey employed on these projects are Leslie S. Porter, Thomas Stovall, William Rennels.

Topographic maps of the Ceological Survey are published on sheets called quadrangles. Each quadrangle covers 7 1/2 minutes in latitude and 7 1/2 minutes in longitude or approximately 64 square miles in this area. The maps accurately show all roads and trails and their classification; all buildings and their use, such as barn, house, church or school. Streams are shown as being either intermittent or perrennial. Also if available the names of all prominent features are given. This is in addition to the contour lines and elevations which portray the configuration of the land,

These maps have many uses. Some of these are planning industrial expansion; ground and water studies; location of new roads, pipe lines, powerlines; and irrigation and drainage ditches. They are used by military people; engineers; the census bureau; and the weather department. In some areas they are invaluable to hunters and fishermen.

The cooperation of local land owners and the general public will be appreciated by those who are working on the project.







PUBLIC NOTICE

OF THE REQUIREMENT FOR RECORDATION AND LIMITA-TION OF CERTAIN CLAIMS OF WATER RIGHTS.

Notice is here given as re-quired by Section 4 of the Water Rights Adjudication Act of 1967 (Article 7542a, Vernon's Civil Statutes) that all claims of riparian water rights, all claims under Article 7500a, Revised Civil Statutes of Texas, 1925. to impound, divert or use public waters for other than domestic and livestock purposes for which no permit has been issued, all claims of water rights under the Irrigation Acts of 1889 and 1895 which were not filed with the State Board of Water Engineers in accordance with the Irrigation Act of 1913, as amended, and all other claims of water rights other than claims under permits and certified filings, must be recorded with the Texas Water Rights Commission. Section 4 does not apply to use of water for domestic and livestock purposes as the same is defined by Commission Rules.

On or before September 1, 1969, every person claiming any water right to which Section 4 applies shall file with the Commission a sworn statement setting forth the nature of the claim of water right. Claims to which the Section applies shall be recognized only if valid under existing law and only to the extent of actual application of water to beneficial use without waste during any calendar year from 1963 to 1967, inclusive. However, in any case where any claimant of a riparian right has prior to August 28, 1967, commenced or completed the construction of works designed to apply a greater quantity of water to beneficial use, such right shall be recognized to the extent of the maximum amount of water actually applied to beneficial use without waste during any calendar year from 1963 to 1970, inclusive; provided an additional sworn statement is filed on or before July 1, 1971. Failure to file the sworn statement or statements in substantial compliance with Section 4 shall extinguish and bar any claim of water right to which the Section applies.


