## -ISTEN TO LUKE

Since Carlos Dunn moved to Alpine last year there has been a vacancy in the office of County Democratic Chairman.

Up to now, this vacancy has been seemingly unimportant, but the time has come when candidates, locally and over the state must file to have their names on a Democratic Primary ballot and the county chairman is the person to take the filing, set up the ballot, election, etc.

The naming of an interim county chairman is clearly set up by law as are all other actions of the county committee and the chairman.

This can be an important post and proper consideration should be given in the naming and acceptance of the interim job. The office is up for grabs in the primary.

It is interesting to note that in recent days the towns of Min-land and Kermit voted down the city sales tax and Odessa refused to have the election on the issue.

We don't know the thinking of the people in those cities and their refusal to accept the tax or hold the election, but it would seem to us that they may have been thinking about their own business economy.

The sales tax is little more than only a nuisance to those who are making the purchase. In these inflated times, two or three cents here and there for a small purchase could not greatly affect the living standard of many families.

This small nuisance could, in many cases, though, cause people to shy away from the cities with the sales taxes when they "go to town".

From where we sit, any town in this area which is a shopping center for a large number of people cannot afford to be the only town with the local sales tax.

It would be impossible for us to conceive of any method of taxation that is more fair than paying a tax for each and every purchase. This is equality of the first order. But the nuisance of the pennies, the keeping of records for the business man, etc., make it an unpopular tax to most people.

And the use of a local sales tax to lower the ad valorem tax on property - which is about as lop-sided a tax as you can think of - is not popular because usually there are more non-property owners and they want those

"with money" to pay the taxes.

There is no conceivable way that we know of for the adoption of a sales tax locally to be sufficient enough to go very far in the operation of anything, so we are not hollering for a sales tax. But if and when the time comes when it would be a large source of revenue locally, we will begin shouting loud and clear for it.

An election of three directors for the Terrell County Water Control and Improvement District No. 1 will be on Tuesday of next week. Polls will be open from 8:00 a.m. to 7:00 p.m. at the county court house.

The incumbents whose terms expire are Jimmy Caroline, M. W. Duncan, and Greene Cooke, and all three are seeking reelection.

### Postal Rates Up To 6c For Mail In And Out of Town

Increased rates for all classes of mail except parcel post and international mail will go into effect January 7, Postmaster J. R. Hodgkins reminded postal customers today. This increase includes mail for delivery out of town and in town. The local postage has also been increased to 6¢ per oz. on first class mail.

Postmaster Hodgkins pointed out that the new rate for post cards will be five cents and for air mail post cards eight cents.

He said the added cent in the letter rate is a 20 percent increase compared to a 24 percent boost in the rates for mailing newspapers and magazines and a 34 percent hike for advertising circulars, "occupant" mail, and other material in the third-class category.

There will be no changes in the charges for special delivery, special handling, registered mail, certified mail, cash on delivery or insurance, Postmaster Hodgkins said.

Higher rates also will go into effect January 7 for all categories of second-class mail, bulk-rate third-class mail, controlled circulation mail, and the educational materials category of fourth-class mail. Mailers using these classes who need information on the new rates should contact the local Post Office, Postmaster Hodgkins said.



### **Drivers' Licenses** Will Cause Trip To Issuing Station

Col. Homer Garrison Jr., director of the Texas Department of Public Safety reminded Texans today that a color photograph becomes a standard part of all drivers' license issued after January 1, 1968.

"The change makes it necessary for all drivers to renew licenses in person at one of our Department offices," Garrison said, "and we have been working toward setting up a procedure that will not cause excessive delay when a person comes to us to renew a license."

Garrison explained that the change in license was incorporated into law by the last legis-

"Renewal notices will be mailed to each driver, just as always," Garrison said. "However, under the new procedure, each driver must take the renewal notice to the nearest DPS office. There he will be given a standard vision test, sign the renewal notice and step in front of our camera. The picture will be snapped and a receipt will be issued to enable the person to drive until he receives his new license in the mail."

Garrison explained that about 250 full-time license offices would be in operation over the state to service license renewals. Issuance of new licenses will also be conducted in many of these new offices as well as at offices already established. A new office has been established in Fort Stockton.



# Drivers' Licenses Will Cause Trip To Issuing Station

Col. Homer Garrison Jr., director of the Texas Department of Public Safety reminded Texans today that a color photograph becomes a standard part of all drivers' license issued after January 1, 1968.

"The change makes it necessary for all drivers to renew licenses in person at one of our Department offices," Garrison said, "and we have been working toward setting up a procedure that will not cause excessive delay when a person comes to us to renew a license."

Garrison explained that the change in license was incorporated into law by the last legis-

"Renewal notices will be mailed to each driver, just as always," Garrison said. "However, under the new procedure, each driver must take the renewal notice to the nearest DPS office. There he will be given a standard vision test, sign the renewal notice and step in front of our camera. The picture will be snapped and a receipt will be issued to enable the person to drive until he receives his new license in the mail."

Garrison explained that about 250 full-time license offices would be in operation over the state to service license renewals. Issuance of new licenses will also be conducted in many of these new offices as well as at offices already established. A new office has been established in Fort Stockton.


