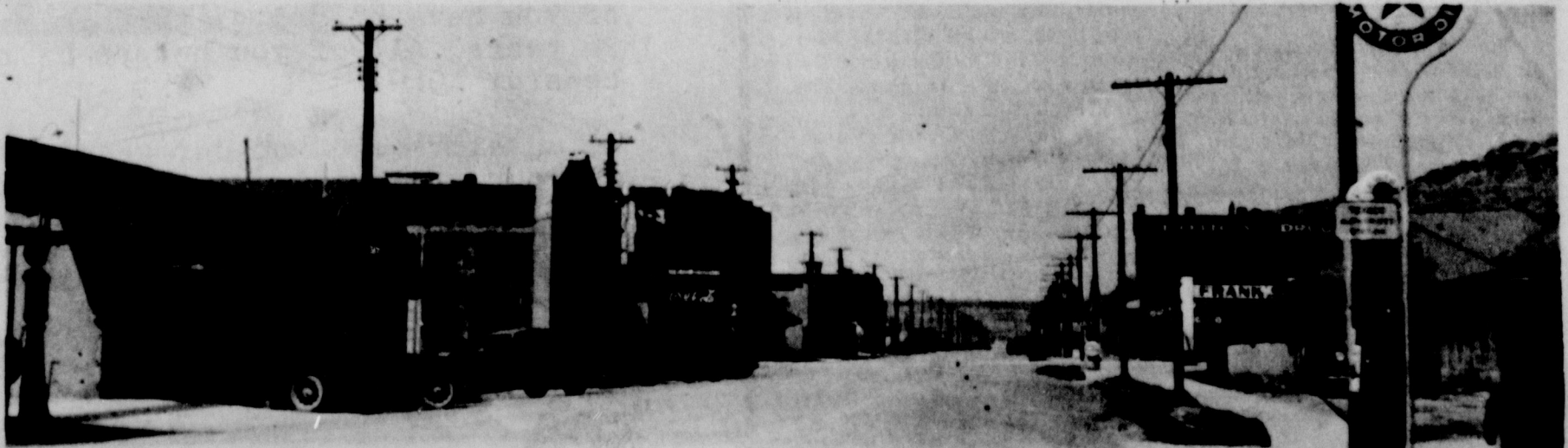

hospital, and it's quite obvious that we can't continue to operate with such a liberal policy". The board instructed John Eathorne, hospital administrator, to prepare a sound policy toward admission deposits at their November meeting. The document was approved by the medical staff on December 16, and the board on December 18.


In essence, a sliding scale of deposit requirements will be effected. The base for the scale is the number of days the patient will be in the hospital as estimated by the attending physician. Patients having insurance policies that will pay directly to the hospital will have the value of the insurance benefits deducted from the admission deposit requirement. Pa-

tients having insurance policies which will not pay directly to the hospital will have to meet the deposit requirements. In this latter case, the insurance company will reimburse the patient.

The medical staff has assured the hospital board that they will advise their patients of this new policy.
