Spring is almost here! It took a lot of money to dispose of the many animal carcasses that were strewn over the entire dump area - from the front entrance all the way back and sideways. This is an unnecessary cost to the taxpayers of the county in our way of thinking and one of the reasons why we have been so adamant about it - not counting the terrible pollution of odors and germs, the literally swarms of flies that accompanies decaying carcasses that are not properly disposed of.

There is no way - feasibly that we know of to prevent something like that happening again except by everyone doing his part in properly disposing of his own garbage, trash, pumped-out se wage, carcasses,

We would think that the proper disposition of ordinary trash and garbage would be a little simpler than some of the other things, but asking about the proper place to dump or the manner of disposition should reveal a good solution.

There are those who take their own trash and garbage out to the dump instead of letting it be picked up on routine collections - and for reasons of eir own. And if they want to be in on the pick-up for \$1 a month then they should contact Frank Weigand, Precinct 1 Commissioner, and we feel sure that something could be worked out. This is not only a cheap service, but it is more orderly in the disposition of the trash, generally!

Probably with the continuation of things in their present trend, it won't be long before the burning of trash might be illegal all over the nation and there will be some strict regulations concerning the disposition of garbage and trash.

Any way you look at it, all of the trash that is dumped in this area winds up now in Lake Amistad and while the washing waters tend to clean up our area of litter, the same waters cause the same litter to be congregated within the lake and pollute the waters there to the same degree.

Marvin Allen was charged with assault with intent to murder with malice at proceedings on Monday afternoon before Justice of the Peace W. G. Shoemaker who set the bond at \$7,500.00. Allen remained in jail at that time in lieu of

The charge followed an incident at the Allen home on Cargile Street about 8:00 a.m. on Monday. Mrs. Allen was shot in the right side of the back with a shotgun, according to the report of officers. Mrs. Allen was in the front yard at their home when she was picked up to be taken to the hospital and according to reports from the doctors to officers and friends, the wound required the removal of a large portion of the intestinal tract and stomach and she remained in intensive care Tuesday morning with her condition reported as critical.

She was taken to a Fort Stockton hospital.

Allen was arrested at his home shortly after the shooting occurred.

## **Approval Given Flood Control Project Work Plan At Meeting Here Tuesday**

Approval of the work plan for the construction of flood control dams on the Sanderson Canyon Watershed was given at a meeting at the Terrell County courthouse Tuesday afternoon. The approval was by the various organizations of the area involved in the plans and maintenance of the project.

The sponsors of the project are the commissioners courts of Terrell, Pecos, and Brewster counties, the Big Bend Soil and Water Conservation, Trans-Pecos Soil and Water Conservation District, and the Rio Grande-Pecos River Soil and Water Conservation District.

The project was worked out under the sponsorship of the Soil Conservation Service of the Department of Agriculture, which was responsible for the complete work plan.

Other representatives of the various agencies of the area and state were introduced and included the Texas Water Rights Commission, Texas Parks and Wildlife Commission, Texas Highway Department, Texas Soil and Water Conservation Board, Southern Pacific Railroad, International Boundary and Water Commission, and officials of the sponsoring organizations.

Special recognition for outstanding efforts were given to County Judge R. S. Wilkinson, Darwin Schrader, Soil Conservation Service; and to the Soil Conservation Service planning and engineering officials who have been the center of the planning and engineering of the entire project.

Following the presentation of the plan and concurrance of the sponsoring organizations in the work plan, signatures of the of-ficers of the sponsors were obtained. Progress of the report will be to present a digest of the project's plans to the governor and his recommendations for approval, then presentation of the plan to the appropriate congressional committees for approval and allocation of the funds for construction.






