We are publishing for the second time the proposed amendments to the State Constitution. The proposals will appear at the bottom of the general election ballot in November for consideration by Texas voters.

The amendments will be printed for the next two weeks in the Times as required by law. Readers are urged to study them carefully.

Most controversy is expected center around proposal Number Two, which would repeal Texas' ban against open saloons in order to allow the sale of hard drinks on local option basis. The pros and cons are ready girding for battle on one and it is expected to come into even more prominence in the weeks ahead.

Of interest were some figures compiled by the Texas Mid-continent Oil and Gas Association showing the taxes paid the petroleum industry of Texas. It says that the Texas petroleum industry taxes provide 26.3% of state tax revenues for public education and 18% of state financing for the following funds: teachers' retirement, old age assistance, disabled assistance, dependent children assistance, medical assistance, and farm-to-market roads.

TS&GRA Backs Amendment No. 3

The Texas Sheep and Goat Raisers' Association went on record supporting Amendment Three to the Texas Constitution at the conclusion of its 55th annual convention in San Antonio.

In the eight major resolutions passed by the general assembly at the meeting, the one dealing with amendment three is perhaps the most discussed of all. It would result in legislation causing agricultural lands to be taxed on the basis of their capabilities rather than on speculative values. TS & GRA officials joined the cattle raisers organization and other agricultural groups in urging the passage of the amendment.

The nearly 400 members attending the three-day convention also passed a resolution from the wool and mohair marketing committee requesting congressmen and senators from Texas to lend their support to the Mills Bill (HR 16920) and the like Senate bill by Senator McIntyre. The bills deal with establishment of quotas on textile products which are currently threatening the existence of domestic wool, mohair and textile processing industries.

Nominations For ASC Committee Now Possible

Terrell County ranchmen now have the opportunity to nominate by petition candidates for ASC county committeeman. "This year we hope producers in Terrell County will nominate by petition a full slate—a minimum of six candidates to choose from to elect one committee member and two alternates," Clarence Jessup said. Jessup is chairman of the Terrell County Agricultural Stabilization and Conservation Committee.

County committeemen serve three-year terms, and one member is elected each year. Alternates are elected annually. "It's easy to nominate a candidate by petition," continued Jessup. "All that's needed is a sheet of paper naming a candidate -- and six or more signatures by voters, who are eligible to vote in ASC elections. Petitions are limited to one nominee each, but a voter may sign as many petitions as he wishes. Any ranchman who is an owner or tenant is an eligible voter is also eligible to vote."

If six eligible candidates are nominated by petitions by producers in the county, no other nominations need be made. However, if less than six are nominated by petition, the county committee will complete the slate, according to Jessup.

Jessup has two more years in his term and Herbert Brown has one year. The committeeman with the expiring term is Lee Dudley.

General Rain Tuesday Some Wind Damage

The first general rainfall in this area in several months began about 6:00 a. m. Tuesday and was continuing at this writing late Tuesday afternoon. A high wind accompanying the rainfall did some damage locally to trees and shrubs and there was a break in electrical and telephone service in some parts of town for a while.

The rain and winds were the results of the Hurricane Celia that hit the Texas Gulf Coast at Corpus Christi Monday. The rains were reported from all parts of the county and radio and television reports acclaimed the general coverage of the moisture.

The sheet metal roof over the tables and benches at the American Legion Hall was blown off Tuesday after lunch and cut power lines. The hazard to passing motorists was soon eliminated, but there was some delay in restoring power to the part of town served by the severed power lines.

Winds also unearthed some trees locally and most of the peach crop of Sanderson was on the ground Tuesday afternoon.

Six Cases Polio Reported In Texas Despite Vaccine

AUSTIN - Polio, a crippling, sometimes fatal, contagious disease, is easily preventable, yet six cases of polio had been confirmed in Texas by early July and eight other suspected cases are awaiting laboratory confirmation. All of the cases have resulted in some degree of paralysis and two deaths have occurred.

Dr. L. S. Thompson Jr., of Dallas, chairman of the Texas Medical Association's committee on public health, pointed out that polio is still with us and urged all parents to obtain immediate polio immunization for their children if they were not already protected. "The first dose of trivalent polio vaccine should be given to infants at two months of

age," Thompson stated, "followed by a second dose at four months and a third at six months. The next dose should come at 18 months of age and the final one upon entering school for the first time." Thompson emphasized that all five doses must be taken for full protection.

Of the 14 confirmed and suspected polio patients in Texas, eight are infants under one year old, four are 12 to 21 months of age, and the other two are ages three and four and one-half years. None of them had received any polio vaccine, according to the Texas State Department of Health.

The vaccine is available from individual physicians or local health department clinics and comes in an easy-to-take oral form.

PREDATOR CONTROL MEET SLATED IN ALPINE AUG. 13

All ranchmen and sportsmen interested in a Trans-Pecos predator control program are urged to be at a meeting at the Ponderosa Cafe in Alpine at 8:00 p. m. Thursday, August 13.

The purpose of the meeting is to hear figures on the damage by predators and the results of predator control to livestock and game and try to organize some sort of predator control.

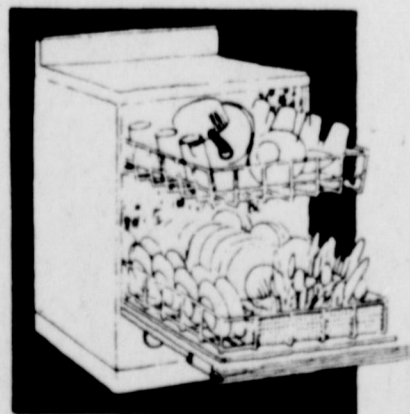

CITIZENS' PETITION SPONSORED BY THE AMERICAN LEGION TO THE ELECTED OFFICIALS OF TEXAS:

We, the undersigned, do hereby support the following principals:
 1. The purpose of a state university or college is to provide facilities for education and training in preparation for responsible positions in our society and not for stimulating political unrest and turmoil.

2. Students attending our public colleges and universities have an obligation to themselves and their schools to attend classes, receive an education and preparation for a useful position in our society.

3. The lives and the future of the vast majority of students are being adversely affected by the disruptive actions of a few.

4. All citizens have the right to dissent, including students and college employees, but that the majority should always prevail in our democracy.

5. The people of this state have a right to expect their tax money to be spent wisely, but not on reconstruction of willfully destroyed property.

6. School administrators have not fully exercised their right to expel law breaking students on the various campuses and required reparations from them.

7. We believe that colleges and universities should be controlled by the Board of Regents who set policy and have same carried out by the Administrators - not by the faculty.

8. This state should no further tolerate rioting by any group, including students. Those found guilty by due process of law should be punished according to law. Students found guilty should be expelled immediately and be prohibited from enrollment in any college or university in Texas which is receiving state aid.

9. Campus discord is being led and promoted principally by individuals who are subversive, radical, revolutionary persons of criminal mind. Certain faculty members of like persuasion are aiding, abetting and sometimes leading disruptive demonstrations or riots.

10. Any faculty member of a state university or college who openly provokes, advocates, urges, campus anti-American political activity, or participates in a riot or anti-American political action on campus should be dismissed and be prohibited from teaching in any school in Texas which is receiving state financial aid.

11. That many of the student leaders of disruption are from out of state and have no place in Texas tax supported institutions. These students should be more carefully screened before admittance.

12. That the Texas Legislature give serious consideration to enacting appropriate legislation and to the writing of safeguards into future appropriations to assure that the foregoing principles are carried out.

Proposed CONSTITUTIONAL AMENDMENT

NUMBER THREE ON THE BALLOT (SJR15) General Election Nov. 3, 1970

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 1-d, Article VIII, Constitution of the State of Texas, be amended to read as follows:

"Section 1-d. The Legislature shall have the power to provide by law for the establishment of a uniform method of assessment of ranch, farm and forest lands, which shall be based upon the capability of such lands to support the raising of livestock and/or to produce farm and forest crops rather than upon the value of such lands and the crop growing thereon."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition:

"The constitutional amendment to authorize the Legislature to provide by law for the establishment of a uniform method of assessment of ranch, farm and forest lands, which shall be based upon the capability of such lands to support the raising of livestock and/or to produce farm and forest crops."

PUBLIC NOTICE

Proposed CONSTITUTIONAL AMENDMENT

NUMBER SEVEN ON THE BALLOT (HJR 22) General Election Nov. 3, 1970

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Subsection (a), Section 64, Article III, of the Texas Constitution, be amended to read as follows:

"Section 64. (a) The Legislature may by special statute provide for consolidation of governmental offices and functions of government of any one or more political subdivisions comprising or located within any county. Any such statute shall require an election to be held within the political subdivisions affected thereby with approval by a majority of the voters in each of these subdivisions, under such terms and conditions as the Legislature may require."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition: "The constitutional amendment authorizing the Legislature to provide for consolidating governmental offices and functions and allowing political subdivisions to contract for performance of governmental functions in any county."

Proposed CONSTITUTIONAL AMENDMENT

NUMBER FOUR ON THE BALLOT (HJR15) General Election Nov. 3, 1970

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article III, Section 51-b, Subsection (a), Constitution of the State of Texas, be amended to read as follows:

"(a) The State Building Commission is created and succeeds to the powers and duties heretofore vested in the agency of the same name by this Constitution and to the powers and duties the Legislature has vested or may vest in the Commission. Its membership shall consist of three Texas citizens appointed by the Governor with the advice and consent of the Senate. The term of each member shall be six years except in the first appointments to the Commission the Governor shall appoint one member for two years, one for four years, one for six years, and thereafter one member biennially. The Governor shall biennially designate one member as Chairman. Vacancies in the Commission shall be filled by appointment by the Governor for the unexpired term. The provisions of this paragraph shall be self-enacting."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition: "The constitutional amendment reconstituting the State Building Commission as a three-member appointive commission."

Proposed CONSTITUTIONAL AMENDMENT

NUMBER FIVE ON THE BALLOT (HJR28) General Election Nov. 3, 1970

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 52, Article III, Constitution of the State of Texas, be amended to read as follows:

"Section 52. (a) Except as otherwise provided by this section, the Legislature shall have no power to authorize any county, city, town or other political corporation or subdivision of the State to lend its credit or to grant public money or thing of value in aid of, or to any individual, association or corporation whatsoever, or to become a stockholder in such corporation, association or company."

"(b) Under Legislative provision, any county, any political subdivision of a county, any number of adjoining counties, or any political subdivision of the State, or any defined district now or hereafter to be described and defined within the State of Texas, and which may or may not include, towns, villages or municipal corporations, upon a vote of two-thirds majority of the resident property taxpayers voting thereon who are qualified electors of such district or territory to be affected thereby, in addition to all other debts, may issue bonds or otherwise lend its credit in any amount not to exceed one-fourth of the assessed valuation of the real property of such district or territory, except that the total bonded indebtedness of any city or town shall never exceed the limits imposed by other provisions of this Constitution, and levy and collect taxes to pay the interest thereon and provide a sinking fund for the redemption thereof, as the Legislature may authorize, and in such manner as it may authorize the same, for the following purposes to wit:

(1) The improvement of rivers, creeks, and streams to prevent overflows, and to permit of navigation thereof, or irrigation thereof, or in aid of such purposes.

(2) The construction and maintenance of pools, lakes, reservoirs, dams, canals and waterways for the purposes of irrigation, drainage or navigation, or in aid thereof.

(3) The construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof.

(c) Notwithstanding the provisions of Subsection (b) of this Section, bonds may be issued by any county in an amount not to exceed one-fourth of the assessed valuation of the real property in the county, for the construction, maintenance, and operation of macadamized, graveled, or paved roads and turnpikes, or in aid thereof, upon a vote of a majority of the resident property taxpayers voting thereon who are qualified electors of the county, and without the necessity of further or amendatory legislation. The county may levy and collect taxes to pay the interest on the bonds as it becomes due and to provide a sinking fund for redemption of the bonds."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition: "The constitutional amendment authorizing any county, on the vote of a majority of its qualified property taxing electors, to issue road bonds in an amount not to exceed one-fourth of the assessed valuation of the real property in the county."

Proposed CONSTITUTIONAL AMENDMENT

NUMBER ONE ON THE BALLOT (HJR30) General Election Nov. 3, 1970

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Subsections (5), (6), (7), (8), (9), (11), (12), and (13), Section 1-a, Article V, Constitution of the State of Texas, be amended to read as follows:

"(5) The Commission may hold its meetings, hearings and other proceedings at such times and places as it shall determine but shall meet at Austin at least once each year. It shall annually select one of its members as Chairman. A quorum shall consist of five (5) members. Proceedings shall be by majority vote of those present, except that recommendations for retirement, censure, or removal of any person holding an office named in Paragraph A of Subsection (6) of this Section shall be by affirmative vote of at least five (5) members."

"(6) A. Any Justice or Judge of the Appellate Courts and District and Criminal District Courts, any County Judge, and any Judge of a County Court at Law, a Court of Domestic Relations, a Juvenile Court, a Probate Court, or a Corporation or Municipal Court, and any Justice of the Peace, and any Judge or presiding officer of any special court created by the Legislature as provided in Section 1, Article V, of this Constitution, may, subject to the other provisions hereof, be removed from office for willful or persistent conduct, which is clearly inconsistent with the proper performance of his said duties or casts public discredit upon the judiciary or administration of justice; or any person holding such office may be censured, in lieu of removal from office, under procedures provided for by the Legislature."

"B. Any person holding an office named in Paragraph A of this subsection who is eligible for retirement benefits under the laws of this state providing for judicial retirement may be involuntarily retired, and any person holding an office named in that paragraph who is not eligible for retirement benefits under such laws may be removed from office, for disability seriously interfering with the performance of his duties, which is, or is likely to become, permanent in nature."

"(7) The Commission shall keep itself informed as fully as may be of circumstances relating to the misconduct or disability of particular persons holding an office named in Paragraph A of Subsection (6) of this Section, receive complaints or reports, formal or informal, from any source in this behalf and make such preliminary investigations as it may determine. Its orders for the attendance or testimony of witnesses or for the production of documents at any hearing or investigation shall be enforceable by contempt proceedings in the District Court."

"(8) After such investigation as it deems necessary, the Commission may in its discretion issue a private reprimand, or if the Commission determines that the situation merits such action, it may order a hearing to be held before it concerning the removal, or retirement of a person holding an office named in Paragraph A of Subsection (6) of this Section, or it may in its discretion request the Supreme Court to appoint an active or retired District Judge or Justice of a Court of Civil Appeals as a Master to hear and take evidence in any such matter, and to report thereon to the Commission. If, after hearing, or after considering the record and report of a Master, the Commission finds good cause therefor, it shall issue an order of public censure or it shall recommend to the Supreme Court the removal, or retirement, as the case may be, of the person in question holding an office named in Paragraph A of Subsection (6) of this Section and shall thereupon file with the Clerk of the Supreme Court the entire record before the Commission."

"(9) The Supreme Court shall review the record of the proceedings on the law and facts and in its discretion may, for good cause shown, permit the introduction of additional evidence and shall order public censure, retirement or removal, as it finds just and proper, or wholly reject the recommendation. Upon an order for involuntary retirement for disability or an order for removal, the office in question shall become vacant. The rights of an incumbent so retired to retirement benefits shall be the same as if his retirement had been voluntary."

"(11) The Supreme Court shall by rule provide for the procedure before the Commission, Masters and the Supreme Court. Such rule shall afford to any person holding an office named in Paragraph A of Subsection (6) of this Section, against whom a proceeding is instituted to cause his retirement or removal, due process of law for the procedure before the Commission, Masters and the Supreme Court in the same manner that any person whose property rights are in jeopardy in an adjudicatory proceeding is entitled to due process of law, regardless of whether or not the interest of the person holding an office named in Paragraph A of Subsection (6) of this Section in remaining in active status is considered to be a right or a privilege. Due process shall include the right to notice, counsel, hearing, confrontation of his accusers, and all such other incidents of due process as are ordinarily available in proceedings whether or not misfeasance is charged, upon proof of which a penalty may be imposed."

"(12) No person holding an office named in Paragraph A of Subsection (6) of this Section shall sit as a member of the Commission or Supreme Court in any proceeding involving his own retirement or removal."

"(13) This Section 1-a is alternative to and cumulative of, the methods of removal of persons holding an office named in Paragraph A of Subsection (6) of this Section provided elsewhere in this Constitution."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition: "The constitutional amendment relating to the removal, retirement, or censure of Justices, Judges, and Justices of Peace under prescribed circumstances."

Proposed CONSTITUTIONAL AMENDMENT

NUMBER SIX ON THE BALLOT (SJR32) General Election Nov. 3, 1970

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 51, Article XVI, Constitution of the State of Texas be amended to read as follows:

"Section 51. The homestead, not in a town or city, shall consist of not more than two hundred acres of land, which may be in one or more parcels, with the improvements thereon; the homestead in a city, town or village, shall consist of lot, or lots, not to exceed in value Ten Thousand Dollars, at the time of their designation as the homestead, without reference to the value of any improvements thereon; provided, that the same shall be used for the purposes of a home, or as a place to exercise the calling or business of the head of a family; provided also, that any temporary renting of the homestead shall not change the character of the same, when no other homestead has been acquired."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition: "The constitutional amendment increasing the value of the homestead which is exempt from forced sale."

NUMBER TWO ON THE BALLOT (SJR10) General Election Nov. 3, 1970

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Subsection (a), Section 20, Article XVI, Constitution of the State of Texas, be amended to read as follows:

"(a) The Legislature shall have the power to enact a Mixed Beverage Law regulating the sale of mixed alcoholic beverages on a local option election basis. 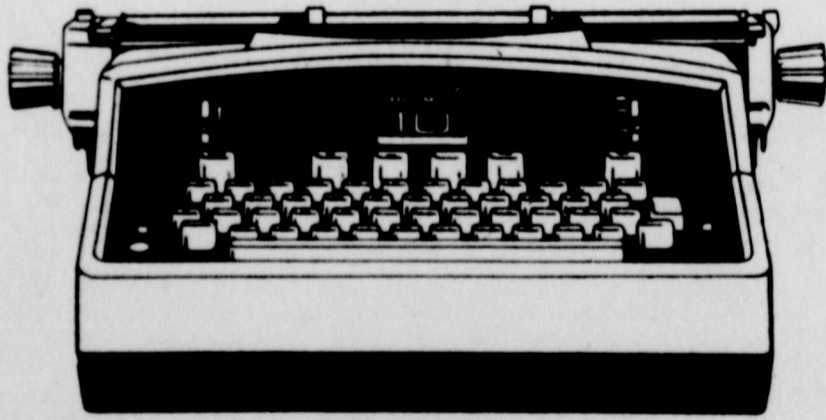
