



Tax Bills Mailed Propoerty Owners

Tax statements have been mailed by the tax assessors and collectors of the Terrell County Independent School District and Terrell County - A. H. Zuberbueler, and Mrs. A. J. Hahn Jr., for the two taxing agencies in the county that levy taxes.

The larger of the two assessments in the county is the school district, which has a total of \$331,585.20 levied in taxes and there were 1,328 statements mailed. Mr. Zuberbueler reports that about 98% of the taxes levied have been collected each year since the division of the assessing and collecting from the county at the time of the formation of the independent school district which levies and collects its own taxes.

The county tax office mailed out 1, 303 statements for a total tax levy of \$111, 675. 12. This figure also includes the state taxes that are collected by the county based on a 37¢ tax on each \$100 valuation.

There is a total valuation of \$8,563, 400.00 on the county's tax rolls, which is different from the school's tax rolls, due in part to fact that the schools' rolls includes automobiles that are not on the county's roll.

The amount of money levied by the two is also different due to the rate that is set by the school board and the county on the total valuations rendered or levied

Property owners or tax payers are offered a discount for the early payment of county taxes, but not for school taxes.

Cong. White Asks Investigation Of Mail Service

Word was received from the office of U.S. Representative Richard C. White Monday that an investigation has been ordered into an alleged deterioration of postal service.

The report was given by Rep. White and W. E. Purcell, representative from Wichita Falls, to the chairman of the House Post Office and Civil Service

A representative of the committee will be in El Paso soon to hear of deterioration or reports of deterioration in the mail service.

The alleged reduction in the quality of the mail service is that of a national scale, rather than a local situation, according to the representative.

Absentee Voting Details Listed

Any qualified Texas voter eligible to cast an absentee ballot by mail may now make application to his county clerk for an absentee ballot for the Nov. 3 general election.

In order to vote absentee by mail in this election, a voter must: (1) be unable to appear Nov. 3 at the polling place because of sickness or physical disability; or (2) expect to be absent from his county of residence on Nov. 3 and during the county clerk's office hours throughtout the period Oct. 14-Oct. 30, inclusive.

All applications for absentee ballots must be received in the county clerk's office not later that Oct. 30.

Details as to absentee voting procedure may be obtained from a voter's county clerk. Generally, these provisions ap-

A voter applying for an absentee ballot by reason of sick ness or physical disability must mail his application to the county clerk. It should be accompanied by the voter's registration certificate, and by a certificate of a duly licensed physician, chiorpractor or accredited Christian Science practitioner certifying to the voter's illness or physical disability.

A voter desiring to vote absentee by reason of absence from the county may either deliver or mail his application for absentee ballot to the county clerk. In the application, the voter must state that he expects to be absent from the county on election day and during the clerk's regular office hours for the entire period of personal appearance absentee voting (Oct. 14-Oct. 30). The absentee ballot then must be mailed to the voter at an address outside his county of residence. Also, the envelope in which the voter returns the ballot must be postmarked from a point outside his county of residence.

Voter registration in Texas this year hit an all-time high of 4, 150,645. On Nov. 3, voters will express their preference in state, district and local races, as well as on 7 proposed state constitution amendments.
