'It's Your World' Essay Contest For Area 5th Graders

Fourth and fifth graders of Sanderson, Alpine, Fort Davis, and Big Bend Park will again have the opportunity to participate in the "It's Your World" essay contest. Co-sponsored by the Alpine Rotary Club and the Big Bend Natural History Association for the third year, this year's contest will coincide with the nationally recognized Earth Week activities of April 19 to 24.

The winning author will win an expenses paid weekend at Big Bend National Park for himself and his family and his teacher and family. In addition, the first, second and third place winners of the overall contest will receive a beautifully illustrated book on the National Parks as well as an engraved trophy. There also will be room winners who will win engraved plaques. The plaques will remain in the school and additional names will be added each year that the contest continues.

According to Co-chairman Paul Forchheimer and Ro Wauer, the object of the contest is for students to express their personal concern about environmental problems and to offer ideas on how to improve our country and world. Four basic attitudes should be realized, 1) a respect for nature, 2) a reverence for life, 3) a sense of responsibility for wise use of land and natural resources and 4) a recognition of dignity in purposeful outdoor work and in development of personal skills.

Here are the details: During the second week of April, fourth and fifth grade teachers will receive packets of booklets and information sheets for each of their students, as well as a list of suggested activities for preparation of lesson plans. They will then have the opportunity to acquaint their students with the materials so that an essay can be written by April 30. A Park Ranger from Big Bend National Park or Fort Davis National Historic Site will visit at each school to talk with the teachers and students during Earth Week. Final selections will be announced about May 15.

Sanderson placed 4th in a field of 17 schools that competed in a track meet at Andrews last weekend. Eldorado won the meet with 90 points, Rankin had 81, Kerrville 70, and Sanderson 62. Others in the meet in their order of finishing were Van Horn, Petersburg, Sudan, Lubbock Cooper, Crosbyton, Clint, Borden County, Happy, Hale Center, Wink, Grandfalls, Andrews, and Wellman.

Coach Willie Myers reported the following results of the meet:

Kendrick Harrell, Leslie Hall, Manuel Olivas, and Bill Littleton were 6th in the sprint relay with a time of 42.5.

Ronnie Stewart placed 5th in the 880-yard dash. Jerry Jones was also a contestant.

Littleton and Randy Louwien were entered in the 100-yard dash.

James Druse ran the 120-high hurdles in 16.3 for 3rd place.

Druse was 2nd in the 330-yd. intermediate hurdles with the time of 42.2.

Olivas was 2nd in the 440-yard dash with 50.0; Rolando Rodriguez also ran in the race.

Raul Ybarra won the mile run with 4:42.5; Juan Lomas also ran the race.

Olivas was 2nd in the 220-yard dash with 22.6.

Rodriguez, Harrison, Ybarra, and Stewart comprised the mile relay team which placed 6th with 3:40.0.

Druse, Hall, and Jim Cash were in the high jump.

Blain Chriesman placed 5th in the discus with 120'2"; and Bill Mott and Louwien were entrants also.

Chriesman, Louwien, and Roger Sanchez were entered in the shot put.

Hall was 2nd in the pole vault with 11'6"; Cash had the same height, but in more tries, and placed 3rd.

The district meet will be in Van Horn commencing today.

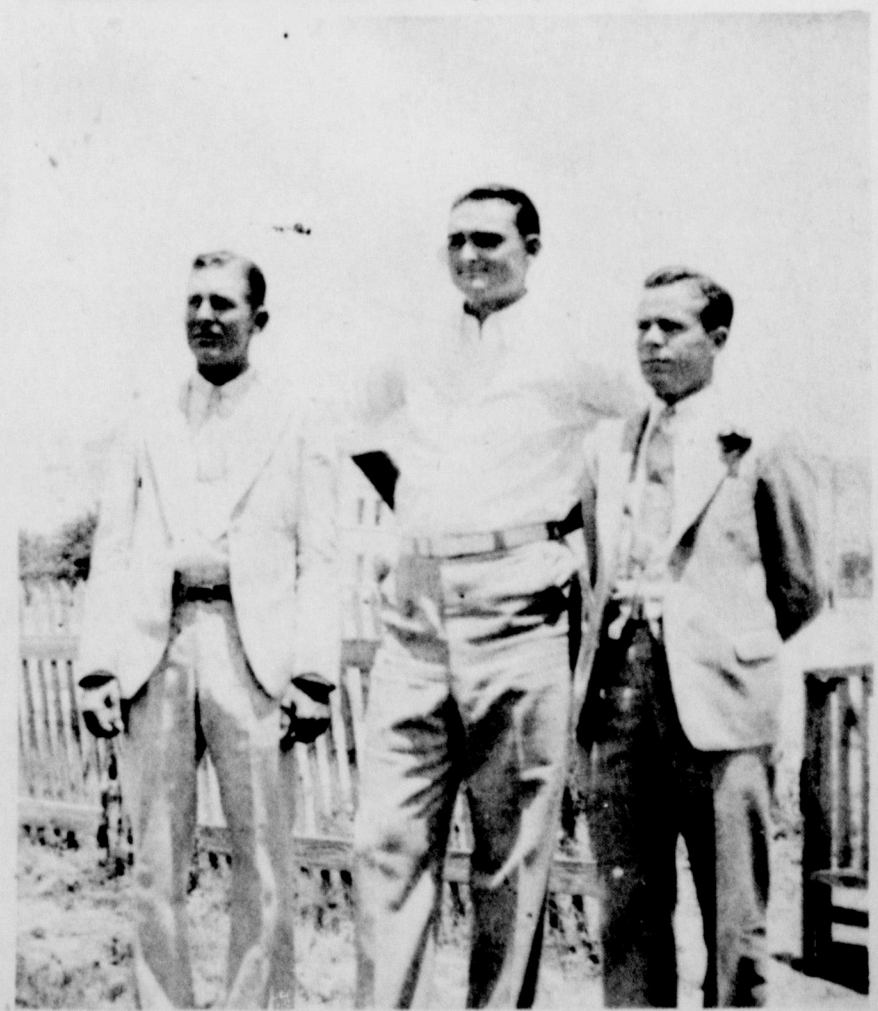

Rate For Letters Still Bargain, Postmaster Says

No one likes to see anything increase in price, and mail service is no exception. Postmaster J. R. Hodgkins, in discussing proposed postage increases, reminds patrons of several comparisons with other items in the national economy.

"When effective, the new rate (8 cents) will mean first class stamp prices have increased by 166% since 1932," Hodgkins said. "If that sounds like a lot, consider that during the same 39-year period, wholesale prices have increased by 230 percent and the average pay of manufacturing workers has gone up by 670%."

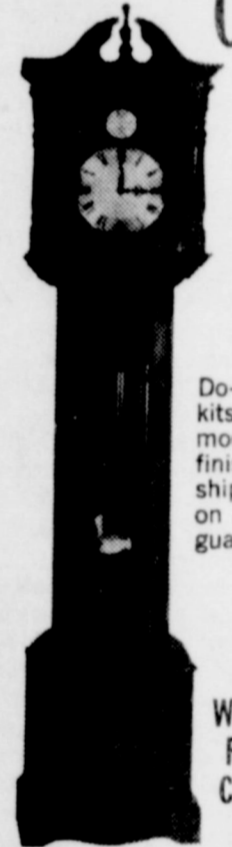
He added that if postal rates had risen at the same rate as retail prices since 1932, it would already cost 10 cents to mail a letter, rather than 8¢.

Mailers holding bulk third class permits for so-called "junk mail" will find their rates per pound rise from 16¢ and 22¢, to 22¢ and 28¢ per pound, respectively, when the proposal is fully effected, and the minimum-per-piece charge will be raised to 5¢.

Increases are also on the drawing board for second class users - which include newspapers, magazines, and newsletter publications.

Notes from the Big Bend

"Dagger Time" comes in late March and April in the Big Bend Country. Then, giant daggers send up their tall flowering stalks and another of nature's cycles begin. Already a few stalks are beginning to grow, and there is good evidence that 1971 will be a good giant dagger year in the Big Bend. Although predictions of the best period of bloom are a little premature, early April looks promising at this writing.

Big Bend's giant daggers are known to science as *Yucca carnerocens*. Yuccas are members of the lily family and are related to the Easter lily, sotol and onions. Usually a solitary plant, they may attain a height of 15 feet. Leaf blades may be four feet long and three inches wide. Giant daggers usually occur on limestone soils between 2,700 and 6,300 feet elevation, but can be found on volcanic soils as well.

Ranging from Zacatecas, Coahuila, and San Luis Potosi in Mexico, to the Dead Horse and Chisos Mountains in the United States, probably, they are most accessible at Dagger Flat in Big Bend National Park. That is where one can most closely view this beautiful, tall lily, and watch the strange story of its reproduction unfold. Although new plants do arise from shoots from the main stem, plants would bear few fruits if it were not for a deliberate act of pollination performed by an inch long moth. Adult moths frequent the flowering heads gathering pollen. Female moths succeed in scraping pollen from the anther by coordinated movements of her head and mouthparts. With the aid of her fore legs she molds the pollen into a ball which she firmly works into a natural pocket under her head. Usually several stamens and more than one flower are visited before the pollen gathering impulse subsides.

Texas Safety Assn. Urges Tougher Drunk Law

"While the rest of the nation moves forward in the area of controlling the number one menace on the highways, the abusive drinker, Texas continues to drag its feet," charged George Wm. Perry, President of the Texas Safety Association, today.

The Dallas attorney, who heads the statewide safety group, said that at the beginning of this year three states did not have laws establishing a level of blood alcohol concentration as presumption of driving while intoxicated, as required by federal standards.

"Now, both Mississippi and New Mexico have established presumptive limits. That leaves Texas as the only state without such legislation," commented Perry.

"Measures have been introduced in the Texas legislature to accomplish this needed improvement in the law. A Senate version awaits

action by the full Senate, but a companion bill in the House is still locked in a subcommittee," said Perry.

"Abusive drinkers, who make up only seven percent of the driving public, last year in Texas were responsible for nearly 1,700 deaths on our highways. This sort of carnage can and must be stopped," Perry stated.

"To do this, Texas must act, and it needs to act now, to establish 0.10 percent blood-alcohol concentration as a presumption of intoxication," he concluded.

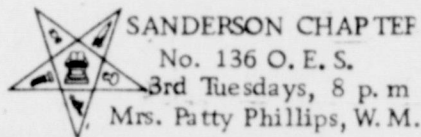

Construction Will Start Soon On New Pipeline From This Area To Scurry Co.

Canyon Reef Carriers, Inc., has been organized to construct and operate a pipeline to move carbon dioxide from Terrell County the the SACROC Unit (Scurry Area Canyon Reef Operators Committee) in the Kelly-Snyder field of Scurry County.

The new company was set up by 14 of the largest owners of the SACROC Unit with J. F. Graham as president and Chevron Oil Co. as operator.

Graham, vice president of production for Chevron here, appointed J. A. Massey as project manager. Massey, formerly division construction engineer for the La Fourche division of Chevron-Calco in New Orleans, will have headquarters at Midland.

The 220-mile line will originate near the Brown-Bassett multipay field in Terrell County and pass through several other fields in Pecos County.

Carbon dioxide, which has no use in these areas, will be collected, compressed and transported for use in the SACROC Unit reservoir.

When the pipeline is operating at capacity early in 1972, over 200 million cubic feet of carbon dioxide will be transported daily and injected into the field. This novel secondary recovery project will result in an additional 150 to 200 million barrels of oil being produced from the reservoir.

The use of Co2 in secondary recovery was pioneered in this area a number of years ago by West Texas Co2 Co., a sub-

siary of Helmerich & Payne, in shallow fields of eastern Pecos County.

A plant built near the Mitchell Plant of Northern Natural Gas Co. took the Co2 after its removal from Puckett field gas, processed it in an adjacent plant and prepared it for transport in liquid form in specially designed tank trucks.

Two years ago the local plant was dismantled and moved to a site near Louisville, Ky.

The big new project will provide an important outlet for what has previously been a waste product. Carbon dioxide, which in its solid form is a refrigerant known as "dry ice," is non-burnable, and when found in sufficient amounts in natural gas must be removed in order to upgrade the heating value of the gas.

Northern Natural, Transwestern Pipeline Co., El Paso Natural Gas Co., and Coastal States Pipeline Co. all have built large plants in major gas fields of the area to remove the carbon dioxide before placing the gas in their pipelines. Millions of dollars in investment and more than a hundred jobs have resulted in Pecos and Terrell counties from the presence of the Co2, which in the past was strictly a nuisance element — except for the small portion of the Northern Natural output which was used by West Texas Co2 Co. before its closing.

The new line to Snyder, with cost unannounced, will put a

part of the waste product to highly beneficial use, with double-barreled benefits to operations on both ends of the line.

The Chevron plan also would eliminate the former process of liquification for transport, and return to gaseous state before injection. It would be moved as a gas, as

needed for injection in the big Scurry county Canyon reef fields.

Increased income to gas producers is expected from the product, as well as added tax values and a limited number of new jobs in the producing areas of Terrell and Pecos counties.

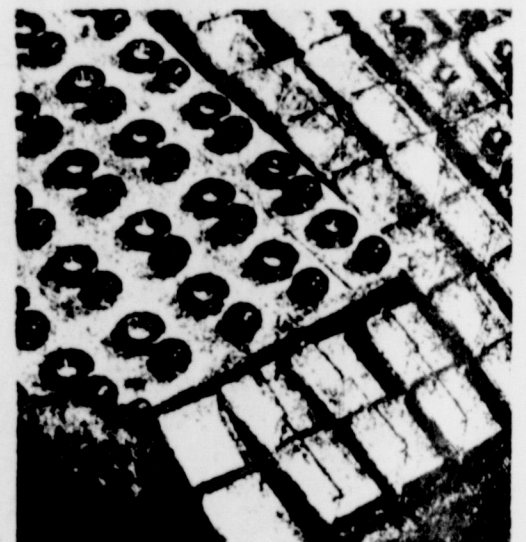

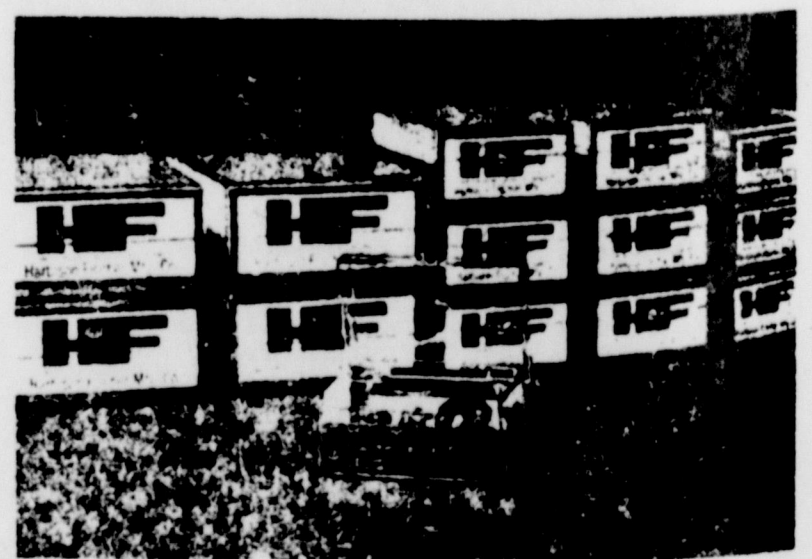

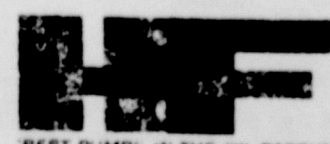
