Final Local Count Show Defeat of All 4 Proposals

The final count of votes on the four proposed constitutional amendments that were voted on Tuesday of last week shows that Terrell County residents rejected all four of the proposals.

The returns available for the paper last week were incomplete, with only precinct 1 votes in by the time of the publication deadline. Mrs. Joe Chisholm ...retires from teaching Mrs. Joe R. Flood Control 1 Step Closer

A multi-million dollar flood control project for Sanderson Canyon watershed moved several steps nearer to final approval in Washington last week as Cougressman Richard C. White testified before the House sub-committee on flood control last Thursday.

The text of Cong. White's speech before the committee is as follows:

"Mr. Chairman and members of the subcommittee. I appreciate very much the opportunity of testifying in behalf of one of the watershed flood control projects before your committee. This deals with the Sanderson Canyon watershed in Terrell, Pecos, and Brewster Counties of Texas, all in my district.

"The need for watershed protection and flood control in that area was demonstrated to me dramatically when I had been in Congress only six months. On the night of June 11th and 12th, 1965, the area above Sanderson, Texas, which normally has a total rainfall of less than 12 inches a year, got nine inches in one night. The next morning, the flood waters came roaring down Sanderson Canyon and into the town. As soon as I was advised of the situation, I took the first available plane and in the meantime, tried to assist in marshalling

of the laziness or wrong tactics of some others.

I also favored with no reservation the passage of the water bond proposal. I know that many cities are in trouble about water and I did not know a better way to help them than to make the bonds available to finance their acquisition of water. On the other two proposals, there was a strong lack of confidence in the legislature that prompted my vote. It seems to my inexperienced eye, and my know-little mind that the legislature has done little or nothing to try to hold down spending or to curb spending in any way in the middle of what seems to be a time that would call for holding the line on spending. And what little I know about it seems to indicate that there has not been enough done to investigate possible wrongdoings of legislators in the stock-vending cases and in loans from banks for campaign expenses.

There seems to be some extreme effort on the part of many to continue to subdue the talk and accusations, when, in our opinion, the legislature should be trying to clean house, so that they could once-again, if they do not now, have the confidence of the people.

l would rather you did not tell how I felt about the proposed amendments, as it is nobody's business how I voted since no one is ever affected in any way by the way I vote!

Don Allen will go to work on June 1 in preparation for assuming the duties as manager of the Terrell County Water Control and Improvement District #1. Jimmy Caroline, who now manages the district, plans retirement soon.

Flood Control

Approval by the committee is expected, and will make the project a part of the year's program of the U.S. Soil Conservation Service. The proposed project has already been included in the SCS watershed work plan for the next fiscal year, if approved by Congress.

Three soil conservation districts in three counties will be involved in the project, Congressman White's office said. The Trans-Pecos District, headquartered in Fort Stockton; the Big Bend Soil Conservation District in Alpine and the Rio Grande-Pecos SCD, headquartered in Sanderson, will all work together in coordinating progress of the project on the local level, as will the commissioners' courts of Pecos, Brewster and Terrell Counties.

Local SCS and county representatives were invited to appear in Washington before the congressional subcommittee, and although unable to attend the hearing today, have sent written information for presentation by Congressman White.

The project calls for 11 flood control dams in the three counties over a 216-square mile watershed, plus 1800 feet of channel improvements and extensive land treatment to promote vegetation, improve ranges, and retard runoff during heavy rainfall, the congressman said.

A prime objective of the

be \$4,700,258, Congressman White said. Of this figure, the federal government would provide \$4,480,695, and the remaining \$289,563 would come from state and county sources.

The congressman further reported that hearings have already been held in the senate, at which he testified, and he has been assured by Senator Hovd Bentsen, a member of the senate committee, that the project has an excellent chance to be adopted

safety. Four children were washed out of a tree, unable to hold on against the raging waters. Twenty-six lives were lost, including 16 children. This represented 2% of the town. Apply this percentage to a town you represent and you will see the magnitude of the tragedy for the people of Sanderson. Two of the bodies were never found. The flood waters cut through the Sander son Cemetery, washing the bodies of the dead downstream with the living.

"The Red Cross survey showed that 54 homes were destroyed and 169 damaged. Several businesses were destroyed. Others were damaged extensively, and both highways and railroads were put out of service for some days. I witnessed the devastation, and for the interest of the subcommittee, I am submitting a copy of the watershed work plan containing some dramatic pictures taken on June 12, 1965, nearly six years ago.

"TheSoil Conservation Service defined this as a "40-Year Flood" of the magnitude that might be expected once in 40 years. Of course, nature does not maintain a schedule of these things, and the next 40-year flood could occur tomorrow. Lesser floods over the Sanderson Canyon watershed area occur almost every year, and the Soil Conservation Service calculates the average annual damage from flood waters at \$316, -359.00 over the evaluation period. This could be reduced to an average of \$6, 590 a year by the construction of this project, a saving of \$309,-769 annually. Other benefits such as improvement of the ranges, conservation of soil and water resources, and improvement of wildlife habitat make this a still more attractive investment, with a total cost to the government of \$4, 480, 695.00.

"Following the flood of 1965, it was my purpose to offer the people of Sanders, every possible cooperation to prevent the recurrence of such a tragedy. Both the Soil Conservation Service and the Corps of Engineers looked into the problem; and the people of the area, themselves, chose the Soil Conservation Service route. They felt it would be less expensive and would afford more widespread benefits.

"It is a program in which the people of Terrell, Pecos, and Brewster Counties have had an active part. Participating with the Soil Conservation Service, Department of Agriculture, are the Rio Grande-Pecos, Big Bend, and Trans-Pecos Soil and Water Conservation Districts, and the commissioners courts of the three counties. They have reviewed and approved the work plan for this project and join me in respectfully asking your approval. I am presenting here, for the record, letters from these participating organizations.

"I want to thank the members of this subcommittee and your staff for your fine cooperation in bringing this project forward. "Thank you".

project is to prevent any repetition of the Sanderson flood disaster of 1965, which took 26 lives and caused damage into the hundreds of thousands of dollars.

The study made by SCS in Washington in preparing its approved work plan estimates the average annual damage by water at \$387,055. Damage caused by the flood in 1965 was considered in computing the figure. This figure it is now estimated, would be reduced to \$8,047 per year, on the average, after completion of the flood control project.





6.6 Miles of US285 South of Stockton Is Presently Under Construction

Construction started last week on a 6.6-mile stretch of U.S. 285 between Sanderson and Fort Stockton. The construction area will begin near the intersection of US285 and US90 in Fort Stockton.

Jones Bros. Paving Contractors of Odessa was the low bidder on the job. \$521,000 was the lowest of eight bids submitted.

Brad Buford, resident engineer of Fort Stockton, will be in charge of the project. He says that there will be a 45mile-per-hour'speed limit set on the entire project during the construction period. The speed limit will be enforced by officers in that city and in Pecos County, and the Texas Highway Patrol.

Buford stated that the purpose for the slow speed limit and for strict law enforcement through the construction area was an effort to avoid injury to a worker or traveler and he asked for the cooperation and understanding of all motorists.


