Delinquent Tax Fee Is Upped

The fee for delinquent taxes will be upped \$1 as a result of legislation passed recently and effective September 1,

The Bill creates a Legislative Property Tax Committee of five members, to make a thorough inquiry into the entire process of ad valorem taxation in Texas and to recommend to the legislature such changes, modifications, and additions to the laws as the committee may deem necessary and proper. The operation of the committee is to be funded by imposing a fee of one dollar on each delinquent tax receipt. There is now a \$1 charge on redemption certificates, which covers delinquent property taxes. In other words you will be paying \$2 extra plus your penalty and interest, according to information received from Mrs. A. J. Hahn, deputy tax assessorcollector.

The Attorney General of Texas will make a ruling before February 1, 1972, if this will also effect the current tax receipts issued during the months of February through June.

Students Must Get Immunizations

All parents and students are reminded of the new state law which requires immunization against certain diseases in order to enroll in school.

All students will be allowed to enter their respective school systems during the summer and fall terms this year with the provision that their immunizations against at least one of the six diseases has been started by January 1, 1972, and completed as soon as is medically feasible there-

Immunization schedules according to grade or age groupings include:

Kindergarten through fifth grade, Polio (at least three oral doses of vaccine), diphtheria-tetanus (minimum of three doses with one being received since the fourth birthday), measles (one dose of vaccine), does not apply if child has had measles; rubella (one dose) not required past age 12, and smallpox (one vaccination) within past 10 years.

In children enrolling in grades 6 through 12, the same innoculations are required as for the younger group with the exception of measles.

Students enrolling in college will need a booster D/T provided they have had the initial three doses when younger, and a smallpox vaccination within the past 10

Schools will be required to maintain records of the immunization status of individual students.

Federal Help Available For Area Ranchers

Terreli County ranchmen are advised that the federal government is making available to residents of the Southwest many types of assistance to help through the drouth and its aftermath.

The programs available are: Agricultural assistance loans from the Farmers Home Administration; business economic injury loans from Small Business Administration; cattle feed at a reduced rate from A. S. C. S.; food, County Welfare Office; hay transportation assistance from the A. S. C. S.; income tax advice and assistance from the U.S. Internal Revenue Service.

Malathion Sprayed On Dump Ground

A 5% solution of Malathion was used to spray the dump ground Monday, according to Dr. A. N. Clanton, county health officer, who said that there were many, many containers there that could be breeding places for mosquitoes. He said that the measure was an effort to prevent or counter the possible spread of Venequelan Equine Encephalomyelitis. It is also good to help control the fly condition, a good source of the spread of many diseases, he stated.

Local and area residents are warned to look around their property and try to eliminate all possible sources of mosquito-sustaining causes. Dr. Clanton stated.

All reports received by The Times indicated extremely scattered showers.


