J. S. Nance, 72, Former Sheriff, Is Buried Here

James S. Nance, 72, died Sunday evening at his home in Sierra Blanca following a long illness.

Funeral services were Wednesday morning in the high school auditorium with Rev. E. H. Carson, pastor of the First Baptist Church officiating. Due to inclement weather, the Masonic service was given before leaving the high school. Burial was in Cedar Gove Cemetery.

Nance was born October 3, 1899 in Ozona, the son of Mr. and Mrs. Joe J. Nance, moving to Terrell County in 1911 and attended Sanderson schools. His father was a former sheriff of Terrell County. He was a veteran, serving in the U. S. Army during World War I. He was married to Sadie Harrell in 1920 and two daughters were born to that union: Mrs. Richard (Ethel Laura) Haley of El Paso, and Mrs. Dan (Katherine Nell) Murrah of Bracketville. His first elective office was as tax assessor and collector of Terrell County in 1932 serving in this capacity until the office was combined with that of sheriff. He served as deputy sheriff for four years under Lee Cook who resigned after he married Nance's sister, Miss Nell Nance, and Nance was then appointed sheriff in February of 1938, holding that office until he left Sanderson in 1953. He moved to Sierra Blanca and was named a Texas Ranger and served until he reached the mandatory retirement age of 70.

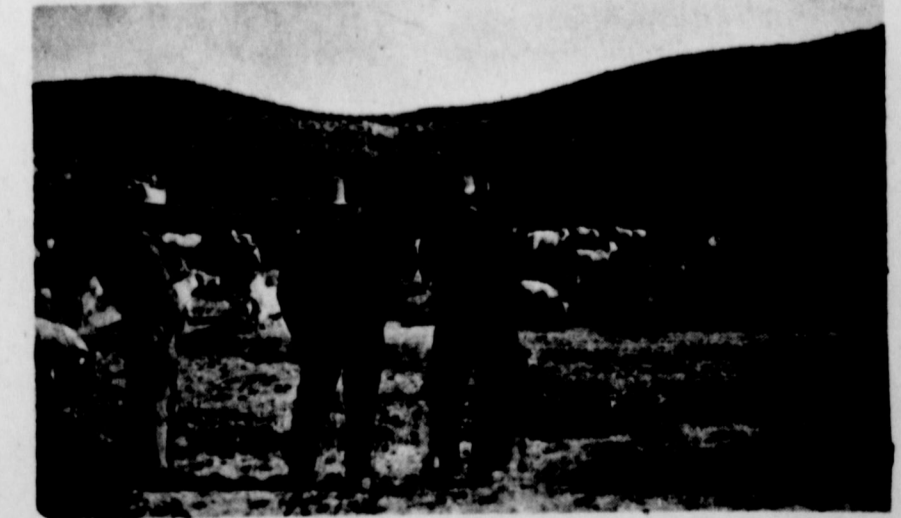
He is survived by his wife and two daughters, a sister, Mrs. Laura Dishman of San Antonio; a brother, Austin Nance, of Sanderson; five grandchildren and seven great-grandchildren.

Nance was a past master of the Sanderson Masonic Lodge, of which he was a member at the time of his death.

Pipeline Crew Moves In Here

McVean and Barlow Co. of Odessa has moved offices into Sanderson to begin construction of a 12-inch pipeline from the El Paso Natural Gas Co. plant on the Herbert Brown ranch north-westward to the Gray Ranch plant in the Puckett Field area to connect to a larger line which goes to Snyder and from there to other transmission lines. The pipeline will carry carbon dioxide gas for injection into weak wells to revitalize them.

The ditch for the line will be from 48 to 72 inches deep and the peak number of workers during the construction is estimated from 250 to 300. Construction is expected to last about two months.

The offices of the construction company will be on Downie St. south of the McKnight Motor Co.

The construction company is contracted by Canyon Reef Carriers, Inc., a company pooled by several major oil companies who use the carbon dioxide in their well injection operations.

Good Rain Falls Here Monday

One of the biggest rains in many months fell in Sanderson Monday afternoon, leaving about 2 inches in gauges here. The streets ran heavily after the fast-falling rain and it appeared for a while that water would enter several businesses and homes.

There was a wary eye kept on the run-off of water into the canyon above Sanderson by many people.

The heavy downpour also demonstrated again the need for some consideration to improved drainage ditches above Oak St. to carry the water to the east and Sanderson Canyon: before it can accumulate in the low-lying areas. The bar ditches on Pine St., Hackberry St., and Mansfield St. east of First St. were running bank full and overflowing through yards to the south, each overflow building up an additional surplus as the water flowed to the south and east.
