## LISTEN TO LUKE

 We have decided that we are in the wrong business, possibly. We decided this after seeing a copy of a booklet last week that stated as a part of its purpose... "Within its pages are found a concise review of the players and coaches that make West Texas football the great sport that it is." And their incorrect English, even of "are found" instead of "is found". Sanderson merchants contributed what is reported to be approximately \$200 for the cost of advertising their individual businesses and the Sanderson Eagles received exactly 24 lines of type, 12 of which were the schedule, and 3 more to say "6-A Sanderson Eagles". This type consumed approximately 4 1/4" and a small picture of one of the players. Using this as some kind of a basis, and taking last week's paper, our total inches in the boosting of the football team was in the neighborhood of 19 inches, and so our local advertising income should have been about \$1,000.00. It might appear to some that the publication that was supposed to boost teams was boosting the publisher more, and the advertisers that were paying for the boosting of the football teams got the advertising they paid for, but the overall accomplishments were not the same. We have never hung out any banners as publishing a paper for the good only of the football teams, or for that matter, even just for the good of the advertisers. It has always been sort of a mutual good that we were trying to accomplish for the town and county — including all segments of the community — and the publisher. Just to keep the records correct, and that is another job of a newspaper, if at all possible, we first became an Eagle booster in 1939, and officially on September 29, 1939, when we wrote the story of a football game between Sanderson and Fort Stockton. And since many of the Eagle boosters are not able to remember that far back — the players included David Allen, Roger Bassett, Sam Bell Jr., Ralph Burleson, Malcolm Davis, Harold Haynes, Campbell Kerr, Curtis Litton, Wilton Murray, Manuel Ochoa, Pablo Perez, Jack Turner, Bill Davis, Don Allen, Joe Bean, Martin Bodkin, Al Creigh III, B. F. Davis, Lynn Haynes, Kenneth Litton, Robert Lochausen, Theo McDonald, Jose Ozuna, Jesus Trevino, Jim Wilkinson, and Ross Stavley. Sanderson won, by the way, 6-0. We still are not waving banners, but in another manner we are trying to sell some advertising, and possibly some subscriptions. We will be happy to continue to boost the Eagles and all of the students in all of the schools, and we would also be happy to run an ad similar in size to those in the publication referred to for about 1/10 the reported cost there. There's no one who boosts Sanderson more than do Sanderson people!

Funeral services were held at 10:00 o'clock this morning at the First Baptist Church for Mrs. Bertha Stavley Mansfield who died Tuesday morning early after her arrival in Victoria. She had not been feeling well and her son-in-law and daughter, Dr. and Mrs. J.M. Flowers Jr., of Victoria came after her on Monday. Death is reported to have occurred shortly after she was admitted to the hospital there. Mrs. Mansfield was born in Juno August 23, 1908. Her parents, Mr. and Mrs. Charles Stavley operated a grocery store and stage stop at Juno for many years prior to moving to Terrell County in 1924. She married Ben H. Brown in 1928 and two sons, Harry Brown, of El Paso, and Joe N. Brown, of Sanderson, were born to this union. Mr. Brown died in 1931 and in 1933 she was married to Francis Mansfield. Two children, Mrs. Flowers (Marilyn), and Tommy Mansfield, who lives in El Paso, were born of this marriage. Mrs. Mansfield had ranched in Pecos County for many years, the ranch being located just to the west of Sanderson. Besides the children, she is survived by her mother, Mrs. Lena Stavley; four brothers, W. E. Stavley of Del Rio, C.H. Stavley and Ross Stavley of Sanderson, and Frank Stavley of Katy; two sisters, Mrs. Roy Mason of Crane and Mrs. Joe Chandler of Dryden. Burial was in Cedar Grove Cemetery under the direction of the Janes Funeral Home of Ozona. Rev. E. H. Carson, pastor of the First Baptist Church conducted the funeral services.

Antlerless deer permits will be issued to landowners or their agents on November 1 at the Terrell County courthouse, according to Texas Parks and Wildlife Biologist Jack Kilpatrick. Those persons who desire permits but foresee not being able to make the above date, should either designate someone as their agent to pick up the permits, or contact Kilpatrick before then. An agent drawing permits for someone else, must have a written authorization from the person in charge of the acreage which specifies the number of permits desired.

## Eagles Stomp Tigers 37-13; Conference Game This Week

The Sanderson Eagles rallied after an early touchdown by their foes, the Brackettville Tigers, and led during the balance of the football game, ending with a 37-13 margin. It was a non-conference tilt. Brackettville's quarterback, Joe Rose threw a pass to Doug Ward, a halfback, that was good for a 10-yard touchdown completion. Their extra point conversion was a place kick that was good and the Tigers went out in front 7-0. There were some long and thrilling runs for the benefit of the Tiger fans that set up the touchdown pass. After the Eagles received the ensuing kickoff, their second play was a pass from Quarterback James Druse to End Randy Louwien that was good for 57 yards and 6 points. Their attempt for extra points failed. Again in the first period Druse went over the goal line from the 2 and Chago Flores converted the extra points. In the second period Kendrick Harrell, halfback, went over from the 1-yard line and Bill Mott kicked the extra point.

The Tigers' Rose executed an excellent bit of deception on a bootleg play to the weak side and ran 10 yards into the end zone for their second and final score. The PAT try failed. Druse ran 40 yards on an option play and got into the end zone for the fourth Eagle score and Floyd Watson took a pitch-out from Druse and went over for the 2 extra points. The final Eagle tally was in the fourth frame and was by Druse who followed Center Ronnie Stewart over from only inches outside the goal stripe. He passed to Louwien for the extra points and brought the final tally to 37-13. The Tigers were very effective against the Eagles' defense until they got deep into Sanderson territory when the defense stood firmly. Their punts were short and their pass tries were few and ineffective. The Eagles' ground game was a mixture of thrilling long runs and short and steady ground-gainers with completed passes helping in the total effectiveness of their offense. Coach Willie Myers reported the following statistics for the game against Brackettville, which was the best of the season in total yards, he said:

Rudolph George Wallace, 47, of El Paso died at 6:30 a.m. Friday in Zarogosa, Mexico, of injuries received in an auto accident.

Burial was Tuesday in Junction.

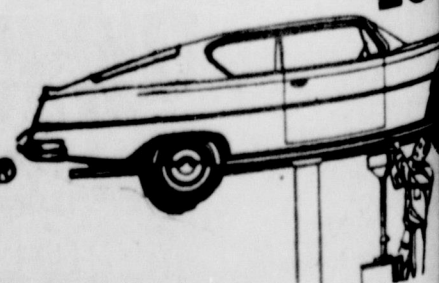

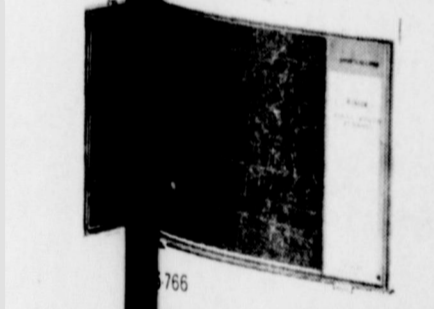

### Regulations Stiff For Businesses

According to information received recently, every Texas business will be subject to inspections of the Federal Occupational Safety & Health Act Regulations by federal inspectors. It is suggested that each employer write his Washington Congressman advising them of your opinion of the OSHA regulations and how critically their help is needed to have these regulations changed.

Some of the regulations would require, according to the information received, that in all business buildings that "permanent aisles and passageways shall be appropriately marked", require posting of design loads approved by building officials; guarding floor and wall openings and holes, without consideration being given for reasons for floor or wall openings, or existing walls that protect such floor openings; protection of open-sided floors... runways, such as docks, etc. Under the section on Means of Egress, it is said that the section is so ambiguously written, that any requirement could be imposed upon an employer. The inclusion of "old" or existing buildings under this requirement would prohibit the use of thousands of existing structures. The fire resistance requirements under the "protective enclosure of exits" section would require extensive remodeling to such an extent, that many businesses would be forced out of existence.

In the "Personal Protective Equipment" section, it is stated that if an injury is sustained for whatever the reason and such safety equipment is not used or furnished, the language expressed indicates "Prima facie" evidence of non-compliance by the employer even though the history of such an occupation would reasonably indicate that such protective equipment was not necessary.

In the section on "General Environmental Controls", it is said that the availability of potable water supply within 200 feet of employees regularly engaged in work is required; and that water cannot come in contact with the ice, forcing the employer to provide either an elaborate water cooler or provide uncooled water as no container now manufactured is between the two extremes.

Another regulation would require hot water into a rest room or wash room in businesses for washing facilities for employees.

The section covering "Medical and First Aid" could work an insurmountable hardship on businesses in many towns in West Texas, according to the information available, making it impossible for them to continue to operate in accordance with the law.

It is also stated that the regulations covered under the sections on "Hand and Portable Powered Tools and Other Hand-Held Equipment", and the "Electrical" section, that compliance requirements would be

### Vehicle Brake Law Is Revised

Ranchers as well as others in Terrell County should become familiar with the new vehicle law concerning brakes that was passed recently by the Texas Legislature, according to information received last week-end.

The new law applies to every trailer, semi-trailer, and pole trailer equipped with air or vacuum actuated brakes and every trailer in excess of 3,000 pounds. These trailers must now be equipped with brakes acting on all wheels which can be applied automatically and promptly and remain applied for at least 15 minutes upon breakaway from the towing vehicle.

However, there are some exceptions to the law. Trailers with a gross weight of 3,000 pounds or less and those weighing 40 percent or less of the towing vehicle are exempt.

Also farm trailers or semi-trailers moving temporarily on highways at speeds of 30 miles per hour or less and having a gross weight of 10,000 pounds or less are exempt from the brake requirements if they are otherwise exempt from vehicle registration laws.

In addition, brake requirements were added for mobile homes, certain vehicles in driveway and towaway operations, and certain trucks and truck-tractors having three or more axles.

Officers of the Texas Department of Public Safety have more specific information on the new law as well as the effective date of the various provisions of the laws.
