Jim Turner Hired For County Work

Jim Turner has been employed as supervisor of work in precinct 1 by Terrell County, according to County Judge R. S. Wilkinson. He was most recently employed by Big Bend Gas Co.

According to Judge Wilkinson, Turner's salary will be paid by funds available by arrangements throught the Permian Basin Regional Planning Commission and he will be responsible for all county work within the precinct.

Judge Wilkinson stated that an agreement had been made between county commissioners of precincts 1, 2, and 3 -F. M. Weigand, Austin Chriesman, and David Mitchell, that would permit the planning of work within precinct 1 for the most expeditious completion. Equipment from precincts 2 and 3 would br brought into Sanderson as needed and the assistance of the two commissioners in planning work and means of accomplishing needed improvements would be available. Turner would be working under the two commissioners as the supervisor of local work, and would work in whatever capacity possible in accomplishing the tasks needed or undertaken. Judge Wilkinson stated that, among other things, Turner would personally supervise the trash pick-up until those employees had a systematic method of pick-up and disposal of local trash; he would be responsible for the maintenance of the county vehicles, making such minor repairs as he could himself; and also be responsible for the repairs to local blacktop and shoulders of local streets. These are the tasks that are immediately planned, the judge stated, but he added that there would be others.

JANUARY 27, 1972 Duane E. Smith, 64, Ab Gholson, 90, Former Coach Here, Dies In Evant **Buried In Alpine**

Duane E. Smith, 64, died at his residence in Alpine Sunday afternoon, apparently suffering a heart attack. He was a former high school principal and head coach at Sanderson.

Smith was born August 17, 1907, in Bellflower, Ill. He was a varsity basketball team member at Texas Christian University in Fort Worth and graduated from that institution in 1931.

Smith came to Sanderson in 1931 as a teacher and head coach. He was named high school principal in 1935 and served as both coach and principal until 1940, resigning the former at that time when he was replaced by "Bodie" Hunter as coach. He moved to Alpine in 1942. He also organized the Boy Scout troop here and served as Scoutmaster during all of his stay in Sander-

He was associated with a men's clothing store in Alpine; was a member of the Methodist Church; and active in little league baseball there for many years. He was a veteran of World War II.

He is survived by his wife, Mrs. Edith Caldwell Smith; a son, Maj. Duane Noble Smith, of Fort Leavenworth, Kans., and four grandchildren.

Funeral services were Wednesday in Alpine under the direction of the Geeslin Funeral Home.

Funeral services were in Evant last Wednesday afternoon for Albert Frank (Ab) Gholson, 90, and burial was in that city.

Mr. Gholson served with the Texas Rangers and with the U.S. Customs service for 40 years before retiring, serving on the border between Sanderson and Del Rio.

He was married in 1905 to Miss Orline Wynne who preced ed him in death three years ago. Two sons, Edwin and James Gholson, died several years ago. Mrs. John Prude of Del Rio and Fort Davis, a daughter, is the only survivor besides nieces and nephews.





Soil Information Aids Decisions For Ranchmen

The shortest distance between two points is a straight line, but this may not be the cheapest route.

Soils information can help you make an intelligent decision on the best route for a planned pipeline, road, or underground cable. A soils map can be used to determine areas where the bedrock is shallow, soils may be corrosive to steel or concrete, hard galiche will encountered, soils contain gravel, cobbles, and large stones, and other soil characteristics which may influence a project. This soils information can be obtained from the Soil Conservation Service office in Sander-

Soils information furnished by the Soil Conservation Service has been used for many years by farmers and ranchers. It has assisted them in making decisions regarding land use and treatment needed to conserve their soil. Soils data available has not been as . widely used in other enterprises, and this is unfortunate according to Herb Senne. He states that soils map is a valuable planning tool in both urban and rural areas. It can be interpreted to determine those areas that are good sites for homes, roads, parks, commercial areas, septic tank filter fields, sanitary land fills. ponds, and shallow excavations such as underground utility lines (pipelines, sewers, cables, etc.), cemeteries, basements and open ditches. It will also point out soil limitations you can expect to encounter on a site when other factors determine the location of a project. This will assist you to plan into your job the necessary features to overcome a soil limitation in advance.

A soil scientist classifies the different kinds of soils and records their boundaries on an aerial photograph. He goes over the land and digs numerous holes to examine the different layers of soil. The vegetation and other features of the landscape are studied. He describes the soil and gives it a seperate symbol which is used to identify each different soil. This description contains information about the structure, texture, slope, natural drainage, depth of different layers and other physical characteristics. This description along with field experience of SCS personnel can give estimates of percolation rates, bearing strength, shrink-swell characteristics, grain size, water-holding capacity, compaction characteristics and many others. With this information desirable and undesirable features of a soil can be determined and its limitations recognized

for a given use. A soils map does not eliminate the need for sampling and testing at the site of specific projects involving heavy loads and where excavations are deeper than six feet. It also may include small areas of different soils which could not be seperated on an aerial photo. These areas could be very significant to the project. Even in these situations, however, the soil map is useful in planning more detailed field investigations and for indicating the kinds of problems that may be expected, states Senne.

A soils map can serve the user as a blueprint of the land. It will help him make wise choices in the use of the land.




