M. de la Cerda Funeral Last Week

Funeral services were in El Buen Pastor Methodist Church Thursday morning for Marcos de la Cerda, 82, who died in an Alpine hospital early Tuesday morning. He had been a medical patient for several weeks. Rev. Amado Elias, pastor, officiated at the rites and burial was in Santa Rita Cemetery. Geeslin Funeral Home of Alpine was in charge of arrangements. A retired sheep shearer, he had lived in Sanderson since 1915. He was born in Mexico April 24, 1889. He was a member of the El Buen Pastor Church. Besides his wife, Mrs. Manuela de la Cerda, he is survived by a son, Baldemar de la Cerda of Kermit, four grandchildren and three great-grandchildren; a sister, Mrs. Petra Reyes of Mexico.

Gas Strike Seen At Turk Well

An Atoka gas discovery was indicated in Terrell County with the flowing of gas at the maximum rate of 6.8 million cubic feet daily on a drillsten test at Skelly Oil Co., Midland, No. 1-4 Oasis Ranch, in 4-Doc Turk-CCSD&RGNG, Abst. 2373, 35 miles northeast of Dryden, 11/4 miles southeast of the depleted one-well Brown-Bassett, North (Fusselman) field and six miles north of the Brown-Bassett (Ellenburger, Fusselman, Pennsylvanian and Wolfcamp) field. On the three-hour test at

11,279-379 feet, water blanket surfaced in 17 minutes, flowing back the 2,000-foot water blanket in 15 minutes and gas in 30 minutes, flowing through the separator at the rate of 6.8 million cubic feet daily and decreasing to 5.4 million cubic feet after one hour.

Then flowed to the separator on a 1/2-inch choke, it made gas in 10 minutes at the rate of 2.3 million cubic feet daily, then flowed 30 minutes at the rate of 2.5 million cubic feet daily, then 30 minutes at the rate of 3.4 million cubic feet daily, then 30 minutes at the rate of 3.31 million cubic feet daily, and then 18 minutes at the rate of 3.25 million cubic feet daily.

Recovery was 10,502 feet of gas and 775 feet of gas-cut mud; recovery from the sample chamber was 6.2 cubic feet of gas. Flowing pressure was 1,403-1,476 pounds; one-hour initial shut-in pressure, 5,815 pounds; and four-hour final shut-in pressure 5,783 pounds. Drilling was scheduled on a 15,200-foot contract. Earlier it flowed gas at the rate of 3 million cubic feet daily, decreasing to 500,000 cubic feet daily, after three hours when drilling reached 11,200 feet. The Brown-Bassett, North opener, Roden Oil Co. (now HNG Oil Co.) No. 1 L.H. Hicks, was finaled Nov. 5, 1961, for a calculated, absolute open flow of 4.05 million cubic feet daily through perforations at 12,844-876 feet. It became depleted in November 1968. A potential of 4.2 million cubic feet daily was reported through Atoka perforations at 11,492-12,072 feet, however, it was never filed with the Railroad Commission.

Water District Lowers Rates Starting April 1

Don Allen, manager of the Terrell County Water Control and Improvement District #1, announced last weekend action by the directors of the water district that would reduce the water rates for all local users for a year beginning with the May 1 reading of water meters.

Currently, the rates set a fee of \$2.50 for the first 1,500 gallons; 10¢ per 100 gallons on the next 1,500 gallons; and 8¢ per 100 gallons on the water used in excess of 3,000 gallons.

The new rates would reduce the final figure to 6¢ per 100 gallons for water used in excess of 3,000 gallons.

The new rates will be in effect on May 1 for all local users, residential and commercial.

Other action of the board of directors at their meeting last week was the decision to build a warehouse and working building on the water district's property on US 285. Details of the building and bids advertising will be given as soon as possible, Allen stated.

Cooperation Asked At Trash Dump Site

Jim Turner, who has been in the employ of the county for several weeks supervising the work of picking up and disposition of trash, cleaning out barrow ditches, and repair of local streets, is asking for the cooperation of local people who take any kind of refuse to the local dump.

A new channel has been cut through the dump ground for water run-off, and pits dug for burying all of the junk and garbage that was at the area, and additional pits dug at the far north end of the dump ground for disposition of trash for the present time. Anyone taking any refuse to the area now is asked to take it to the far north end of the plot and put it in the pits if possible or as near to the pits as possible so that it can be pushed into the pits and covered. A lane is going to be constructed in the near future to prevent dumping in the clear area so that there can be a systematic and efficient disposal of all refuse by burial. Turner stated that a lot of time and some money had been spent in getting the dump area in good shape and that with a little cooperation and effort on the part of everyone, it could be kept sanitary and more sightly. He asked that anyone who is not getting a systematic and regular trash pick-up, to let him know so that they can begin, and anyone who is taking their own refuse to the area and would permit the county employees to pick it up, to let them know, also.


